#### DELIVERY IS MADE OF TOWN WATER PUMP

Delivery of the 500 gallon water pump for the municipal water works system was made last week by Layne & Bowler of Memphis. The 50 H.P. direct connected motor which will operate this pump was shipped on the thirteenth from Schenectady by the General Electric Company. Water will be forced from 65 feet below the level in the deep well to the tank 100 feet in the air, the many modern automatic features of the outfit assuring an abundance of pure water at good pressure at all times.

Paul N. Howard, general contractor, will be on the job in about a week to complete the installation of the fire hydrants and connect up the lateral mains. The special crew of engineers from the pump concern will make their installation at the same time so that complete testing of the plant may be secured. It is expected that water will be available to consumers not later than November first.

#### J. A. BROWN ON NORTHERN TRIP

#### FEW COMPLAINTS ON TAX ASSESSMENT

Town Clerk E. T. Owen reports the receipt of twenty-nine complaints up to the time of closing the assessment roll Monday, September 13th. The Council, sitting as a board of arbitration and equalization, heard a number of these at the regular meeting Monday night and adjourned until Friday night at 8:00 o'clock, when it is expected that the roll will be finally approved and the millage set.

It is generally felt that the number of complaints is small inasmuch as the total number of properties assessed this year is nearly six hundred, indicating that only about five per cent of the property owners are asking for adjustments. The Council is doing all in its power to secure for the taxpayers a just and equitable assessment so that the burden of the town's expenses will fall alike on all.

Unofficial reports have it that when the taxes for this year are collected the town will be in the best financial condition in its history, with all special fund deficits cared for and all hang-over current bills paid. Much comment is heard complimentary to the sound business like way in which Mayor Upmeyer's administration has dealt with the town's affairs.

#### FRESH FRUITS ALWAYS AVAILABLE

Perhaps not all Maitland people appreciate the fact that there is available practically all the time some variety of fresh fruits grown in this vicinity. Just now grapes are in abundance, as well as several varieties of guavas and papayas. Japanese persimmons are beginning to ripen and are particularly lucious this year. Early grapefruit will soon be palatable and some early oranges are already being used. Many varieties of tropical fruits can be and are being raised by some people more or less as an experiment or as a novelty. These can be produced on a commercial scale with profit and some people are seriously considering them as a money crop between the citrus seasons.

#### THE TAX ASSESSMENT

The Council, Tax Commission, Assessor, and the town as a whole are to be congratulated upon the general equanimity with which the recent increase in assessed valuation has been met by the taxpayers as a whole. This increase, owing to the present needs of the town, has necessarily been a considerable one, and the fact that relatively few protests have developed to date clearly indicates that the work of revaluation has been well done. In a task of this size some errors and inequalities are bound to creep in. These should be, and we have every confidence that they will be, satisfactorily adjusted by the Council. In the main, however, we believe the assessments to be just. That they appear high is undeniably true, but it is just as true that in the past they have been far too low.

According to a special act of the Florida State Legislature all assessments are to be made at full cash value, and the present valuation, saving exceptions, are more nearly in accordance with the law than hereto-

If our town is to progress and keep pace with its neighbors we must strain every effort to develop and improve its natural resources to such an extent that it will not only cause com-

ment upon its general attractiveness, but will also result in its being a finer and better place in which to live. All this takes funds and it is only too evident that these have been ridiculously inadequate in the past.

In our opinion the Assessor and the Tax Commission were entirely qualified to conduct the work which has just been accomplished. We earnestly hope that they will not recede from their position, other than to satisfy all justly sustained complaints. Absolutely nothing is to be gained by a general reduction of valuations with a consequent increase of millage. However, if the adjustment of inequalities should result in bringing the final total assessed valuation below the figure required to raise the necessary funds, it is then conceded that some slight increase in the millage would be justified to cover the deficiency. We feel that any change in the millage or valuation for reasons other than that as above, would only result in discredit to the men who have worked hard and conscientiously to effect a fair valuation. We believe that the taxpayers as a whole appreciate what has been done and that as time passes their co-operation in everything that will result in benefit to the town will be increasingly in evidence.

Let's stand pat.


Rev. Robert H. Viser, with wife and two children, of Baltimore, Md., are visiting the mother of the former, Mrs. A. W. Viser, at Wayside Inn. The family will spend the winter at Clearwater. Reverend Viser is a noted preacher of the Presbyetrian faith and a brother of Rev. Edmund Viser, pastor of the Apopka Presbyterian Church. Out of four sons in this family, three are clergymen.

"Three brothers, all ministers of the gospel, will occupy the pulpit of the Lafayette Presbyterian' Church tomorrow morning. The pastor, Rev. James H. Viser, D.D., will be assisted in the service by his brothers, Rev. Robert H. Viser, of Clearwater, Florida, and Rev. Edmund D. Viser, of Apopka, Florida. All three are graduates of the Presbyterian Union Theological Seminary, of Richmond, Va. The sermon at the service tomorrow morning will be delivered by the youngest of the brothers, Edmund D. Viser. Although in the work of the ministry only one year, Mr. Viser has built up a reputation as a pulpit orator and Bible expositor."

Rev. Viser expects to return to his work here in October.

Mr. J. C. Nicholson, of Vero, is in town for a few days, looking after property interests here and renewing old acquaintances.

The Seaboard Railway, in a letter to Clifford R.
