C. of C. Officers Are Elected

Retiring President Makes Stirring Address

Charles D. Horner, president; L. L. Coudert, vice-president; Arthur B. Rowland, secretary-treasurer; H. E. Angell and C. N. Beecher, members of executive board, were unanimously elected for the coming year at the an-nual meeting of the Maitland Cham-ber of Commerce held Thursday evening at the White Way restaurant.
The nominating committee further recommended that the present secretary,
Mrs. C. N. Beecher, be made executive secretary.

L. L. Coudert, retiring president, in his farewell speech, stressed the fact that the coming year will be a vital one in the history of Florida and each community in the state, when it is essential to our present existence as well as our future development that we hold what we have got, do the things that we have promised, dig in and help the other fellow and our town, for the town must grow before the individual business enterprise can develop. This is no time to lie down on the job, but it is a man's opportunity to show what he can do. Anyone could make money last year, no brains were needed. During the com-ing year Florida will be closely watched in the north where there are thousands who look with envy upon their neighbors who have come down here to make their homes and are deterred from following only because they have no certainty of getting

"All must get behind our new of-ficers," was Mr. Coudert's parting word, "and those who worked to full extent of their ability last year must work doubly hard this."

Mr. Coudert's speech was received with great enthusiasm by the members and Mr. Bennett moved a rising vote of thanks to the retiring officers for their earnest and successful year's

It was decided to have a reception for the retiring and incoming officers and the suggestion was made that this be an outdoor affair.

Emphasis was laid by President Coudert and J. H. Hill on the obligation to support home industries, and the point was made that when funds are needed for local enterprises, it is not the Winter Park and Orlando merchants or the mail order houses who are expected to support town ac-tivites but the local merchants, while the residents of the town go shopping through the neighboring cities for articles which in many instances they could get just as well at home.

Reports were given by various com-mittees and the secretary read the re-port of the year's work, which is printed in full elsewhere.

Secretary's Report for 1926

1926 marked the third year of the Maitland Chamber of Commerce and in many ways it was an auspicious one. Perhaps the most important thing accomplished was the new Chamber of Commerce building which was built by the members; all materials being furnished at cost by members, the total cost including furniture, etc., was \$603.48. \$53.00 of this was for carpenter labor. This building was erected for the purpose of giving fruit and road information to our visitors, and Maitland claims the distinction of and Matthand caums the distinction of being the first town in the state to ex-tend this courtesy. A full time secre-tary was also engaged.

The folders which were gotten out are a very creditable asset to our or-ganization and town. The committee

which arranged these was composed of J. H. Hill, E. A. Upmeyer and K. N. McPherson. They are unique and McPherson.

McPherson. They are unique and beautiful, the air map giving people a clear idea of the topographical ar-rangement of this locality. The membership drive was very successful, ninety-one members being secured. Since the first fall meeting the names of twenty-two people have been presented and elected to mem-bership.

Big Crowd at Caucus Monday

Large Number of Candidates Cho

Never has a larger crowd gathered at a public meeting in Maitland than came out last week Monday to choose candidates for the offices of mayor and councilmen to be voted on at the elec-tion on the fifth of March. The auditorium at the schoolhouse was filled with voters and spectators and the liveliest interest was manifest.

Only qualified voters were allowed to cast their ballots for candidates and one hundred and ten residents of Maitland voted, a larger number than has ever been known to vote in the history of the town.

Mayor Upmeyer presided over the meeting and E. T. Owen acted as clerk. Assisting them were Arthur B. Rowland, J. T. Stover, Forrest B. Stone, George Russell and C. M. Niven

After calling the meeting to order Mr. Upmeyer read the list of regis-tered voters and those present re-sponded to the roll call. An opportun-ity was given for those who were eligible to register if they had not done so before.

Two ballots, an informal and a formal were taken for mayor and for five councilmen. Only those who received at least one vote in the informal ballot were candidates for the final formal ballots. All candidates receiv-

ing 15 per cent of all votes cast will have their names on the election ballot. The candidates for mayor are Elli-son Adams and Charles B. Water-

The candidates for councilmen are J. H. Bennett, J. A. Brown, W. T. Clare, J. G. Friedland, J. W. McNair, K. N. McPherson, W. F. Parker, E. A. Upmeyer, W. B. Willett and C. J. Woodward.

Mr. Upmeyer is the present mayor and Mr. Brown, Mr. Priedland and Mr. Woodward are now on the coun-

EVANGELISTS BRING

GOSPEL MESSAGE

One of the most substantial spirit-ual awakenings ever held in the Mait-land Circuit of the Methodist Episcopal Church, South, came to a close Sunday night at the Conway church with a stirring, soul-convicting gospel message by Rev. J. I. Whitworth, Florida Conference Evangelist.

The day was filled with religious services and a picnic dinner on the ground at noon hour. Sunday School at ten and a powerful heart searching message by Rev. Whitworth at the eleven o'clock hour. Many friendship groups were noticed after the mid-day meal, until 3.30 when "From Race-Track to the Gospel Highway" was given by C. A. Moberg and wife, who had charge of the music, young people's and children's work during the campaign.

This evangelistic party arrived at the Maitland church the first Sunday in January, continuing two and a half weeks when they moved to Conway for a like period. They have done a lasting work and endeared themselves to the membership of the churches and the communities in general. The churches have been resurrected and are on fire in the Kingdom of God.

Rev. J. I. Whitworth, the evan-gelist in charge of this campaign, is a Florida product, born in Callahan, Nassau county, where he was known as a successful farmer, until 17 years ago, when he was converted and answered the call of God to the ministry, serving many churches as a local preacher until four years ago, when was appointed district evangelist, and worked under the direction of the Florida Conference Mission Board and two years later was appointed confer-ence evangelist by the Annual 'Con-ference of this state. He is of a strong physique, a powerful man of God, whose winsome smile, stirring, appeal-ing and convincing messages lead to a climax that is irresistible, and thou-sands of happy souls have been brought to the Light of the Gospel by his efforts. He has a family of wife and six children living at Pompano, Fla, to which place he has gone to pay them a "visit" he says.

C. A. Moberg, who is musical director and in charge of the young people's work during their campaigns about the state, was born in New York City and was converted three years ago in Bible Hall Mission, Washington, D. C., founded by Dr. H. E. Ressler, who later became his father-in-law. Mr. Moberg is a past master at the piano, which together

with his earnestness, sincerity of purpose, closeness to his Master, and humorous nature, make him a power for good to all the church. He was, before his conversion, associated with race-track gambling and cabaret sing-ing and his "From the Race-Track to the Gospel Highway," a life story of himself and wife, depicts sin at its worst and salvation at its best, and makes a lasting impression for good on all who hear him.

Mrs. C. A. Moberg, soloist and in charge of children's work, wins the hearts and souls of all and especially the children, with her solos and choruses and duets with her husband. has a sweet mellow voice, which, coupled with a smile that is irresistible and a countenance beaming with glory in her Master's work, and songs whose words ring with a true gospel mess-age, touch her hearers in a way that prepares their souls for the reception of the message of the evangelist. Before her conversion and marriage, most of her life was spent in esthetic dancing.

Mr. and Mrs. Moberg moved to iami in the spring of 1925, where ey attended one of Rev. Whit-Miami in the spring of 1925, where they attended one of Rev. Whit-worth's meetings, and it was during this time that they felt the call of God to devote their entire lives to His work in singing, playing, and personal work, and have been associated with Rev. Whitworth ever since.
