SEMINOLE SOIL CONSERVATION DISTRICT

ANNUAL REPORT - 1965

SANFORD FLORIDA

Since the organization of the Seminole Soil Conservation District in 1948, many changes in land use has occurred within the District. Housing developments have been built on land once devoted to Citrus and Vegetables. Other land, formerly in woods, has been cleared and set to Citrus. Some acreage formerly devoted to vegetables has been put into Citrus using ditching, bedding, and deep tiling practices to control the high water table on these lands.

Through an up-dated Memorandum of Understancing entered into with the U.S. Department of Agriculture in 1963, the District has been better prepared to cope with these changes. We are now able to provide technical assistance to Rural Areas Development groups; give assistance in the development of private and public recreation areas; and give consultive assistance to county commissioners, zoning boards, real estate people, and others. Usually this assistance is relative to soils and soil capabilities. Here the completed soil survey of this district will be of immense value. It is our understancing that this survey will be off the press about the middle of 1966.

But we, the supervisors of the Seminale Soil and Water Conservation District, have not lost sight of our primary objective of getting the required soil and water conservation practices on all the land within the District.

During 1965, our concerted efforts were directed toward providing technical assistance to farmers, ranchers, and other landowners in developing basic conservation plans and establishing the conservation practices necessary for the conservation of soil and water resources and the improvement of Agriculture in this District.

The District has available two soil conservation technicians to assist landowners in putting in necessary soil and water conservation practices. They are; Russell Rudd, Work Unit Conservationist, and John Winter, the Conservation Engineering Technician. Also available on request are technicians from

the Soil Conservation Service office in Orlando.

Other personnel and agencies assisting with carrying out the District program are personnel form the Central Florida Experiment Station; the Fla. Agricultural Extension Service; the Farmers Home Administration of the USDA; personnel from the county ASCS office; Vocational Agriculture teachers; and personnel from the Florida Forest Service.

In 1965, the Board of Supervisors functioned in this District with only three members until an election was held in October. At that time, Mr. W. W. Linz and Mr. C. A. Wales were re-elected to the Board. Mr. H. O. Bagwell and Mr. James Hughes were elected to fill the two vacancies on the Board that existed up to that time. At the Board's reorganizational meeting in October, Mr. Linz was re-elected Chairman; Mr. Mark Bullock was elected Vice-Chairman; and Mr. Wales was re-elected Secretary-Treasurer.

A total of six meetings were held by the Board in 1965. The District was represented at the Florida Association of Soil and Water Conservation District's meeting in Jacksonville this year by supervisors Linz, Bullock, and Wales.

They also attended one area meeting of supervisors in Orlendo. The Board feels that attendance at these meetings are necessary for carrying out the District program.

Our District again sponsored a public speaking contest on conservation for high school students even though an area and state contest was not held this year. It is felt that this is a very worthwhile part of the District program, and, as in past contests, the first place winner received \$25.00; second place \$15.00; and third place \$10.00. A total of five boys participated in this event.

Several talks on conservation were made to Gerden Clubs, civic groups, and school groups. Three films were secured for showing to a Boy Scout group, a 4-H Club, and a grade school class. A total of ten news articles dealing with conservation and the District program were written and published in the

Sanford Herald and the Seminole County Farm Bureau Newsletter.

A survey was made in this District in 1965 of all public outdoor recreation enterprises. This survey was requested by the National Association of Soil and Water Conservation Districts to determine what each District had in the way of recreation enterprises for public use. The Board is aware of the importance of a survey of this type, particularly in our area. As we expect a tremendous influx of people into this area in the next few years, the demands on existing recreation areas will increase considerably. Planning for additional recreation areas to take care of the demand should begin now. A completed result of this survey will be forthcoming in the near future.
