and grace and leaving barely a ripple in the glass surface of the Olympic pool. Greg Louganis was my hero then; the Olympic champion who had overcome dyslexia and racism to become the greatest springboard and platform

diver in history. He had swept the diving gold medals in two Olympics. I lived vicariously that summer of 1988, glued to the television hoping for glimpses of Louganis' glory. As a runner in high school, my dreams of Olympic gold went no further than a fourth-place State AAU finish in the race-walk. And my own struggle with dyslexia had been frustrating. I will never forget my parents threatening to send me to a school for retards, "because there was no difference between 'can't learn' and 'don't learn." Now someone was telling my story of alienation and frustration. And people were listening because he was a champion - it made his courage seem even more significant.

At the time, I didn't know how much more I had in common with Greg Louganis. His sexuality was a deeply guarded secret (as was

### MEL'S CRUSADE **Gay Christian Activist** Mel White Fasts In Jail

Virginia Beach, VA – Dr. Mel White, the gay Christian activist arrested two weeks ago on the grounds of the Christian Broadcasting Network, says he does not hate Pat Robertson but he does have grave concerns about the negative way the television evangelist depicts gay people. White says, in fact, that his mission is to "outlove those who oppose us."

"Pat made a big mistake by not meeting with me and by having me arrested," White said from behind a barred screen in the Virginia Beach jail. "Staying in jail is a matter of conscience for me. If I pay the fine I can get out of here, but I admit guilt. And I

am not guilty because Pat doesn't own the CBN property, an act of civil disobedience that he had not intended to do God does, and all the people who send money to keep that place going. If I get out on bail it is only on the condition I

never step foot on the CBN campus again. And that I can-

White, who holds a Doctor of Divinity, has been a pastor, seminary professor, Christian filmmaker and a ghostwriter for Robertson, Jerry Falwell and Billy Graham. He co-wrote Robertson's 1988 pre-campaign manifesto, America's Dates With Destiny. But in 1991, after decades of struggles with his sexual orientation, years of trying to pray his homosexuality away, and aversion therapy that included electric shock, White came out.

One of his first acts as an openly gay man was to tell all of his former employers. He wrote to Robertson, Falwell

and Graham and asked each to meet with him. White wanted to tell them that their rhetoric, often used in fundraising campaigns for their ministries, was leading to increased violence against gay people. None of the ministers responded, even to decline the invitation until three weeks ago. On Feb. 7, Robertson faxed a letter to White saying that homosexuality "is the last stage in the decline of a population," and that he did "not wish to meet to debate the merits of homosexuality.'

White decided then, he said, to go ahead with

The U.S. Supreme Court set the stage for its most significant gay-rights ruling in a decade, agreeing last week to decide whether states can forbid laws designed to protect homosexuals from discrimination.

The court said it will review a Colorado constitutional amendment that would cancel local laws protecting gays from bias in employment, housing and public accommodations.

Colorado voters in 1992 passed Amendment 2 it prohibits state and local governments from passing laws protecting homosexuals from discrimination but courts blocked it from ever taking effect.

The Colorado Supreme Court then declared the law unconstitutional, saying Amendment 2 violated the equal protection clause of the 14th Amendment because it denied homosexuals equal access to the political process. The state appealed to the U.S. Supreme Court, which agreed to review the case and the wider issue of whether states can forbid laws designed to protect homosexuals.

State officials say voters have the right to prevent homosexuals from being given "preferred legal status." Gay-rights advocates say local anti-discrimination ordinances extend civil rights protection to homosexuals but grant them no special privileges.


"The rights of any minority should not be swept away by popular vote," said Kevin Cathcart of the Lambda Legal Defense and Education Fund.

Will Perkins, whose Colorado for Family Values wrote and campaigned for the amendment, said homosexuals are not entitled to the same civil rights



### **NEW DIRECTOR AT** HOPE AND HELP

After a lengthy search, the board of Hope and Help Center of Central Florida, Inc. has selected Michael Slaymaker, CFRE, as their new Executive Director, effective Mar. 1, 1995. Slaymaker will fill the position previously held by Chuck Hummer, III, who died of AIDS last September.

Slaymaker has a decade of experience with non-profit groups, and while in Iowa he was responsible for raising over \$16 million for charity. He has chaired fundraising efforts for the Heartland AIDS Walk for the past two years.

A national award winner in management from the American Heart Association, Slaymaker is also certified in fund raising from the National Society of Fund Raising Executives. Slaymaker's most recent position was Personnel Supervisor for the Olsten Corp.

According to Hope and Help spokesperson Michael Fuchs, The entire board, staff and volunteers of the Hope and Help Center are excited by Slaymaker's commitment to the agency and the Central Florida HIV community."

Slaymaker plans to become active in other community activities which are suited to his background and new position.

The Hope and Help Center of Central Florida is a non-profit organization founded in 1988 to provide education, referral and resource services to anyone infected or affected by HIV or AIDS.

Concerned Citizens of Alachua County in its battle over the legality of an anti-gay rights charter amendment. The amendment would prohibit Alachua

County commissioners from passing ordinances creating civil rights protections based on sexual orientation. The amendment, approved by about 57

percent of those voting in last November's election, was put on the ballot after a successful petition drive by Concerned Citizens.

Now, gay rights activists are challenging the amendment's validity in court, saying it is unconstitutional. They have the help of Lambda Legal Defense and Education Fund, in their lawsuit.

Steve Summerlin, president of Concerned Citizens of Alachua County Inc., said Friday he had negotiated an agreement with the National Legal Foundation of Virginia Beach, Va., for assistance.

Gainesville attorney Robert Edewaard will continue as local counsel for the group, Summerlin said.

The National Legal Foundation has been involved in similar fights in Colorado and Cincinnati and has handled cases involving Bible clubs in schools, said Robert Skolrood, an attorney with the organization.

Concerned Citizens pushed for passage of the charter amendment because the county's civil rights ordinance extended what it called "special rights" to gays, lesbians and homosexuals, who opponents say do not merit such protection. Those challenging the amendment say it violates their equal protection, free speech, free association and due-process rights guaranteed by the Florida and U.S. Constitutions.

Skolrood said that judging by the election's outcome, the public was firmly behind Concerned Citizens.

'What could be more democratic than that?" he said.

Boedeker, who came to The Sentinel from The Miami Herald in January, was less optimistic than Boyar. He noted that much-ballyhooed television shows featuring regular gay characters have been largely unsuccessful.

### **ADOPTIVE PARENTS** WITH AIDS GIVE UP 3-YEAR-OLD

ST. PETERSBURG, Fla. - A 3-year-old girl adopted by a couple infected with the virus that causes AIDS will be moved to the home of the people she now knows as her grandparents, a judge has ruled.

Circuit Judge Horace Andrews, who approved the adoption nearly a year ago unaware the couple had the deadly virus, reversed himself in December and has now approved adoption by the infected man's

Under the arrangement, the child will continue to keep in touch with the infected couple she has known as her parents since she was 6

The unusual case began in June 1992 when the child was placed with the couple, who were licensed foster parents. When the child's natural mother lost parental rights, the couple sought to adopt her.

But to protect the confidentiality of the couple, HRS did not inform the court of the couple's health status before Andrews approved the adoption last March.

HRS Secretary Jim Towey later said it was a mistake to place the child with terminally ill parents and asked the judge to reconsider.

HRS officials now say they will no longer recommend an adoption if HRS employees are aware that a prospective parent has AIDS or the HIV virus that causes AIDS.

### STREET DEDICATED TO AIDS ACTIVIST PEDRO ZAMORA

MIAMI - Microphones emitted earsplitting screeches before the sound system failed altogether, and many chattering children wouldn't shut up during speeches last week dedicating a street to the late AIDS activist Pedro Zamora.

Zamora would have loved every minute of it. His world was the real one. Chaotic. Imperfect. That's probably why he was such a hit on MTV's "Real World."

The ceremony was to give 59th Street in NW Miami the name of Pedro Zamora Way.

Ten residents a block from the school were asked if they knew who Zamora was.

Only one knew Zamora was a gifted speaker, traveling around the country talking to young people and others about AIDS. He

Marc Crispi, 18, a member of the Braddock High School marching band that performed at Tuesday's ceremonies, recalls hearing Zamora speak four years ago.

Crispi said many people wept that day, and the speech made Crispi "think twice about how precious life is, that I'm not invincible after all. It made me realize that it can happen to everyone, that no one is singled out with a sign that says, you know, they've got AIDS."

Zamora's longtime live-in companion, Alex Escarano, exhorted the children to "carry on Pedro's torch."

### MILITARY VIOLATING "DON'T ASK, DON'T TELL" POLICY, GROUP SAYS

WASHINGTON – Military officials are violating the "don't ask, don't tell" policy on homosexuals in uniform, a group that supports lifting the ban on gays in the armed forces said.

The Servicemembers Legal Defense Network, a Washington-based group that assists men and women affected by the military's policy on homosexuals, collected what it said were 340 violations of the policy.

The alleged violations included instances in which military officials reportedly asked servicemen and women about their sexual orientation, punished permissible statements about sexual orientation, pursued or "witch hunted" individuals and condoned harassment based on sexual orientation, the group's report said.

Based on a review of the policy from March 1, 1994, to Feb. 28, 1995, the study "reveals a pattern of violations that often renders the policy little more than 'ask, pursue and harass," according to a summary of the report.

It suggested that a lack of training and guidance on the new policy, "and in some cases, willful disregard of military policy by commanders" lie at the heart of the problem.

A Defense Department spokesman, Maj. Tom Schultz, said he could not comment on data that the group had collected on its own and which had not been submitted to the Pentagon.

The report represents what the legal defense group called the "tip of the iceberg," since the information came from people who came forward with complaints.

Under the policy, military officials may not ask a service member his or her sexual orientation. Overt homosexual behavior may result in removal from the military, but generally the policy considers sexual orientation "a personal and private matter."

Only two cases challenging the "don't ask, don't tell" policy have reached federal court. From last Feb. 28 – when the policy took effect – to Oct. 31, 507 service members were discharged from the military under the new policy, Schultz said.

Before the new policy took effect, the military services had 949 discharges for homosexuality in fiscal year 1991, 708 in 1992, and 682 in 1993, Schultz said. In fiscal year 1994, which included seven months under the new policy, there were 597 discharges.

### LESBIAN MOM ASKS VIRGINIA SUPREME COURT TO RETURN HER CHILD

RICHMOND, Va. – Homosexuality is no reason to declare a woman an unfit mother, the attorney for a lesbian fighting to regain custody of her son argued Monday before the Virginia Supreme Court.

Donald K. Butler told the justices that a trial court had little reason beyond Sharon Bottoms' sexual orientation to take her son, Tyler Doustou, away from her and her live-in partner. April Wade

The child has lived with his grandmother, Kay Bottoms, since a Henrico Circuit Court judge ruled in 1993 that Sharon Bottoms was an unfit mother because she engages in sexual conduct that is illegal in Virginia.

"We have many cases that have been heard before this court on parental unfitness. We have murderers, peeping toms ... a whole rogues' gallery of people this court has ruled in the past cannot be deprived of custody without some showing of harm (to the child)," Butler said.

But Kay Bottoms' lawyer, Richard Ryder, told the justices, "What this court is being asked to do is chip away at family values and public morality. This case involves two women who regularly engage in sodomy. They live a lifestyle that this court has condemned as repugnant, immoral and evil," Ryder said.

Sodomy, both heterosexual and homosexual, is illegal in Virginia.

"This child is almost 4 years old and will be going to school soon," Ryder said. "He will be introducing this April at PTA meetings and to his peers as his daddy. It takes very little imagination to see or know the harm this will do. You should not let a child grow up in a houseshold where adults are committing a felony every day."

In June, the Virginia Court of Appeals overturned Henrico Circuit Judge Buford Parsons' ruling that gave Kay Bottoms custody of Tyler. Despite the appellate ruling, the boy remains with his grandmother pending the Supreme Court's decision.

The case is being closely watched nationally by gay and lesbian groups. Neither attorney in the case expected the court to rule quickly.

### BRIEFS

▼ ARKANSAS WON'T LEGALIZE HOMOSEXUAL ACTS: For the third time in six years, a Senate committee killed legislation Friday that would make private, consentual homosexual acts legal in Arkansas. The state sodomy law makes sexual acts between people of the same sex a misdemeanor, along with sex with an animal.

▼ OFFENSES TO GAYS NOT HATE CRIMES IN COLORADO: A bill that would have added crimes against gays, lesbians and bisexuals to the list of Colorado's "hate crimes" died in a legislative committee last week.

▼ CALIFORNIA TO REVISIT VETOED DOMESTIC PARTNERSHIP BILL: Assemblyman Richard Katz will reintroduce to the Legislature a domestic partnership bill already vetoed once by Gov. Pete Wilson. The measure would allow gay or heterosexual unmarried couples who live together to register with the state so they can receive hospital visitation rights and conservatorship rights. "This bill would affect the one million people who live together in California without benefit of marriage — tens of thousands of senior citizens, middle-aged couples, younger couples, heterosexual or gay and lesbian," Katz said.

▼ SOUTH DAKOTA SENATE PANEL AXES MEASURE TO BAN GAY MARRIAGES: A plan to bar legal marriages between gays in South Dakota was killed by a Senate committee Monday night. The Judiciary Committee voted 4-3 to scrap legislation that said marriages between people of the same sex could not be recognized in the state. It is already state policy not to marry gay couples. Without the proposed law, South Dakota may have to recognize same-sex marriages from other states, some said.

▼ UTAH PROCEEDS TO BAN GAY MARRIAGE: Legislation that would deny recognition to same-sex marriages won unanimous endorsement by a Utah House committee that was told the measure could face a legal challenge. Utah already bans same-sex marriages. House Bill 366 would deny recognition of such marriages performed in other states. Hawaii is one state that could legalize such unions.

▼ MISSOURI'S FIRST OPENLY GAY LAWMAKER ARRIVES: Freshman Democrat Tim Van Zandt raised his right hand and, along with 162 others on the House floor, took the oath of office for Missouri's legislature. Van Zandt, 31, represents the Westport and Country Club Plaza areas of Kansas City. He talked about his homosexuality when asked but didn't make it an issue in his campaign.

**▼ BRITISH COLUMBIA APPROVES HOMOSEXUAL ADOPTIONS**: British Columbia's government has changed its adoption rules to allow single persons — including homosexuals — to apply to adopt infants.

### **GOP CUTS KEY AIDS FUNDING**

WASHINGTON - The mother of Ryan White, who died of AIDS five years ago, is urging Republicans not to cut the AIDS program that bears her son's name.

"Congress can't turn its back on people with AIDS at this point in the crisis and expect not to face a crisis of its own – a crisis of confidence," said Jeanne White-Ginder.

House Republicans this week cut \$13 million from this year's budget for the Ryan White CARE program. The money goes directly to states and cities to care for people with AIDS or the HIV virus that causes it.

Overall, GOP lawmakers in the House plan to cut \$209 million from AIDS-related

As part of a \$17.5 billion reduction from this year's budget allocations, Republicans also would eliminate a housing program for those with AIDS, which has a \$186 million budget, and cut \$23 million from prevention programs run by the Centers for Disease Con-

Rep. Barney Frank, D-Mass., called the cuts "one of the most appalling acts of callousness that I have seen.'

"This week the House voted to increase spending on the military. The Appropriations subcommittee left the space program virtually untouched," Frank said. "But program after program that tries to meet the needs of people who are in pain and in need have been cut."

"The Republicans are shopping for dollars to pay for their tax cut for the rich," said Rep. Steny Hoyer, D-Md., who said he was shocked by the "all-out assault on training, education and health."

Activists said Congress should look elsewhere for cuts.

"We cannot balance the budget or cut the deficit on the backs of people with AIDS," said Winnie Stachelberg of the Human Rights Campaign fund.



### AIDS PATIENTS UNDERGO CONTROVERSIAL BLOOD-**SCALDING EXPERIMENT**

LAFAYETTE, Ind. - A radiator sucked all the blood from the unconscious AIDS patient, heating it to 114 degrees. The man's blood pressure plummeted and his heart raced to 180 beats a minute as the blood steamed back through his organs.

That normally would be cause for alarm, but Dr. Stephen Ash just smiled as he described how the high heat might temporarily clear some of the fatal AIDS virus from the patient's bloodstream and give his exhausted immune system a chance to fight back.

"A cure would be an overstatement," said Ash, an Indiana internist. "But if we put the disease in remission, it would be a staggering accomplishment."

Ash and 30 AIDS patients are spending the next month trying to prove whether one of the most controversial therapies ever proposed for AIDS actually works. In it, patients' blood is scalded, then reinfused until their body temperature rises to 108 degrees.

The theory is that heat will kill some of the HIV, the AIDS virus, that roams free in the blood as well as HIV-infected cells, offering the patient a temporary respite.

A handful of patients tested in July saw HIV in the blood drop significantly and their number of vital immune cells, called CD4s, rise modestly.

One, Richard Farrell of West Palm Beach, Fla., was bedridden with infections until the July trial. He has since gained 21 pounds and seen a 1/3 drop in his viral load.

Testing of the 30 patients, 10 of whom are controls who won't be heated, started Feb. 15, so it's too early to tell what works.

▼ CDC WANTS ALL 4 MILLION PREGNANT WOMEN TESTED FOR AIDS: Doctors should counsel every pregnant woman - 4 million a year - about AIDS and urge each to be tested for the fatal virus so infected mothers can try to protect their unborn children, the government has proposed. An estimated 80,000 heterosexual women of childbearing age have HIV, about 7,000 give birth each year, the Centers for Disease Control and Prevention acknowledged. But doctors recently discovered that the drug AZT cuts by two-thirds the chance a mother will infect her unborn child - if she knows to take it.

▼ TESTS ENCOURAGING ON AIDS DRUGS: Three drug companies have presented encouraging test results on experimental AIDS medications. Merck & Co. said its drug, MK-639, works better and longer at inhibiting the AIDS virus than AZT, the most commonly used AIDS drug on the market. And, it does so without the side effects of AZT. All of the drugs are protease inhibitors.

▼ AIDS PHOBIA LAWSUIT REJECTED: A man's malpractice lawsuit, based on his fear of developing AIDS after sitting in a pool of blood on a hospital stretcher, has been rejected by the Connecticut Supreme Court. According to the decision, the trial court correctly found that the plaintiff, despite his fears, had not been exposed to HIV, the virus that causes AIDS and had not established a compensable claim for 'AIDS phobia.'

▼ RUSSIAN PARLIAMENT REQUIRES AIDS TESTS FOR VISITORS: The lower house of Russia's parliament on Friday approved a measure requiring foreigners who intend to come to Russia for more than three months to prove they do not carry the AIDS virus.







After watching Louganis on ABC News' 20/20, I now understand why he had avoided that kind of publicity.

In his interview with Barbara Walters, Louganis told the world that he has AIDS, and that he was HIV-positive when he hit his head during the 1988 Summer Games.

In one of the most riveting moments in sports history, Louganis cracked his head on a reverse dive during the preliminaries of the 1988 springboard event. He became "paralyzed with fear" when he started bleeding in

"I was so stunned," Louganis said. "I mean, what was going on in my mind at the time was, 'What's my responsibility? Do I say something?"

"I just held my head... I just wanted to hold the blood in," Louganis told Barbara Walters.

He did not reveal his condition to the U.S. Olympic Committee doctor who gave him five stitches, and felt sure the chlorinated water in the pool would dilute the virus.

In a thrilling and inspiring comeback the next day, Louganis easily won the springboard gold. When it was over, he wrapped his arms around coach Ron O'Brien and sobbed. Watching on TV, I sobbed with them.

Louganis told his coach "nobody will ever know what we've been through." With his book and interviews, he is now beginning to share his ordeal with us.

Louganis told Walters he received word that a former companion was dying of AIDS six months before the Seoul Games. He said he was tested and learned he was HIV positive.

"Dealing with HIV was really difficult for me because I felt like, 'God, the U.S. Olympic Committee needs to know this ... U.S. Diving needs to know it,' because what if I get sick at the Olympic Games and am unable to compete?" he said.

But Louganis said he never told the USOC because "I was encouraged not to."

When his coach was asked if he wasn't afraid that Louganis would hurt himself or infect someone else, O'Brien told 20/20:

"No, not really. Because there's very, very little chance. If it were in a sport like boxing or wrestling, football, where there's a lot of contact, personal contact, I would have been very concerned. But our sport is such that you don't ever come close to anybody."

Although I had suspected Louganis was gay, he disclosed that he was homosexual at the Gay Games in New York last year.

But didn't Louganis reveals his HIV infection until publication of his forthcoming Random House book, Breaking the Surface.

The book deals with AIDS, as well as homosexuality, dyslexia, racism he suffered because of his Samoan heritage, an allegedly abusive stepfather, teen-age depression and three suicide attempts.

Last week, Louganis spoke with talk show hostess Oprah Winfrey about an abusive relationship, and about keeping his HIV status away from the press. Louganis disclosed that he was raped by a former lover, and Winfrey asked how he could continue to live with a man who had raped him. "I felt like I deserved it," said Louganis. "I was made to think that's what I deserved."

He also told Winfrey, "Lying was incredibly stressful and energy-reducing, which I knew wasn't good for someone in my health condition...so I just avoided interviews and really all kinds of personal interactions."

Louganis' book is dedicated to his friend Ryan White. "I gave my '88 gold springboard medal to Ryan's mother," he told Winfrey. "After I hit my head, I thought to myself, 'what would Ryan do?' and I knew he would fight, so he was my strength."

Louganis won four gold medals for springboard and platform diving at the Olympics in 1984 and 1988. He is the only diver to score consecutive perfect 10s in an international competition.

Through his recent interviews and his book, I have come to understand why Greg Louganis was such a tough competitor. Being different has a way of making one stronger and more secretive. When one feels isolated from others, excelling in activities to build self-esteem is a common coping mechanism. For Louganis, coping led all the

way to Olympic gold.

Today I am sad for my hero, as I am sad every time a close friend tells me that they are affected by AIDS. Greg Louganis is still my hero, though now for very different reasons.

this visit but the time felt right," White said. "The flood of anti-gay rhetoric coming from Pat and Falwell, James Dobson and all the others has polluted the nation's moral environment and leads to suffering and death for gay people. It's time for it to stop."

On February 14 White and a group of 12 local religious leaders went to the CBN complex and, again, White asked for a meeting with Robertson. He was refused by CBN

spokesperson Gene Kapp but White remained on the grounds until he was thrown out by security guards late in the afternoon. He was told that if he returned again he would be arrested for trespassing. White did return on February 15 and was handcuffed and lead off the grounds, by Lt. Wray Boswell of the Virginia Beach Police. Ironically, Boswell is the brother of gay historian John Boswell who died in December of last year. Boswell told Atlanta's Southern Voice that he is in complete sympathy with White and had requested to be allowed to make the arrest.

There is disagreement over the significance of White's actions among Christians, of course, but also among gay people. White's history, his close ties with the Religious Right before he came out, make him very suspicious to some. He has been accused of being a self-appointed leader who hasn't paid his dues, and of bepublicity. White knows this, is

painfully aware of it, he says. Last year, after publication of his book, Stranger at the Gate: To be Gay and Christian in America, he commented, "the gay press doesn't like me because I'm Christian and the Christian press doesn't like me because I'm gay."

White is in isolation at the jail, placed there for his own protection. The guards treat him well, he says, but his cell is cold and always lit. The other inmates in his block constantly yell and bang things against the steel cots and bars. And he is fasting, first only drinking skim milk and Tang a few times a day, but since Feb. 25 only drinking water.


On the day of our interview, White was on day eight of his fast, but seemed quite fit. He was energetic and talkative. The bright orange jump suit he wore seemed appropriate for this man who is as optimistic about the future for gay people as he is serious about helping to make it happen. As Minister of Justice for the Universal Fellowship of Metropolitan Community Churches, the network of gay Christian churches founded in 1968 by Troy Perry, White says it is his duty to combine social action with faith.

"God's business, as in the words of the prophet Micah, is doing the business of justice, and I have the unique opportunity to deal with the very source of our problems," White explained. "Robertson and the like, I know who they are, I've dealt with them many times. And I am finally doing what I've talked about doing all my life. I'm taking a stand for my brothers and sisters who are gay. I'm putting my life where my mouth is. I feel so certain that God created me gay, and I'm convinced that the next stage of our community's resistance to oppression rests in the power of love coupled with truth. You must move toward an untruth, not away from it. My job is to rescue Pat from his untruth, not for my sake, but for his and everyone else's. Every day in here I am more thankful that I didn't miss my chance to take a stand."

The people who are supporting White are thankful, too. His lover of 10 years, Gary Nixon, and a dedicated group calling themselves "Bearing Witness" are making sure that White's momentum is not lost. Each day

a group of 12 people deliver a flower and a message to the door of CBN headquarters. The message usually states, "Please meet

respond, walking away in silence. Spitz's words seemed all the more ridiculous for it. Few people believe Pat Robertson will


ever agree to meet with Mel White.

But White says he would not be sitting in jail otherwise, and he is prepared to stay there as long as it takes. "What I am asking for is very simple, to meet with Pat and ask him for two things. One, stop denouncing gay people because you are leading, directly or indirectly, to violence against them, violence that is increasing every day. And two, denounce those who are committing the crimes. That's it. Pat is a smart man, he just has the wrong information."

In a more somber moment, however, White is more realistic. "I don't really know how long I can do this," he confessed. "I take it one day at a time. It's only me and God in that cell. And though I pray everyday for Pat to see the truth, if I feel God wants me to do something else, I'll do it. I feel called by God to be part of the solution. And it's my struggle to understand how to do it."





protection as ethnic minorities or the disabled.

Colorado Attorney General Gale Norton said the Supreme Court's upcoming review of Colorado's anti-gay-rights amendment could be the most significant civil rights case of the 1990s.

Jean Dubofsky, the lead lawyer representing opponents of Amendment 2 before the Colorado Supreme Court, said the high court's decision positions the issue of gay rights for a final resolution.

She predicted her side would prevail because "this type of discrimination is so contrary to what our country has always been about."

Voters in Oregon and Idaho defeated antigay-rights amendments last November. Eight states provide some sort of civil rights protection for homosexuals: California, Connecticut, Hawaii, Massachusetts, Minnesota, New Jersey, Vermont and Wisconsin.

The Colorado gay-rights case does not address homosexual conduct. But the high court's ruling, expected by July 1996, could provide insight to the justices' views on the continuing validity of a 1986 Supreme Court ruling that let states outlaw consensual homosexual conduct.

Some Amendment 2 opponents were uneasy about the Supreme Court's decision to take the case.

"It always makes me nervous when the Supreme Court takes cases like this," said Cathcart of Lambda Legal Defense, which represents Colorado cities and residents who challenged the amendment.

"The question ... is whether the voters should have the right to deny constitutional rights and access to the political process to a

minority group," Cathcart said.

Colorado for Family Values' Perkins said he was happy the Supreme Court chose to review the case. "We're looking forward to their decision."

Perkins said he hopes the court sides with his group's position that homosexuality should not be a protected class.

"The position that we take is that when someone chooses to practice homsexuality (that) does not put them in an equal status with ethnicity or being disabled," he said.

The Colorado amendment, which has never been enforced, would cancel ordinances in Denver, Boulder, Aspen and other cities that ban discrimination against homosexuals.

Voter approval of the amendment led gay

activists to organize a nationwide boycott of Colorado tourism. State officials said the state lost about \$40 million in convention business.

The cities of Denver, Boulder and Aspen and a group of gay men and women sued, saying the amendment violated homosexuals' rights to equal protection and free speech and impeded their right to petition the government.

A state judge ruled in their favor, and the Colorado Supreme Court agreed last October.

"The right to participate equally in the political process is clearly affected," the state's top court said. The amendment "singles out one form of discrimination and removes its redress from consideration by the normal political process."

The state's appeal called that ruling "a dramatic and unwarranted interference in the political process" that improperly gives special protection to homosexuals.

Howard L. Hurwitz, chairman of the New York-based Family Defense Council said, "To have reversed the will of the people is totally unwarranted. Let the homosexuals do what they want, but to have their political agenda enacted is something else again."

In a related matter, the U.S. Supreme Court will decide whether Massachusetts courts violated the First Amendment when they ruled that the St. Patrick's Day parade in South Boston is a public event open to everyone, including gay activists.

The parade's sponsor, the South Boston Allied War Veterans Council, has tried to exclude gay activists from the parade. The Irish-American Gay, Lesbian and Bisexual Group has fought for the right of gays to march in the event, which honors both the patron saint of Ireland and the evacuation of British troops from Boston during the Revolutionary War.

State courts in Massachusetts have ruled that, because the parade does not have a specific, protected message, gays could march under the state law banning discrimination.

A ruling to that effect last year by the Massachusetts Supreme Judicial Court caused the veterans' group to cancel the parade.

But U.S. District Judge Mark L. Wolf ruled last month that the veterans' group could bar gays this year because part of the parade will be a protest against the state court rulings, and so was protected under the First Amendment.

John Ward, lawyer for the gay group, then asked the U.S. Supreme Court to reverse its Jan. 6 decision to hear the case.

"Maybe there is a new line in the sand that says it's OK for gays to have condos in the South End, but when it looks like real participation in American life, then people's prejudice, I think, reasserts itself," Ward said.

But Chester Darling, lawyer for the veterans' group, said: "The issue in this case is judicially compelled speech. This is not a fight my client started. Now we are going to finish it."

Nike began running the ad featuring Los Angeles runner Ric Munoz earlier this month. The 30-second commercial shows Munoz






Do you think that straight conservatives, especially those in the religious right, see the acceptance of homosexuality and homosexual lifestyles as a threat to the values they have learned and grown up with; or do they use homosexuality as an issue to gain and/ or maintain their power structures?

After reading in The Advocate's February 7, 1995 issue of the fight by a Seattle gay couple to adopt their foster son, I have concluded that the issue of homosexuality revolves around the power structure established by religious conservatives to maintain the influence they have over their constituency. The news that Rocky Ward resigned from the office of president of GLCS reveals problems within that organization. When a problem is recognized, it must be met and handled in a calm and resolute manner.

The unfortunate words of board member Spencer Osborne appear calculated to intensify the problem without addressing the issue; Osborne's comments were aimed at the recent election of officers which is not the matter at hand. Charging the election was "a fraud and a sham and we ought to apologize to our members," is a curious accusation by Osborne, who sits on that board as a result of that election. Angry words may create an illusion of authority, but responsible leadership and constructive analysis are what embody authority.

A display of petulance is an opportunistic pursuit of self promotion and fleeting attention, but it is no substitute for leadership. Let GLCS pursue the solution to its problems and, if Osborne believes he has committed a wrong and wishes to apologize, he should feel free to do so.

Lack of esprit de corps in the gay community is reflected in organized activities, especially in elections. When membership is small and participation even smaller, the result will almost always be an inaccurate representation of the community. This apathy often results in the election or appointment of persons seemingly dedicated to conflict to positions that should go to those committed to stability, balance and progress.

The large numbers of gays and lesbians should represent great strength and influence in matters of law, commerce and government. Our financial resources should be a magnet to the business community on both national and local levels and should affect politics with the strength of a lobbyist. But these things will come about only if we come together displaying our unity, for therein lies our strength.

Until we, as individuals, elect to empower ourselves by coming together, our voices will be dismissed and our presence ignored. Failing to take part in the pursuit of one's community is an unfortunate choice. Employing invective to diminish the reputation of one's community as it pursues justice can only be recognized as a malicious act.

We aspire to greater things: the full Constitutional rights of American citizenship. It's time to be positive - to join and build our community so that tomorrow will be better than today.



I called my grandmothers to wish them a Happy Valentine's Day and to make sure they received my cards. Nana, my mother's mother, gossiped graciously with me in her jolly tone about my mother's side of the family. I could tell by the lack of comments about babies that she does not know the "new" family secret. My father's mother (or, as my family calls her, my grandmother), still insisting I call collect, gave me a brief "hello" and then "goodbye." I knew she did not know the new family secret, either.

For me, the first family secret arose back when I was sneaking off to the local gay bar. I was often afraid that I would find my father there. As young children, my brother and I would beg my parents to tell us the story of their first date.

They would begin with my father's attendence at the Academy of the Arts in Newark, New Jersey, then glamorized their adventure at the village Cafe; a dark smokey jazz club. My mother was enthralled with the music, horrified by the smoke and confused by the clientele. My father cautioned her about going to the bathroom alone, and remarked that the women dancers were really men. Tensed, she smiled at him and decided that night she was going to marry him.

My brother and I would sit on the edge of our seats waiting patiently for the funny part, clueless as to their innuendo. Finally, ...the drive home..." my mother would say, giggling. It was only later in life that I recognized it to be a nervous laugh, denying the truth of my father's secret passion.

"Your father pulled the car over, causing such a commotion about the bad smell." My mother had stepped in a pile of dog doo at the Cafe's parking lot. We laughed at the thought of her scraping it off her red pumps while my dad searched the tires for the culprit. Long after my baby sister was born, he was still mad at my mother for lying to

him about the source of the dog doo. I was mad at him for lying to her.

Because at twenty-one, my father was sneaking off to gay bars. At twenty-one, I was secretly dating the daughter of one of his college bar-hopping buddies. How small the gay world seemed.

In 1985, my grandmother became severely depressed as old age beckoned. Having experienced this before with my mother's father, Gramps, we nursed her every step of the way. At the climax of her

depression, she invited me over for dinner to tell me her secret. She prepared veal cutlets and cheese cake, my favorites. I took this as a sign of recovery. I didn't know what was coming next.

After dinner, she went into her bedroom, rummaged through her dresser drawers, and returned to sit next to me. She placed a plain 24-karat gold wedding band in my palm. For a while, we both gazed silently at the ring. My grandmother seemed to have drifted off to a far away place.

'When I was in Naples," she began, "I had a very close girlfriend, Rita..." Bewildered and exhilarated, I felt as if I was about to hear of a wonderful lesbian romance.

"When I was twenty-one and leaving for America, Rita came running through the

crowd before I got on the big boat and handed me the ring. She told me to save it for when she got the money to come to America. She promised to marry me when she did." Breathlessly I waited, tears welling in my eyes.

"I waited ten years. Rita never came. So my family convinced me to marry your grandpa Joe. Shortly after we were married, I found out she was coming to America. I went to Ellis Island to get her the day she was to arrive. She never got off the boat. When I asked where she was, I found out she had died on the boat. Many people had died on that trip. I was devastated." Through her crying, she continued: "I want you to have the ring. Find your true love and never let her go."

When my mother "outed" me at twentyone, she instructed everyone not to tell my secret. She made excuses to the relatives about my lack of interest in men as a conscious choice of career over love. For years, she was content in her belief that everyone had been fooled. Finally it didn't matter any more. Most people assumed I was gay. If no one asked, she didn't have to answer, and that relieved her of embarassment, responsibility, and her sense of failure.

Ironically, when it became socially acceptable to know someone gay (or have them in your family) in the '90s, I became the family's show-and-tell piece. Suddenly my mother was an expert on the gay world. She spouted about gay events, and made note of intolerance. At times, she even educated me on the remarkable strides and accomplishments of the gay community, and reminded me of the long struggle that still lay ahead.

I thought my mothe had acquired a passionate understanding and acceptance of life outside "the norm." I thought I had paved the way for my siblings as an example of personal courage, by getting a college education, and becoming a recognized and accepted member of the gay community. I thought the secrets were behind us as a family.

"Happy Valentine's Day, Aunt Ro," my brother called to tease me. He knows the new secret. My unwed sister, Joy, is twentyone, and is pregnant. It took my family five months to tell me about it. Being Catholic, my parents' official reaction was that they were proud their youngest child had chosen to have the baby rather than an abortion. Proud, but not proud enough to tell anyone.

I was instructed not to tell any of the relatives, especially my grandmothers. My parents worried what everyone would think of them, with children that ranged from queer to unwed and pregnant.

I think back at how they hid my homosexuality and wonder how they will hide a pregnant woman. My mother assured me that, after the baby is born, most people will forget that my sister isn't married, but my homosexuality? She believes that will forever stain our family image. Little does

who would be His wife. I myself have Carol, and even Mom sees my point.

I spend a lot of time on the telephone talking to Carol in Brooklyn. No matter how many discount long-distance companies we've inveigled to carry our accounts, it is an expensive hobby, yet rewarding. We've managed to theoretically cure the world of its ills while shedding light on the "other side's" characteristics - Carol has learned a lot about the gay world, while I have gained some insights into the maze of heterosexuality.

Talking with her is like engaging in a verbal version of Microsoft Windows - we find we've opened too many topics, all vaguely related to one another, and somehow held together by gossamer threads. Often we have to retrace our steps, close up unused files,

Carol has no qualms about the physical aspects of homosexuality, as long as the details are not too graphically personal. For her part, she does the same - I don't need to know the intimate details of her relations with her husband. When we do delve below the waistline, we speak in the third person singular - a handy point of view all too lacking in today's big-mouthed, tell-all, cheap talk-show atmosphere. More often, we discuss what our guys are like around the house and in public, how they walk, talk, eat, work...how they deal with us, or not...you know, the myriad details of daily life. Often we are surprised at how similar our guys are to one another, and we wonder - are Carol and Jim therefore alike? Probably, we decide. Who else would put up with the likes

We're very close, or as close as two people can be who've spent most of their time as friends on the telephone. I moved to Florida shortly after meeting Carol at school, so practically every conversation we've had has been via a toll call. When we do get together once a year, we sometimes find it difficult to talk in person. We tried speaking to one another using two of her extension phones and found, horribly enough, that we had no problems talking that way. We are simply products of a technological age.

For almost twenty years we've supported each other through the ups and downs of one another's lives. I recall the angst-ridden, unrequited crushes when we'd spend hours analyzing to death each and every word, sentence, and phrase the he-of-the-week may have flung in our direction. We've suffered through one another's marriages and divorces, the boyfriends, the dates. Our



Hilarious film clips, courtesy of Jim and Geri Michael, were set to a script by David Almeida and Wm. André Provencher and narrated by Stephen Miller and Penny Ensley. The crowd of over three


hundred was clearly impressed.


A packed Presidential Ballroom at Church Street Station

### THE MADNESS OF KING GEORGE

film review by DAVID ALMEIDA

The Madness of King George, now playing at the Enzian Theater, is an interesting but flawed cinematic statement on the British monarchy. The film is the story of King George III (Nigel Hawthorne), best known as the King who lost the American Colonies in the Revolutionary War. The film chronicles a strange illness that affects his central nervous system, causing him to be-

come delusional, violent, and hyperactive. When the royal doctors cannot explain or find appropriate treatment for his condition, a rural physician, Dr. Willis (Ian Holm), is brought in. Willis begins to aggressively adjust the King's behavior through disciplinary treatment. Meanwhile, Parliament is in disarray over the rumors that the King has gone crazy and is not fit to rule. George's spoiled son tries to take control of the country, and the King finds himself rushing to the House of Commons to reestablish the status quo before his power is stripped away.

Director Nicholas Hytner gives the film a wonderful majestic feeling, with beautifully composed shots of Windsor Castle and Parliament underscored by the lush music of Handel. Hawthorne is very affecting as King George, and even at George's maniacal worst always gives him just the right touch of humanity. (Hawthorne also originated the role on stage.) Helen Mirren turns in a moving performance as the Queen left out in the cold, uncertain of her husband's condition or treatment.

For such a well-acted and directed film as this, it is disappointing to see the film raise several interesting themes, without developing them to their fullest. The first sign of the King's illness is when it is noticed his urine is blue. One would assume this implies a physiological disorder. The treatment administered by Dr. Willis, however, is all on a behavioral level. Just as the King is starting to act more like his old self, his urine has gone back to its normal color. The film alludes to the behavioral treatment being his cure, yet it seems more logical to deduce from the urine that his body was sick, and not his mind. The question still remains was his illness physical or psychological?

The film also aims for a theme about the preciousness of the gift of speech. At the film's beginning, we know that George has men who write his political speeches for him. Later, when he is ill, and starts to shout or misbehave, he is disciplined by being gagged and tied to a special chair (which looks like

an ascendant of the electric chair). When George is first shown the chair, he exclaims how villains are often shown the instrument which will make them speak of their crimes. He, now, is faced with that which will silence him. The uncertainty of this theme continues to the end, where we are left guessing if he still has speech writers or if he is doing the talking for himself. If he can speak

for himself, the film becomes the emotional journey of a ruler who finds his own "voice" through his illness. If he still has speech writers, it could be construed as a statement on the unchanging role of the monarchy in an ever-changing world. In either case, we simply do not know.

The film may also be dealing with the concept of medicine as science vs. medicine as art. The royal doctors, out of respect for the throne, will not treat the King until they are addressed by him. They administer archaic burn-therapy treatments to no avail. When Willis is brought in, the King's doctors shun his "modern ideas," he stares the King down, uses physical restraint, and reinforces, "You are the patient," to the ruling monarch. And we are led to believe that it is in Willis' techniques that results are found. But the vagueness as to whether the treatment was successful or not weakens this theme.

The strongest of the film's ambiguities lies in whether or not George is truly cured in the end. He says, "I may not be more myself, but I do seem more myself." It is strongly implied that he is not better, but that he has learned to act as though he is cured. This raises the question: why should an audience be involved with a protagonist who is completely unchanged by the suffering and self-reflection just witnessed.

In spite of its many underdeveloped allusions, The Madness of King George does

### Confessions of a Sondheim-ite

In his rise to glory as Broadway's current Maestro, Stephen Sondheim has contributed music and lyrics to well over fifty theatrical productions and revues, film and television soundtracks, and incidental music for nonmusical plays. Listening to recordings of his compositions could take months, years even. One could choke on the limitless interpretations of "Send In the Clowns" alone.

For instance, this past December, a newlyformed jazz division of Varese Sarabande Records released a jazz interpretation of Sondheim's Passion; the score's operatic score was reinvented for piano, drums, and bass. At last, the show's magnificent, moving, and humble melodies could be distinguished and understood.

But importantly, 1995 heralded Sony Classical's release of Color and Light: Jazz Sketches on Sondheim. Finally, Sondheim's

well-constructed masterpieces have been isolated, recast, and performed anew as independent sketches of music, free from any character, setting, or plot.

In the duet "Color and Light," featured in 1984's Sunday In the Park With George, neo-impressionist painter George Seurat laments, "... Seeing all of the parts and none of the whole." Color and Light allows audiences to hear Sondheim's parts, separate and apart from the whole, - the cast, the show, or the theatre - perhaps for the very


Highlights from Color and Light include a near eight minute interpretation by trumpeter Terence Blanchard's of "Poems," based on the oriental Haiku form of poetry. One of Sondheim's simplest melodies is so developed that one must dig out the original cast recording of Pacific Overtures (1976) to rec-

ognize and even remember the tune. Terence Blanchard's muted horn returns to accompany Nancy Wilson in a rousing rendition of the poignant, sublime ballad "Anyone Can Whistle," performed with much vigor and even more heart.

Herbie Hancock offers the most admirable interpretation of the composer's brilliance with the title track. Displaying Hancock's own magnificence on the piano, the tune takes on a darker, more sinister form; still, the song's sincere melody manages to soar, reminding us of the immense power of the seemingly mundane subjects, color and light, and the profound inspiration the two had on the nineteenth-century painter, who became the Father of Pointillism.

The opportunity to hear the maestro himself perform his own material is rare and delightful. Sondheim accompanies Hancock on the all-but-forgotten "They Ask Me Why I Believe In You" from an unproduced television musical I Believe In You (1956). This composition appears to be the earliest written by Sondheim.

If one can overcome Peabo Bryson's overwrought vocals, "Pretty Women" spotlights Joshua Redman's luscious saxophone.

Likewise, "Loving You," the only offering from Passion, is a welcome treasure in spite of Bryson; at least, this time we have Nancy Wilson to compensate (look for this tune to become a standard among performers of Sondheim's repertoire).







### NEWS UPDATE FOR THE GAY

Several things are happening that I thought you should know, so instead of transporting you to a glamorous and romantic destination, this week I thought I would bring you some NEWS.

On Feb. 9 Delta Airlines announced a capping on the commissions they pay to travel agents for processing your reservations. It has been a long-standing agreement within the industry that airlines would pay travel agents a base commission of, on average, 10% of the fare prior to taxes and service charges. Delta has now proposed a capping of \$25.00 for one way tickets and \$50.00 for round trip tickets. Following Delta's lead, American Airlines, Northwest and USAir have all announced capping.

What will this mean to the travel consumer? It may mean you'll get a disconnect message the next time you call your local travel agent. This capping will likely force small travel companies out of business. The personal service provided by a local travel agent will be lost, replaced by mega-agencies where your plans are far from personal

and your lifestyle will never be considered.

In a recent statement issued by I.G.T.A. (International Gay Travel Association) in response to the capping, statistics are cited showing that should the capping go into effect, thousands of agencies would be forced to close their doors. It was estimated that more than half of the 500 gay owned and operated travel businesses in the United States and Canada will be sacrificed. Jobs will be lost and other lives will be impacted. At a time when the industry is looking with heightened awareness at the gay and lesbian travel

market, it is increasingly important to look where your financial support is directed.

How can you help? Write your local elected officials and express your concerns. Refuse to fly airlines supporting the capping process. And continue to support your local I.G.T.A Travel Agent. Now more than ever they need your support or you may not find them there next time you want help planning a trip. If the gay travel agent is


not there, who will take the time to research the gay exclusive resorts,

hotels and cruises. When one of our number falls in this industry it will only be a matter of time till the rest of the gay travel providers feel the impact.

And now for some good news!

The Marketing Department, a privately owned marketing and promotional company specializing in gay and lesbian travel options, has been hosting seminars and trade expos around the country for the past several years. On Mar. 16 they will bring their expo to the Orlando market for the first time. Representatives from major airlines, tour companies and cruise lines will make presentations to area travel professionals during daytime seminars. In the evening an information expo, open to the general public, will offer the opportunity to learn more about gay and lesbian destinations and programs of interest.

Several area travel providers will be present, so make a point of supporting local





"Every Day A Little Death" becomes an instrumental duet between piano and sax. The Holly Cole Trio treats "Children and Art" as a bossa nova, replete with Oscar Castro-Neves' classical guitar. Sadly, both of guitarist Jim Hall's contributions come off as little more than elevator Muzak.

At last, Stephen Sondheim is being recognized as a master of melody, suitable to jazz variations and interpretations; something shamefully obvious since his earliest compositions, Anyone Can Whistle (1964) or even Company (1969).

In essence, listeners are being treated to "...all of the parts." Certainly, Sondheim's music is able to stand on its own. But perhaps it is sometimes true: Less is more.

state clearly that appearances are everything to the British monarchy. In one early scene, the King will not let a pregnant woman sit down at a music concert because all in the presence of the King must stand. After the King and Queen leave the room, all of the attendees collapse in exhaustion. The image of the English nobility strewn about the music hall is both comical and effective. Before George addresses Parliament, the servants carefully handle and affix the crown to the King's head. After the speech is over, they throw it across the room to pack it up and put it away - the "show" is over. When George seems to be cured, all the servants who knew of his illness are fired, while those who act as though it never happened keep their employment. And in the film's final scene, George suggests that the royal family should begin appearing as a happier family to the commoners, and instructs them all to smile and wave. "After all, that's what we're here for." Whether or not the King was (or is) ill seems to be secondary to the fact that he no longer appears ill. Throughout, it's difficult to avoid parallels to the present-day royals.

Alan Bennett's script, based on his play, is well-written with sharp and clever dialogue. There are many truly comical moments and one particularly moving scene has George reading aloud the title role of King Lear. Though interesting and thought-provoking, The Madness of King George is still thematically overwrought, raising too many questions without giving the audience the necessary tools to find answers.


