Pioneer Hardware Man Dies At Home After Short Illness From Attack Of Diabetes

had Been In Poor Health For Year

Lived Active Part In Civic Life And Was Ardent City Booster

G. Ball, veteran hardware merchant and one of the prominent and popular business men of Sanford, died away suddenly at about 11 o'clock this morning at home, 1702 Magnolia Avenue, following an illness only a few days. Death due to toxic poisoning induced by a diabetic condition and chronic bladder trouble, news of the death spread rapidly this morning, casting a pall over the entire city. It is a great shock to friends and business associates, many of whom had not been apprised of Ball's critical condition. A family member began to call him in from all directions, and soon the house was filled with visitors. The 65-year-old Republican Mayor last used a Chevrollet Limo to drive, American consul at Shantung, informed the department that he deemed it advisable to have naval protection there and has communicated this to the commander-in-chief of the American naval forces in China. In response to this, the cruiser Trenton was ordered to proceed to Chefoo from Manila. There are already four Japanese and two British warships in Chefoo Harbor.

## FIGHTING LOOMS IN SHANTUNG AS FORCES GATHER

U. S. Sends Cruiser To Give Protection On Request Of Consul

WASHINGTON, Feb. 21.—(INS)—Advice to the State Department indicates a widespread anti-nationalist movement in the Shantung Peninsula in China, in which large numbers of former Republic troops and brigands engaged in effecting an encircling movement around the nationalist forces.

Hwang Fang Chi has arrived at Hwangshien and has raised the five battle standards, according to a report. The 65-year-old Republican flag last used a Chevrollet Limo to drive, American consul at Shantung, informed the department that he deemed it advisable to have naval protection there and has communicated this to the commander-in-chief of the American naval forces in China. ## STEWART SAYS HE WASN'T IN ON OIL DEALS

Makes Formal Denial Of Charges That He Had Something To Do With Teapot Dome

Attacks Aldrich For Statements

Gilman Flays Enemies In Open Letter Sent To His Stockholders

CHICAGO, Feb. 21.—(INS)—"I have had nothing to do with Teapot Dome leases," Berger declared at last in a formal denial of the charges brought against him by John D. Rockefeller Jr., seeking to oust him as chairman of the board of directors of the Standard Oil Company of Indiana, that was Col. Robert W. Stewart's reply to Rockefeller today.

Col. Stewart's denials are contained in an open letter to the stockholders of the company. It is distressing to one's sensitiveness," the first paragraph of the letter reads. "To feel constrained to reply to such statements as have been published by Mr. Wadsworth W. Aldrich and Mr. E. Lee Jr. My John D. Rockefeller Jr. for more than a year our company and myself have been libeled and pursued by a certain type of political self-seeker and certain newspaper which either had reasons of their own for their attitude or were too indolent to ascertain the truth."

Referring to a summary of the Rockefellers' position in the statement issued Sunday by Aldrich, Col. Stewart accused him "of placing in circulation a grossly unfair deception—unfair because it was largely innuendo rather than accusation—a deception of engineers as well as of statement."

"I cannot believe that John D. Rockefeller Jr. ever gave his approval to the publication of such a slander," Col. Stewart declared. "He sailed away to Egypt at the very beginning of this campaign and possibly the above named men may conceive that any edition of the paper over shady tactics pursued by others may be attributed to their overzealousness and not reflect upon Mr. Rockefeller Jr."

The Aldrich-Lee document was given to the newspapers in advance of its supposed mailing so that no purpose behind it all is obvious. "To further beguile the newspapers into printing untrue and misleading matter concerning me—a trap devised by Mr. Rockefeller's publicity agent into which many persons innocently enough, no doubt have fallen."

"I never had anything to do with the Teapot Dome leases. They never have been introduced anywhere a single line of testimony or a shred of evidence that I had anything whatever to do with or knew anything at all about the leasing of Teapot Dome."

WASHINGTON, Feb. 21.—(INS)—Victor L. Berger, the only socialist in Congress, sang his swan song in the House today, a warning that England and the United States are drifting along the path to war. The late Amos W. Albinson, his predecessor, will now be a member of the new Congress.

Anglo-American relations, he said, are now about the same as Anglo-German relations were just before the World War. "The rivalry between Great Britain and the United States during the last two or three years has grown with a speed that is unanny," Berger declared. "A year ago we were told that war between the two countries was unthinkable—which means people are thinking about it."

We are destroying Great Britain in the markets of the world. In 1914, when Germany would trade as much as the British the World War did not delay. The

United States has replaced Germany as England's most formidable competitor and England which has destroyed every other major rival, does not intend to be supplanted by and yield to the United States.
