

Highest Court Of U. S. Passes Upon Important Cases

WASHINGTON, Oct. 15.—(AP)—The supreme court yesterday dealt with three cases of national importance in a rapid disposal of many actions accumulated during the summer recess.

One case involved the flexible provision of the tariff act in another oil production and the third power.

While refusing to pass on the validity of the tariff act, the court decided whether the duty on sodium nitrate raised under it can stand.

In the Clarion River Power Company action it refused to review a decision by the federal power commission from fixing original costs and net investments of hydro-electric power developments operating under federal licenses.

The commission will thus be free to make for its own use such valuations.

The court announced it would hear on Nov. 14 such argument as Governor Sterling, of Texas, desired to offer in support of his contention that he had the right to use state troops to restrict the production of oil in the east Texas fields.

The regulatory power of states over motor vehicles operating in interstate commerce will come before the court in another case in Texas advanced yesterday for oral argument on Nov. 14.

Young Man Loses Nose in Fistic Row Lasting Long Time

George Malm, young white employee of the Crown Paper Co., today is minus his nose and \$7.50 in cash as the result of a bitter fight with E. S. Rigney, a friend, most of which was staged in and about the San Lanta Apartments late Saturday night.

He lost his nose sometime during a fight which lasted, according to various estimates, from 20 minutes to an hour. He lost \$7.50 in Police Court yesterday as did Rigney, when Municipal Judge R. W. Ware decided that the disturbance they had raised was in violation of the peace and dignity of the city.
