Dec. 7, 1941 78
--County VA Boss On Arizona

Sundays were always special days to Clint Westbrook at the beginning of the 1940s. He was in the navy then and Sundays were the only days you got to sleep late.

That one Sunday Westbrook will never erase from his mind did not seem special at the time. In fact, it was a disappointment. He was supposed to have been off for the day.

It was just Westbrook's luck to be called on to dump the garbage on the day he was supposed to have been off. What rotten luck. It probably saved his life. Had he not been on the garbage boat that Sunday he might have been sleeping late on his ship.

You see, this was not just any Sunday. This was Dec. 7, 1941.

This was not just any navy base. This was Pearl Harbor.

It was not just any ship. It was the USS Arizona.

The Arizona lies now beneath the still waters of the channel that runs Ford's Island, the permanent tomb for 1,102 of Westbrook's shipmates.

The quiet man with the New York accent who served as director of Seminole County Veterans Affairs, was a witness to history.

Thirty-seven years ago today he saw the beginning of global war and the end of many young lives.

Over the remains of the Arizona and the men entombed within, is a shining white monument accessible by tour boats that visit the site hourly. The structure was assembled after the U.S. Department of Interior designated the spot a national landmark in 1964.

Visitors will come in greater numbers to the

memorial today — the anniversary of the attack.

It is said one can look at the water beneath the monument and see an emerging air bubble or some of the one million gallons of oil leaked on board Dec. 7, 1941.

Of all those who have seen the site, few have viewed it as Westbrook remembers it on that day so long ago...

As the 50-foot launch carrying Westbrook and a handful of fellow crewmen approached the USS Nevada, down the line from the Arizona in "Battleship Row," he heard

Legionnaire Clinic Started In Sanford

In what may be a first for an American Legion Post in the United States, Sanford Post 33 has opened an out-patient clinic on its premises.

Initially the post, at 3500 Orlando Drive, (U.S. 17-92) is offering outpatient care two days a week, Mondays and Thursdays.

The man behind the clinic, Post Commander Octavio "George" Castro of Sanford said he hopes to expand the program and include 24-hour

emergency ambulance service for anyone who needs the services.

"We have to do this," Castro said. "There is so much red tape with the veterans administration (V.A.) Now we just do it and send them the paperwork."

Castro said the red tape has prompted many local veterans to cash in veterans' medical benefits.

"Thirty to thirty-five percent of the doctors in town won't take it," he said. "They want you to pay cash and then you can apply to the veterans ad-

ministration for a refund and wait 90 days.

"But, a lot of people can't afford to lay out that kind of cash. Now we are supposed to live in the meantime."

"This is everybody's problem," Castro said. "It's not my problem. My God, somebody has to help them. They helped us."

He said many local veterans have been forced to travel to Orlando's V.A. clinic for medical treatment.

In addition to the convenience, the new clinic offers veterans, Castro, who is retired, is on

hand to help patients fill out the often complicated V.A. forms for payment of benefits.

Two Orlando doctors travel to the Sanford post to provide treatment. On Mondays, a heart specialist complete with cardiogram machine works at the clinic.

On Thursdays, a general practitioner complete with a portable x-ray machine works at the clinic. There is also a social worker on hand Thursday.

"Now we just do it and send them the paperwork."

"The men of post 33 are proud now," Castro said. "We have something to offer them now."

Castro said the clinic has been open several weeks and is averaging 30 patients on Mondays and 10 patients on Thursdays.

School Board, Clerks Approve Pact For 400

School district clerical workers and the Seminole County School Board have reached agreement on a new contract, bringing to an end six months of negotiations marred by the clerical association's internal strife.

The agreement which affects about 400 workers is retroactive to Aug. 1 and was greeted with applause by the approximately 50 workers who had gathered Wednesday at Lyman High School's library.

The contract still has to be approved by the general membership of Seminole Educational Clerical Association (SECA) as well as the school board.

If ratified, it would be the last of the four employee associations to successfully bargain a contract.

SECA employees fall into three categories depending upon the number of months they work—10, 11 or 12.

In the 10-month category:

A first year, 10-month side will be increased from \$4,750 to \$4,874. An aide with four years' experience will be increased from \$5,283 to \$5,387. An aide with nine years' experience will receive an increase from \$5,825 to \$6,233.

In the 11-month category:

Petitions Circulated In Longwood Over Trash Pickup

City trash collection, scheduled to be dropped after Dec. 26, is far from a dead issue in Longwood, according to interim City Administrator David Chacey.

"I have already received a couple of petitions asking that it be continued and the petitions have asked to be on the agenda at Monday's meeting," he said. "I'm prepared to go either way."

Action comes Nov. 13 by the city commission to discontinue the free city trash collection after more than 60 years, because no one in Longwood's municipal election.

The commissioners returned to office — R. Russell Grant and Steven Burton — credited their opposition to stopping the service as important factor in their victory.

"Every place I went in the city the people said the same thing,

said Bartee after Tuesday's win. "The people told me trash collection is one service where they can see what their taxes are being used for."

Notices were mailed out with the December water bills informing the residents that city crews would no longer collect

trash on Jan. 1.

The city has been investigating the option of granting a single garbage collection franchise in the city to a company that would also provide trash pickup. There are several private firms operating in the city at present, none of which provide trash

pickup to customers.

"I found that one of the concerns when I went around campaigning was that they have their own garbage companies and they want to keep it that way," said Grant. "I don't see any way we can franchise it. I don't think the people would put up with it."

According to former councilman Percy White, there are five petitions circulation in different sections of the city stating "we don't want to discontinue trash collection in the city after 60 years and don't want franchise garbage service."

"Not a city has refused to sign," he added. "This election came out the way it did because of the trash issue. We've got to change some minds. We'll find out Monday if John Crystal of Highland Hills has signed to go on the agenda to prevent this petition."

"The whole city is disturbed. This is a service we pay for with our taxes. They had \$25,000 in the contingency fund for trash collection and I see no reason to discontinue it," said White. "The city is well off."

During the years it has operated in the city, the trash collection

was halted for one six-month period as an economy move by a former city council, but was restored after numerous complaints by residents.

"I'm sure it will be coming up at the next meeting," Grant said.

"And I look for 40 to 50 names on the petitions. The residents deserve the best service we can give them for the money they pay. There is no way we can get rid of the trash truck as we have got to have something to keep our streets clean anyway."

Councilman Ray Lichtenberger, who along with commissioners Larry Goldberg and Jane Lorraine voted to halt the trash collection, has called the cost to the city "prohibitive." At the Sept. 26 meeting Lichtenberger said, "The trash is there. It's a losing proposition." Grant, however, insisted, "The truck can be replaced."

"At the Oct. 9 meeting the commission voted to spend \$200 to replace the engine in the trash truck and it was replaced.

Let's Zero In

On Key Issues

One additional trip to the polls is now needed by voters in Sanford and Lake Mary. The trip is planned for Dec. 19 when the two municipalities hold their run-off elections.

In Sanford, incumbent City Commissioner A. McClamahan, who garnered more votes than any of his challengers — but not enough to avoid a second go-round — will be facing David Farr who squeaked past Ned Yancey by a scant seven votes Tuesday.

In Lake Mary, Bill Smathers and Francis Mark will be meeting head-to-head for a seat on city council.

We congratulate all four gentlemen (as we do all the other winners from Tuesday in Longwood and Casselberry).

And we commend all the candidates for taking the high road in the just-completed campaign and avoiding the temptation for the campaign to evolve into a personally-name-calling contest. As Mr. Yancey observed following his losing effort in Sanford: "I think it was a very clean campaign. Everything was according to Hoyle."

But at the same time we encourage them and we beseech them.

We encourage them to use this occasion — the next two weeks — to zero in meaningfully on pertinent issues, issues which deal with the quality of life the people they seek to represent.

We beseech them to eschew the temptation of going over some of the ground that has been gone over and over and over — particularly in Sanford as it pertains to the operations of some of the city's governmental entities.

There are certainly enough key, significant, positive solid issues that can and should be addressed by the candidates and governing bodies they want to join.

We'll throw out just one — and it is one that pertains equally to both Sanford and Lake Mary: growth.

How are these two cities — either individually or, preferably, in concert, going to cope with the growth and expansion which we all know is coming closer and closer?

There is very little time for procrastination or delay. The issue, if not the actual growth, is upon us. And it must be dealt with — at the very least a game plan must be prepared.

If it is not, we shall be facing — after the fact — some of the same problems the sudden sprawl created for our neighbors in the southern end of Seminole County.

WASHINGTON — The seemingly uncontrollable growth of the federal budget clearly has emerged as one of the budget's most pressing problems. Until recently, however, some of the problems involved were both economically sound and politically sound.

Rep. Ron Paul, an exceptionally bright, tough-minded Georgia Democrat, now has developed a "carrot-and-stick" plan that offers the promise of true budget discipline for the first time in several decades.

The "carrot" is a series of reductions in personal income taxes, averaging 5 percent annually, in every year from 1981 to 1985. That would cost the government \$5 billion in 1981, \$25 billion in 1982, \$45 billion in 1983 and \$65 billion in 1984.

The "stick" is a trio of stringent requirements that would be a mandatory prerequisite to these tax cuts:

— Total spending on the part of the federal government, after being adjusted for inflation, could grow at a rate no higher than 1 percent a year.

Total federal outlays, which were approximately 21.4 percent of the Gross National Product, would have to drop to 21 percent in 1982, 20.5 percent in 1983, 20 percent in 1984, 19.5 percent in 1985.

Beginning in 1982, the federal budget would be balanced. (According to Rep. Nease, economists generally agree that 1982 is the earliest feasible date to achieve a balanced budget.)

Paul's proposed first surfaced in the closing days of the recently adjourned 96th Congress, but it received little public attention until now.

The unprecedented approach was considered and approved overwhelmingly by both the House (where the vote was 285-12) and the Senate (where it passed 68-30) but it never was incorporated into this year's omnibus revision of the tax code.

A Rare Tumor, But It Can Be Treated



DEAR DR. LAMB — My son died in 1964 at 26. The death certificate states the cause of death was hemorrhage from the left adrenal due to pheochromocytoma. Now my grandmother, age 34, who lives in Australia, writes that he may have a pheochromocytoma. Is it hereditary? What would I appreciate any information.

DEAR READER — A pheochromocytoma is a tumor of the sympathetic nervous system, that part of your nervous system (sympathetic nerves) that forms adrenaline.

Most of these are in the adrenal gland, the small organ located at the base of the spine. The name of this gland is the same as is in the autonomic nervous system. This is the major source of adrenaline for the body. The large amount of adrenaline producing cells in the gland is why so many of the tumors are located there.

The tumor can occur elsewhere in the nervous system, and about 1 percent of them are in the abdominal cavity.

They are very interesting and somewhat rare tumors. They are one cause of high blood pressure. About 1 percent of the people who have high blood pressure have one. The blood pressure may be periodically elevated, associated with a short period of time or a normal normal punctuated with intermittent episodes of high blood pressure.

The high blood pressure and other symptoms that the patient has are directly related to the sudden release of excessive amounts of catecholamines. That's why the attacks of high blood pressure are often associated with sweating and

transpiration along with a considerable amount of anxiety. In between such attacks, the patient may be entirely well.

Yes, there do have a tendency to occur in families. You can have more than one tumor. For example, both adrenal glands can be involved.

The good news is that if the diagnosis is made, about 90 percent of the patients with this disorder can be completely cured. Cure is accomplished by surgical removal of the tumor. When the tumor has been completely removed, and if everything else is normal, the blood pressure returns to normal.

Smoking Poses Unborn Babies Danger

An unborn baby shows a sharp decrease in chest breathing motion after its mother smokes only two cigarettes, according to new ultrasound findings. A disturbing image? Every pregnant woman who reaches for a cigarette eight to 10 times a day.

A fetus cannot be expected to thrive with a limited supply of oxygen. Yet that is essentially what a mother who smokes is doing to her fetus to do.

Research from our laboratory shows that smoking in pregnancy causes a decrease in the fetal oxygen supply.

Nicotine sets off a sympathetic nervous system discharge that causes constriction of blood vessels leading to the fetus. As a result, the blood flow carrying oxygen to the fetus is reduced. This, together with the prevention of carbon monoxide in the fetal blood stream may cause a continuous oxygen deficiency.

The influence of smoking on the outcome of pregnancy can be seen when comparing groups of pregnant women who smoke with those who do not. He's Going To Be Out Of His Job...

Lake Mary City Clerk Sig Pearson said today he will probably not be working for the city after Jan. 6, the beginning of the new term of office for Mayor Walter Borow.

City Council Thursday night voted 3-4 to recommend Borow appoint a new city clerk. Councilmen Pat Southward, Bert Harry, Terrell and Harry Terry voted for Mr. Borow; Councilmen Cliff Nelson and Lillian Griffin voted in the minority.

The council cited inefficiency in the performance of duties as the

primary reason for making Pearson's removal.

Pearson reportedly forgot to schedule meetings, contact officials when requested and keep minutes of council meetings up to date, according to members of the council.

Pearson said he was aware of the council dissatisfaction.

"I expected some dissatisfaction, but it's not my nature to do office politicking," said Pearson. Specifically, Pearson said he knew of "gross abuse of power."

"I don't think there's anybody who can satisfy this council," he added.

The council is expected by the mayor with the consent of the council, according to city Attorney Gary Massey. However, the council does not have the power to fire the clerk. That power lies solely with the mayor.

Borow said today he will work with Pearson on a smooth departure.

"Big can either resign or I will appoint someone, whatever he wants," Borow said today.

Pearson admitted he had already planned his career and had hoped he could do so before the council took their action.

"I had asked that the clerk's review be on the agenda," Mrs. Southward told fellow councilmen. "But it was not." The later charged Pearson kept his review off the agenda.
