Carter: World Economy Slowing Employment Effort

WASHINGTON (UPI) — President Carter said today there is no easy answer to high unemployment because it is "a tedious, slow process" affected by a worldwide economic slowdown. He repeated his support for the concept of the Humphrey-Hawkins full employment bill.

Carter said he would have an announcement on Humphrey-Hawkins "within the next few days," and hopes a final agreement will contain an anti-inflation clause as well as full employment provisions.

Court Rules On Confession

ATLANTA (UPI) — The Georgia Supreme Court has ruled a suspect's right to have an attorney present during interrogation does not have to be "literally expressed" by police officers in order for a confession to be legal. The court ruled Wednesday that failure of police to advise a suspect of all of his so-called "Miranda rights" is not grounds in every case to reverse a criminal conviction.

Cancer's Death Toll Climbing

WASHINGTON (UPI) — Cancer's death toll is expected to climb to 390,000 in the United States next year and the American Cancer Society predicts nearly one of four victims of the disease will die of lung cancer.

Of all the cancer deaths expected in 1978, perhaps three of 10 could have been saved by earlier diagnosis and treatment, the group said Wednesday in an annual report.

Kidnapper Committed

INDIANAPOLIS (UPI) — Anthony Kiritis, the admitted but acquitted kidnapper, was committed to the Indiana Department of Mental Health Wednesday but his lawyers predicted he will be a free man again in a few months. Kiritis was found innocent by reason of insanity for a nationally televised abduction. He was turned over to the mental health agency by a judge who ruled he is still dangerous.

A Sanford man has been sentenced to 15 years in prison for the robbery of a gas station attendant.

Ward Curtis Steward, 2281 Sipes Ave., pleaded guilty to robbery charges in Seminole Circuit Court, Judge Robert McGregor presided. Steward waived a pre-sentence

investigation and was immediately sentenced. He was found guilty of robbing 775 from Mark Dyal, an attendant at the Fire Service Station, 1219 Park Ave., on July 12. An aggravated battery charge stemming from the incident was dropped by prosecutors.

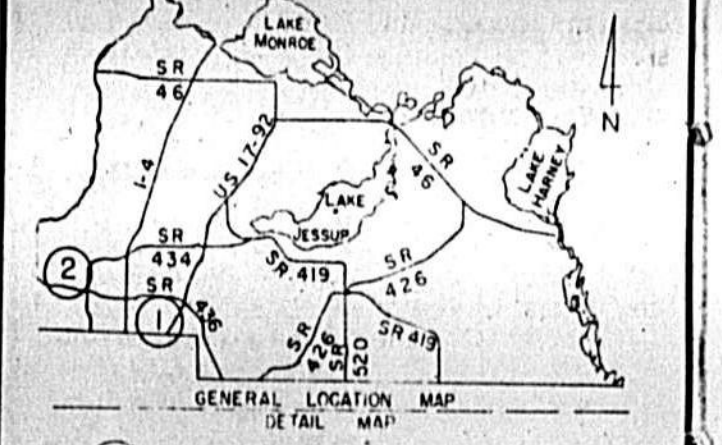

Ammonia Gas Kills, Injures, Routs Hundreds

PENSACOLA (UPI) — Ammonia gas that killed one person and injured 32 others late Wednesday continued leaking today from two overturned railroad tank cars. Authorities said more than half of the 1,100 people routed from their homes would remain away from the area into the afternoon. Emergency crews set up a command post near Escambia Bay and fought to dissipate the gas still spilling from two of three cars that ruptured when 35 cars of a Louisville & Nashville freight train derailed. The derailment about 6:08 p.m. Wednesday occurred along Scenic Highway, a road that skirts an area known as Gull Point and along a picturesque bluff overlooking the bay.

ST. PETERSBURGH (UPI) — Divers opened a hold of the sunken shrimp boat "Gunsmoke" in search of murder evidence Wednesday and a bale of marijuana popped out and floated to the surface of the Gulf. The eight divers, working in pairs, were searching for clues in the slayings of four Panama City, Fla., residents whose skeletons were found in a flooded sink hole near Perry three months ago.

JACKSONVILLE (UPI) — The state's second-largest community college said Wednesday it will accept students who flunk Florida's new functional literacy test even though they won't have high school diplomas. Tax Reform And Carter

President Carter is holding back his tax reform proposals until next year. First things first, says Mr. Carter. He wants Congress to finish on his energy program and Social Security legislation before he submits his tax package, and besides, the delay will give him a few more months to see how the economy is responding to the stimulus measures passed by Congress earlier this year.

The fact is that the White House and Congress are engaging in tax reform already, in the very legislation the President mentioned, energy and Social Security. Mr. Carter concedes there are "tax connotations" in the Social Security bills, which is an understatement considering the staggering increase in payroll deductions voted by the House. And the Senate balked at his energy program because it served mainly to produce more tax revenue rather than more energy.

Mr. Carter railed against the "disgrace" of the federal tax system during his campaign, so he is committed to tax reform. But the tax system is so disgraceful — with its loopholes, inequities and oceans of baffling fine print — because Congress is forever amending the tax laws, with a new levy here or a new credit there, meeting some special circumstance, fine-tuning the economy, or using tax provisions as a penalty or reward to get people to behave in a certain way.

That is exactly what the President and Congress have been doing so far this year. The energy program Mr. Carter is pushing would make the tax system enormously more complicated, with its taxes, rebates and credits aimed at getting people to conserve energy or convert plants from oil to coal. The payroll tax increases proposed to rescue the Social Security trust fund would exacerbate the inequities of a program which is rapidly losing the faith of the people who must support it.

If Mr. Carter wants the tax system to be simpler and more fair, he is going about it the wrong way. If he is concerned about the economic implications of tax reforms he has in mind, he faces the added complication of the potential effect on inflation, unemployment and economic growth of new energy taxes and the increasing burden on employers of the Social Security tax.

Some analysts believe the poor performance of the stock market recently is the result of uncertainty among investors about the fiscal and monetary policies of the Carter administration. That's easy to understand, and now Mr. Carter's hesitation with tax reform suggests that even the administration is uncertain about what those policies are going to be.

Tax reform is now promised as part of a comprehensive economic program that will emerge with Mr. Carter's budget early next year. With the energy and Social Security taxes likely to be on the books by then, it will be a case of reforming a tax system that is even more disgraceful than the one Mr. Carter inherited.

ANGLE-WALTERS Energy: Long Has The Aces

WASHINGTON — No matter how long it takes, sooner or later President Carter is going to get the energy bill he deserves — and Russell Long wants.

The wily chairman of the Senate Finance Committee holds all the face cards in the table stakes game between the House and Senate energy conferees, and Carter dealt him the hand. The President gave Long every ace in the deck when he declared that his own performance in the White House this year should be judged a success or failure depending on whether Congress sends him an energy bill he can sign. Even Carter's most loyal political supporters winced at that little exercise in hyperbole. With one rhetorical swoop, the President tossed away the option of vetoing an unacceptable energy bill and then blaming Congress and the oil companies for their intransigence.

Now he must deal with Russell Long, who has been known to walk off with the Capitol dome under far more challenging circumstances. And Long's price for sending Carter an energy bill the president can live with boils down to one thing: financial incentives to the oil and gas industry for increased production and the development of alternative sources of energy. The House energy bill, which is virtually identical to Carter's original proposal, contains no such incentives — at least in the view of Long and the industry.

What it does contain is a "wellhead tax" on domestic oil which would drive the price up to the international level, thereby discouraging consumption and promoting conservation. Carter wants all proceeds of this crude oil tax, which he has repeatedly called the "centerpiece" of his energy program, related to consumers.

Forget about natural gas deregulation. Forget about the gas-guzzler tax, the user tax to force conservation and get us out of our oil and gas tax credits for home insulation. The outcome of the energy conference is going to turn on Russell Long's determination to grab some of the proceeds of Carter's wellhead tax for production incentives to the industry.

Carter is already hollering "rip-it!", and insisting oil and gas producers don't deserve any more money. But he can talk until he's blue in the face, and the end result will be the same. If he wants a wellhead tax, the president is going to have to let Russell Long divert some of the proceeds to the producers — probably indirectly, through the creation of an energy development corporation.

Such a corporation, or fund, was originally proposed by former Vice President Nelson Rockefeller. As envisioned by Long, it would probably provide other low-interest loans or loan guarantees to industry for extraction of hard-to-reach oil and gas and development of alternative energy resources. The Senate has more or less endorsed Long's approach, and has given the Finance Committee chairman a virtual blank check for negotiating with House conferees.

WORLD WINDOW Haitian Human Rights

PORT AU PRINCE, Haiti (UPI) — American diplomats are apparently satisfied with the human rights progress made in Haiti over the past several months, and have stopped pressuring President-for-life Jean-Claude Duvalier to make even greater concessions. The real question is whether the Haitians themselves will be content with just a little freedom and just a few human rights.

Jean-Claude, now 56, took over from his father, Francois "Papa Doc" Duvalier in 1971 and has liberalized Haiti quite a bit since — with some no-so-subtle nudging from the United States, especially since the Carter administration started its human rights campaign.

Gone, at least from the government payroll, are the Toussaint Louverture, Papa Doc's private army, and most of the other trappings of terror of his regime. Gone also are all of Haiti's political prisoners, at least the 104 surviving ones, released on the 20th anniversary of the Duvalier dynasty last September.

The publication of some anti-government political content in the weekly Jeune Presse and elsewhere is being tolerated these days, even though the Inter-American Press Association still lists Haiti among those countries which do not have freedom of the press in the Western Hemisphere.

Strikes and unions are still illegal but some labor activity is getting results instead of brutal repression these days. Faced with protests spilling over into street demonstrations and even the occasional occupation of a radio station to air complaints against employers, the labor ministry took the unusual step of announcing that it is open to receive complaints from workers against employers about abusive or illegal behavior.

It even got tough with some factories which had been flouting Haiti's labor laws by paying their employees less than the \$1.30 day minimum

VIEWPOINT German Code Cracking

The British government has begun unwrapping the details of one of the best-kept secrets of World War II. Summaries of 70,000 messages between Berlin and German command in the field, which had been intercepted by British intelligence's fantastic Operation Ultra, are being made available to historians and journalists for the first time.

The story of how Ultra geniuses cracked the German secret code by duplicating the Nazis' Enigma encoding machine became public knowledge some time ago. But the 70,000 messages are the first to be released from a file that began to be accumulated as early as February 1940.

It was months, however, before Operation Ultra was fully cranked up, during which Hitler scored some of his most stunning successes, such as the blitzkrieg through the Lowlands and France in May 1940. But eventually, the Allied high command was reading virtually every message the Germans sent out on the air, sometimes even before they reached their intended recipients.

The intelligence ranged from the tactically significant to the strategically crucial, from the camouflaged positions of planes on a German airfield, for example, to the extent of German strength opposing Allied troops bogged down on the Normandy beaches on D-Day.

A number of "fiddling" questions have been posed by the Ultra revelations: Did chiefly, since the Nazis were in effect fighting with one hand behind their back, at least in the latter part of the war, why did it take so long to smash them? Or was the war shortened by Ultra, and if so, by how much? Could it conceivably be lost without Ultra?

The documents now being made available are not expected to result in any fundamental rewriting of the story of World War II. But the great number of Ultra revelations will certainly keep scholars well-fed with the raw meat of history for years to come.

Some of Goodwin's colleagues referred to him as the "grand inquisitor."

Goodwin is now keeping in the shadows, but he is still keeping an eye out for witches in the Justice Department's Internal Security Section. Footnote: Goodwin refused to take our calls for his comment.

Lebanese Claim 100 Dead In Attacks; Peace Pushed

U.S. diplomats scrambled today to arrange a new cease-fire in the volatile southern Lebanese border region amid reports that at least 100 bodies have been dug from the rubble left by Israel's devastating air strike.

Reports reaching Beirut said rescuers had recovered 30 more bodies today in the Borjeh Chennal refugee camp. If true, the death toll would rise to 100 dead, with at least as many wounded.

One newspaper, the right-wing daily Al-Anfal, put the casualty figure at 150. UPI correspondent David Pearce visited the hamlet of Hazyziy outside the biblical part of Tyre and reported the Israeli warplanes Wednesday had blasted it into "just a heap of rocks and rubble."

"Weeping women who walked through bomb craters where their homes once stood, their breasts and faces in grief and said their husbands were civilians, not guerrillas," Pearce reported.

In an interview today on Israeli radio, Prime Minister Menachem Begin said he told U.S. Ambassador Samuel Lewis "if the reports of civilian casualties are true we express our deep sorrow. But we don't apologize for the action."

Israel has said it ordered the devastating raid in retaliation for Palestinian rocket attacks on the resort town of Nahariya. The rocket attacks, Wednesday's air strike and the renewed shelling between Israeli-backed Lebanese rightists and Palestinian-leftist forces effectively buried the U.S.-mediated cease-fire that took hold Sept. 28.

"The Americans are scrambling to get things calmed down again," said a Western diplomat in Beirut. "But I think you'll have to call that a second cease-fire. When 70 people get killed in a single day, that pretty much closes the book on the first one."

Right-wing former President Camille Chamoun warned of "greater catastrophe" if the Palestinians remain in south Lebanon. The American proposal, the sources said, calls for the Geneva conference, to issue invitations to the countries concerned, specifying that the Arab side be represented by a unified delegation that would include Palestinians.

"We have already warned that as long as the Palestinians remain in the south, this would drag us and the people of the area into a crisis," Chamoun said.

Sadat: 'I Am Going To Geneva'

CAIRO (UPI) — Egyptian President Anwar Sadat has accepted a new U.S. formula for recovering the Geneva peace conference, even though it does not mention the Palestine Liberation Organization, diplomatic sources said today.

"I declare it openly that we are ready to go to Geneva to discuss the question of peace, regardless of all procedural issues," Sadat told an inaugural session of the Egyptian parliament Wednesday night. "I am going to Geneva."

Sadat's statements meant Egypt no longer insisted on PLO participation, heretofore a steadfast Arab demand and Israeli objection. But diplomatic sources said the new U.S. plan appears to be the reason behind Sadat's concession with regard to the PLO, removing a major hurdle from reconvening the Geneva conference.

The American proposal, the sources said, calls for the United States and the Soviet Union, co-chairmen of the Geneva conference, to issue invitations to the countries concerned, specifying that the Arab side be represented by a unified delegation that would include Palestinians.

S. Africans On Young: 'Racialist'

JOHANNESBURG, South Africa (UPI) — South African leaders have denounced Andrew Young as a "racialist" and accused President Carter of using double standards.

Two government ministers, in separate speeches Wednesday, also defended the government's Oct. 19 crackdown on black dissent and denied any police involvement in the death of black leader Steve Biko, who died in police custody.

Foreign Minister Roelof Botha, in an unprecedented personal attack on America's U.N. ambassador, told a cheering campaign rally Young had misled white Americans for what they "had done to his forefathers as slaves."

"But must I pay the price of Mr. Young's hatred of white Americans?" Botha said. "Andrew Young is basically a racialist. That's his problem."

In the past Prime Minister John Vorster has called Young "the talkative one." Young in turn this week said the bumpy, 62-year-old prime minister was "over the hill."

Botha and Vorster have become increasingly enraged by the mandatory U.N. arms embargo imposed last week against the white-ruled republic. Their rhetoric has become harsher as the Nov. 30 elections draw closer.

Police Minister Jimmy Kruger, asked about U.S. pressure to ease South Africa's racial segregation policies, condemned Carter's "double standards" in calling for the respect of human rights.

"We'll be damned if we go over to one-man, one-vote, ever," Kruger said. "That's a silly proposal. Must we also become infantile?"

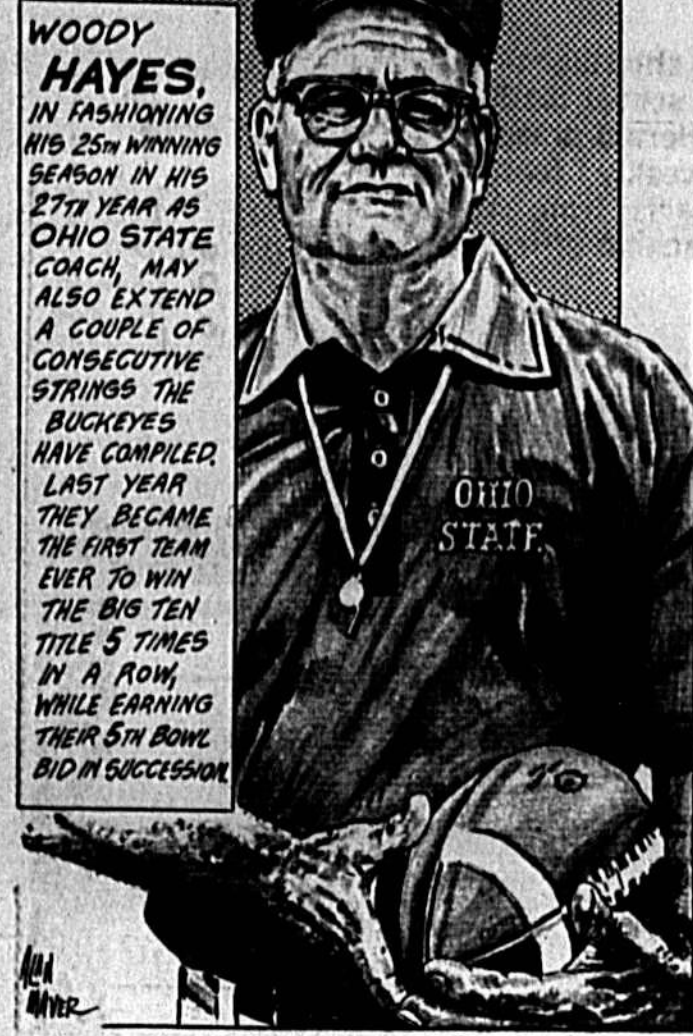

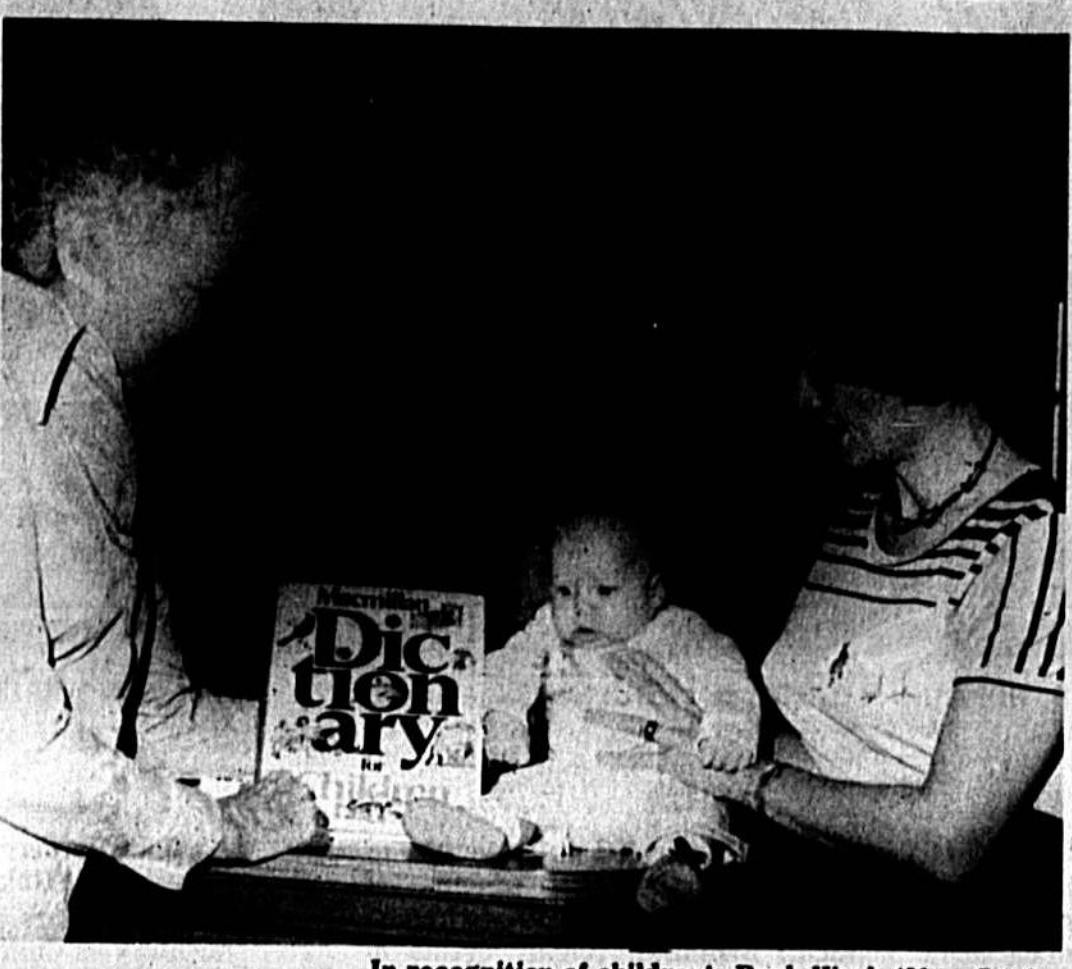

They took it. And, under the chamber's leadership, the Golden Age Olympics was born. And it has grown. And it promises to grow even more.

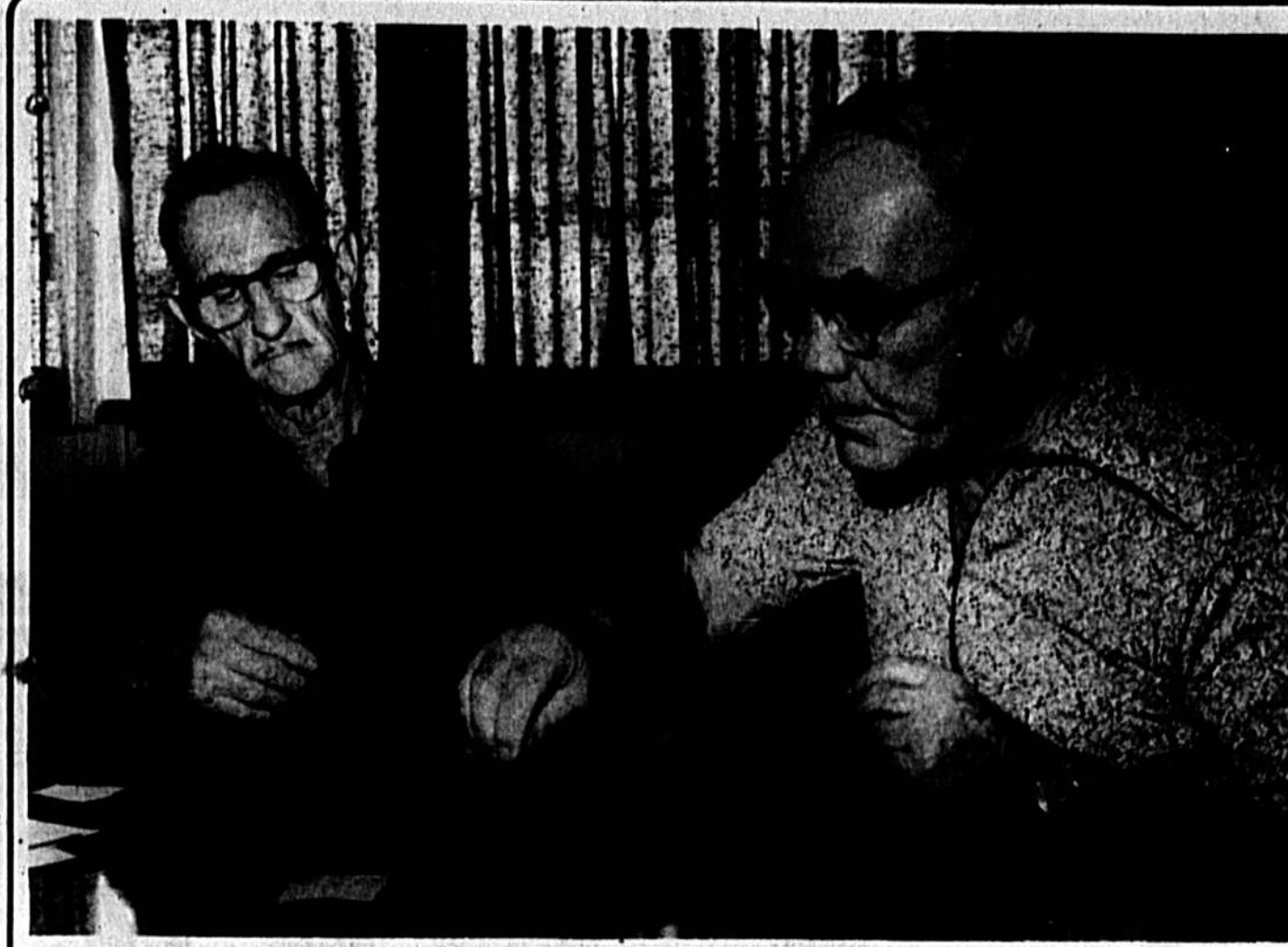
Jack Horner, executive manager of the chamber, envisions a nationwide Golden Age Olympics.

Hopkins Chalks Up Win, Defeat In Billiards Matches

Tom "Hopple" Hopkins won the battle, but lost the war, Wednesday.

Hopkins won his grade match with one Orlando challenger, James Whelan, at the rotation billiards event.

But Clyde Burns, 55, also of Orlando, took home the gold medal; defeating Sanford's Eric A. Carlson, 69, of 215 Tangerine Dr., in the finals.

Carlson's silver medal was his second of the Olympics — he also picked up one in golf Tuesday. Carlson is the first person to have

more than one medal in this year's Olympics.

Burns said that "steady nerves and good eyesight" were the keys to his first place victory — those, and getting in the opposite bracket from Hopkins.

"There's no doubt about it, Hopkins is the best player here," Burns said. "I think I come in next. He (Hopkins) beat me in eight ball. This time I didn't have to play him, because he lost before he got to the finals."

Burns says the whole Olympic idea "is wonderful."

"It gives senior citizens something to do that is fun and good for them," he said. Burns came north with an idea of winning the whole

thing. He has entered 12 events.

Hopkins won the gold medal in eight ball on Monday, defeating Orlando's Whelan in the finals. After the match, Whelan declared he would whip Hopkins in rotation.

And by the luck of the draw — officials swear it was not arranged — the two met in the first round Wednesday.

Hopkins had some trouble early — "We were tied at 108," — but won going away. Then on the next match, Hopple was upset by another home town boy, Leonard Payton, 71.

"I guess I'd used up all my good shots on

Whalen," Hopkins said. "Which is another way of saying that I played the worse game of pool I've played in years."

"But that's the way it goes," he said philosophically. "You can't play a good game every time." Then Hopple paused, smiled, and said, "But I wouldn't mind playing Payton for a dollar a game...until he ran out of money."

Payton finished fourth in the event, losing to Burns in the semi-finals.

M.H. Petynia, 74, of Jacksonville, knocked off Payton in the consolation match to pick up third place, and a bronze medal.

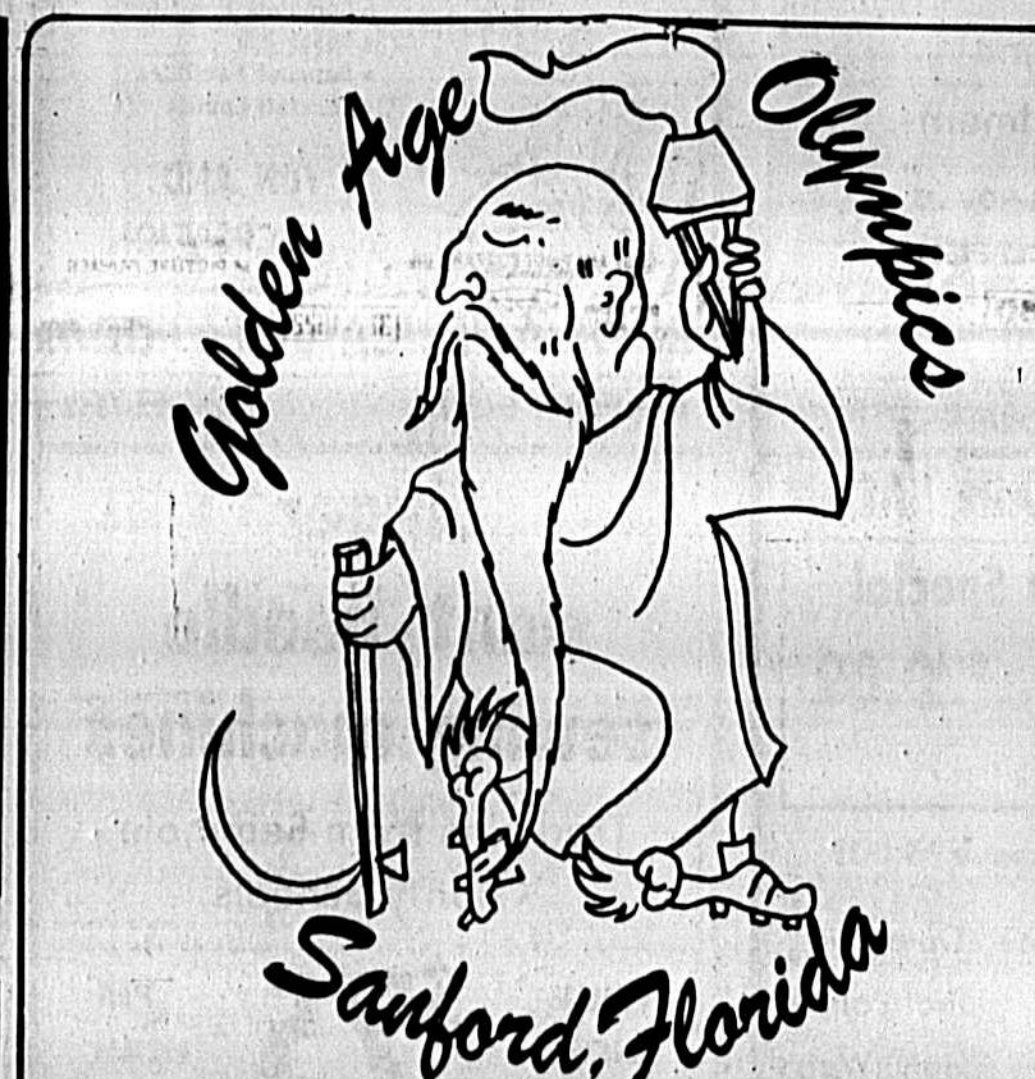
Whoops—Mildred Won After All

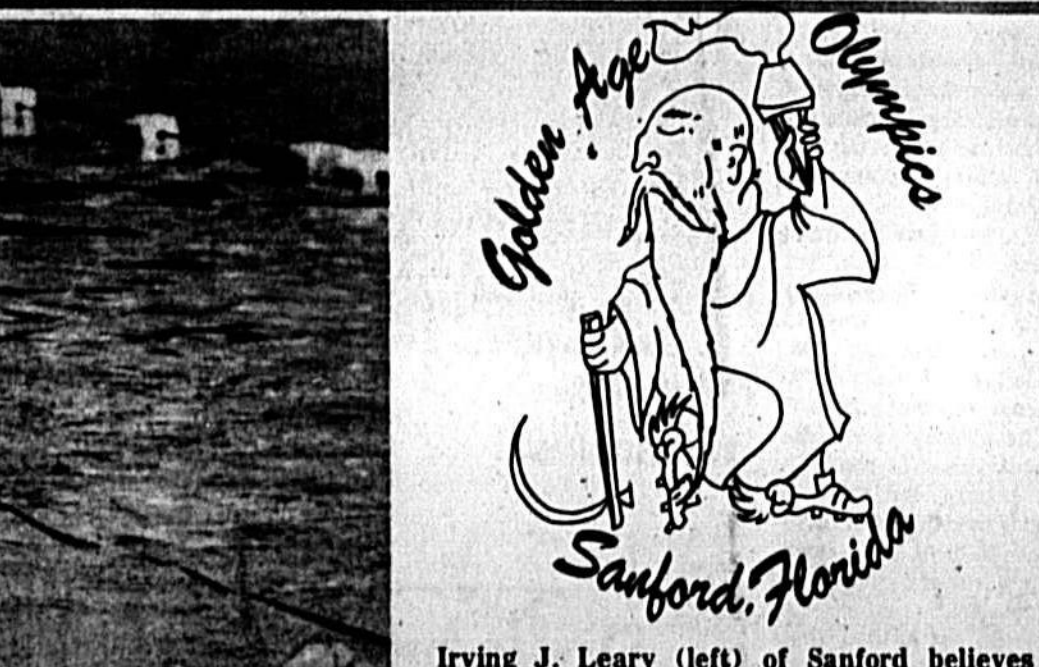

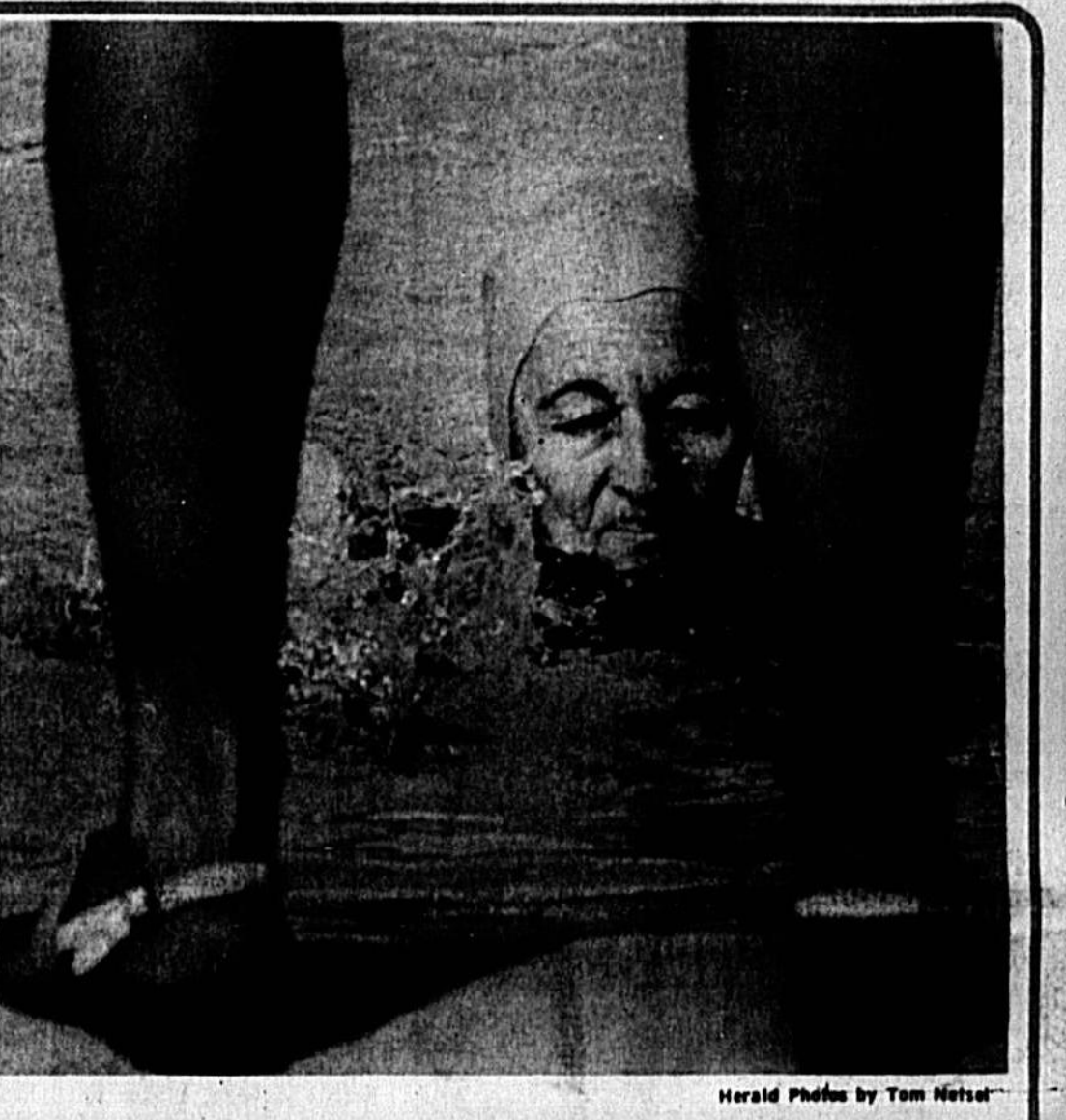

Consolidation: It's On Ex-Officials' Minds



Should governments in Seminole County — the county, the cities and the School Board — be consolidated? A group of citizens, most of them former elected officials, agreed Thursday night to put the Seminole County Legislative delegation on notice that a local law will be proposed to create a government study commission to look into consolidation.

The study, according to the proposed legislation, would call for \$20,000 funding over a two-year period from county coffers. At the same time, the group decided that it would appoint members of the study commission, a total of 17, refusing to leave the appointments open to recommendations from any of the city governments, the county commission or the legislative delegation.

Altamonte Springs City Commissioner Cal DeVoney, one of those who organized the meeting, said appointments by the elected officials would be necessary because political. State Rep. John Mica (R-Orange County), who was a consultant for the Orange County governmental study commission several years ago, explained the methods of studying local government with a view toward limited or full-scale consolidation. He noted that efforts toward consolidation or charter county government have failed in 75 percent of the cases in Florida.

He pointed to successful instances, specifically Jacksonville, which was not a total consolidation and for all intents and purposes abolished county government there. Because of the method used, whereby city residents voted separately on whether to retain or abolish their city governments, several cities including Jacksonville Beach and Neptune, were not consolidated with Jacksonville. Mica said that in his opinion it is not necessary to have individual elections in the cities.

But Wouldn't That Be A Crime, Too? "The purpose is to make our government more effective, more responsive and more efficient," Michael Davis, legal counsel for the Seminole County Republican Executive Committee said. The proposed legislation would create the study commission's term from Oct. 1, 1978 to 1980, Davis said, adding the group's function would be to "gather facts and make recommendations, not wave flags or banners."

Tom Kanelis, president of the Seminole County League of Civic Associations, said many citizens have approached him about the need for such a study, particularly concerning "double taxation and multiple jurisdictions," adding many are fearful of being annexed by cities. Mica said the group would have the authority to go into every governmental unit and "look at anything you wished."

Also attending Thursday's meeting at the invitation of DeVoney, included ex-Orlando Mayor Leon Olliff; Bob Cuevas, recent unsuccessful candidate for the Altamonte Springs City Commission; former Lake Mary Councilman Virginia Mercer; past Casselberry Council Chairman Charles Glascock; former County Commissioner Al Davis; and Gloria Ward, a past unsuccessful school board candidate and current member of the Seminole County Planning and Zoning Commission. The next meeting of the group was scheduled for 7:30 p.m., Nov. 21, at First Federal Savings and Loan, Longwood branch.
