### Man loses finger in explosion

**SANFORD** — A 25-year-old Sanford man lost a finger and was hospitalized Wednesday after a firecracker he lit exploded too soon.

Jason Morton of 2816 Park Avenue lit the device in his bedroom shortly after 6 p.m. Wednesday, and it exploded suddenly. The force of the explosion injured Morton's left hand and chest, said Steve Osborn, spokesman for the Seminole County Sheriff's Office.

He was taken to Orlando Regional Medical Center for treatment of his injuries. He is in stable condition.

He was conscious and talking with deputies while being transported to the hospital, according to the incident report.

Surgery was performed Thursday to repair injuries Morton suffered in the explosion. Doctors are uncertain about whether Morton's middle finger on his left hand can be reattached. He also suffered burns to the tips of his other fingers, said hospital spokesman Joe Brown.

Morton told deputies the explosive he lit had a fuse similar to an M-80. Investigators are looking into the type of explosive Morton used.

# Feds grant \$1.7 million for water project

## Plan will ease reclaimed water restrictions during summer months

**SANFORD** — Sanford has received grant funds for a program to supplement the reclaimed water supply in north Seminole County.

The plan would reduce the severity of reclaimed water restrictions frequently experienced during the summer months. Sanford will receive \$1.74 million in grant funds from the U.S. Environmental Protection Agency and the St. Johns River Water Management District to reduce groundwater withdrawals and supplement the reclaimed water supply

in the north Seminole County area.

In addition, Sanford has received permits to withdraw water from Lake Monroe to supplement the reclaimed water supply.

The total program cost is \$4 million. The local share of the project, estimated at \$2.26 million, will be split among Sanford, Lake Mary and Seminole

County.

Sanford plans to use the first phase of grant funds to add filters and a pump station at the city's Water Reclamation facility to withdraw up to 3.65 million gallons per day of water from Lake Monroe to supplement the reclaimed water supply. Phase I of the project is expected to begin operation this summer.

In addition, Sanford proposes to the second phase of grant funds to further expand the withdrawal capacity from the lake from 3.65 MGD to a total withdrawal capacity of 7.3 MGD. The current capacity of the Water Reclamation Facility is 7.3 MGD.

"Phase one will increase the reliability of our current system," said Bill Morrison, the project administrator for Sanford. "Phase two expands reuse water service to the area."

Water management officials said combining the current reclaimed water with the supplement of up to 7.3 MGD from

## Hillman left business world to teach

**WINTER PARK** — Richard Hillman of Lake Howell High School was conducting a stock market exercise with his senior Economics class Thursday when school district Superintendent Paul Hagerly knocked on the classroom door.

Hagerly led a group of administrators, family and friends who surprised Hillman with the announcement that he is the Seminole County Teacher of the Year.

Hillman has taught economics and math at Lake Howell for 14 years.

The state is expected to announce finalists for the Florida Teacher of the Year in May. Hillman is the school district's nominee.

This is the third time in seven years that the school district's teacher of the year is from Lake Howell High School. Hillman said that he is

overwhelmed by the award.

"There are a lot of people at this school who also deserve this award," Hillman said.

Technology plays a significant role in Hillman's lectures. By using Power Point, he visually displays data and graphs. For example, he created a computer program that displays

how continuous investments of small increments of money can accumulate.

"I started out using the Internet in the early '90s," Hillman said. "Then, I learned to do some programming. The trick is to use it for the benefit of the students. I try to model what they are going to see in the business world."

Prior to teaching, Hillman was a marketing specialist. He became a teacher because he finds working with students to be more rewarding than working in a corporate environment.

Teenagers from grades six through 12 are being sought to volunteer their services in American Red Cross projects. ## New at the Zoo: International Migratory Bird Day

**SANFORD** — Somewhere along the way, Partners in Flight, a coalition of federal and state agencies, bird clubs and organizations, called for a specific day dedicated to migratory birds.

The observance is held in most areas during the month of May, but in Sanford, this is the time for migratory birds, so, according to Central Florida Zoological Park Marketing Director Andrea Farmer, Saturday, March 11 will be International Migratory Bird Day (IMBD) at the zoo.

IMBD will take place from 9 a.m. to 1 p.m., and feature many events such as bird feeder making for children, bird watching, identification, and participation by the Audubon Society, Sanford Middle School, and others including zoo bird keepers Steve DeCresie and Cindy Dupree.

Cost for the morning event is \$7 for adults, \$2 for children 3-12, and \$3 for seniors.

From 7 until 9 a.m., there will be an early bird trek tour, allowing participants to discover native bird species throughout the park, led by bird keepers. Cost is \$10 for adults and \$6 for

children.

At night, beginning at 7 p.m., it's an Owl Prowl tour, with a nighttime guided tour of the area in search of owls, flying squirrels, bats and others. The event also includes a nocturnal presentation. Costs are \$10 for adults and \$6 for children.

Reservations are required for both early and nighttime tours, by March 9. Phone 407-323-4450, ext. 122.

The Central Florida Zoological Park is located at 3755 Highway 17-92, west of Sanford near exit 52 of Interstate-4.





# State, Coast Guard win case against man who faked death

**TALLAHASSEE** — The Florida Department of Insurance, the U.S. Coast Guard and the Monroe County Sheriff's Office, involved in the hunt for a Key West man missing for 18 days in 1998, will be compensated for what turned out to be a faked death.

Kerry Stephen Scheele told authorities he was in the throes of a divorce and staged his disappearance because he needed time to think. Today, Monroe County Circuit Court Judge Mark Jones gave Scheele something else to think about - more than \$55,000 in restitution to cover law enforcement's cost for the search.

Earlier this month, Scheele pleaded guilty to one count of insurance-application fraud and one count of third-degree grand theft, charges brought by the insurance department after

investigators concluded Scheele actually was trying to cash in on a \$1 million life insurance policy that named his father and a girlfriend as beneficiaries. In addition to the restitution, Scheele was sentenced to two years probation, ordered to undergo a psychiatric evaluation and pay extradition costs of more than \$1,000.

"This case sends a message that neither insurance fraud nor such blatant disregard for emergency resources will be tolerated in Florida," Insurance Commissioner Bill Nelson said today.

Scott Carr, a spokesman in the Coast Guard's Miami office, said several hours are spent investigation every distress call. Unfortunately, he said, there have been instances where the Coast Guard has responded to a hoax, diverting resources and putting lives at risk.

Scheele led his estranged wife and others to believe he drowned during a lobster diving trip off the Florida Keys on Aug. 8, 1998. When he failed to return from the trip, a friend of Scheele's notified the Coast Guard and the Florida Marine Patrol and an extensive search ensued.

Investigators later tracked Scheele through phone records to a girlfriend's house. Scheele said he swam ashore just north of Big Pine Key, discarded his rented diving gear in some mangroves and then hitchhiked and rode a bus to his girlfriend's home in Wisconsin.

In the meantime, investigators said Scheele's father initiated a claim under his son's life insurance policy with Kemper Insurance Company. There is no evidence, investigators said, that he was aware his son was still alive.

## The sinful truth about sin is in the Bible

If you've been watching David Letterman's return to Late Night television, you have probably seen him make fun of decaffeinated coffee, which he says "tastes like water from hell."

Not too long ago, a coffee company actually did advertise that its product tasted so good "it's sinful."

A pastor wondered what it is about sin that tastes so good and makes people buy products.

He gave a sermon about why most lives are full of pleasures and problems. We do things we were told not to do—things we feel guilty about but keep on doing.

The word sin appears 171 times in the New Testament alone. One of the earliest faith statements recorded in the New Testament appears in 1

Corinthians 15:3 "Christ died for our sins in accordance with the scriptures."

Strictly speaking, the word sin means a voluntary act that cuts apart one's relationship with God.

Pastor Wayne Harvey at First Baptist Church in Orlando held a story about Chuck Colson in a recent sermon.

Colson, he said, was visiting the chairman of a large publishing company. The chairman bragged to Colson that his newspaper's chairman was instrumental in the removal of the Ten

Commandments from the walls of public schools.

Colson, the ex-Nixon aide who founded the Prison Fellowship, asked the publisher why he thought the Commandments should be removed.

"They offend people of other religions," the man said. "Besides, we must separate church and state."

As the meeting went on, Colson and the publisher talked about some bad things that were happening at schools. There was no missing from delinquency and theft; no campus had its named by

an alarming rate—in fact, a suicidal rate.

"What should we do to teach the kids that stealing is wrong?" Colson asked.

The publisher answered quickly: "Maybe we could put a sign on the wall that says, 'You shall Not Steal!'"

"Good idea," Colson said.

Pastor Harvey's suggestion to Colson was to avoid sin is to trust in the Bible. "It's possible to have and disability. It comes from God to you. It will point you to Jesus. His message will change your life. You can trust the people."

"I started out as a substitute teacher," Hillman said. "I had to start at the bottom and learn the ropes. At the end of the day, I want to feel like I've done something great for other people. And, this is fun. I don't feel like I'm working."

For five consecutive years, his students played the Florida Stock Market Game and were undefeated in the region. They were the Florida champions in 1996.

The announcement that Hillman is the school district's teacher of the year came as no great surprise to 18-year-old senior Richard Varner.

"I've never had a teacher like Mr. Hillman," Varner said. "He respects the students, and we respect him for that. In all of his lessons, he takes a complex idea and he breaks it down into something simple that we can relate to."

This past year, Hillman's Advanced Placement Economics class had a pass rate of 95 percent on the AP National Exam, the most successful AP course in the school district.

Hillman's wife of nine years, Linda, teaches second grade at Lake Orienta Elementary School in Altamonte Springs. She is an 18-year veteran teacher at the school.

She said that although she teaches at a different grade-level than her husband they can share the joys and frustrations of teaching.

"We can't plan any lessons together," Linda Hillman said. "But, at least we can share the good times and the bad times. He truly loves teaching."

Her son, Mike Serbert, took senior economics with step-father Richard Hillman last year. He had the option of taking the course with another teacher, but said he wanted to take it with

his step-father.

"As a teacher he wants you to have a plan for the future," Serbert said. "His focus is not just on education, but also on your future. As a father, a couldn't ask for a better parent. He's there when I need him."

In his spare time, Hillman is the sponsor of Lake Howell Teenage Republicans. He was also the Florida Council for the Social Studies Teacher of the Year in 1993, and the Junior Achievement 1998 National Economics Teacher of the Year runner-up.

The school district's Middle School finalist for Teacher of the Year is Vicki McCary of Indian Trails. The Elementary School finalist for Teacher of the Year is J.J. Royer of Midway.

Last year's Seminole County Teacher of the Year, Trent Dierick of Winter Springs High School, was one of five finalists for Florida Teacher of the Year.

Lake Monroe results in a significant flow available for the reclaimed system.

In addition, the funds will be used to further increase the supply of reclaimed water for Lake Mary and Seminole County through a Tri-Party Agreement.

The charge for the reclaimed water would be the same as the city rate, which is \$0.25 per 100 gallons.

State and local officials toured the North Sanford Water Treatment Facility on Thursday.

The goal of the project is to help expand reclaimed water in Sanford, Lake Mary and Seminole County to help ensure fresh water in north Seminole County's future," Marcus said.

The project is being performed to address concerns among water management officials regarding the maintenance of adequate water supplies in the face of population growth.

The population within the St. Johns River Water Management District is projected to increase 50 percent by 2020.

The District has formed a water supply plan addressing water demands, traditional and alternative water sources, and water supply infrastructure improvements required to meet water supply needs through 2020.

"This is a pioneering project that meets what the needs will be in 2020," Marcus said. "I think you'll see more of these Tri-Party Agreements in the future."

Meanwhile, Sanford is also planning to construct a second waste-water treatment facility near the Orlando Sanford Airport. The estimated cost of building the facility is \$10 million.

"We envision a lot of development coming to the airport area," Marcus said. "We need to have utilities in place, which means water, sewer, and these days it includes reclaimed water."

The city is working on forming an agreement to purchase land for the facility. A two-year construction project is expected to begin this autumn.

Prior to starting a reclaimed water program in 1989, the city used to discharge treated effluent into the St. Johns River.

"Now we're using the old discharge line to remove lower quality river water and treat it," Marcus said. "We blend it with our treated product, and pump it into the system."

The student shared the bullet with a teacher, who contacted administrators. He has no prior history of discipline problems, according to Staats.

"He clearly did not intend any harm," Staats said. "The innocence of this child is just overwhelming."

Staats reported the incident to the Seminole County Sheriff's Office, and the bullet was seized. No further action will be taken by law enforcement, said sheriff's spokesman Steve Olson.

The boy brought the bullet from home. His father is retired from the U.S. Army and had apparently retained some ammunition, according to the incident report.

The matter is being handled internally by the school. The student is receiving discipline and counseling.



## Win at Bridge: Even looking at all four hands

**By Phillip Aider**

The expression double dummy means with all 52 cards on view. You are allowed to base your line of play on an exact knowledge of where every card is located. If your opponents hold their cards back, it rarely happens in the real world. But today, you may look at all 52 cards to see if you can find a way to get home in six spades after West leads the club king. Over two no-trump, South bid what he hoped he could make, appreciating that his hand, despite containing only 13 high-card points, had great slam potential. South discarded a diamond under dummy's club ace, then cashed the spade ace. West's discard was a bad blow. Now declarer hoped for a 3-3 diamond split, playing a diamond to his ace, a diamond to dummy's king, and a low diamond ruffed in hand. Yet he was out of luck there too, so he lost two major-suit tricks. If spades are 4-0, South should aim at these 12 tricks: seven spades, two hearts, two diamonds and one club. So, declarer should ruff in hand at trick one, then play a trump to dummy's ace. When the break is revealed, South discards a diamond on the club ace, ruffs a club in hand, cashes the diamond ace, plays a diamond to dummy's king, and ruffs the final club in hand. Now come the heart ace, a heart to the king, and the diamond eight. East has the J-10-9 of spades and the heart queen left. South retains the K-Q-8 of spades and the heart six. If East discards, South ruffs with the spade eight; if East ruffs, South throws his heart loser away. Either way, he is home.

## How long should women get Pap test?

**DEAR DR. GOTT:** In a recent column, you stated that Pap smears should be performed on all pre-menopausal women. The implication was that this testing can be stopped after menopause. My understanding is that all women with uteruses, regardless of age, are at risk of cervical cancer and should have annual Pap tests. In addition, even women after hysterectomy should have annual pelvic exams to detect ovarian cancer. I hope that you will retract your statement.

**DEAR READER:** Well, I won't. All pre-menopausal women should have periodic Pap smears. That's all I said, and it's true.

Now, with respect to your other points, I disagree. Many authoritative gynecologists now believe that routine Pap tests in post-menopausal women are unnecessary, provided the women have had at least three consecutive normal smears during preceding exams, and provided they have no symptoms, such as vaginal spotting. This recommendation is not universal, of course, and individual decisions should be made between a woman and her physician.

Second point: During a hysterectomy, the cervix (uterine opening) is customarily removed. Therefore, there's nothing left "to Pap." Furthermore, a routine pelvic exam is unlikely to reveal an ovarian cancer, which is exceedingly difficult to diagnose in its early stages before symptoms develop, without special tests (such as ultrasound) that are not appropriate for mere screening.

I acknowledge that there is disagreement about these issues and I am not a gynecologist. I am simply reporting the facts as they have been published. As I mentioned, each woman should discuss this with her physician. To give you related information, I am sending a copy of my Health Report "Menopause." Other readers who would like a copy, should send \$2 plus a long, self-addressed, stamped envelope to P.O. Box 2017, Murray Hill Station, New York, NY 10156. Be sure to mention the title.

**DEAR DR. GOTT:** We believe our house is infested with dust mites, even though we have had several extensive treatments by exterminators. My wife is particularly bothered by mites. Will this affect her diabetes or her daily home dialysis?

**DEAR READER:** I am certain that your house IS infested with dust mites, everyone's is. These tiny creatures are as ubiquitous as the air we breathe. Actually, it's not the mites themselves that cause coughing and congestion, it's their excrement.

Mites are virtually impossible to eradicate. They happily survive and reproduce in dust, furniture, rugs and so forth. Therefore, most of us have to develop methods of living with them, rather than without them. Of course, this means we have to keep our homes as clean as possible, without becoming over-concerned to the point of obsession.

For those individuals who truly have uncontrollable dust-mite allergies, a visit to an allergist may be helpful. Desensitization injections may be necessary, in conjunction with the judicious use of antihistamine medication. Whether or not your wife chooses to see a specialist is a matter of personal preference. The mites will not influence her diabetes or dialysis.

## Easy credit: The truth about advance-fee loan scams

"The Company guaranteed I would get the loan if I paid an up-front fee. I never got the loan and now they won't refund the \$150 I paid in advance."

Advance-fee loan scams "guarantee" or represent a "high likelihood of success" that an advertiser will be able to get or arrange a loan or other form of credit for a consumer, regardless of the consumer's credit history. These scams differ from legitimate, guaranteed offers of credit in one critical way: they require payments up-front, before the lender is identified and the application is completed. The fee may range from \$100 to several hundred dollars. Legitimate lenders may require consumers to pay application, appraisal, or credit report fees, but these fees never are required before the lender is identified and the application is completed. In addition, the fees generally are made payable to the lender, not the broker or arranger of the supposed

"guaranteed" loan or extension of credit. Legitimate lenders rarely guarantee a loan or extension of credit before evaluating a consumer's creditworthiness. However, there are legitimate guaranteed offers of credit. For example, guaranteed offers of credit cards or other extensions of credit do not require any payments up-front for a consumer to accept the offer. These are firm offers of credit that require a consumer to accept the offer; they are advance-fee loans only if they offer the consumer the "opportunity to apply" for credit. Advertisements that promise loans

generally appear in the classified section of newspapers and magazines. Often, the ads feature "900" telephone numbers, which result in charges on your phone bill. Advance-fee loan scams also are promoted through direct mail and radio and cable TV spots. The appearance of an ad in recognized media outlets — such as your local paper or radio station — does not guarantee the legitimacy of the company behind the ad.

## Another Aussie on Daytona 200 pole

DAYTONA BEACH - Troy Bayliss put his Vance & Hines Ducati 986 on the pole for Sunday's 59th running of the Daytona 200 by Aral. It marks the third time in the last five years that an Australian rider has won the pole for the 200.

Bayliss turned a lap of one minute, 49.075 seconds at 117.497 mph on the 3.56-mile road course. He follows in the footsteps of Troy Corser in 1996 and last year's polewinner Anthony Gobert, an Australian racer to win the prestigious Rolex Award for winning the pole for the 200. All three Aussies rode the Italian-made Ducatis.

The fact that the 30-year-old Bayliss had never even seen Daytona International Speedway before tire testing sessions this winter makes his accomplishment even more impressive.

Joining Bayliss on the front row, which was locked in Thursday, is defending AMA Superbike champion Mat Mladin, also of Australia, who clocked a lap at 1:49.083 on his Yoshimura Suzuki; 18-year-old Honda rider Nick Hayden from Owensboro, Ky., who turned a lap of 1:49.500; and Baltimore, Ohio's Larry Pegrum who rode a Competition Accessories Ducati to a time of 1:49.887.

Defending Daytona 200 winner Miguel Duhamel qualified seventh on a Honda despite suffering from a serious neck strain, which he sustained in practice Wednesday.

Kurtis Roberts, son of legendary former world champion motocyclist Kenny Roberts, earned the pole for Friday's 600 SuperSport International Challenge riding a Honda.

Roberts, of Modesto, Calif., will try to avenge last year's narrow loss in the 600 final to Duhamel. Shawn Higbee, Waterford, Wis., dominated qualifying for the Pro Thunder event. Higbee's time of 1:58.594 on his Tilley Buell 1200 was almost a second faster than defending series champ Shawn Conrad.

Yet another Australian, Damon Buckmaster, won the pole for Friday's 750 SuperSport final. Buckmaster turned in a lap of 1:53.914 on his Chaparral/Mazda Suzuki GSXR750.

Two-wheeled racing action continues Friday at Daytona International Speedway with second round qualifying for the Daytona 200 by Aral, the Lockhart Phillips 750 SuperSport Final and the Pro Honda Oils 600 SuperSport International Challenge.

The AMA Grand National Short Track series also kicks off at Daytona Municipal Stadium starting at 8:30 p.m.


