Dr. Frederick Tice, Chicago heart specialist said the patient's heart which struck at the mayor last Saturday "Continues to cause discomfort and distress. His heart action is only fair and sometimes is the cause of much anxiety. Correction of his lungs has become much less, and practically has disappeared."

His chief physician, Dr. Karl A. Meyer of the Cook County (Chicago) Hospital, said Cermak's recovery was "50 to 60" and added that only the "possibility" of recovery.

Mr. Meyer also said that the mayor's condition for a time Wednesday was such that he apparently had "only one chance in five to live."

Intravenous injections of glucose, a food substance to build up the patient's strength were given yesterday. The liquid is administered through the skin, and about an hour is required to give one pint.

General improvement yesterday also was reported in the condition of Mrs. Joe H. Gill, wife of a Miami golfing club president, who was shot down, along with Cermak and three others, in an attack upon Roosevelt last week.

Her doctors announced she was definitely out of danger. The three other persons were not seriously injured.

State Schools To Get Share Of Tag Sales

TALLAHASSEE, Feb. 23—(AP)—W. S. Cawthon, State superintendent of public instruction, said today the State will distribute to 67 county school systems a total of \$1,852,045.79.

Unlike the house where blocs are usually organized the august senators are mostly individuals, forming into cliques only for the purpose of passing certain bills.

### Cannon Warns Drys Fight For Repeal Needs Organization

(Continued from Page One) Sociated Press stories. He termed Smith as a "rabbi for prohibition" and said that he is the leader of the wet reaction and had been since 1920.

The statement included a reference to the "lawless lawmakers" in both houses who, in voting for the resubmission of the prohibition amendment, "violated their oaths of office, their oaths to support the Constitution of the United States."

The speaker assailed Dr. Nicholas Murray Butler when he said "infallibility second only to that of the Pope at Rome", for his "false philosophies and misleading statements" which he said had largely influenced John D. Rockefeller, Jr., to assert that "prohibition is a failure."

"I believe in the sincerity of Rockefeller", Bishop Cannon said, "but he has been grossly misled, and is ignorant of the facts in the case. He does not know what he is talking about, that's all, when he said that drinking is on the increase and that prohibition is a failure."

In references to Jane Adams, noted woman sociologist and Nobel prize winner, Amos W. Wood, and then dissolving their lines. Among the hold-overs who drag considerable weight are to be noticed Senators Hayes Lewis, of Marianna, tall, white-haired and rough and ready in debate. William C. cock, national prohibition director, and Evangelist Booth of the Salvation Army, Bishop Cannon quoted statements attributed to them relating to the success of prohibition. "Yet," he said, "the press of the nation would not play up their statements as they did Rockefeller's although they are persons of wide experience and close contact with the problem. I ask you frankly, which opinions do you consider correct?"

"The trouble with the prohibition question," he said, "is this constant undermining of the morale of our people by subtle charges and statements that have no basis of truth. The purpose of the Eighteenth Amendment has been entirely overlooked. Society passed the amendment because it didn't want a pack of drunken people roaming the streets of our cities and towns violating and infringing upon the rights of others."

"Dr. Butler tells us that the prohibition law has demonstrated that the surest way for a man to get liquor is to tell him he can't have it," Bishop Cannon said. "That statement is one of the best examples of the undercutting of the prohibition question that is doing so much damage. That is the kind of false philosophy which is going the rounds."

In answering this statement, Bishop Cannon asked whether or not people sold rotten fish or vegetables because there is a law against such driving, or whether they drove recklessly in automobiles because there is a law against such driving, or whether they deliberately started under "No Smoking" signs and smoke?

Further, he told of an experience with a mother who had complained that prohibition had made her daughters take to liquor and were harder to manage. He asked the mother whether the girls smoked or "petted", and when she said that they did, he asked why the mother is not playing fair in the matter. "Why should she say that prohibition had made her daughters 'crink', he asked. "When they smoke and pet, although there are no laws which say that they shouldn't!"

Digressing, he said that what appears to have been a wet victory at the polls in November did not come as the result of a wet and dry fight. "It was the outcome of a mass movement of discontent and unrest by people who did not want liquor, but food and clothing," he said.

As he neared the conclusion of his talk he said that "We never have claimed that this prohibition law is perfect or would not be violated. I do not say there is no drinking going on for I know that there is. The Ten Commandments are broken every hour of the day, yet does anyone say that it is time to repeal them? They are the underpinning of all of our moral laws and they shall remain in effect to the end of time. The only question I want you to study is "Are conditions better now than before prohibition?" After 40 years of the fight against the liquor traffic, I say that they are, immeasurably so."

Concluding he said that "The trouble with us is that we dry people believe in prohibition but we've been made to read that things are worse. The way to meet these people and their statements and charges is to prove them. We've got to win this fight with our heads up, for we will lose if we let the financially powerful wet crowd get away with their work."

F. B. Esbert of the Anti-Saloon League at Washington preceded Bishop Cannon on the platform. He made an appeal for financial and moral support, and said: "We are straight up against a situation which we can't escape. If you are going to be negative and indifferent, there is no way in the world to save prohibition in this country. You must come forward now to help us carry on this fight against our age-old enemy."

Non-ferrous metal plants are said to have felt no upturn, but the trade's attitude is described as hopeful. The recent increase in automobile activity was reflected in plating shops, foundries and die-casting plants.

### "King" Bootlegger Of Palatka Is Held On Slaying Charge

PALATKA, Feb. 24.—Omar Wilson, known as a "king" bootlegger, is being held in the Putnam county jail, and will probably face a charge of first-degree murder following the sensational killing of Isham Rufus (Buck) Bennett, 32, Friday night. Jimmie Bailey, colored chauffeur for Wilson, also occupies a cell at the jail, and is being held as a material witness.

Bennett was shot and killed while standing in front of his home, Sixth and Madison Streets. The death wound was inflicted by a bullet, fired from a revolver, that entered the back of the head, ran down, ranging upward and lodging in the front of the skull. Five shots were fired, witnesses stated, all of which took effect. One bullet entered the left arm,

above the elbow, emerging at the shoulder. Another grazed the right temple, but inflicted no serious injury. Another was through the right arm, below the elbow and the fifth penetrated the leg, near the hip.

Bennett lived but a short while, and was gasping for breath when Constable B. B. Jernigan and Deputy Sheriff W. P. Revels arrived on the scene, about three minutes after the killing. They were the first officers to get there, Jernigan making a quick drive from his home on 16th Street. Bennett did not speak, Jernigan said, after his arrival.

### Fire Protection Seen As Helping Private Forests

TALLAHASSEE, Feb. 24.—Of the 1,009,244 acres of private forest land now being protected from uncontrolled fires in Florida, only 4233 acres burned during the first six months of the present fiscal year, according to statistics released by the Florida Forest Service. The average size of the 126 fires, which were extinguished during this period was 33 acres.

The Florida Forest Service is now co-operating with 210 landowners for the control of promiscuous woods burning. Of this number, 40 are turpentine operators who are co-operating by plowing fire lines, and suppressing accidental fires instead of burning the woods as a protective measure. Many naval stores operators report increased gum flow and higher grades of rosin on land where fires are not permitted to burn.

There are 779,929 acres of forest land under protection in the three national forests of the state which, together with the above mentioned area of private land, gives a total of 1,789,173 acres under protection in the state of Florida. This represents 7.7 per cent of the total forest area needing protection, which is placed at approximately 23,000,000 acres.

### Leesburg To Study Plan Of Continuing City School Term

LEESBURG, Feb. 24.—Efforts to raise a deficit of approximately \$8,000 in order that the Leesburg schools may operate for the eight months' term, will be made, according to the decision of representatives of the various civic organizations of the city, at a meeting in the city hall recently, addressed by Rev. S. J. Johnston, chairman of the board of local trustees.

A flat tuition rate for all pupils of the district, with a somewhat larger amount to be paid by those coming from outside the district and county, is one of the methods proposed. Children from several other districts, to the number of 160, attend the Leesburg schools, and from these pupils no money has been received for the past few years, although their respective districts receive funds for educational purposes. A committee composed of J. Locke Williams, E. M. Fain and John Clark was appointed to confer with the trustees of these outlying districts.

Letters asking parents to pledge themselves to pay tuition for their children attending school are being sent out this week to every parent in Leesburg and on the response received largely depends on the ability of the schools to remain open after Feb. 24. There are one hundred seventy-five pupils in the city schools.

### War Veterans Have Responded To Plan Made By Atlantan

COLUMBUS, Ga.—The plowshares used on the Argonne Farms near here may not have been beaten from the swords of the Argonne battle front in France, but the same courage and determination shown there in 1918 are found today in the fields of this rapidly growing agricultural community.

About a year ago Charles J. Haden, Atlanta civic leader, conceived the plan of using his extensive farm lands as a haven for war veterans who wished to farm and supplement this work with occasional employment in the city.
