Seminole County School Board Tuesday adopted a resolution aimed at selling the present Altamonte Elementary School and its adjacent properties to an unnamed buyer in return for either cash or titles to two of three Altamonte tracts, reportedly owned by the prospective school purchaser.

Walter Teague, associate superintendent for finance, had advised the board that James K. Froehlich, an Altamonte Springs investment broker, had asked to buy the property for a use not disclosed Teague said Froehlich was acting only for, he presumed, a trust wanting to purchase the property; however, Teague said the buyer had three tracts of land they would like to trade two of them to the board. He listed the proposed trading sites as located south of SR 436; in Rolling Hills and north of SR 434.

Douglas Stenstrom, board attorney, said law would allow the property sale if board determines the present site is unsuited for school purposes.

Stenstrom warned to dispose of the property without advertising for bids would cause the board to be severely criticized. "The law says you must sell to highest and best bid," the attorney cautioned.

Teague commented if the board desired to sell the school and its grounds, it should stipulate the property would not become available until another school has been built and ready for use.




### FIERY HEAD-ON COLLISION KILLS TWO

And that is one big problem with the high rise, Radley observed. Great security blanks are caused by elevators. More must be done with them architecturally - perhaps "some form of reinforced perspectives' so one can see into the elevator.

With other police officers he visited one area where he wouldn't enter the building. much less enter the elevator.

"In such buildings in Chicago, they are experimenting with some form of security, but I was told they are not going to build any more high rises in public dwellings. That doesn't apply to people living in the \$400-a-monch high rises on the lake." he added

Seven days after he arrived in the United States, Radley, a big man, well over six feet, was mugged, he says, "at tea time" while waiting for a bus in New York. On that occasion he responded to the request for money by kicking the robber in the groin, a good thing to remember, he advises

In his opinion the average homeowner or apartment dweller in the United States is well protected by an active dedicated police force. He met a great many high-caliber police officers and he was particularly mpressed with the police in Cincinnati. He also liked New York's strong youth division. and Atlanta's adult education programs in the juvenile area.

If he were to criticize it would be only "the lack of uniformity in the various forces. In England there is one juvenile division and one court of law which works well. But England is smaller and its population one quarter (56,000,000) of the United States "crammed into an area about the size of California."

Drummond told those present that Seminole County was not proposing anything - "we just want to see how we can help the cities with the dog problem. According to reports, the City of Casselberry has one vehicle which is out six hours a day to pickup dogs and they have their own disposal and interment programs.

A single ordinance which will be uniform throughout the county and in the municipalities is the program sought by the County government. Drummond pointed out that with the boundary lines being uncertain in some areas, dog control is a problem. Residents just don't know always which law applies to them individually.

Sanford City Manager, Pete Knowles stated that Sanford has a full time program which has a designated control officer. He has a regular patrol to pickup dogs. "Not cats, though," Knowles commented, "we don't pickup cats. That's a whole problem in itself." He said that it is necessary to seek out the troublesome dogs which -1 - Summer ...... in packs, or may be diseased or just problems Sanford has its own lisposal system.

Knowles agreed that a unified consolidated dog program would be be ..... "This is not a full-time job for our officer. We assign him to other luties when he is not out on patrol." The annual income in Sanford from the sale of dog tags amounts to two to four hundred dollars while the cost of the program is from four to five thousand dollars.

In Sanford, tags are required, but dogs are allowed to run loose if tagged. In Longwood according to Councilman, Lou Klosky, a leash law is in effect as well as the dog tag requirement. Klosky said that Longwood charges \$1. for its tags and realizes about \$140-150 dollars annually in fees. He was of the opinion that the tag fee should be higher to help defray the cost of the program. The cost of enforcing a leash law in Sanford would be astronomical,



3. If the board can require itself not to usurp the authority of the superintendent's office by conspiring to place certain people in high administrative positions.


4. If members of the board will avoid the practice of "going around" the superintendent's office and to only operate within the spirit and intent of the Sunshine Law. 5. If you can come to the




## One State House Bill Is Filed

MIAMI (AP) — State Sen Sherman Winn, D-Miami, has a constitutional prefiled amendment calling for the creation of a 120-member unicameral legislature to replace the current two-house setup with 160 lawmakers.

"The argument for a bicam eral legislature is that one serves as a check and system against the other." Winn said. "However governmen structure is set up the governor can serve as the check and palance for a singlehouse egislature.

## New Stage Reached In Vietnam Parley

The Communist negotiating tactics that Dr. Henry Kissinger says caused a breakdown in the Vietnam peace talks would not have come as a surprise to one of America's first diplomats in

He was Townsend Harris, the first U.S. consul general in Japan, who negotiated this country's first treaty of amity and commerce with the Japanese in 1856 and 1857.

Kissinger returned to Washington Dec. 12 after 10 days of intense but fruitless negotiations with North Vietnam's Le Duc Tho in Paris. He told newsmen four days later that the North Vietnamese kept raising issues that had been settled, kept surfacing new issues, had failed to include accepted changes in the Vietnamese language version of the peace agreement being negotiated.

Harris kept a complete journal of his negotiations that has became a classic. He wrote of the Japanese:

"One would think the translation of a paper to be a simple process. But it is not so with the Japanese." He said they were guilty of "duplicity and constant efforts to vary the substance.

In another entry he stated:

I am forced day after day to listen to useless debates on points that have been exhausted and are only varied by some new phase of falsehood."


Two other examples - "Fraud, deceit, falsehood and even violence is justifiable in their eyes . .

- "Now will it be believed that during all this time the governors (the Japanese manatic is thad an authentic copy of that very convention (which the Japanese denied ever having seen) lying before them in a dispatch box All this barefaced falsehood was a fair specimen of Japanese diplomacy."

The similarity in complaints raised by Harris and Kissinger suggest that what both encountered was a not unfamiliar Asian negotiating tactic; adopted for some unspecified purpose.

But the record of the present U.S. - North Vietnam impasse, at least that part of it that has surfaced in Kissinger's public remarks, suggests far more than that. Note these passages from **Kissinger's press briefing:** 

- "By the end of the third day we had made very substantial progress ... All of us thought we were within a day or two of completing the arrangements . . . But from that point on the negotiations . . . had the character where a settlement was always just within our reach and





From the early New Deal days, Americans learned that enlarging government could venture into social programs successfully, bringing human betterment with them. Dependence upon government grew strongly. From at least the post-World War II era, industry's new technologies-founded on rapidly multiplying scientific advances - have helped to spread more and more material things before us. And industry's advertisers have drummed into our ears

for decades the idea that all these riches are "easy" to come by. Count the times in a day or week when a seller, speaking through a television commercial, tells you either how easy it is to acquire his product, or how much easier it will make your life if you do. Somehow, out of this mix of full-hearted assurances

from both government and industry, Americans have grown to believe that they were being taken care of by others - and should be. There is a monumental flood of things, easy at hand,

### It's Blood Donor Month---Easy Gift By DAVID HENDIN

The traditional season of gift giving is over. Unfor-tunately now too few will think of giving a gift that costs nothing, but may mean everything to some fellow human being.

It is the gift of a pint of blood, the precious life fluid that is closer in composition to sea water than any other substance.

To remind potential blood donors, however, January has been proclaimed the annual National Volunteer Blood Donor Month.

In his proclamation on the observance, President Nixon has noted that the gift of blood "is an offering for which there is no substitute, and which annually helps restore to good health countless fellow citizens." The American Assn. of Blood Banks will give special plaques to 57 donors in six states and the District of Co-

umbia for donating 10 or more gallons of their blood. Ten gallons is a lot of blood. The standard donation is a single pint. This means

that each of the 57 individuals has given blood at least 80 times in their lives. Some procrastinate giving blood because they fear pain

or inconvenience, but it hasn't hurt enough to keep Jack E. Robbins of Watertown, N.Y. (14 gallons), or Robert Cartter Jr. of Tampa, Fla. (13 gallons), or Russell T Bowie of Washington, D.C. a year," says Dr. Robert Langdell, president of the AABB. "The need is as great in January as in any other month, but holidays, illnesses ar.d, sometimes the weather, keep many donors away. Sanford city commissioners have been told the city has enough money available to construct the \$260,000 "Big Inch" sewer interceptor main from Lake Monroe through the Goldsboro community to a point north of West 25th Street utilizing an old railroad right-of-way. But commissioners delayed any action to advertise for bids, until next Monday's regular meeting in hopes a snag preventing acceptance by the U.S. Department of Housing and Urban Development for federal funding participation in the project may be cleared.

The 24 inch diameter "Big Inch" will serve over 5,600 dwelling units under construction or planned in developments in the city's southwestsector. The HUD snag developed when it was revealed the East Central Florida Regional Planning Council, which is to do the environmental impact study required with the federal funds application isn't certified by HUD to make the study. The Councils application for re-certification is lodged in a bureaucratic maze of red tape, according to city officials

and no date has been advanced for certification. The city has told developers the "Big Inch" will be complete by June.

### City Cannot Issue Warrants

Commission received an opinion from State Attorney General Robert Shevin saying since the city has abolished its municipal court under Article Five, Judicial Revision, the police chief and city clerk can no longer issue arrest warrants for offenses under municipal ordinances authorized by the city charter.

Shevin said it is obvious that the charter authority to the City Clerk to issue warrants was granted to him in his capacity as Clerk of Municipal Court and not as City Clerk. "It necessarily follows," Shevin said, "that when the municipal court was abolished (Jan. 1), the offices of municipal judge and clerk of the court and executive officer of the court (the police chief) were abolished also, along with the right to exercise the powers formerly exercised by such officials in those capacities."

### McClanahan Volunteers

Commissioners heard a report from Knowles that the county's idea of furnishing countywide dog control, including inside municipalities, "seems to be the most logical approach."

The Commission authorized commissioner A. A. Mc-Clanahan to work as liason man with the county on the proposal after he volunteered for the duty. Commissioner Gordon Meyer said he's agreeable to such a plan with the county getting dog license fees collected from

city residents. Knowles said first estimates by the county for countywide dog control were about \$40,000. Apparently the deficit not collected in dog license fees would be made up by taxing property owners, he said. Knowles said in "best years" the city of Sanford had

collected only \$500 in dog license fees. Last year the amount dropped to \$83, according to McClanahan. The city presently has one dog warden. His budget including salary and a new truck is \$7,000.

### **Restored Docks Use Delayed**

Commissioners decided to wait until their January 8 meeting to authorize use of restored docks on pier A in the west basin of the city-owned marina. Knowles said the docks could be used now even though

Commissioners instructed Knowles to notify county sanitarian Val Robbins of Mrs. Joy Cotton's complaint of raw sewage flow from septic tanks in a "pocket" adjoining the city limits on South Palmetto Avenue. Mrs. Cotton, 2823 S. Palmetto, told commissioners it

would be a "sin and disgrace" if the pocket where migrant labor "shacks" are located is taken into the city under legislation the city has requested of the Seminole delegation. "I live next door, just inside the city," she said, "and I challenge each commissioner to ride by and inspect this situation."

She said she believes the reason people are fighting annexation of the "pockets" is they know the city will make them clean up the mess. The resident also complained of impassable conditions

on the dirt city street leading to her house. Commissioners instructed Knowles to look into the street situation.

Sanford City Commissioners have banned issuance of building permits and utility connections in the San Lanta subdivision until developer Wick Austin of Altamonte Springs remedies a drainage situation to the commission's satisfaction.

The action came Tuesday night after city manager Warren E. Knowles reported he had held up issuing building permits and utility connections requested by a second builder who apparently was purchasing 10 lots in the northern sector of he subdivision from Austin.

For months the city has tried to get drainage problems rectified on Valencia Court West where rainwater floods the partially completed street in front of several occupied homes which the city says it never authorized to be occupied.

Knowles told commissioners, 'It appears the city can not get the attention of the contractor or the Federal Housing Administration to do something NOW to help the lots."

Amount of the award was \$3,402,000. The EPA awarded a total of 36 new grants and 11 grant supplements to Florida governmental units by the deadline. Total of federal funds allocated for the construction of wastewater treatment facilities in Florida was \$59.2 million. Making the announcement was Jack E. Ravan, regional administrator from the Atlanta office.

Of the grants given, Altamonte's was exceeded in size only by those awarded to Gainesville, Orange County and Jacksonville. The North Orange County city of Maitland was also granted some \$447,750.





Marsee changed that vording to read counties "May be requested" to pledge these funds. This does not obligate pledging, however.

Also limited by the changes, are the powers of the expressway authority. Provisions were included to regulate any disputes which might arise. Counties may withdraw under the new agreement and there are now provisions for termination of the agreement

The purpose of this proposed beltline is to ease some of the Interstate 4 congestion around the City of Orlando. The route will skirt the downtown Orlando area and insure a smoother flow of traffic.

Seminole County Commissioners adopted an Air and Water Pollution Control Ordinance Tuesday, According to Assistant County Attorney Howard Marsee, this ordinance enacted under the Home Rule Power of the County, relates to the prevention, regulation and control of air and water pollution within Seminole County. It creates a Seminole County section of the State Department of Pollution Control, with Langley Adair, County Pollution Control Officer, as head of the Seminole section.

Under the ordinance, control, prevention and regulation is authorized in both the unincorporated and incorporated areas of the County, Certain of the State laws and administrative regulations are incorporated in the new document; providing penalities for violations, which according to the ordinance, will constitute a misdemeanor.

Marsee explained that a violation within a municipality is actually a state violation, while a violation in the unincorporated area is against the County and State. The ordinance means that the County allows Adair to act in behalf of the State in enforcing the regulations.

## Yam Quick Bread Is Treat

on my shelves devoted to making all kinds of breads, only two of these volumes give recipes for baking Yam Quick Bread the kind made with baking powder and/or baking soda. And these two books are of recent vintage. Bread books before this neglect this delicious and truly American bread, although one of them does suggest recipes for making yam biscuits, vam yeast bread, yam muffins and yam pone.

To rectify this omission here's a delightful recipe that's quickly and easily put together This yam loaf cuts well shortly after cooling and is beautifully moist - two attributes that not all quick breads can boast. If you are going to keep it as long as a week, it would probably be best to refrigerate it after a couple of days (because the yam flavor may change slightly unless the bread is kept cold and then bring the loaf to room temperature before serving We think you'll be as enthus astic about this Yam Ouic

1 1/2 cups unsifted flour 1/4 teaspoon baking powder 1 teaspoon baking soda


Wine is one drink that is a natural food and still, money wise, can cost unbelievably lit

For everyday drinking there is no need, other than shop ap peal to buy a wine out of one's budget range. There are a number of inexpensive wines available at almost any fairsized neighborhood liquor store and some supermarkets. It's merely a matter of knowing what to look for.

The larger size you buy, the more savings. (The company economizes by using only one label, one bottle, one cork or screw cap and passes the benefits onto the consumer.)



The only conditions on the cutoff, which was adopted by House Democrats Tuesday, would be release of U.S. war prisoners and safe conduct for withdrawing American rorces. Senate Republicans, meanwhile, with 17 of their number

seeking "a disguised victory with the October draft peace agreement." Saigon Ambassador Pham Dang Lam told the 172nd session of the semipublic Paris peace talks: "Unless they admit that their design is to achieve the reunification of Vietnam their way and to place the whole of Vietnam under their domination, the Hanoi authorities cannot fail to acknowledge that there are two distinct states of Vietnam."

Porter said the past four years of negotiations had been "largely sterile exchanges which only developed last October into a phase which can today be described as a serious negotiating process."


