





A review of aviation during the past year reveals the fremendous strides which have been taken in this industry. The remarkable trip of the Lindberghs on which they visitad most of the countries of Europe and crossed both the north and south Atlantic, the spectacular flight of General Balbo and his twenty-four seaplanes from Italy to Chicago

and return, the new world-circling record of Wiley Post, all serve to exemplify the development which aviation witnessed in 1933.

To obtain a complete picture of the improvement in aviation facilities. It is advantageous to compare the figures on air transportation companies today with those of 1929, the beginning of the depression. Then there were only 26,547 miles of national airways; today there are 45,-486. Then only 12,448 miles of the various alrway systems were lighted; today 19,500 miles are lighted. Actual miles one-half times as many this year as in 1929.

Four years ago the speed of the average mail and passenger plane was less than a hundred miles an hour. The cabins were small and uncomfortable. Pay load capacities vere only a few hundred pounds. Today the same type of planes, vastly improved, cover the country at 225 miles per hour. Many of them carry as many as fifteen passengers, two pilots and a stewardess, in comfort and luxury, together with 600 pounds of mail, in perfect safety, at upwards of 175 miles an hour.

In considering the progress of aviation during the past four years one should remember that it, too, like all other businesses has had to deal with the worst depression this Mott, Miss Villa Nelson, M. One wonders what uwell, Mrs Perkham, Orten progress would have been made, how far aviation could tapp, 8. tobson, Dr. Janu have gone, if the financial considerations which have utledae. cramped all businesses, had not also impeded aviation.

Mr. L. B. Manning, chairman of the Board of the American Airways, Inc. predicts that aviation will be largely instrumental in providing the initiative to business which is so essential to recovery. He points out that in every depression which this country has weathered, some form of transportation played a most important part in the recovery which followed. In fact, it can be argued that these transportation agencies and their development were responsible for the recovery.

Early in American history, Mr. Manning says, one depression was put to rout, by the invention of the steamboat, with the resultant development of the vast Mississippi valley through the widespread use of the Mississippi River and its tributaries. New impetus was given to business, in the great depression following the Civil War, by the construction of railroads, their organization and the opening up of the far west, made possible by the railroads.

**4 Marx Brothers Are** Starred In Late Film


