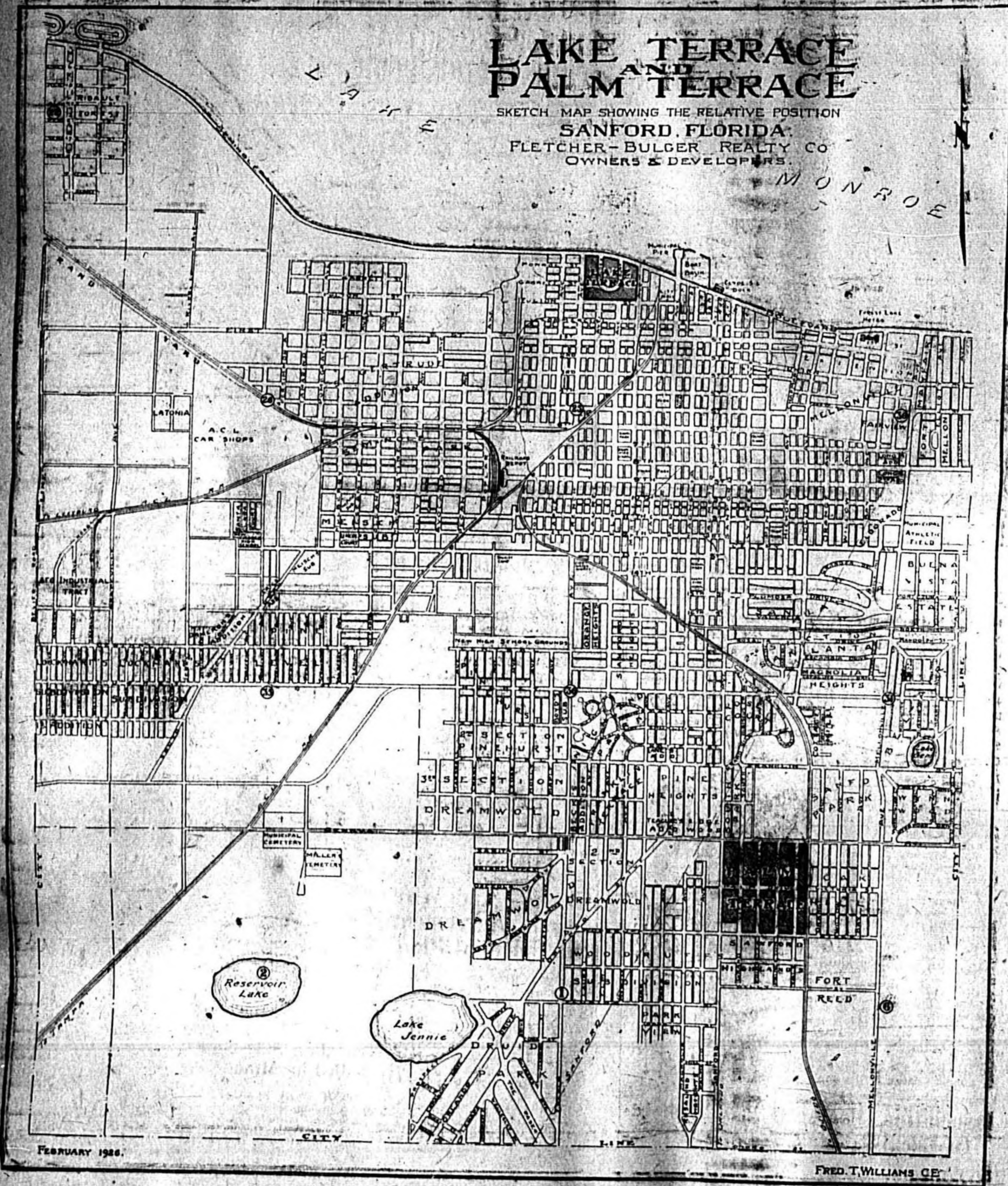

ROBBERS' LOOT FAKE CHARITY BEING SOUGHT BY N. Y. POLICE

Safe Deposit Box, Believed To Contain Approximately \$500,000 Stolen by White-More, Is Object of Search... Many Murders in 4 States Laid to Gang... Police Undecided Whether to Allow Extradition of Ring Leader for Baltimore Case

NEW YORK, Mar. 22.—(AP)—A safe deposit box, which police believe holds a part of the \$500,000 loot of numerous crimes in four states alleged to have been committed by a gang led by Richard Reese Whitmore, escaped convict, was sought today.

Police also were working on evidence tending to link the gang to seven murders committed in a little more than a year in Baltimore, Buffalo, New York City and New Jersey.

As a result of evidence found on one of the seven men under arrest, state officials were undecided today whether they would permit the extradition of Whitmore to Baltimore for trial for slaying a Maryland pentagonist guard during his escape last year...

Among the murders laid at the gang's door are those of three former members of the gang—Simon L. Golden, whose body was found in Trinity churchyard in December, Chicago; Tommy Langrella and 'Spikie' Kenny, who were found dead in New Jersey.

The seventh supposed victim is former Police Captain Victor Helwig, who disappeared after a band recently held up two jewelers on fifth avenue and escaped with \$150,000 of unset diamonds.

Helwig, then employed as a private detective, first notified police officers who are believed to have killed him to prevent recognition by him.

Detroit Man Killed In Atlanta When Car Hits White Way Post... ATLANTA, Ga., Mar. 22.—(AP)—Joseph Finn, 26, of Detroit, Michigan, died here early today of injuries received last night when crushed beneath a white car which fell after being struck by an automobile.

Hughie Reeves, driver of the machine, was held by police on charges of operating an automobile while drunk. After the death of Finn, the charges were amended and Reeves held without bond.

Jail Confinement Disgrace To Woman Dry Officer So She Attempts To Kill Self

EL PASO, Texas, March 22.—(AP)—The colorful career of Daisy Simpson, who established a record of law enforcement unguise for one of her sex, seems doomed to a tragic end in an El Paso hospital.

With a self-inflicted bullet wound in her abdomen, the 36-year-old former prohibition agent, whose methods of apprehending dry law violators were so drastic as to bring the censure of federal courts upon her, hovered on the verge of death today.

Overcome by the shame of jail confinement after her arrest on charges of receiving narcotics through the mails, she shot herself late Saturday night, after appeals for her release had failed.

REVIEW IN OIL CASE ORDERED BY HIGH COURT

Lower Court Decision Cancelling Leases With Doherty Subject of 2nd Hearing... All Phases To Be Studied In Case... Legality of Harding's Order Will Be Main Question to Settle

WASHINGTON, Mar. 22.—(AP)—The Supreme Court agreed today to review lower court decisions cancelling the oil leases and contracts which Edward L. Doherty negotiated with Albert B. Earl, as secretary of the interior.

Involved in the case are the Elk Hill Naval Oil Reserves in California and the contract between Doherty's companies and the government, by which the oil leases have been cancelled.

While agreeing on cancellation of the district court and the circuit court in California, disagreed on the question of compensation for the storage tanks. The district court allowed \$10,000,000, but the circuit court overruled that decision.

Besides this question, the Supreme Court is expected to go into all phases of the case and particularly that act to the legality of the executive order issued by President Harding, and in effect transferring jurisdiction over the naval oil reserves from the navy to the interior department.

The civil actions at issue grew out of the sensational Senate investigation two years ago which questioned the validity of the lease question in which both Doherty and Earl's Secretary, Earl, were named.

TROY, O., March 20.—"Fran was a better man than I was!"

And because Jacob Nesbitt, Ohio State University graduate, job man and social leader of this inland river city, was forced to admit that Fran, his trim young "modern wife," was his business superior he murdered her.

"A man can only stand so much. When the red flash comes," he says today in his cell here on the Main street, where he, the sleek young salesman with the fraternalistic watch chain, was once High Mogul.

"Fran was a better man than Jake!"

Troy, on the banks of the sleepy Miami, said it, too. Said it wonderingly, sometimes catly, but always admiringly. Troy women may cлик tongues at a young wife's unwashed dishes in the sink. But Troy women, too, mindful of certain own personal urges to "cut loose," hand it to a woman who dares be "a new woman" in place where tradition and prejudice forge iron and steel shackles.

"Fran was a better man than Jake!"

And Jake Nesbitt, not quite modern enough to eat this new message of "superior women," moans in his cell.

"I wish I were with Fran!"

Finally Confesses

Jake Nesbitt, who confessed how he hammered in the head of his wife of little more than a year, hurled her bloody body into a tub of water which she had drawn for her morning bath, went to his job, returned home "to find" the crime, spread the alarm, and then "lent his help" to the state for over three weeks, tells the story in simpler words than "the struggle between man and woman for superiority."

"Fran nagged!" he says.

"She knew she was a better salesman than I was. She made more money than I did. She had all the prospects. I knew she was good, too. That in itself was enough—for a man to know that his wife brings home the bacon. But Fran robbed it in. Asked me why I couldn't be a pusher like other men. That morning after we quarreled I couldn't keep it any longer. I ran red. The next I knew I was running my bloody pajamas in the furnace."

Jake Nesbitt, confessed murderer, said the above in the little "love nest cottage" out in the woods a few miles from Troy, where a tame version of the third degree was given him, here in this setting of blood-spattered bungalow.

He used the word "nagging" over and over again.

The story of the young Nesbitts is only one of the thousands of similar stories today.

High school and college sweethearts, Frances Drake, partly worked her way through college by selling a certain kitchen device which whipped and mixed cream and salad dressings. Business No. one finger tips.

The war came. Jake went across. Never actually on the front. Drove a car in motor transport division in Ohio State University.

Jake and Fran then were sweethearts in Ohio State University. They called Nesbitt "The Kid From Oxley Hall" when he was initiated into his fraternity. This because he courted Frances in the

## Scientists Seeking Traces Of Ancient Races In Many Countries Of The Globe

NEW YORK, Mar. 22.—(AP)—In efforts to reveal secrets of the human race long hidden by time and to bring new specimens of life to this country, scientists of the American Museum of Natural History are working in many lands—some in the far stretches beyond civilization.

Not all the work is being done in foreign countries, however, for out in Arizona Erich Schmidt, of the department of anthropology, has made valuable archaeological discoveries.

One important ruin was on top of a mountain where an old cemetery gave up skeletons of people of a past age. At the request of Phoenix officials, Schmidt examined a ruin there which proved of such historical interest as to merit restoration by the city.

In company with Harvey S. Lodge, who financed the trip, George H. H. Tate is collecting mammals and birds in Peru, Argentina and Bolivia. Dr. Frank M. Chapman, curator of the department of birds, Francis L. Jacques and Raymond Potter are in Panama, collecting specimens of bird life as representative of the American tropics. The party will be away six months.

Bird Life Studied

Working on Maya ruins with the Mason-Spinden expedition, sent out by the Peabody Museum, is Ludlow Griscom, assistant curator of birds. Already he has reported many interesting and heretofore unrecorded facts of existing bird life.

Carl F. Akeley, the explorer and sculptor, is on a big game hunt in Africa for groups to be placed in the new African Hall. He has mounted three gorillas and will obtain material for the physical reproduction of the background which includes studies of the vegetation, color notes and specimens of soil.

In East Africa, Dr. James P. Chapin, associate curator of birds, is with DeWitt L. Sage and Frank E. Mathey, who financed the expedition, collecting birds of the sub-tropical zone. They also will visit Kivu Volcano, the eastern edge of the Congo and through Katanga on their return.

A biological survey of Porto Rico and the Virgin Islands is being conducted by E. E. Anthony, assistant curator of mammals, and C. G.

## Modern Two-Passenger Foreign Plane Will Come To Local Field Tomorrow

A modern Sikorsky plane similar to the machines used so successfully in air transportation abroad, will be brought to Sanford tomorrow for passenger flights over the city from the local aviation field following a wing walking and plane climbing stunt at the field scheduled to commence at 3 o'clock, according to F. D. Henderson, Indianapolis flyer, now located in Sanford.

Mr. Henderson was formerly an instructor at the army flying post at Brooks Field, San Antonio, Texas, and his aviation experience dates over a period beginning shortly after the outbreak of the World war.

He has spent much time in passenger transportation, and is convinced that the airplane will in a number of years become almost as common as the automobile.

In commenting on the development of commercial aviation locally, Mr. Henderson said today that the greatest detriment to increasing the popularity of the airplane is the cheap, unsafe machines commonly used in passenger flights by gypsy flyers.

"The average passenger plane in this section of the country is generally unsafe," Mr. Henderson said, "and accidents due entirely to faulty planes have somewhat frightened off the general public."

"The machine that will be used tomorrow to enable Sanford citizens to see their city from the sky is one of the most modern and reliable planes in operation. The type has been used abroad for years, and in thousands and thousands of flights not one accident has occurred."

Passenger flights for very nominal fee will begin about 2 o'clock and continue until darkness, Mr. Henderson announced, and those desirous of inspecting the big foreign airplane and enjoying a hop in it are advised to be at the field early.

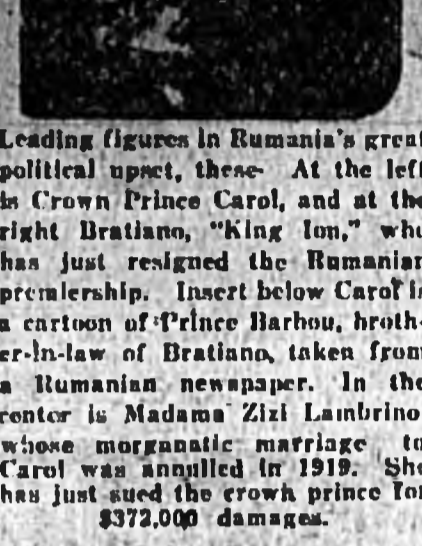

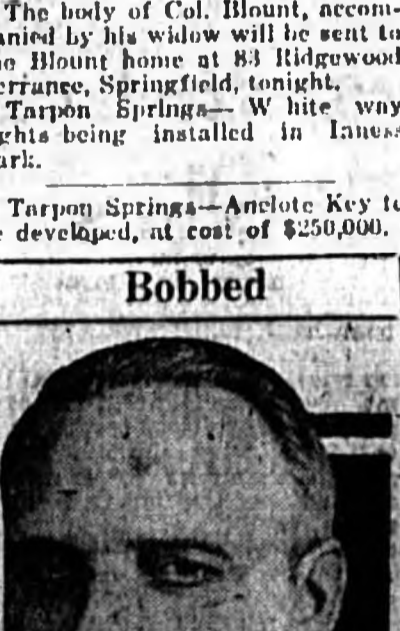

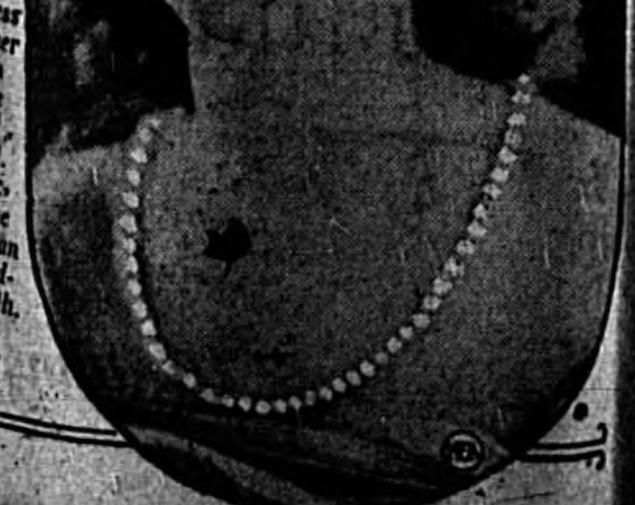

Under date of April 30, 1666, People made the entry which ushered in his day-to-day account of the growth and progress of the dreadful visitation. He wrote this:

"Great fears of the sickness here in the city, it being said that two or three houses are already shut up. God preserve us all!"

Substantially a week later he set down these words:

"May 7th. The hottest day that ever I felt in my life. This day, much against my will, I did in Drury Lane see two or three houses marked with a red cross upon the doors, and Lord have mercy upon us." (Write there, which was it sufficient to me, being the first of the kind that to my remembrance I ever saw.)

From Peppy's records we may note how within a month and a little more the pestilence had spread until it claimed its victims in hosts:

"July 12th. A solemn fast-day for the plague. It is growing upon us.

"July 13th. Above 700 died of the plague this week.

"July 20th. Walked to Redriff, where I hear the sickness is, and indeed is scattered almost everywhere. There dying 1039 of the plague this week.

Burying by Daylight

"August 3rd. To Dagenhams. All the way people citizens, walking to and fro, inquire how the plague is in the city this week by the bill (death list), which by chance, at Greenwhich I had heard was 2020 of the plague and 3000 and odd of all diseases. By and by met my Lord Crowe returning; Mr. Marr telling me by the way how a maid-servant of Mr. John Wright's (who lives thereabouts) falling sick of the plague, she was removed to an outhouse and a nurse appointed to look to her who, being once absent, she maid got out of the house at the window, and ran away. The nurse coming a-knocking and having no answer, believed she was dead and went and told Mr. Wright, who and his lady were in great strait what to do to get her buried. At last resolved to go to Brentwood hard by, being in the parish, and there get people to do it. But they would not; so he went home full of trouble, and on the way met the wench walking over the common, which frightened him worse than her story, and he was forced to send people to take her, which he did; and they got one of the pest coaches and put her into it to carry her to a pest-house. And passing in a narrow lane, Sir Anthony Browne with his brother and some friends in the coach, met this coach with the curtains drawn close. The brother being a young man and wondering there might be some lady in it that would not be seen, and by the way being narrow, he thrust his head out of his own into her coach and to look, and there saw somebody look very ill, and in a sick dress, and stunk mightily; which the coachman also cried out upon. And presently they came up to some people that stood looking after it, and told our gallants that it was a maid of Mr. Wright's carried away sick of the plague, which put the young gentleman into a fright, had almost cost him his life but is now well again.

"August 12th. The people die so that now it seems they are busy to carry the dead to be buried by daylight; the night's not sufficient to do it in. And my Lord Mayor commands people to be in at nine at night all, as they say, that the sick may have liberty to be abroad of air."

"August 13th. It was dark before I could get home and so laid at Churchyard stairs, where it is great trouble to get down, for the plague is the narrow alley just bringing down a little pile of stairs. But I thank God I was not much disturbed by it. Now

ever, I shall beware of being late about again.

Plague Takes Decline

"August 23d. I went away and walked to Greenwhich, in my way seeing a coffin with a dead body therein, dead of the plague, lying in an open close belonging to Coome Farn, which was carried out last night, and the parish have not appointed anybody to bury it, but only set a watch there all day and night, that nobody should go thither or come thence; this disease making us more cruel to one another than we are to dogs.

"August 31st. Up, and after putting several things in order to my removal to Norwich, the plague having a great increase this week, beyond all expectation, of almost 2000, making the general bill 7000 odd; and the plague above 8000. Thus this month end with great sadness upon the public, through the greatness of the plague everywhere through the kingdom almost. Every day sadder and sadder news of its increase. In the city died this week 7196, and of them 6102 of the plague. But it is feared that the true number of our dead, exceeding a near 10,000; partly from the poor that cannot be taken notice of through the greatness of the number, and partly from the Quakers and others, that will not have any bell ring for them.

"October 10th. I walked to the Tower; but, Lord! how empty the streets are and melancholy, so many poor sick people in the streets full of sores and so many sad stories overheard as I walk, everybody talking of this dead, and that man sick, and so many in that. And they tell me that in Westminster there is never a physician, and but one apothecary left, all being dead; but that there are great hopes of some increase this week: God sent it!"

"October 29th. In the streets did overtake and almost run upon two wench's heads; and carrying a man's coffin between them; I suppose the husband of one of them, which, methinks, is a sad thing. The epidemic, although diminishing, continues to claim its victims far more than a year thereafter. It scarcely had been stayed when on September 2, 1666, the Great Fire broke out. Every measure a disguised blessing, for in the flames the lingering seeds of the disease were destroyed, and London never thereafter was devastated of its people by so grievous an affliction.

Flames Scorch the Thames

Regarding the fire Peppy entered in his diary a graphic first-hand description. This is what he wrote:

"September 2d, 1666. Lord's Day. Some of our navys sitting up late last night, got things ready against our feast today, Jane called us up about three in the morning, to tell us a great fire they saw in the City. So I rose, and went to her window, and thought it to be on the bank side of Market-Lane at the farthest; but being dressed to such fires as followed, I thought I had got enough off, and so went to bed again and to sleep. About seven rose again to dress myself, and there looked out at the window and saw the fire not so much as it was and further off. By and by Jane comes and tells me that she hears that above 300 houses have been burned down by the fire, and she said that it is now burning down all Fish-street by London Bridge. So I made myself ready presently and walked to the Tower and there got up upon one of the high places, Sir J. Robinson's little son going with me; and there I did see the houses at that end of the bridge all on fire, and an infinite great fire on the other side, and the smoke of the bridge was so thick that I could not see any thing. So I down to the water-side, and there got a boat and through the bridge, and there was a banner of fire. Everybody endeavoring to

remove their goods, and flinging into the river or bringing them into lighters that lay off; poor people staying in their houses as long as till the very fire touched them, and then running into boats or chambering from one pair of stairs by the water-side to another. And among other things, the poor pigeons, I perceive, were both to leave their houses, but hovered about the windows and balconys till they were some of them burned, their wings, and fell down. Having staid, and in an hour's time seen the fire rage every way and nobody, to my sight, endeavoring to quench it, but to remove their goods, and leave all to the fire; and having seen it get as far as the Steele-yard, and the wind mighty-rising and driving it into the City; and everything, after so long a drought, proving combustible, even the very stones of churches.

The King Commands

"I to White Hall (with a gentleman with me who desired to go off from the Tower, to see the fire, in my boat) to White Hall and there up to the King's closet in the Chappell, where people come about me and I did give them an account that dismayed them all, and word was carried in to the King. So I was called for, and did tell the King and Duke of York what I saw, and that unless his Majesty did command houses to be pulled down nothing could stop the fire. They seemed much troubled, and the King commanded me to go to my Lord Mayor from him, and commanded him to spare no houses but to pull down before the fire every way.

"Here meeting with Captain Cooke, in his coach which he lent me, and Creed with me to Paul's, and there walked along Watling-street as well as I could, every creature coming away laden with goods to save, and here and there sick people carried away in beds, extraordinary good goods carried in carts and on backs. At last met my Lord Mayor in Cannon-street, like a man spent, with a handkercher about his neck. To the King's message he cried, like a fainting woman, 'Lord! what can I do? I am spent; people will not obey me. I have been pulling down houses; but the fire overtakes us faster than we can do it!' That he needed no more soldiers, and that, for himself he must go and refresh himself having been up all

night. So he left me, and I went and walked home seeing people almost distracted, and no manner of means used, to quench the fire. The houses, few and many, burnt, as pitch and tar, by Thames-street; and warehouses of oyle, and wines, and brandy, and other things.

"Soon as dined, I and Creed away, and walked through the City, the streets full of nothing but people and horses and carts laden with goods, ready to run over one another, and removing goods from one burned house to another. They now removing out of Cannon-street, and further; and among others I now saw my little goldsmith, Slokes, receiving some of his friend's goods, whose house lately was burned the day after. We parted at Paul's; he home, and I to Paul's Wharf, where had appointed a boat to attend me, and took in Mr. Carcasse and his brother, whom I met in the streets, and carried them below and above bridge to and again to see the fire, which was now get further and further below and above, and no likelihood of stopping it. Met with the King and Duke of York in their barge, and with them to Queenhithe, and there called Sir Richard Browne to them. Their order was only to pull down houses above, and so below bridge at the water-side; but little was or could be done, the fire coming upon them so fast.

"So near the fire as we could for smoke, and all over the Thames, with one's face in the wind, you were almost buried with a shower of fire-drops. This is very true; so as houses were burned by these drops and flakes of fire, three or four, may, five or six houses, one from another. When we could endure no more upon the water, we to a little above house on the Bankside, over against the Three Cranes, and there staid till it was dark almost, and saw the fire grow; and as it grew darker, appeared more and more, and in corners and upon steeples, and between churches and houses, as far as we could see up the hill of the City, in a most horrid malicious bloody flame, not like the flame of an ordinary fire.

"We staid till it being dark, we saw the fire as only one entire big arch of above a mile-long; it made me weep to see it. The churches, houses, and all on fire and flaming at once; and a horrid noise them flames made, and the cracking of houses at their ruins.

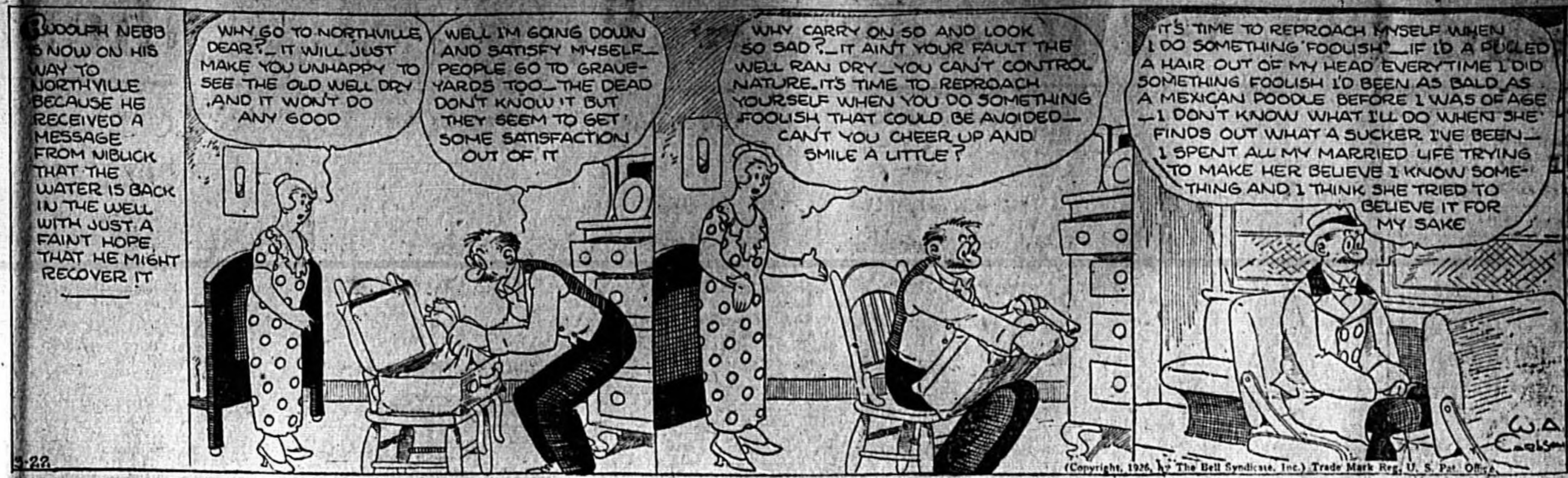

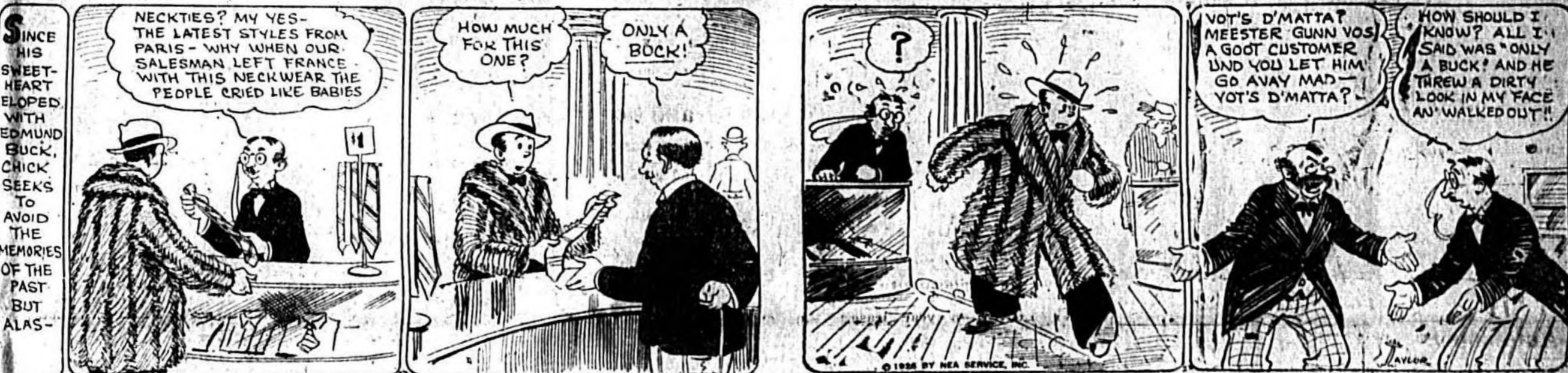
