# -Expects \$1 Billion For Holdings-Turner Plans To 'Sell Out'

ORLANDO, Fla. (AP) - Florida businessman Glenn W. Turner says he eventually plans to sell his legally embattled corporate empire for a reported \$1 billion.

The 37-year-old Turner, who has maintained he'd sell holdings in his 10company conglomerate one day, told the Miami Herald he expects to collect \$1 billion from sales over the next five

He did not divulge further details Turner, the son of a dirt farmer parlayed a borrowed \$5,000 and a bottle

of mink oil into what he claims to be a multimillion dollar business with the hard sell of an evangelist. Last year he said firms in Glenn W. Turner Enterprises Inc. grossed \$120 million. "Mr. Turner has said before he

# A Splendid Week To Read "Constitution"

This is "Constitution Week."

It is high time that its observance be stripped of its formalities and that the relevancy of its truths be acknowledged. For this is the document which has these

challenging sentiments as adopted in 1789: We the people of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defence, promote the general Welfare and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America."





Neither unitary schools, school desegregation, nor school busing is on stage center. These are now facts of life which are generally accepted with commendable grace and dignity.



### Why Samaritans Are Hard To Find

We find our lesson for today in the Tenth Chapter of the Gospel According to St. Luke, as follows: "... A certain man went down from Jerusalem to Jericho, and fell among thieves, which stripped him of his raiment, and wounded him, and departed, leaving him half dead.

"And by chance there came a certain priest that way: and when he saw him, he passed by on the other side. "And likewise a Levite, when he was at the place, came and looked on him, and passed by on the other side.

"But a certain Samaritan, as he journeyed, came where he was, and when he saw him, he had compassion on him. "And went to him, and bound up his wounds, pouring in oil and wine, and set him on his own beast, and brought him to an inn, and took care of him."

And thus from the Gospel comes the classic story of helping one's fellowman, immortalizing the Samaritan in the language as one ready and not afraid to help. And it is said that what we need in the world today is more Good Samaritans, and fewer who pass by on the other side and decline to become involved.

On the other hand, Luke's story was set a couple of thousand years ago. Civilization has come a long way since then, they keep telling us.

In this enlightened 20th Century, the story might have had another ending. Let's pick up Luke at the end of the fourth paragraph, and bring it up to date: ". . . He had seized the Samaritan as he bent over him, clobbered him with a tire iron, filched his wallet and fled, leaving the certain Samaritan for dead."

This is not heretical treatment of the Gospel, but realism - for such a fate has fallen a great many latter-day Samaritans, who, if they have survived, will next time maybe telephone the Highway Patrol from the next town, but wouldn't essay another roadside good deed if their life depended on it - and it probably does.

Time was when any traveler was glad to stop and offer a lift to a fellowman set afoot on the road; not to do so was unthinkable. Then hitchhiking was prostituted into nothing more than undersguised mooching, a sort of regard for free transportation as a right, another symptom of our times; but more sinisterly, too many Good Samaritans have picked up hikers and wound up with knives or guns in their ribs and set afoot themselves - ofttimes left for dead. The desire to help is still strong in modern man, but he has learned his lesson himself, the hard way, or learned it

from others. Like the recent case, where a neighbor intervened in a fight to protect a woman from her maniacally enraged husband. The husband attacked the neighbor, who fired a gun in self-defense. What happened next? The neighbor was convicted of manslaughter and sent to jail, and when he is out



A prominent Democrat, who is giving full support to Sen. George McGovern's candidacy, told me privately that a lot of his friends are not doing so. Their doubts, he added, go to the question of the senator's competence. It is not the first time I have encountered this response among liberal Democrats who ought to be allout for McGovern as "one of their own."

Two things bother them. First, they question the senator's grasp of the intricacies of economic and social matters. They think he was too flip and casual about going back to the old drawing board after his original tax reform and welfare proposals crashed in flames. They have something less than complete faith in his substitute proposals.

Second, they seriously suspect McGovern is accidentprone in his handling of people. From the moment the Democratic convention ended in Miami Beach July 14, he has been plagued by mishaps of one sort or another. His accident report includes:

The backing and filling begun that first day over the use of Lawrence O'Brien, the Eagleton affair, the absurd flap over Pierre Salinger's approach to the North Vietnamese in Paris, the staff chaos highlighted by O'Brien's late August blast, the resignation of New Jersey Rep. Frank Thompson as head of the registration drive, the departure of veteran top staff man Gordon Weil.

Some McGovern aides take the view that these things are "internal" matters which don't affect the voters' impression of McGovern. They would be less complacent if they had seen the damaging headline in the Chicago Daily News the day O'Brien struck hard at staff con-

The fact is, these foulups are so numerous they are perceived by most newsmen as a pattern, and they are being reported as such. Furthermore, whatever their impact upon voters generally, it is clear that many influential Democrats, who ought to be toiling enthusiastically for the ticket, are seriously disenchanted by the McGovern performance and are doing little or nothing. I'm talking here not about party regulars who never favored McGovern anyway, but about liberals who should

be his. Some supported Eugene McCarthy in 1968. Even if the broad range of voters is not troubled by McGovern's "boo-boo of the week" campaign management, there are unmistakable signs they are indeed upset by the senator's positions on the major issues. A new Harris poll summed it up with a finding that 55 per cent of voters agree with the statement Mc-Govern "wants to change things too much."

While the heated California primary campaign was at its height in late May, the senator's key advisers seemed to recognize the peril in this impression. They led newsmen to believe they were going to move strongly to correct it. But the Harris poll indicates the impression has deepened, by a factor of about 26 per cent since April.

McGovern is supposed, at the very minimum, to be the purest symbol of anti-Vietnam war sentiment. Yet here, too, he is in trouble. The poll shows that by a margin of more than three to one voters don't believe he can fulfill his pledge to get U.S. troops and prisoners out Vietnam 90 days after he occupies the White House. These doubts even grip his own supporters, by 52 per cent to 36.

So, at this stage, McGovern is being whipsawed. Voters have a damaging impression of him. And a good many of the influential Democrats who might help to change it actually think it is well founded and reflects a basic lack of good judgment on McGovern's part.

The military, in a rare burst of enlightenment, had decided that jobs like this were demoralizing, and began its "civilianization" program (sound familiar?) as part of its drive toward making the services more attractive for an all-volunteer force.

The Appropriations Committee, however, has decided that using civilians was costing too much money for too little results and that doing KP and scouring the general's lawn for cigarette butts do not detract from a serviceman's image.



### Pensacola Fish Kill Is Probed

PENSACOLA, Fla. (AP) -City officials have sealed off the entrance to Texar Bayou in an attempt to halt a massive fish kill in the polluted waterway.

An air curtain - a pipe with air holes - was strung across the entrance to the bayou Tuesday to prevent healthy fish from swimming into the area from Escambia Bay.

"Texar Bayou is just jammed with rotting f'sh," said an official. "The stench is awful."

The city has organized a special 30-man force to tour the banks of the bayou, scooping out the dead fish.



SAIGON (AP) - The North Vietnamese struck heavy, new blows at Quang Ngai province south of Da Nang today while more than 150 miles to the north President Nguyen Van Thieu visited recaptured Quang Tri City. He indicated a new northern push toward the demilitarized zone in the coming weeks

In the air war, the number of American planes downed over North Vietnam in the new 512 month bombing campaign hit the 100 mark, the U.S. Command announced. A Navy A7 Jet was shot down Tuesday by antiaircraft artillery fire. The pilot was recovered by a rescue helicopter in the Tonkin Gulf 40 miles northeast of Vinh.

The Command said Air Force, Navy and Marine fighter-bombers carried out more than 310 strikes across North Vietnam Tuesday, concentrating on bridges, highways, truck traffic, water craft and warehouses in a continuing





### THE BACKHAND SLICE

The backhand slice should be one of your most important strokes. You'll probably use it most in returning the serve, because it gives you more room for error than the flat or topspin service return. You'll also use the slice for your ground stroke and offensive and defensive lobs (shots hit high in the air). To hit a backhand slice, carry your racquet back to about shoulder level. From here move the racquet down and swing under and across the ball (figure 1). You will then swing out and finish up to the right, with the racquet face open (figure 2).


The league office denied Tuesday that Rozelle opposes instant replays on the giant television screens planned for new football stadiums.





# **Nicklaus Still Great But Myth Shattered**

prestige tournaments are hisbility has been shattered.

The Golden Bear's stature as one of golf's greatest performers, however, is no myth. It's just that too many experts, perhaps hopeful that Jack could grab all four major golf titles this year, went out on limbs and persuaded some nonexperts he could make it.

Nicklaus won the Masters and that was a start, but the experts still were cautious as the U.S. Open approached. Then Jack went out and conqured the treacherous winds and glasslike greens of Pebble Beach, Calif., to win that one.

It was then the prognosticators began their war chants. Many predicted that Nicklaus this year would achieve what no other golfer has been able to manage - titles in the Masters, the U.S. Open, the British Open and the U.S. PGA Champion-

They reasoned that while Lee Trevino was playing well again and winning money, he was not the Trevino of 1971 who captured three national championships in the space of a month the U.S., Canadian and British

That assessment held true through the U.S. Open. But at Muirfield on Scotland's Firth of Forth it was a different story. The stocky Mexican-American broke the Nicklaus spell over

the rest of the pro golfing corps by beating out Jack in the closing holes of the British Open's final round. He did it only with a miraculous string of birdies in the third round and a chip shot which dropped into the hole to save a par on the 17th hole of the final day.

Nicklaus played superb golf in that closeout round, pulling ahead of Trevino briefly at one point with a string of his own birds. But even Nicklaus' amazing concentration couldn't pull it off. And there went the myth and the British Open title to the talkative Trevino for the second straight

Some of the experts, like former golfing phenomenon Byron Nelson - who won 11 of 19 pro tour tournaments one year in the 1950s - and veteran Gene Littler, never had given Jack much chance of achieving the four-title Grand Slam.

There are just too many fine pros on the tour today, they easoned. On any day or in any four-day period, a dozen or more of them could catch fire and burn by Nicklaus. And so it



### - Gourmet Corner Jewish Cookery Wins Accolades

By TOM HOGE AP Newsfeatures Writer

Back in my bachelo days. I worked what news men called the "graveyard " that runs from midnight til 8 a.m. I had no kitchen at the time, so eating became a problem, especially on Sunday morning when most of New York's restaurant owners were still asleep

Then someone suggested that visit New York City's pre iominantly Jewish Lower East Side. Restaurants there did a flourishing business early Sunday, since their Sabbath fell the day before

I spent many Sunday mornings seeking out the fine Jewish restaurants in that part of Manhattan

It opened up a whole new area of food for me, from Kartoffel Latkes, the potato pancakes slathered with sour cream, to Goldene Yoich, the rich chicken broth

One thing that struck me was the tremendous variety of foods produced by these Kosher kitchens. Except for foods proscribed by Jewish dietary laws, the cooking is influenced by the countries from which the various Jews emigrated, and that includes a good part of the world

The Jews living in the United States, however, have come mostly from Eastern Europe and their cookery is heavily influenced by the recipes of presoviet Russia, the Balkans, Poland and Germany.

Thus you have the rich borscht-type soups inherited from the Russians, German dumplings or Kreplach and Cholent, a rich Sabbath dish from Poland which features beef brisket, potatoes and dried lima beans. Jewish cookery is closely

ked to their holy days and olidays, in accord with the pronouncement of the Talmud that "there is no festive celebration without eating and drinking

One of the finest breads have ever tasted is the challah. the twisted white loaf which is blessed by the master of the house on the Sabbath. And remember the festive cakes filled with poppy seeds, prunes and other fruits that were served by friends of mine on Purim, the Feast of Esther.

There are many main courses on the Jewish menu made from flesh, fish and fowl. One of the most satisfying is Cholent, and here is a recipe.

CHOLENT 2 onions, diced

4 carrots cut into 2-inch lengths 1 garlic clove 2 tablespoons vegetable short-

ening 1/2 lb dried lima bean soaked

overnight in cold water 1/2 cup barley 8 potatoes pared and quartered

2-pound brisket of beef in single piece 2 tablespoons flour

salt, pepper and paprika to Brown onions briefly in short-

ening in bottom of a large iron kettle with lid. Pour in carrots, garlic, lima beans, barley and potatoes. Place meat in center of this mixture. Mix flour and seasonings and sprinkle over other ingredients. Add boiling water to come close to top of pan. Cover and simmer very slowly. Use an asbestos pad over heat to keep from burning. Cook for 5 hours.

Makes six servings and is good with a robust Burgundy.

For centuries, the versatile bulb knewn as garlic perhaps has been used to flavor more types of food than any other seasoning.

Despite the potent aroma this member of the onion family gives off - by scientific estimate one millionth of an ounce can be detected by the human nostril - garlic is delicate if prepared properly.

In the Mediterranean area where garlic is used lavishly, cooks have discovered that crushing the bud reduces its potency. Boiling garlic also tames the scent. In fact kitchens in Provencal feature a soup composed of a couple of dozen garlic cloves, water and not much else.

In ancient times, garlic served as a food rather than a seasoning. Historians tell us the Egyptian slaves who built the Great Pyramid in the 5th century B.C., virtually lived on garlic and onions. And the Roman poet, Virgil, urged reapers to eat garlic to help them withstand the broiling sun as they toiled in the fields.

Garlic also was used for medicinal purposes in olden days. When one suffered from a toothache, a sliver of the bulb was placed in the cavity. 1 generally was believed in medieval times that garlic could cure dog bites, poison arrow wounds and the sting of a venomous snake.

One tends to link Italian food with the flavor of garlic and this is true of many dishes of that land, from the rich tomatoe sauces of southern Italy to the tangy dishes of Milan in the north. Good Italian cooks are careful not to over-season a dish or sauce with garlic, but there is usually enough of an aroma to make it clearly detectable

In Naples they serve a pasta flavored with garlic and olive oil, and in Piedmont restaurants feature a powerful sauce known as bagna cauda, or hot bath. Made from butter, anchovies, white truffles and garlic with olive oil, this authortative mixture is used as a hot dip for cold raw vegetables and makes a delicious antipasto.

In Milan, they have several garlic specialties that have ound their way to America. One is Osso Buco, which consists of veal shanks braised

with vegetables, white wine and tomatoes. Before being served. this pungent dish is garnished with a mixture of chopped raw garlic, lemon peel and parsley. One of the most delightful

garlic dishes for which Milan is noted is Vitelio Tonnato. It consists of sliced veal flavored with garlic, wine and herbs, served cold with a sprightly tunafish, anchovy and garlic sauce

Vitello Tonnato is a specialty of L'Aiglon, a restaurant in midtown New York. The owners picked up the recipe in a small trattoria in the Milan region, and adapted it for their cuisine

VITELLO TONNATO 1 five-pound veal roast, boned and tied







The course, according to Kelly Aide, board of trustees, exofficio, is ideal in that a course of study can be completed without interference with an individual's regular employment and at a considerably less cost in tuition than would be required in a residence program.

The method of instruction is a omplete theory being received by each student which can then e applied through internship programs. Since a single stulent-professor relationship exists, a student competes only with himself and progresses accordingly.

CREDITS ACCUMULATE

A minimum of 180 quarter hours with a 2.0 average on a 4.0 scale is required for all university work attempted for a bachelor's degree and a 2.25 average for all course work in the student's major field.
