Republican Candidate For Governor Forecasts His Election In Poll Next Month

Says State Costs Must Be Reduced

Rebukes Opponent For Playing Politics On Trip To Storm Area

Declaring that he is opposed by the professional politicians, that state newspapers are refusing to publish his speeches accurately, and that recently the use of courthouses for speech-making purposes had been denied him, William J. Howey, Republican candidate for governor, speaking last night in Sanford for the second time in four weeks, pointed to these reasons for the prediction of his election in November.

Opening his address, which was cut short because of a severe throat irritation, Mr. Howey referred to the fact that his first speech here, that he is running on a platform of efficiency and economy in state government. With scarcely more than a million and a half population, Florida paid last year for state expenses \$16,000,000, Mr. Howey said. Such a situation, he declared, cannot long exist, because it is not economically sound.

AL SMITH WILL START TOUR IN SOUTH MONDAY

Finishing With West Governor Plans To Carry His Campaign To Doubtful Border

Carolina Appears To Be Unfriendly

Nominee To Exert His Best Effort To Put State Back In Line

ALBANY, N. Y., Oct. 2.—(INS)—The new brown derby which Governor Al Smith brought to Rochester to replace the one he "waded" for a new dog in Milwaukee was paraded today on the familiar hall car of the executive mansion in Albany.

It will remain there until next Monday when, barring upsets by the national committee, the Democratic nominee will take to the road again—going this time into the border states that are considered doubtful, if not actually inimical to his candidacy. Governor Smith has finished with the West. He will leave Albany on Monday for the corn and wheat country during this campaign. The 6,000 mile trip which the Governor completed here last night, reflects the Smith bid for the electoral college, which he will take to the road again on Friday.

Although Governor Smith's itinerary is still in the process of formulation, it has been virtually determined that when he leaves Albany again next week it will be to go into the so-called border states, some of which he must carry in November if his candidacy is to be successful.

A tentative schedule has been arranged, which will take him to Baltimore, Raleigh, Charlotte, Norfolk, Louisville, Ky., Sedalia, Mo., possibly Indianapolis, and winding up in Chicago in Mid-October. Several other points are under consideration, particularly in Ohio on the same trip.

The ultimate decision will be made by Governor Smith himself sometime during the present week. He is running his own campaign, and is not bound by the approval of the national committee. (Continued on Page Four)

CARNES, UNDER GUARD, BEGINS TRIP TO DIXIE

Abandoning Treasurer Shuns Crowd As He Boards Train Which Will Take Him South

Appears Worried About His Family

Refuses To Discuss His Affairs And Begs To Be Spared Questions

WINNIPEG, Man., Oct. 2.—(INS)—Clinton S. Carnes, abandoning treasurer of the Southern Baptist Home Mission Board, started back to Atlanta Monday morning on a special train, escorted by a posse of police and a deputy sheriff. He refused to pay his own way, Assistant Solicitor General John Hudson refused the offer.

Carnes, toppled from his position in the community as a churchman, business leader and club man, shrank nervously from the public gaze as he got on the train. Deputy Sheriff R. L. Tolbert had the celebrated prisoner handcuffed. The officer was taking no chances.

Charles Evans Hughes, standard-bearer in 1916, will share the spotlight with Hoover at the nominee's personal invitation. Both Hoover and Hughes will address the gathering in Madison Square Garden and a national hookup of broadcasting stations will carry their speeches to every corner of the country. Under the plans which met Hoover's approval, the rally will be one of the greatest political gatherings ever held in America.

Albert Ottinger, Republican nominee for governor, and former Ambassador to Albania, Hugh Hooton, the party choice for the Senate, will speak from the same platform with Hoover and Hughes, under present plans. An effort is being made to get Ellis Root, the "grand old man" of the Republican Party to preside at the meeting, or at least participate in it. R. H. Edmund MacFaid, state chairman, probably will introduce Hoover.

The Republican nominee will remain in New York City over night in order to confer with the state and county leaders the next morning. He will return to Washington after these conferences. So much importance is attached to this rally by the Hoover strategists that the national radio hookup will be employed for two hours during the evening, making it the greatest use of the radio by the Republican since Hoover's acceptance speech in Boston.
