"That kind of evidence comes from the Semihole County Chamber of Commerce which, in its organ, 'Good News,' prints 38 items of progress towards prosperity in that county." Continuing the Tampa newspaper quotes some of the more convincing items: "Ten tons of seed sold by a San-ford seed company to the Reconstruction Finance Cor-poration; 2.400,000 cans of grapefruit hearts and juice put up this season, with a total payroll of \$50,000; two San-ford stores lead the state in percentage of sales increase for six months; new boat launched for St. Johns River trade; pretzel factory opened by Pennsylvania bakers; diorama studio which has made 65 dioramas for one cus-tomer."

Then the Tribune goes on to say: "And, as a most ex-ceptional achievement, Sanford's municipal government has established an operating cost of 1.8 cents per capita, while Seminole County maintained its schools for the full term and does not have a dollar of bond principal or interest in




