Longwood To Pay For Drain Woe

By DONNA ESTES Herald Staff Writer LONGWOOD—The most feasible solution to South Island Lake flooding is to reopen drainage pipes under SR 434 and rework the Winsor Manor drainage system to permit overflow to follow its natural course northward, County Engineer Bill Bush told city officials this week.
The county and lakefront property owners have threatened legal action against the city, claiming the city's approval of the Winsor Manor subdivision, north of SR 434, with its raised elevations and drainage system, is the major cause of flooding.

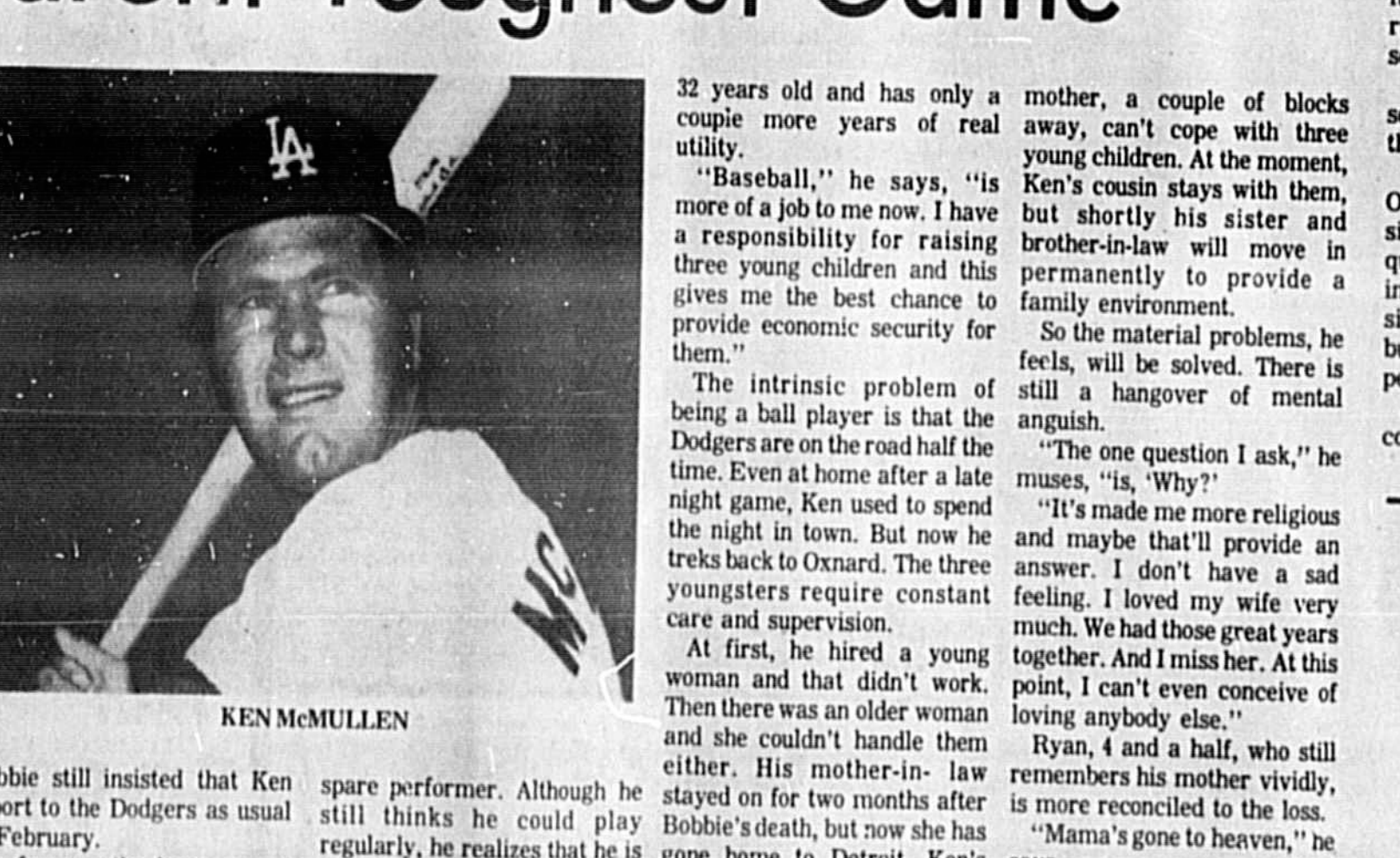

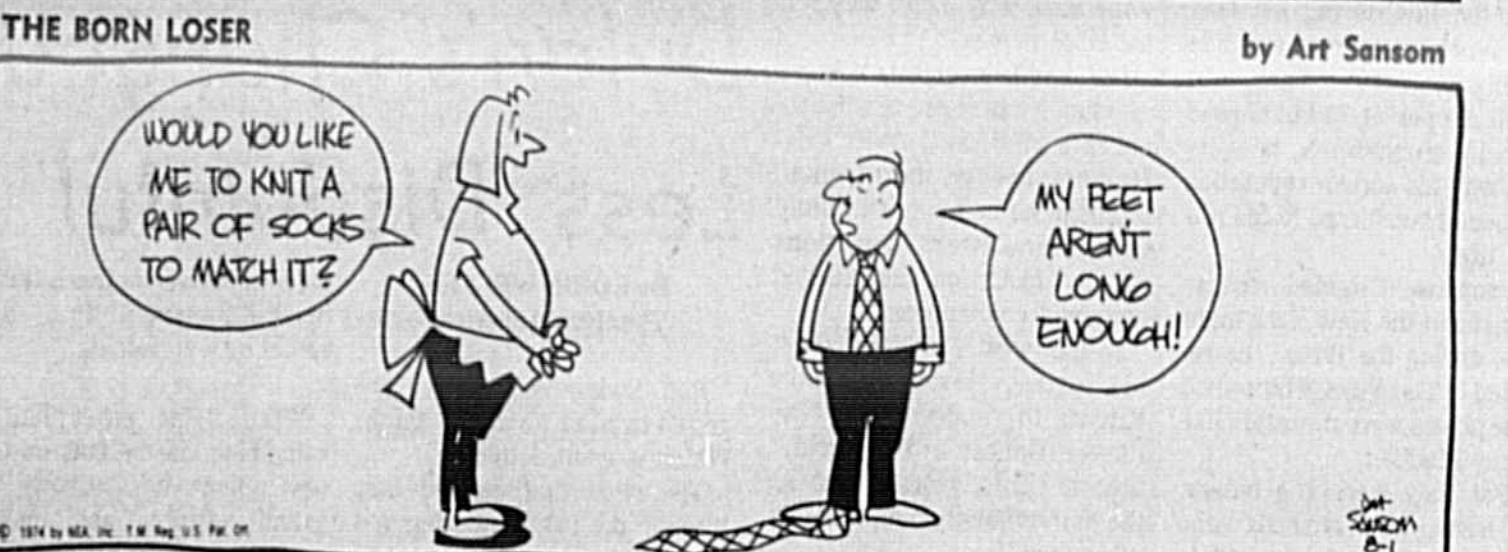
