

### Pick The Winner Fans Lose Out In Gridiron Upsets

### Tried Only Nine Made The Correct Forecast Saturday

Army upset Notre Dame by a 14-10 score; Duke topped North Carolina; Rose Bowl chances and the aftermath of Purdue once again hit their stride in the Iowa game Saturday. The Herald-Mirror picked the winner fans lost heavily by these unexpected reversals of "underdog" teams and consequently only nine out of 1000 passed to Wednesday's sports.

Winners of two-tickets each were: A. C. Maddox, bid; Mrs. Nellie Moseback, Berwick; Anna Cornell, F. A. Palmer; Caroline Palmer, Mrs. I. H. Hedges, and H. D. Lagona.

Most of the contestants lost because of the Army-Notre Dame game. Thirty-three were eliminated because of this contest. Only seven Iowa threw out the team, but even though the victory was considered one of the major upsets in the nation only five fans lost on account of this game. Apparently, they were afraid of the possibilities of Duke and therefore chose other teams instead.

One fan picked St. Mary's to win from Santa Clara. This game was played on Sunday and therefore had to be eliminated. The rules of the contest say that games must be played on Saturday. This rule was included because sometimes on Monday games are not heard by "short" radio and therefore "delays" the announcement of winners.

Several other fans picked Mississippi State to beat Mississippi State did win. The game was played on Friday night and these scores were: 14-0.

To H. D. Lagona goes the unofficial title of champion of the pick-the-winners so far this season. Since the beginning of this contest Mr. Lagona has turned in perfect scores with the exception of one time, when no one else won. He picked Notre Dame to win from Northwestern and like all others guessed wrong.

Another interesting feature of the week's results was the fact that out of the nine winners only two were among the first 10 admitted. The other winners were: Burned in at The Herald in the following order: Nos. 19, 42, 71, and 82.

Fans have until Saturday noon each week to submit their selections and it is pointed out that the most important thing about the contest is first to make sure the game is a "sure winner."

### Conservation Of Wild Life Urged By Game Warden

In the shooting of ducks this season is made to Seminole County sportsmen today by Game Warden, Claude Howard. Due not only to hunting but to several seasons unfavorable to breeding, from the drought and drainage in the northern summer homes of the ducks, the number of ducks has decreased to a critical point. Where there were ten ducks a few years ago, there is but one today. If every duck hunter were to take his bag limit each day from the opening of season, the duck season would last about four days instead of thirty, for at the end of the first four days the ducks would be completely exterminated. This statement is based on actual duck population counts made by several hundred experienced observers last season.

True sportsmen who wish to see the ducks have a chance to multiply next summer, now that normal rains are bringing back the water to their northern haunts, will restrict their kill to the lowest possible limit this fall, instead of even trying to get what the law allows. A number of local hunters have already expressed their feeling in the matter by saying that they will not hunt ducks at all this fall. Anyone who has observed the rapid decline of ducks on the Lake Jessup marshes the past three seasons will agree that there are mighty few ducks to be found and that these should be preserved for seed stock if we are to have any hunting in future seasons.

Mr. Howard also calls attention to the following restrictions that have been adopted this year in an endeavor to help save the remaining birds:

The duck, Wilson's Snipe and Coot, season opens Nov. 20 and closes Dec. 19. This is a federal regulation and must be followed by the state. Hunting is permitted only between the hours of 7 A. M. and 4 P. M. The following may not be taken at any time: Snow Goose, Ross's Goose, Wood Duck, Buffhead Duck, Wood Duck, and Swans. Hunters who do not recognize these birds should get acquainted with them in order to avoid killing protected birds. The penalty for violation of this or any other federal regulation dealing with migratory birds is \$500 or six months in jail or both.

No shotguns of larger than ten gauge may be used, shot from the shoulder only, and gun may not hold more than three shells. Repeating shotguns must have chambers plugged to reduce their capacity to three shells.

No live decoys are permitted. Baiting is also not permitted regardless of the reason for putting out the bait.

The above birds may be hunted on land or water, but may not be hunted on the water more than 100 feet from the shore line. They may also not be hunted with the aid of auto, airplane, glinbox, powerboat, sailboat, or boat in tow of sailboat or powerboat. Powerboats or sailboats may also not be used to stir up the birds.

Bag and possession limits are: Geese and Brant, 4; Ducks, 10; Coot, 15; Wilson's Snipe, 15.

Hunters will kindly note that balls are permitted to be hunted on salt water marshes and are therefore not to be taken in Sem-

### Citrus Group Wants Federal Agreement

ORLANDO, Nov. 18. —(AP)—Directors of Tree-Gold Cooperative Growers adopted a resolution for a federal marketing agreement for the Florida citrus industry "to insure growers adequate returns for their fruit."

A copy of the resolution was sent to Secretary of Agriculture Wallace.

"This board of directors believes that no program relating to the grading, merchandising and advertising of Florida citrus fruits can be of maximum benefit to Florida citrus growers unless the industry is regulated so as to prevent haphazard and indiscriminate shipments," said the resolution, "and that no method of providing such regulation can be effective without the co-operation and assistance of the federal government."

Chinese officials at Peiping said today they had agreed to autonomy of North China because of fear of the Japanese army. Five provinces flanking up the area will receive financial and economic independence from the republic, although still acknowledging nominal sovereignty of the national government.

Chinese sources said that Major General Koshiro of the Japanese army had presented ultimatum to China demanding action on the autonomy plan by noon tomorrow. From Tokyo came word that the new state will operate under Japanese control, with Japanese commissars, both civil and military, "directing" the new government.

The new state will be governed by the "autonomous council of the Republic of China," Hsiao Chang-Ying, governor of Chahar, said today.

General Sung Choh-Yung, commander of the Peiping Tientsin military area, may be chairman of the council. He formerly was governor of Chahar but was ousted under Japanese pressure when he became commander of the garrison here he made friends with the Japanese and since then has been one of the most important pro-Japanese leaders in the north.

The new regime will be completely independent in civil, military and financial affairs. Chinese officials now in office probably will be retained for the time being.

A majority of Chinese appeared to favor the movement and many of them vociferously were in favor of it because of their opposition to Nanking financial policy and the tax situation.

### Cotton Production Control Act Will Get In Test Court

WASHINGTON, Nov. 19.—(AP)—Over the protest of the government, the Supreme Court yesterday agreed to let Governor Eugene Talmadge of Georgia file a suit attacking constitutionality of the Bankhead cotton production control act.

Talmadge has been a frequent critic of the Administration.

This was the first request received by the high tribunal from a state seeking to start original action in the Supreme Court against New Deal legislation.

Usually cases are started in lower courts and brought here on appeal.

The high court already had agreed to review a case brought by Lee Martin of Texas, planter, which attacked the Bankhead act.

But some attorneys contended it could be decided without passing on the validity of the act itself.

Most sought to compel the Government to show that it had complied with the act. His petition was dismissed by lower courts. Arguments will be heard here in December with government attorneys participating.

Talmadge contended the legislation was "unconstitutional" was rendering the state's cotton lands "unprofitable" worthless. It operates two prison farms in which cotton is grown.

Georgia's petition, which asked that the act be declared unconstitutional and that Secretary McLaughlin and other federal officials be enjoined from collecting the tax imposed on cotton produced in excess of a fixed quota, had been opposed by Stanley Reed, the solicitor general.

### Gut Answers Queries About Age Long Past

Following his address on the glacial age delivered in the East, Congressional Church Sunday night, James Gut told an interested audience he would be glad to answer questions. The address was about 20 minutes long but the questions kept the archeologist on the platform for an hour. It was reported by the Rev. J. B. Root, pastor of the church.

Asked how he could be sure bones found in the St. Johns and Wekiva Rivers and Lake Monroe in Seminole County were those of a certain animal, Mr. Gut answered by asking, "How do you know whether you are cutting celery or cabbage?" Another querulous person wanted to know how it was that bones of wolves requiring a cold climate and of mastodons that inhabited tropical climates were both found in this section. This was easily answered by Mr. Gut who explained that the coming of the glacial ages ago caused marked changes in the climate, and that some of the bones found might have been in the ground from 60,000 to 200,000 years.

Mr. Gut told the audience that in ages past there lived in Central Florida such animals as the mammoth, mastodon, sabre-toothed tiger, three-toed horse, lions as big as the African lions of today and ground sloths.

## Son-In-Law Of Mussolini Is Brought Down

### Ethiopian Fire Hits Plane Being Flown By Count Ciano In Battle Near Makale

### Selassie Leaves His Capital City

### Takes Airplane, But Ultimate Destination Is Not Known

By The Associated Press. Emperor Haile Selassie left Addis Ababa today by airplane for an unannounced destination. He travelled in a twin-motored plane, the empress and two princesses seeing him off.

The application of sanctions against Italy by 51 nations of the world in accordance with the League of Nations' action was the signal for an Italian aerial attack on Ethiopia which Haile said resulted in 2000 deaths among native warriors.

A squadron of 20 planes, led by Haile's son-in-law, Count Galeazzo Ciano, engaged in a pitched battle with the army of Emperor Selassie south of Makale.

Emperor Selassie's aircraft fired on the machine gun and bomb attack from above and succeeded in bringing down the plane of Ciano who escaped unhurt. Before landing his disabled plane Ciano directed a double attack which Italian authorities said led to the dispersal of 16,000 Ethiopian troops and gave the Fascists one of their most important victories of the conflict.

Mussolini's two sons, Bruno and Vittorio, took part in the attack. Emperor Selassie expressed doubts as to the efficacy of sanctions. He said that while grateful for the imposition of sanctions, he felt hostilities never would have begun if such measures were of force to prevent war. He is more optimistic about the position of his troops in the fight against the Ethiopians but has not yet met defeat and has not yet called their full strength against the invaders.

Whether the emperor flew to join the army, as he had said he would do, was not known.

Armistice Day celebration in their town.

In his address to the veterans State Commander Hopper of the V. F. W., himself a Legionnaire, and former district manager of the Legion, expressed confidence that more would be accomplished by the veterans' groups in forgetting differences "as we are all working for the same purpose, for justice to the veterans, especially the disabled, and to instill in the hearts of the people principles of peace and security."

Veterans of 1898 were "ticked from pillar to post," he said, because they had no voting strength, and then the "damnable economic act" took from them what they had until the larger veterans organizations got together and demanded that they be given justice.

"Those who decide to have a war are always beyond the means of making a profit out of war," he said, but the V. F. W. stands with the Legion in the contention that both capital and industry should be drafted in the event of another war.

"There is a comradeship here in this group tonight that you won't find up town tomorrow," he said. "There is something about service under the flag that makes

for friendship, that instills that feeling of love, or our fellow men that the Nazarene taught, a feeling we found in the sacrifices we made in the service.

Holding in his hands the old Springfield a General left on his locomotive 37 years ago, Mr. Shelley told some of his experiences in transporting soldiers to the Port of Tampa during the war of '98 and said he wanted the Legion to have the old rifle because "you in the American Legion have done your part."

"I hope you will maintain and perpetuate this organization to which you have the honor to belong," said Mr. Shelley. "You earned that honor, honesty, and every one who served in the war should feel it an honor to belong to this organization. Then referring to communism he declared that "it is up to you to watch this thing, to fight against the element that is trying to overthrow our government, and you can do it, because you have been tried and not found wanting."

The speaking came after the 100 veterans had started away 20 gallons of stew, 15 gallons of coffee, and quantities of fry bread, pickles and beer. After the meeting Hayward Walker, past commander of the local post, showed a picture of a hundred feet of million pictures he took of Sanford Legionnaires and their old engine in the Armistice Day parade.
