

Thieves steal museum artifacts

Loss includes 300 arrowheads that were 700 to 6,000 years old

SANFORD — The Native American spear-point collection, was stolen from the Museum of Seminole County History this weekend.

Most of the 300 arrowheads and spear-points ranged from 700- to 6,000-years-old. They date to an era before the Seminole Indians settled along the shores of Lake Monroe.

A staple of the museum for 10 years, the spear-points were found missing by a janitor at 4:15 p.m. Saturday. The museum, located at 300 Bush Boulevard in Sanford across from Flea World, had

closed the previous day at 4 p.m. Staff left the museum at 5 p.m.

Some time during the intervening 24 hours, thieves smashed through a front window with rocks found outside the museum, then shattered the thick glass of a pair of octagon-shaped display cases with rocks and stole the collection, said Museum Specialist Karen Jacobs.

"I am just sick," Jacobs said. "I'm sick for the kids. The small children just loved to look at the arrowheads, and now they can't. It's very disheartening."

Investigators are searching for those responsible for stealing the artifacts, said Sanford Police spokeswoman Cleo

Greyhound Fundays provide a chance to give a dog a home

CASSELBERRY — More than 100 canines are expected to converge in the Seminole Greyhound Park this weekend for the eighth semi-annual Greyhound Fundays.

Starting Saturday, greyhounds, their families and curious spectators are invited to participate in numerous events throughout the day, including costume contests, a wet T-shirt contest, bobbing for weenies and a biscuit eating contest. All the events are geared for the four-legged canines and their owners.

"We are going to have a lot of entertainment," said Stephen French, one of the organizers of the event. "There is going to be a lot of fun stuff to watch, even if you don't own a greyhound."

"And, once people meet the greyhounds, they will see what kind of dogs they really are."

The event is sponsored by Greyhound Pets of America / Greater Orlando, a non-profit organization. The group's mission is to help find homes for retired greyhounds.

One of the highlights of the event is the chance to adopt one of the 100 greyhounds ready to find a new home.

"We will actually have

between 80 to 100 greyhounds available for adoption," French said. "We are hoping for a really big turnout."

There is a \$185 fee to adopt one of the greyhounds, which covers emergency medical costs and other expenses incurred while taking care of the dog. According to French, it actually costs about \$350 to take care of a dog before it is adopted.

People concerned about adopting a racing dog don't need to worry about the greyhound's character. They do not go right from the track to their new owner's home.

Maloy first to qualify for county race

Van Der Weide's \$81,675 tops war chests for commission race

SANFORD — Three county commissioners have collected nearly \$200,000 in contributions as they seek re-election in 2000.

District 3 Commissioner Dick Van Der Weide, seeking a third term, has collected the most — \$81,675. After expenses, Van Der

Weide still has more than \$67,000 to spend — more than any other candidate has collected.

As required by the Florida Department of State, Division of Elections each candidate files a campaign treasurer's report each quarter. The first reports of 2000 were due this week. Incumbents Van Der Weide, Grant Maloy and Daryl McLain led the charts.

Supervisor of Elections Sandy Goard notified Maloy that he was the first in the commission race to officially qualify, having collected 1,995 alternative method petitions for placement of his name on the ballot.

Florida Statutes required Maloy, as well as all other commission candidates, to collect 1,862 valid signatures.

Van Der Weide reported \$81,675 in total monetary contributions, and having \$13,705.25 in expenditures. His opponent in District 3, former Altamonte Springs Mayor Dudley Bates, reported \$16,665 in contributions and \$2,413.61 in expenses.

Maloy, seeking a second term for District 1, collected \$63,647, spending \$11,640.52. He has far more in his war chest than opponents Tom Hagood who has collected \$10,660 and spent

Police plan to dupe crooks with decoys

SANFORD — Thieves who think they are getting away with taking an unattended car may be in for a surprise.

The Sanford Police Department is starting a program of placing decoy bicycles, cars, lawn mowers, and other items in the open to be stolen. Then, when someone does steal the decoys, police will be hiding to make an arrest.

"We want people to think twice before they steal things in this city," said Sanford Police Chief Brian Tooley. "If you do steal something, the police might be there waiting for you."

The Sanford City Commission was briefed on the new program this week.

The decoy program is just one of many ways in which the Sanford police are cracking

down on crime in the city, Tooley said. Police will also be using the department's speeding trailer in covert mode, hidden behind shrubbery or signs, to survey areas with speeding problems in preparation for a crack down on speeders.

The same speeding trailers are also commonly used in "covert mode," with radar tracking the speed of approaching vehicles and posting the speed as vehicles pass.

"We're making a commitment to cracking down on speeding," Tooley said.

In addition to speeding and vehicle theft, a common complaint among many Sanford residents is that some cars play their radios too loud. The city has a noise ordinance which allows police to issue a \$90 citation if the radios can be heard

Why 'Fail Safe' was hardly a failure

"Fail Safe" was the best television show I've seen in 50 years. Silly me, I kept adjusting with the color switch.

If it wasn't for the commercial breaks, I'd have thought we really were nuking Russia.

And, how did they ever get a soldier boy uniform big enough for Brian Dennehy, anyway?

Redoing the 1964 movie classic "Fail-Safe" was actor/director George Clooney's brainchild. Clooney, who is 38, wasn't alive when live TV was the deal. He was three when "Fail-Safe" the first was made. Henry Ford was the president in that one — "Jaws" guy Richard Dreyfuss drew the role in Sunday's TV remake.

For those of us who grew up on live, black-and-white TV,

"Fail Safe" was deja vu all over again — only better.

I liked it when television was a novelty, when only one home in a dozen had a set. I used to skip over to my uncle's house. He was the one in a dozen in our neighborhood with a TV. We'd sit before the set, thrilled to see John Cameron Swayze doing the news. Even better, a Captain Video serial.

One dramatic presentation that sticks out in my memory — I believe it was live — was "Bang the Drum Slowly." Paul Newman was in the black and white TV original. There were other live dramas, most of them of very high quality.

As TV became not only a segment — but the focus — of many homes, what it gained in technological breakthroughs it

seemed to have sacrificed a great deal of the early drama and quality. There seemed to be more when there was less as there is less today when there is more.

If George Clooney failed in his "Fail Safe" effort, he did so for a worthy cause. America could use more thought provoking live TV drama and much less Stern/Springer/Sajak. Most of what's on TV today would have killed early TV. We were smarter then.

My suggestion to the people who run the Seminole County's SGTV is to consider televising live some of the wonderful plays and musicals produced by the county's seven high schools, by Seminole Community College and the University of Central Florida.

Live TV has a place for grand theater. Do we?

Pain-free Martin relishes latest win

Eight Winston Cup races, eight winners. Not bad. So whose turn will it be next Sunday when NASCAR goes to Talladega, where anything goes and usually does?

"Eight different winners? That's cool," Mark Martin said after becoming No. 8 with his where-hid-he-come-from victory in the Goody's 500. "Somebody will get on a hot streak, and that will change."

Just after his 1999 postseason back surgery, Martin vowed that this season would be different, that, now out of pain, he would be a happier, freer Mark Martin, enjoying this life he has made for himself on the Winston Cup tour.

During the past few years, Martin, a weight pumping, intensely focused racer, has suffered stoically through raging back pain, never complaining, although the mental effects were obvious in his frequently brusque manner, even when he had won.

In the first few days of this season, Martin indeed appeared happy, only to lapse into morosity as the weeks dragged on.

So it was delightful to see the new "old" Mark

Martin bounding out of his car after Sunday's victory here, throwing out quips like he used to. And it's not only Martin who has a happier face. It's also Jack Roush, his boss.

"Mark has had a great attitude all year," Roush said. "He's been fun to be with in the truck. He's joking with the guys. He's had more patience." As has Roush.

Sunday's race was Rusty Wallace's, almost all the way. He had the best car, although

on a more uneventful afternoon he might have had some closer challengers — Dale Earnhardt, Ricky Rudd and Tony Stewart among them.

But it wasn't an uneventful day. Earnhardt pounded his way home to ninth, just ahead of the stunned Wallace, and then pronounced his fellow drivers "jerks" for the 17 cautions, which could have been 19 or 20 if NASCAR officials hadn't been so merciful at the end.

With all those yellow flags, it was impossible for any crew chief to make all the right calls. The leaders were most vulnerable, because their rivals had plenty to gain and nothing to lose by gambling. So Wallace and Robin Pemberton could only bite their tongues when their by-the-book calls left them stuck way back in traffic down the stretch, while the more opportunistic, such as Martin and teammate Jeff Burton and hot-driving Michael Waltrip, wound up in front. "I thought Rusty was the man all day, and that there at the end he'd just bounce back up there," Martin said. "So we stole it. I'll take it."

"This is a little like blackjack," Roush said of the crew chiefs' game on pit road here. "If you've got 14 and see the dealer with 16 and you know he's going to take a hit, you sit on 14."


Martin said, "When you're not running that great, and you don't really have a chance, it's a lot easier to take chances and gambles. When you're a consistent, man, you've got to hedge your bet. You've really got to make sure you do the right thing."

"We had 16 or 17 cars on the lead lap, and I was about halfway to the back of that line, and I wasn't going forward. So why not? I had to believe they were all going to stop before the end of the race, so we just stopped and got our stop done first. It was just a matter of chance ... and brilliance on Jim Ferris's part."

Lucky? Or smart?

"The luck we had wasn't bad. But we didn't need good luck to win," Roush said. "Either with cautions or without cautions [over the final 100 laps], we were going to be fine, as long as we didn't get caught up in somebody else's wreck. It all played as we hoped it would. If they [Wallace and company] had closed up on us, either we would have better tires or we would have better track position, and either one would have given us a good shot to win the race."

Winless Michael Waltrip likes his chances at Talladega

Michael Waltrip slumped in his chair in the media center, looking at his hands while he talked about his latest race. Still in his driver's uniform, and still sweating, he pensively looked around.

He'd just finished third, his best showing since 1995. But he wasn't celebrating.

Unlike winner Mark Martin and second-place finisher Jeff Burton, he found no humor in his sudden appearance at the front after pit sequences and crashes caused the leaders to start in the middle of the pack.

Waltrip just hung his head, apologizing.

On the final restart of the Goody's 500 at Martinsville Speedway on Sunday, Waltrip tagged John Andretti, then running third, spun him out of position.

It took all the fun out of what had been a stellar day for a struggling team.

"I wish I could be smiling and laughing about committing a felony like Jeff Burton did," said Waltrip, referring to Burton's comment that his second-place finish was "a borderline felony."

"Obviously, we didn't have a third-place car. We were good all day, but we got more than we deserved. I just wish I could have finished fourth and John could have finished third. I hadn't touched anybody all day long."

Waltrip understood what Andretti had been through in the 500-lap slugfest.

"A guy that had done the same thing I'd done, fought and battled all day long, to get bumped at the end and I took it away from him," Waltrip said.

"That hurt my heart, and I hate that. I'd rather never win a race than to do that because I know what it's like to lose and have somebody take it away from you. I feel like I took something away from John. It was certainly unintentional."

Waltrip lost all the joy his performance could have created. For him, it was just the latest in a series of disappointments.

Personable and talented, Waltrip remains one of those mysteries in Winston Cup racing: someone who has run well but hasn't won a points race.

Waltrip has the skill and ability and is respected by his competitors, so his lack of a victory mystifies his team. Now, in his second year with owner Jim Mattel, Waltrip finds himself wondering about his future.

He's one of the favorites heading into this weekend's race at Talladega, but Mattel has been difficult to find at the track, and even Waltrip is wondering whether the team is, indeed, for sale. And then there's that lack of a win hanging over his head.

It's been a long wait. Waltrip has run 436 Winston Cup points races. He has finished second, led laps,

been on the verge of winning when his engine failed. Victory lane is unknown territory.

This was supposed to be the year all of that changed.

"We've had eight races now, and something has gone wrong in six of them," Waltrip said. "We finished 11th at Bristol and third today. We feel like we're a better team than where we are right now. They say you've got to run in the top five before you can win one. I'll go to Talladega and be a factor in who wins that race. I can tell you that."

Waltrip is smooth on the track, understands racing and can see problems unfolding and avoid the crashes. Maybe it sounds like an excuse to say he hasn't run with the right equipment, hasn't found that magical combination of team and car and driver needed to turn those top-five finishes into wins.

He doesn't resort to excuses or explanations. But others do.

"The only reason Michael Waltrip hasn't won a race before in Winston Cup is because he hasn't sat in something that could win, or when he did, something happened," Burton said. "It doesn't surprise me [that he finished third] at all ... You've just gotta sit in good stuff and everything's gotta work your way."

This weekend gives the team one of its best shots. Waltrip is outstanding at Talladega. He showcases his skills on restrictor-plate tracks, where the engine power is harnessed by a plate that limits air flow.

In the past five restrictor-plate races, Waltrip either has led laps and then been sidelined with problems or has finished in the top five.

This weekend, he has a chance. And he knows it. "My confidence level was already high going into Talladega," he said.

"If you can remember going back to last fall, with 30 laps to go, I was leading the race when my engine broke. We tested over there the other day and we had a fast car. We've proved over and over again we know how to get to the front in these restrictor-plate races. ... I'm excited about the car we're taking down there."

He's enthusiastic and optimistic — but unwilling to continue down his current path. He entered this season intent on improving. He won't settle for less.

"I really like my team," Waltrip said. "We're going to stay together for the rest of this year, and I have no intentions of driving that car in 2001 if we don't perform to the level that I expect us to."

"Last year, quite frankly, was a disaster and disappointment. I started this year looking like I had one year to get back up to where I'd been in my whole career, into the top 20, and hopefully to the top 10 and contend for wins."

Oviedo clinches top seed for 6A-3 tourney

DeLAND - Blaine Schulte's two-run single, Larry Grayson's two-run home run, and Jered Goodwin's seven-hit complete game helped the Oviedo Lions defeat the DeLand Bulldogs, 6-1, at DeLand High School's Bulldog Field Wednesday afternoon.

With the win, the Lions (21-3 overall and 6-1 in 6A-District 3 play) clinch the top seed in the district tournament in two weeks.

Oviedo (which hosts Winter Springs in its final district game this coming Friday night) and Lake Mary (which had a 5-2 district record heading into its game with Winter Springs Wednesday night) could still finish in a tie with 6-2 district marks if Lake Mary was to beat Winter Springs and Winter Springs defeated Oviedo.

Since the Lions swept their two-game series with Lake Brantley while Lake Mary split its two games with the Patriots, Oviedo would receive the top seed.

"That's nice, but we need to keep playing well and stay on a roll into the district tournament," said Oviedo head coach Harold Hill. "We have to keep playing hard and taking care of business. Any of the other teams in this district is capable of knocking you off if you make the mistake of looking past them."

On Wednesday, Schulte staked Goodwin and the Lions to a 2-0 lead when he hit the first pitch he saw in the top of the first inning to drive in Nick Tenekedes and Grayson. Tenekedes had reached base on a fielder's choice and moved to third on Grayson's single. Grayson taking second on the throw.

Oviedo added two runs in the sixth when Kenny Starling scored from third on a throwing error by the DeLand catcher and Paul Lubrano rode home on Nate Green's single. Both Starling and Lubrano singled their way on base.

In the top of the seventh, Tenekedes made his way on base when his ground ball to first base was misplayed. Grayson came up, worked the count to 3-0, then crushed a fastball over the left-center field fence.

DeLand's only run came in the bottom of the sixth when Craig Candeto led off with a single, stole second, and scored on Dan Swartz' second double of the game.




