Church Groups Recently Find Pressing Need

A demanding need was uncovered recently when local church groups, visiting the Mount Dora Orphan Home to deliver Christmas gifts, found children without shoes, beds for girls, and space to house boys.

The Children and Youth Division of the First Methodist Church of Sanford, accompanied by Mr. and Mrs. Roy Wall, S. Rector, pastor of the Sanford Memorial Methodist Church, and Robert M. Baker, a ministerial student, visited the orphan home to take gifts which turned out to be the only Christmas gifts the children would receive.

"They found that there were five more boys in the home than space was available. They were being housed in a building hardly decent enough for occupancy," it was stated.

"There are 23 boys in the home and 20 girls, all from broken homes and ranging in age from three to 16.

"The group visiting the home found that there was no recreational equipment at all through lack of funds.

"The most crying need, uncovered by the visit, was for shoes. All of the boys need shoes, some of them are without shoes altogether and must go about barefooted. Some of the girls need shoes for winter protection.

"Double decker bunks are being needed for the girls. The space available for them but they are lacking beds in which to sleep," Baker related.

The Mount Dora Orphan Home, an interdenominational institution for the care of orphan children of the Christian Church, they are operating on an approximate \$20,000 yearly income which is received mostly through contributions.

Medicine, hospitalization, eye care and other such necessities are being furnished through the generosity of physicians and civic clubs of Mount Dora.

Only nine people are employed to operate the home and each one receives only \$18 per month as salary and with room and board furnished to the home here from contributions.

Local citizens who would like to contribute to the home are asked to contact Mr. and Mrs. Roy Wall.

Lester Tharp Tells Of Retirement Here Following 31 Years

Letters Damaged In Plane Crash Received In City

Western Union Post Left Many Experiences Told By Manager

Sanford, Fla., Dec. 29.—Lester Tharp, manager of the Western Union Telegraph office here, today told of his 31-year career in the service of the company, and of his retirement here following 31 years of service.

Tharp came to Sanford from Lexington, Ky., in May 1902 in an emergency capacity for Western Union but that the same day he was still widely used. Tharp recalls that 31 years ago only two telegrams could be handled simultaneously over one wire while today, Western Union carries hundreds of messages on a single circuit.

Tharp is a member of the First Christian Church where he is an officer. He is a past president of the Kiwanis Club of which he has been a member for over 25 years.

Among the many messages of congratulations on the completion of his 31-year career, Tharp received one from G. P. Osborne, District Superintendent for the Western Union Telegraph Company, Inc., who congratulated Tharp on his 31 years of service and wished him well in his retirement.

Tharp also worked as telegrapher in many major league baseball parks, race tracks and during many other special events including several presidential campaigns.

The retired Western Union Manager's profound interest in baseball and other sports events is keenly shown now by his versatility in reporting news occasions by wire.

With the advent of the automatic telegraph, Tharp saw the passing of the Morse operator in his specialized field and returned to Western Union as a manager. He began his telegraphic career as a messenger in Mt. Sterling, Ky., Feb. 1, 1904.

When Tharp began as a messenger for Western Union the typewriter had just come into use among telegraphers, the pointed top was still widely used. Tharp recalls that 31 years ago only two telegrams could be handled simultaneously over one wire while today, Western Union carries hundreds of messages on a single circuit.

Savings Account Holders To Receive Year End Dividends

Holders of savings accounts at the First Federal Savings and Loan Association will find their balances increased by a total of \$24,000 in dividends that are now being added for the six-month period from July 1 to Dec. 31, according to George Toubey, Executive Vice President.

"This figure represents an increase of 2.5 per cent over the similar six-month period of last year," he said.

"The dividends are being paid out at three per cent a year added to the payment on June 30 total over \$12,000 last year accounts during the current year.

Unconscious Man Found On Roadside With Nail Wounds

PALATKA (AP)—Officers today sought to solve the strange case of an unconscious man who was found on a Palatka county roadside with nail wounds and burns on his stomach.

Highway Trooper H. L. Siplel who brought the man here from just south of Palatka, Pa., limited his age to 30 and said he carried papers which indicated his name was Donald H. Skinner of Philadelphia, Pa.

He was taken later to the Veterans Hospital at Lake City without regaining consciousness. Attendants there said last night they had been unable to obtain any information from him.

Sticking in the man's stomach were 15 one-inch nails and there were 12 or more burns about the size of a 25-cent piece. Dr. C. M. Knight who treated him here said the nails had not penetrated the abdominal cavity and the wounds appeared to be several days old.

"She's on the floor," Charles replied.

Firemen extended the conversation. They have the call traced. Then they raced to the home and found Mrs. Finkensaid unconscious on the floor.

She was revived by oxygen and taken to a hospital for observation.

Oregon: Lake, Jackson, Douglas, Benton, Jefferson and Coos Counties.

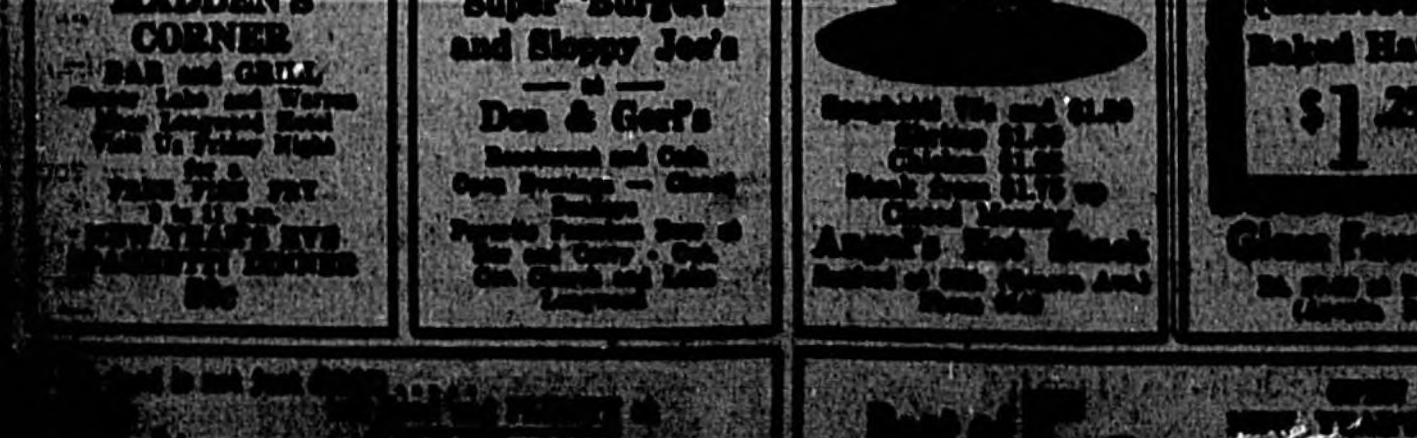

Spotlight On Hollywood

HOLLYWOOD—If Ernie Ford had been born a few miles distant, the nation's No. 1 record might have been "Sixteen Tons" by Virginia Ernie.

That's the thought for today.

As a matter of fact, Ernie's hometown is on the Tennessee side of the border city of Bristol. It's a good thing too. He probably never would have gotten very far as a Virginia Ernie.

But as Tennessee Ernie Ford, his career is booming. It looks as though his "Sixteen Tons" is going to be the biggest seller in recent history.

"I'm amazed by it all," said the modest singer over breakfast. "Nothing like this ever happened to me. I guess nothing like it ever happened to anyone."

The astounding sales: over two million records in eight weeks, and the amount is still climbing.

No wonder Ernie is amazed—he has only been a performer for six years. He came to California in 1946, landing in San Bernardino as a radio announcer. He moved on to Pasadena and that's where he adopted the Tennessee, using it as a disc jockey for country music.

In 1948, hillbilly emcee Cliffie Stone enlisted Tennessee Ernie on his Hometown Jubilee TV show. That's when Ernie's career started taking off. He rumbled around in the TV and record world, then came to national attention as Lucille Ball's country cousin on I Love Lucy.

For the past year he has been doing 10 shows a week, five on NBC-TV in the morning and five on CBS radio at night. He has been called a bucolic Arthur Godfrey, since he has much the same kind of voice and delivery.

Now did he find "Sixteen Tons"? He explained that he was able to do a variety of songs on his TV and radio shows because he needed so many to fill the time. He remembered some folk tunes that Merle Travis, a guitar player and singer, had recorded. He picked "Sixteen Tons" out from the sheet music.

"I did it three times on the show," Ernie recalled. "The mall response was terrific. Then I sang the song at the Indiana State Fair last summer. There were 18,000 people in a big hall and you could have heard a pin drop. That's when I decided I'd better record it."

Truce Group Thinks Peace Proposals May Bring Progress

JERUSALEM (U. P.)—Blaming both Israel and Egypt for the delay, the U. N. Palestine truce group has indicated that progress may be made soon on Secretary General Dag Hammarskjöld's frontier peace proposals.

In a communique, the truce group said further discussions will be held soon on Hammarskjöld's plan.

The communique replied to an Israeli statement charging that Egypt had reacted negatively to the proposals, the U. N. group said.

"The government of Egypt has not yet formulated its final position on the secretary general's proposals and considers the negotiations still in an open state."

The communique said "preliminary introduction of questions beyond the scope" of the Hammarskjöld proposals by both Egypt and Israel had "complicated negotiations and greatly delayed them."

A new 1956 Mercury sedan, stolen in Sanford Christmas eve morning, has been found in running condition in New Iberia, La., according to a report from the Florida Highway Patrol at DeLand relayed to the Sanford Police Department here.

The owner of the car, Al Wallace, of Sanford had stopped into Roumillat & Anderson's Drug Store shortly before 9 o'clock Christmas Eve morning leaving his car parked on Park Ave.

The new car was driven off by William Arthur McLaughley, a 20-year-old youth who gave his address to Louisiana authorities as 130 Bellemeade, Greensboro, N. C.

According to reports received here at the Seminole County sheriff's office, the youth was apprehended after he had stolen the sheriff's car of the New Iberia, La., area and completely wrecked it. Reports indicated that the law enforcement official's car was a total loss and the youth was injured in the accident.

The Florida Highway Patrol reported that McLaughley admitted stealing two cars and leaving them outside Jacksonville and another just outside of Orlando.

It is understood that the youth will face charges in Louisiana before being brought back to Florida to face charges here.

The number of work stoppages was 21 per cent greater than the 3,468 reported in 1954. Last time in 1955 was nearly 24 per cent more than last year.

The review noted that while strike idleness this year exceeded 1954, it was the third best year since the end of World War II. The number of strikes in 1955 was about 20 per cent less than the postwar peak of 5,117 stoppages recorded in 1952.

Khushchev Calls Crude Interference Against Eisenhower

MOSCOW (U. P.)—Communist party boss Nikita Khrushchev today charged President Eisenhower with "crude interference" in the internal affairs of the Communist-ruled countries of East Europe.

Khrushchev's blast before a joint session of the Soviet Parliament was occasioned by Christmas messages the President and other leading Americans broadcast to the East Europeans.

The party boss accused the United States of trying a "re-establish capitalism" in the countries of the Soviet bloc.

"But it is impossible to turn back history," he declared.

Khrushchev said the American Christmas messages, which generally stated the authors were praying for the liberation of the East European countries, were "incompatible with the Geneva spirit."

"It leads to the incitement of passion," he declared, adding that "I speak about President Eisenhower in such a manner unwillingly, because I respect him so much."

Cordell To Vacate Office

Mayor Denver Cordell retires from the commission and the position he has held in the City's governing body.

Other commissioners on the Board are John Krider, Earl Higginbotham, F. D. Scott, and Jack Raligan. Krider and Higginbotham have both served as Mayor of the City. Commissioner Scott and Raligan were seated on the Board at the 1958 organizational meeting.

In case the commissioners are unable to choose a Mayor, according to the City Charter, within five days after the organizational meeting, the Mayor will be chosen by lot conducted by the City Clerk, with the results of the lot becoming a part of the minutes of the City Commission.

CHICAGO (U. P.)—The nation's governors have been urged to take drastic, emergency measures to cut the traffic toll over the new year's weekend.

The action was asked yesterday by the National Safety Council in view of the record 600 traffic deaths over the Christmas weekend.

The governors were asked to "use every resource at your command to step up traffic enforcement in your state over the holiday."

The council predicted 430 persons will be killed in traffic mishaps Friday night, Saturday, Sunday and Monday. That would be a record toll for a New Year holiday period.

CHICAGO (U. P.)—Insurance man William Balmer says a planned congressional investigation of the government's nickel operation in Cuba stems from what he called "a fight between world-interests and National Lead Co."

Balmer commented to newsmen on reports that he was among those named for possible questioning by a special Government Activities subcommittee which said it intends to explore financial and legal details of the big government expansion program.

Rep. Jack Brooks (D-Tex.), head of the committee, said in Washington that Balmer's firm, Balmer & Moore of Chicago, receives two thirds of the insurance brokerage fee in connection with workmen's compensation insurance on the project.

Little Girl, Parents Reunited

DALLAS (U. P.)—A pretty, 13-year-old girl, who cried to use the telephone and call her parents, was held in juvenile homes for six days — including Christmas — in a strange mixup of records.

Authorities revealed yesterday that police couldn't find the records of what was done with her, since she had no records, and the people who locate her, and the people who think where she was couldn't contact her parents.

Then the Dallas County Juvenile Department shut down for the Christmas holidays for 2 1/2 days. Apparently there was no official attempt during that time to contact her parents.

Her mother said the girl could have contacted relatives if allowed to use the telephone.

The girl's name was not disclosed. The solution came from a city detective, who once searched records but failed to find the child's card. The case kept nagging his mind. He looked through the records again, found the name, and a few telephone calls later had located her.

The story began last Wednesday when the parents, in a comfortable middle-income bracket, quarreled. The father went to the home of relatives for the night. The mother, after seeing that her daughter was in bed, went driving to think about the quarrel.

The girl awoke, found the house empty, became frightened and began walking to a friend's house. Police picked her up at 3:48 a. m., tried to locate the parents and couldn't.

Officers overlooked the record the next day when the parents began searching.

The girl had been sent to a maximum security juvenile home because of the hour. She was transferred later to Sunshine Home a residence for homeless girls.

Mrs. Ruth Steinhilb, intake supervisor at the Dallas County Juvenile Home, the maximum security home, said she tried repeatedly to call the parents, up to Saturday afternoon, when the juvenile Department closed for the holidays until Tuesday.

Mrs. Lorraine Becker, manager of Sunshine Home, said the child cried because she wasn't allowed to use a telephone herself. Mrs. Becker asked Mrs. Steinhilb to press her search for the parents.

After the reunion, the child's mother said she was out of her home frequently while searching for her child, and even changed her base of operation to her mother's house.

"If they had given her access to a telephone, she would have called me at her grandmother's," the mother was quoted as saying. Christmas wasn't a total loss for the girl. All her presents were waiting for her when she and her parents were reunited.

'Stars and Stripes' Are Raised Again At Little America

LITTLE AMERICA (U. P.)—The Stars and Stripes were raised again at Little America yesterday.

The site of the first two camps built in the antarctic by Rear Adm. Richard Byrd was desolate.

The buildings of the first camp built in 1928 are covered by an estimated 60 feet of snow and ice. The second camp is about 40 feet below us.

All we found on the surface at 3 a. m. were the tops of towers and poles.

The experts aboard the icebreaker USS Glacier haven't decided yet where to build the permanent main base of the current United States antarctic expedition. The base will be used during the next three years by International Geophysical Year scientists.
