Search Is Intensified For Man Who Told How Baby Was Slain And Where Buried

DANBURY, Conn., May 21.—(A.P.)—Dr. John Condon, the "Jafie" of the Lindbergh kidnaping case, arrived at a roadhouse near here today after a fast automobile ride from New York. He said the next stop after lunch here would be Pawtucket, Rhode Island and also wanted to go to New Bedford, Mass. "Jafie" said he had received a communication and expected to receive another along the way and added "I want to bring those around to justice."

HOPEWELL, N. J., May 21.—(A.P.)—Search was intensified today for the mysterious gangster believed connected with the Lindbergh baby kidnap case who recently said in Maryland, before the baby's body was found, that the tot was dead. Police said he had long been identified with liquor running activities but declined to divulge his name.

JACKSONVILLE, May 21.—(A.P.)—An attempt to draw financial assistance for the Florida East Coast Railway from a recent trust established by the widow of Henry M. Flagler, was started in federal court yesterday. It was a suit by Douglas Findlay, of this county, seeking a court interpretation of Mrs. Flagler's will in which Findlay charged provision was made for a trust fund for maintenance, administration and development of the railway. Findlay claims trustees and executors of the estate have not given financial assistance to the railway. He also charges that officials of the railroad have not taken proper steps to obtain the industry from the will of the company, not handling the fund. The Florida East Coast was permitted under federal receivership last year. William R. Keenan, Jr. of New York, and Scott M. Lottin, of Jacksonville, were named trustees. Keenan and Lawrence C. Haines, of New York, are executors of Mr. Flagler's will. A program of expansion, he charged, was undertaken in 1924 and was "greatly in excess" of what was planned. (Continued on Page Six)

Federal Unemployment Relief Program Proposed By Democratic Committee

WASHINGTON, May 21.—(A.P.)—A \$2,500,000,000 federal unemployment relief program was proposed yesterday by the special Democratic relief committee of the Senate.

The counter offer to President Hoover's compromise called for a \$500,000,000 bond issue for public construction. It accepted proposals for \$300,000,000 for direct relief loans to the states and \$1,500,000,000 for public and private loans, both to be administered by the Reconstruction Finance Corporation. Proposals for an expanded public works program have been approved by President Hoover and this feature of the Democratic plan was expected to bring negotiations for a new compromise more satisfactory to the administration.

CHAPMAN IS BIG GUN IN FED WIN OVER PARKERS

Headly Catcher Takes Advantage Of Every Chance In 2-1 Tilt

Bert Chapman 2; Winter Park, 1.

That, friends, is the real score of the jam-up game of baseball played at Municipal Park yesterday afternoon between Manager Joe Barnes' Colery Feds and Manager Joe Gufford's Winter Park nine, although the score was actually Sanford 2, Winter Park 1.

Chapman, catching his second game of the year, so manipulated the slants of young Lake and so steered the Fed youngsters that despite the fact that they got but three hits, one of them a very doubtful one, they won a baseball game by sheer cunning and baseball wisdom.

As in the New Smyrna game last Sunday, it was Chapman's general directing of a team that accounted for victory, and the fans today are abuzz with comment about the team and its chances now that Chapman has made such an auspicious return.

The game was one of those pitcher's battles that grow more tense as the innings progress. Lake, hurling one of his best games of the year, was about on a par with young Mock, the Parker ace, but he wasn't quite as wild. Lake struck out five men and walked one, and during the nine innings, only 30 men faced him, just three more than are needed to start and finish a game without a score.

Only 30 men faced Mock in eight innings, and he gave up three hits, one in the first, fifth, and ninth, completely sinking the Fed heavy hitters, Barnes, Pittman, Reed, and Harrison. His wildness in the seventh, proved his undoing however, although it must be said that since rain halted the game for nearly an hour, a heavy ball and his return to the game "cold" had a big hand in the three walks he gave. Mock pitched brilliantly, and had good batting support from Buck Taylor and White Powers. His battery mate, Adair, gave the Feds one run, while the Feds earned the other on three walks.

Lake held the Parkers hitless for the first three innings, only nine

men facing him, in the meantime Mock had been in trouble twice. In the first, Taylor fouled out at third. Bach singled to center and went to second when Oterstreet juggled the ball. Bach went to third on Barnes' grounder to first, but he died there when Pittman tied out to short. In the second, Reed walked and went to second on Moore's neat bunt in front of the plate. Harrison was out, pitcher to first, and Chapman hit a line drive to deep right, caught by Ratterree after a hard run. The third was uneventful for the Feds.

The Parkers scored in the fourth, earning the run, too. Hall had struck out when Powers singled to center. Maltby fled out to Bach, but Taylor hit one down the left field foul line for two bases, scoring Powers, Ratterree fled out to Pittman.

The Feds got the run back in the fifth, after the Parkers had gone down two, three in the fifth and the Feds had gone down in the same manner in their left of the fourth. Moore singled to left and went to second on Harrison's sacrifice hit. Chapman worked some of his baseball magic on Umpa Lasater, after Chap had noticed that Mock made a false move toward third, and the Umpa called it a balk, sending Moore to third. Chap then dumped a ball in front of the plate, Moore scoring by a half when Adair dropped Mock's perfect toss into his hands. Lake went out, short to first.

The Parkers got a pair of hits in the sixth but couldn't score, while the Feds went down one, two, three again in their half.

Some of Chap's fancy playing again loomed up in the seventh when he tossed out the fast Ratterree at second. He did the same thing in the eighth to get Oterstreet by a mile.

Here's how the Feds won the ball game: Reed opened the seventh with a strike-out. Moore walked and stole second on the first pitch to Harrison, after which Lasater called the game because of heavy rain. One hour later, after much arguing, it was decided to continue the game. The Feds had warmed up long before the Parkers, and Lake had a decided edge on Mock in the warming up process. With play resumed, and Mooreback on second, Mock couldn't find the plate, and walked Harrison just as Moore stole third. Chapman worked Mock for a walk, and the bases were full. Lake, seeing Moore racing for home with the count three and two, bunted in front of the plate, Moore scoring. Lake was tossed out at first, and Harrison was doubled out at the plate.

Costly Errors Aid In Islander Victory Over DeLand, 3 To 0

Florida Baseball Team Averaged 10 Hits A Game In '32

GAINESVILLE, May 20.—The University of Florida average of more than ten hits a game through the 1932 season and for the 20 scheduled contests, registered a team batting mark of .288.

Seven 'Gators' finished with batting averages above the .300 mark. Harold Butts, substitute infielder, hit for .500, and Al Ratterree, pitcher, not only hurled brilliantly all season, but batted for .444.

Brushful Bill Bradley, fleet center-fielder, was really the club's foremost swatman, garnering a .321 average in 81 trips to the plate. Bob Pittman, star third baseman, and captain-elect for 1933, ran a close second, polling 25 hits for a mark of .316. Pittman was one of the long-range batmen of the team and his hitting was consistently a feature of Florida's play. Ed Sauls, outfielder, who was injured early in the season and compelled to abandon competition, was hitting .312; Caspar Vandlandingham, catcher, ended with

an average of .307, and Bobby Treadgold, outfielder first baseman, bagged a .305 average.

Johnny Gufford, second baseman, hit for .297, and Coffee Moore, shortstop, who tied Bradley in total number of at-bats for the season, 26, had a .295 average. Pete Schirard, outfielder, pingied himself into a .291 record for the season.

Florida won 12 games and lost eight, and by virtue of two triumphs over Rollins last week, annexed the state intercollegiate title.

Coch Cowell's prospects this past spring were seriously impaired with the early advent of four first-rate players into professional ball, and the loss of two others from injuries; however, the 1933 outlook is bright inasmuch as only three players are not slated to return next spring, Ben Clemmons and Louis Tofalietti, pitchers, and Captain Vernon Clark, catcher.

Brilliant fielding characterized the play of the 'Gators' through the entire 1932 season, many games being played without commission of a miscue.

Since then he has gone far. Always conducting himself with the highest degree of propriety, always accomplishing whatever he tries, yet with becoming modesty. In five years he has made money and has become the outstanding hero of the American people. He has married the daughter of an American ambassador. And he has suffered on a wave of crime in his country perhaps more than any other American citizen.

Frank Wheeler's Record

In considering a man's candidacy for public office it is always well to review his public record. Not every candidate, of course, would ask that. There are those who would urge the voter to forget the past and look only to the future, but most citizens have found that the best indication of what the future will be, can be found in the acts of the past. If a man is proud of his public record, he will not seek to hide it. If he is not proud of it, he is hardly the man to reward with public office.

Frank Wheeler, now a candidate for the Legislature in Group No. 2, invites the closest inspection of his public record, we feel sure. It is one in which any man might justly take pride. For some eight years, including the exacting period of the boom, when countless other public officials of cities and counties throughout all Florida, forgot their public responsibilities, and followed the lead of private speculators into an orgy of extravagance and dissipation of public funds, Mr. Wheeler served as a county commissioner. He was elected in 1922 and re-elected on the board until January 1, 1931.

How well the county commission guided the destinies of this county during that trying period is well known to all our citizens. There was progress and development, to be sure, the same as in any other county of the state. The Court House was paid for; the County Home, second to none in the state in point of comfort, was built; a County Jail was erected, and many splendid highways throughout the county were constructed. Yet today Seminole County yields to none in Florida for financial integrity.

Early in Mr. Wheeler's service as a county commissioner, a three year road building program amounting to \$1,660,000, was inaugurated. Those who recall the almost impassable sand roads, and occasional narrow brick lanes, of a decade ago, realize the importance of this movement. But in some cases, familiar to most sections of Florida, where road bonds were voted, roads were not always constructed. In Seminole County every dollar of the \$1,660,000 voted for highways was spent on highways, and so economical were the commissioners in their administration of these funds, that in some instances where nine foot roads were voted, eighteen foot roads were built, at no additional expense to the taxpayer.

Early in 1926, however, Mr. Wheeler was one of those who saw that a financial crisis was impending. A resolution had previously been adopted at the insistence of some of our citizens, authorizing a million dollar bond issue for additional road construction. At a meeting of the commission on Oct. 4, 1926, Mr. Wheeler together with John Meisch, and L. A. Brumley, was most outspoken in condemning a policy of further borrowing, and the resolution was finally rescinded, saving the people of this county additional tax burdens today.

It was about this time that the banking situation in Florida became precarious. Sound public policy demanded adequate security for public funds deposited in any Florida banks at a time when such security was not easy to give and insistence upon it was not contemplated to increase one's popularity. Mr. Wheeler publicly asserted that if local banks would not provide ample security he would favor sending the money to Jacksonville, and he was backed up in this stand by the other commissioners, thus saving Seminole taxpayers thousands of dollars.

This has always been Mr. Wheeler's policy in public office. He has never sacrificed the public welfare for the sake of personal popularity. This attitude of his is well attested by the fact that during his eight years in office, in spite of many constructive programs completed, the assessed valuations for taxable purposes in this county were increased less than \$800,000, and the tax millage was actually reduced from 60 1-2 to 54 7-8.

Such a record as that, we believe, entitles Mr. Wheeler to every consideration from the public in his present race for the Legislature.

A Fireproof Ship Burns

With reports stating that between seventy-five and a hundred persons lost their lives when the big French motorship, Georges Phillipar, was destroyed by flames off Cape Guardafui, Italian Somaliland, the thought occurs that science, with all its inventions, has not overcome the danger of marine disasters of this nature.

The ship involved in the tragedy was on its maiden voyage. It possessed every device to protect it against fire, and to sound a warning if one occurred. It was built of steel from keel to funnel tops and had fireproof materials throughout. But despite all this, it caught fire and burned so rapidly that those who did escape had very close calls.

One can easily understand how a wooden vessel, or one of steel that is not otherwise fireproof, might ignite and become an inferno before the passengers could take to the lifeboats, but the case of the French boat is a puzzling one. Besides the watchmen who were supposed to be patrolling the innermost recesses of the ship, the companionways, and the decks, the ship had automatic devices running from stem to stern, and centered on the bridge, which were supposed to sound a warning at the first sign of fire. It appears that the human and mechanical elements must have both failed.

No matter how far inventive and mechanical genius advances, there has been no sure preventive found to curb accidents and disasters, although many advances have been made to minimize them. We can only hope that more and more devices will be invented so that some day in the future, a tragedy, as befell the Georges Phillipar, will not occur again.
