





## Work Is Finished On Compromise OPA Bill

War Probe Group To See Why Adequate Defenses Were Not Built Before Raid

WASHINGTON, July 22 (AP)—The joint House and Senate Conference Committee completed its task of writing a new OPA bill, and the legislation will be submitted to both branches of Congress tomorrow. The joint conference agreed that if OPA is revived, no price controls should be placed on meat, poultry, dairy products and other basic foodstuffs. Any

price controls must be re-started at all on those items will be decided by a three-man board with higher authority than OPA.

The compromise was signed by 11 of the 14 senators and representatives making up the joint committee. Those who refused to sign were Senator Eugene Milliken of Colorado and Representatives Jesse Wolcott of Michigan and Frederick Smith of Ohio. All are Republicans.

It's beginning to look as if Congress will have to remain in session longer than most members had anticipated. The thing that's likely to postpone their summer vacation is the compromise bill to revive the OPA.

Senate Majority Leader Alben Barkley talked with President Truman about the OPA measure today. After his visit to the White House Senator Barkley admitted that he sees no prospect of adjourning Congress before the middle of next week at the very earliest. Previously the law makers had hoped to be on their way home by Saturday.

Barkley said Mr. Truman is having the OPA bill analyzed before he makes up his mind whether he'll sign it or not. He again called for the vote. The majority leader expressed hope that the President will sign the OPA revival measure. But, the Senator added, nobody at today's conference asked Mr. Truman whether he'd sign, and Mr. Truman did not volunteer the information.

The OPA is drafting a report to President Truman on the economic consequences of the complex price control bill written by a House-Senate conference committee.

The analysis is expected to guide the President to a decision on whether to sign or veto the measure if and when it is passed by Congress.

### Rebels Seeking Need Is Stressed To Restore Order For Safety Plans In Bolivian City To Cut Accidents

### President Villarroel Was Assassinated; 2 Thousand Killed

LA PAZ, Bolivia, July 22 (AP)—Leaders of the revolt in Bolivia are today trying to restore order after a four-day uprising culminated by the assassination of President Gualberto Villarroel. Every hospital and dispensary in La Paz is filled to overflowing with casualties of yesterday's street fighting. Many members of Villarroel's military regime died with their leader—but most of the 2,000 killed or wounded in the street fighting were revolutionaries. Some of Villarroel's men managed to escape to the hills, but there are no indications yet that they will try a counter-move on the capital.

Meanwhile, the revolutionary regime—so-called institutional government—has promised immediate restoration of the civil liberties suspended by Villarroel's "returning man" rule. The revolutionaries also have promised that all political prisoners will be freed and all political exiles welcomed back in Bolivia.

The revolution led by university professors, students and labor groups began on July 13, when a student was killed during a demonstration demanding higher pay for teachers. Trouble increased when the government prohibited all demonstrations and Villarroel realized his regime was wavering. He made some attempts to stop the revolution, but when all hope was gone, he resigned yesterday and made plans to flee the country in his private plane.

However, the revolutionaries were too quick and too strong. They overran the presidential palace and captured Villarroel. He was hurled from a balcony, on the mob in the street lost no time in stringing him up on a lamp post. Several of his lieutenants and members of the palace guards were hanged on other lamp posts in the square. Then the president's body was cut down and paraded through the streets that halted most of the street fighting. Villarroel's body was returned to the lamp post.

Tributes were paid to the memory of the late C. C. Blane, former superintendent of the Atlantic Coast Line and a Rotarian, by Walter Haynes and President Speer.

### United States Is Attacked By Chinese Reds

### Madame Sun-Yat-Sen Says America Had Better Watch Out; Russians Echo Slap

The United States again is the target of ferocious editorial and verbal barrages from Chinese communists and Russians over what is happening in China.

There even is a warning from Madame Sun-Yat-Sen to the United States to watch out. The widow of the founder of the Chinese republic contained it with a blistering denunciation of Chinese Communists, government party stooges, the powers behind the central government which is headed by her brother-in-law Generalissimo Chiang Kai Shek.

In one of her rare public statements, Madame Sun claimed that the communists are trying to stir up civil war in order to start away between the United States and Russia and in that way, at last crush the Chinese communists. She said there must be an immediate coalition government something which General Marshall has been unable to achieve for months without success. If the Chinese communists are not to continue starving while corrupt officials ruin fortunes. She argued that the United States must increase its aid to the Kiangtung for a coalition by cutting off all military supplies to China. Referring to the so-called Kunming plot to start a war between east and west, Madame Sun said:

"The American people, who are allies and long friends of China must be clearly told of the road to disaster. They must be told that American communists are teaming up with Chinese communists, each encouraging the other. They must be told that the presence of United States armed forces in Chinese soil is strengthening peace and order among the Chinese people. They must be told that the Chinese should be encouraged to organize and truly representative Chinese government. They must be told that if America makes it plain that she will supply munitions or military assistance, there will be no hindrance of the Chinese civil war."

**Poliomyelitis**

In spite of its current prevalence in Florida, the death rate from poliomyelitis (infantile paralysis) has had a distinct downward trend during the last 35 years, interrupted only by periodic epidemics, according to the Metropolitan Life Insurance Company.

"Girls have benefited more than boys from this improvement in mortality among white children," reports the Metropolitan. For the period 1911-15, the death rates for both sexes at ages 1 to 14 were practically identical. By 1941-45, the death rates for the girls were only half those for the boys, the rates being 1.1 and 2.2 per 100,000, respectively.

The improvement in mortality has been concentrated among children under five years of age. The death rate among girls at ages five to nine has also been reduced. No definite tendency toward improvement is observed at any other age. The point of highest mortality has meantime shifted from the age group 1 to 4 years to 5 to 9 years among boys and 10 to 14 years among girls.

It is difficult to account for the decline in "polio" mortality. Both improved diagnosis and improved methods of treatment have no doubt contributed.

Effective measures to prevent the spread of this disease have not yet been found, but the company holds out the hope that continued research will bring it under control, just as the more common infections of childhood have been greatly reduced.

**The Thinking Man**

When Byron Price, who went from the Associated Press to be director of censorship during the war, made the recent Phi Beta Kappa address at Harvard University, he said that only the thinking man can save us.

"What we have in this country today is a national sense of confusion, hesitation and reviving bigotry; of legislative lethargy, timidity and neglect; of economic strangulation at the ruthless hands of 'morphots'; of future operations in the black market; of increasing juvenile delinquency; of padded relief roles, while work waits for millions; of waste and profligacy in a world of dire need."

For the American to point an accusing finger at his neighbor and exhort him to reform, said Price, has been tried and achieved less than nothing.

"The truth is that in our thoughtless haste to arouse one another we have rendered complicated a really simple matter. The one human force left in the world is public opinion. If our affairs are out of joint, the mass of our citizens cannot escape the blame. To recover our nation and its ideals, the responsibility of the disciplined mind arises."

Not the cloistered thinker is needed, not the half-baked theorist, says Mr. Price, nor the writer who wishes to substitute brooding for philosophy. "But the man in the world today who knows what it is, who believes in a Golden Age for American culture and who has the faith and the courage to work for it and to reject the temporary substitutes. The man to whom anything less than fair play is shoddy, to whom cowardice is a post-war reflection on the bravery of our millions who won the world's most unbelievable victory." He wants the youth which was not afraid to die for us given reasons to want to live for us.

True, clear thinking is the hardest work in the world. But it is the most necessary. Price has given the call for the thinking man to take hold. Shall he fail, or shall he put the strong muscles of his mind into this essential job?

## Production To Capacity, Plea Of Johnston

Co-operation Between Management, Labor And Full Production Seen As Solution

CHICAGO, July 23, (AP)—President Eric Johnston of the Motion Picture Association of America today urged that labor and management cooperate to increase production. Johnston asserted that any American union that doesn't believe in full production is, in his words, doomed to oblivion as something anti-social. This was part of his speech delivered before the convention of the A. F. of L. International Alliance of Theatrical Stage Employees and the Motion Picture Machine Operators Union.

Johnston says the progressive viewpoint today is one that puts production paramount and condemns the creed of scarcity. In calling for labor and management cooperation for full production, he declared that make-work practices, featherbedding and work stoppages would have to be eliminated. He also urged labor unions to outlaw the jurisdictional strike, which he termed an indefensible practice. Johnston declared, "I know of nothing that outrages the American people more than a strike because two unions can't agree on who should collect dues from whom."

## Bikini's King Juda May Not Get To See Atom Blast

ABOARD THE U.S.S. MOUNT MCKINLEY, July 23—(AP)—King Juda of Bikini may not get to see the underwater atomic bomb explosion after all. He seems to be all snared up in white man's protocol and regulations.

Juda returned to his native Bikini today, all set to witness the test. Bikini's king and his subjects have been living on nearby Rongerik Island ever since the Army and Navy decided to take over Bikini for their atomic experiments.

Recently, the overall atomic task force commander—Vice Admiral W. H. P. Blandy—paid a courtesy call on Juda at Rongerik. Blandy told the native king he could return to Bikini to sleep there one last time. But Blandy added that only the joint chiefs of staff in Washington could decide whether it would be okay for Juda to witness the explosion which may send a tidal wave rushing over his one-time domain.

That permission hasn't come through yet. But in any event, Juda says he's happy to see that his island wasn't burned up in the first atomic bomb explosion on July 4. Juda declared he and his subjects had seen the atomic cloud on Rongerik, 130 miles away. King and subjects alike believed their former home had been burned up. Apparently he had expected a lot more of the white man's awesome weapon.

## Rationing Is Hurt By Buyers' Strike

LONDON, July 23, (AP)—A buyers' strike threatened Britain's bread rationing program today and left Ministry of Food officials faced with the prospect of heavy losses of bakery products.

In West Scotland, housewives delayed their purchases until late afternoon in the hope that bread leaves and pastry would be sold off without coupons. But ration divisions food officials announced that there would be no relaxation of the rules.

A number of London bakeries sold cakes without coupons. In one shop window piled high with drying loaves, a sign read: "owing to bread rationing, all this bread is wasted."

In northern Ireland the Ministry of food set up 21 emergency distribution centers to provide supplies threatened by a strike of delivery men protesting against the extra work of collecting coupons.

## 2 Suits Filed Against 5,000 Eye Doctors

### Optical Wholesalers Who Fixed Prices On Spectacles Are Also Under Attack

CHICAGO, July 23, (AP)—The Justice Department today filed two civil suits charging optical wholesalers and approximately 8,000 leading eye doctors throughout the country with violating antitrust laws.

The defendants are charged with fixing prices on spectacles by refusing to let the eye doctors about half of the total price their patients paid for glasses. One suit named Bausch and Lomb of Rochester, N. Y., and four subsidiary companies—as well as 30 eye doctors, who were named in a so-called representative capacity. Justice Department officials explained that these 30 represented some 30,000 doctors in the country who are said to have received rebates from Bausch & Lomb and the subsidiaries.

The other suit was filed against the American Optical Company of Southbridge, Mass., described as a voluntary association, and another firm of the same name described as a corporation. Twenty-two doctors were named as receiving rebates from these companies, doctors who were representative of 1,000 other eye physicians throughout the country. In each suit the doctors doing business with the defendant companies were sued as a class.
