Kissinger, Tho Meet

PARIS (AP) - Secretary of State Henry A. Kissinger met today with Hanoi's Le Duc Tho to discuss the failure of the Vietnam cease-fire agreement they negotiated last winter. American officials expected Tho to renew North Vietnam's demand for economic aid from the United States, promised by the agreement. U.S. officials indicated they did not expect spectacular results from the meeting, but Kissinger told newsmen: "What is important is that the signatories do everything in their power to reduce the dangers of conflict and contribute, as they pledged themselves, to bringing peace to Vietnam." He stressed that he and Tho did not plan to draft a new Vietnam agreement.

Cong Frees American

SAIGON, South Vietnam (AP) - An American civilian held for 21/2 months by the Viet Cong said today he was bound with ropes or chains for the first six weeks and moved to eight or 10 locations, sometimes within 1,000 feet of air and artillery strikes. But Homer I. Elm. 43. of Arcadia, S.C., who was released Wednesday, told a news conference he got "adequate" treatment during his captivity in the Mekong Delta.

British Miners' Wages

LONDON (AP) - The British government says it might agree to a bigger pay raise for the coal miners whose slowdown is crippling Britain if other union leaders pledge not to make similar demands. William Whitelaw, secretary of employment, told the House of Commons that, if the government modified its anti-inflation ceiling on pay raises "to the miners' further advantage, then other trades union leaders ... would have to make it clear that in negotiations they would not seek to follow the miners' lead."

Governor's Wife Leaving

ANNAPOLIS, Md. (AP) - Barbara Mandel says she has given up hope for her marriage and will leave the overnor's mansion today. Mrs. Mandel has remained in the mansion since her usband, Maryland Gov. Marvin Mandel, announced last

July he was leaving her to marry another woman. Mrs. Mandel said she had hoped and believed he would return "Five and a half months have passed and our marriage

has not returned to normal. Therefore, with deep regret, I am leaving the mansion as of December 20th," she said in a statement Wednesday.

Mandel, 53, a Democrat, announced last July that he was in love with a southern Maryland divorcee, Mrs. Jean Dorsey, and was leaving his wife after 32 years. The Mandels have two children.

Impeach Move Head Picked

WASHINGTON (AP) - Chairman Peter W. Rodino says he has found the man to act as special council for the House Judiciary Committee's impeachment inquiry. But the New Jersey Democrat would not tell committee members who he had chosen to direct the inquiry. Rodino said the name would be revealed at a news conference

Gate Panel Demands Tapes

WASHINGTON (AP) - The Senate Watergate committee is demanding 481 tape recordings and hundreds of other items from White House files. Subpoenas for the material were served by the committee Wednesday White House comment came from Samuel J. Powers, a Miami attorney acting as a White House consultant., Powers said that the demand for hundreds of tapes "really would almost shut down the executive department for us to have to do that kind of work.

Laird Yields To Ford

WASHINGTON (AP) - Melvin R. Laird says he is quitting his job as a presidential counselor. Laird said he would step down Feb. 1 and turn over his duties to Vice President Gerald R. Ford. Laird said he has taken a job as an executive for the Readers Digest Association that would permit him to travel, write and speak on such current issues as national security and detente.

Congress Facing Adjournment

WASHINGTON (AP) - The Congress continues to move toward adjournment, but faces complex and costly bills on energy, social security, railroads, defense, and foreign aid before it can recess for the year-end holidays. But House Democratic leader Thomas P. O'Neill says the lawmakers could finish the session late tonight or "at a reasonable hour on Friday."

GM, Ford Acquitted

DETROIT (AP) - General Motors and Ford have been acquitted of a federal charge that they had a silent agreement to eliminate discounts in sales of fleets of cars. The fleet market - sales in lots of 10 or more vehicles -

accounts for about one million vehicles a year, or 10 to 12 per cent of United States production. Before the 1971 model year, Ford and GM offered

discounts averaging \$250 per car to fleet customers. Since dropping the discounts, Ford and GM have seen their share of the fleet market fall from nearly 75 per cent to less than 50 per cent.



Sugar Cane Damaged

CLEWISTON, Fla. (AP) - Warm and rainy weather will hurt chances of saving Florida's sugar cane crop damaged during a major freeze earlier this month, a sugar industry official says.

Nelson Fairbanks, general manager of Florida Sugar Cane League, said Wednesday that the Dec. 12 freeze may cost farmers between \$20 and \$50 million in crop damage. He estimated three-fourths of the state's 265,433 acres of sugar cane was damaged.

"A lot now depends on the weather. If it is warm and rainy, it's going to hurt chances of saving the damaged cane," he said. "We will be able to minimize losses if the harvest can proceed at a rapid pace."

Temperatures during the freeze were reported as low as 25 degrees in some parts of the sugar growing areas of Henry, Martin, Palm Beach and Glades counties with some regions having freezing temperatures for as long as

He didn't get the decision many times and many times lost innings pitched which directly effects the number of strikeouts.





than on a balmy summer day. There are a few things that can be done to make it easier to start on cold days.

Make certain all accessories are turned off before turning on the ignition key when trying to start the car.

You should resist the temptation to continuously pump the gas pedal when starting the car. Turn the key and depress the

gas pedal to the floor once and let it up halfway. Don't grind the starter for more than 30 seconds. If the car doesn't start within 30 seconds, stop and make repeated attempts. allowing 30 to 45 seconds between tries.

If the carburetor floods, you'll know it by the smell of gasoline. Shut off the ignition, push the gas pedal to the floor and hold it there for a full minute. Then, with the pedal still on the floor, turn the starter. This procedure allows any excess gasoline to drain through the manifold. Enough fuel usually remains to give a proper start.

Warm the engine at an idle. Never race a cold engine. The rapid action of internal parts before lubricants are flowing puts severe wear on engine

Even these pointers may not work if the battery is not properly charged and if the car is not kept tuned. Check the battery often and have a tuneup before each driving season. Spark plugs are an important and inexpensive part of the

time than those filing closer to the April 15 due date, O'Donnell urged employers to distribute W-2 withholding forms as soon as possible. W-2's for 1973, generally must be distributed by Jan. 31, 1974 Most taxpayers who file in January receive their refunds in

four to five weeks, while later filers may have to wait as long as eight weeks, because of the greater volume of returns received, O'Donnell said.







Oct. 17, 1973, was a special kind of victory day for consumers. On that day, the Food and Drug Administration (FDA) issued a final order making ingredient labeling mandatory for all cosmetic products.

The new labeling regulation will become effective March 31, 1975, to give manufacturers time to clear out existing stocks and to redesign and order new labels.


