



Last year, the Rams defeated Winter Park for the ring.





Somehow, when I think of fruits I think of summer fruits: berries and peaches, cherries and nectarines, apri-cots and melons. When I think of cooking with fruits, I think of pies and shortcake and cobblers. I don't imme-diately think of citrus fruits and how - especially in winter - they bright-en up our kitchens and our palates. The citrus family is a large one, and includes oranges, grapefruit, kum-quats (those little "pygmy" oranges, eaten rind and all), lemons, limes, tan-

gerines and even ugli fruit (a tanger-ine-grapefruit hybrid). All are high in vitamin C. And all are colorful, tasty and make good eating. The best way to enjoy any fruit, in my book, is fresh and unadorned, although you are forgiven if you don't feel like biting right into a lemon or lime. Most fruits can come to the table as an instant dessert or snack. But an excellent "cating" food

makes an excellent ingredient, so here are some ways to put winter's bounty to good use. Three of the recipes below — for Kumquat Chutney, Citrus Salsa, and a citrus-flavored Creme Anglaise —

come from students at the New Eng-land Culinary Institute in Montpelier, Vt. The others come from a book that keeps on surprising me with its useful and user-friendly recipes: "Le Cordon Bleu Home Collection: Sauces."

SANFORD - The battle lines are drawn over the possibility of a nonprofit soup kitchen for the needy opening in Sanford's historic district.

Seven residents of the historic district told the City Commission Monday that they will fight against plans by Seminole Volunteer Enterprises Inc. to open a soup kitchen that will feed needy people at 407 W. Fourth Street.

Jean Metts, executive director of Seminole Volunteer Enterprises, said a date has not been set for opening the soup kitchen. She said the agency has spent \$172,000 in Community Development Black Grant money to restore the two

buildings where the soup kitchen would be located.

"We have tried hard to be a good neighbor," Metta said. The people we hope to help are not just homeless. Many of the seniors who volunteer with us are short of money at the end of the month. I want to help working mothers who atruggle to feed their family." Linda Kuhn, director of Main

Street Inc. and a resident of the historic district, said the soup kitchen would encourage joblessness by offering "a hand-out, not a handup." She said the soup kitchen would foster crime in the historic district.



SANFORD - Next school year Hamilton Elementary School is hoping to host a pilot after-school program that will provide learning ac-tivities for children and their families.
