Bullet Riddled Body Of Bomb Suspect Is Found Suspended From Tree

Victim Had Been Taken From Officers Who Had Arrested Him As Plant City Bomber

TAMPA, Fla., April 28.—(AP)—The bullet riddled body of John Hodz, suspect of the Plant City bombing, was found swinging from a tree in an oak hammock 10 miles northwest of Plant City early today by N. M. Davis, a woodcutter, according to Sheriff R. T. Joughlin.

The body was clasped in a cheap black almond coat and white duck trousers. A few minutes after the officials reached the place of the discovery, dashed through the countryside and before the body had been removed, 15 persons arrived in automobiles.

The body was found in a natural gully surrounded by live and palm trees, and the scene undergrowth. The spot is secluded and rarely visited, the road leading thereto being only now and then by woodcutters.

SEVERE BLAST SHAKES YACHT OF VANDERBILT

Flames Shoot High As Terrific Explosion Blows Off Part Of Deck On Large Craft

NEW YORK, April 28.—(AP)—A violent explosion of the largest magnitude ever witnessed in New York Harbor, which occurred Saturday night, has caused a loss of \$250,000 in damage to the yacht of George Vanderbilt, millionaire owner of the famous Catskill Mountain house at Ulster Park, N. Y.





Unruly Convicts In Ohio Prison Renew Their Recent Revolt

MEMORIAL DAY IS OBSERVED HERE WITH CEREMONY

COLUMBUS, O., April 28.—(AP)—Unruly convicts in the idle house at Ohio State Penitentiary renewed their revolt again this afternoon, after 150 Columbus police reserves had been taken from the prison yards. The convicts refused to obey orders of guards and refused to return to their cells.

When it became evident that the convicts in the idle house had decided to resume their revolt again this afternoon, the program was suspended. Lt. James G. Edwards, chief of the Ohio State Penitentiary, addressed the convicts, telling them that if they would give up their rebellion, he would release them.

STATE TAX GROUP QUIZZES CITIZENS ON RELIEF IDEAS

Chairman Says Board Does Not Agree On Sales Tax Problem

MIAMI, April 28.—An interesting public meeting of the Florida Citizens' Committee on Finance and Taxation was held here Monday with a large attendance from the Miami area and from neighboring counties and cities. Each citizen appearing before the committee was questioned closely as to his ideas about tax relief.

"There seems to be a general impression throughout Florida that this commission intends to recommend a sales tax," Perry G. Wall, chairman of the commission said. "I want to say in regard to this that at the present time the commission has no views one way or another. Some of us think one way, some another, but our opinion is withheld until we have all the information before us."

Mr. Wall promised the Miami meeting the best thus far held not only in interest but in attendance. The chamber in which the hearing was held was packed in the morning session and half full in the afternoon.

William R. Griggs of Okeechobee, the last to appear before the commission, recommended some relief for the Florida growers. He told of one instance where a northern farmer had wanted to come to the section around Lake Okeechobee and wished to purchase 100 acres of land. When the taxes were looked up by Mr. Griggs, who investigated, he said, their amount to \$6,600 an acre, and the man could not buy. The back country never will be settled up under the relief if afforded, Mr. Griggs said.

Separation of long haul and local transportation companies of taxation, he pointed out, should be maintained as lines operating within corporation limits are hard hit by present laws, said G. H. Dunn, Miami bus. operator.

His company is operating more than \$20,000,000 miles a year, Dunn said, and last year gas tax totaling \$9,505 was paid and other taxes amounting to more than \$24,000 also were paid. A one-cent gasoline tax added would increase the corporation's \$1,000 a barreling further operation impossible. It will cost \$240, he said.

George Smith, Lakewood, suggested the tax structure be modified, keeping in mind that the main thing needed is law enforcement. Ninety per cent of the people pay the taxes in Florida, he said.

Others who spoke at the afternoon session were C. E. Masterson, Habahab Al. Goldstein, William Fetter, Chicago; Benjamin Seigel and W. S. Lumberg, Cincinnati.

After a hurried meeting of the commission which followed the open session, the members adjourned to their respective rooms by auto and train about Monday afternoon. Members attending here were: Mr. Wall, Tampa; Joe H. Gill and Harry Watt, Miami; G. H. Griggs, Bartow; M. M. Hartman, Jacksonville; Karl H. Quinn, Clearwater; R. A. Hendon, Jay, Fort Myers; J. A. Gandy, Tampa; J. Mark Wilson, West Palm Beach; George W. French, Jacksonville; Cyril Babcock, St. Louis; and Roy A. O'Conor, West Palm Beach.

"So far as I can see, there will be only one real ray of hope in the answer," Perry G. Wall, chairman of the Florida Citizens' Finance and Taxation committee, gave to the question on the objective of the committee in seeking a statement in The Sanford Herald. Mr. Joseph D. Mahan, chair of the committee, responded to the query by saying, "The way to get the Florida citizens to put the tax relief in the law is to put the tax relief in the law."

"We have divided our committee into subcommittees, of which I am chair of the Miami subcommittee. We are going to meet in Miami next Saturday and begin to make a concerted and organized effort to get down the over-head. Our committee is not taking any stand except that the tax relief must be distributed to everybody and with more fairness."

"These hearings are open to the public to talk with the public wants. We must get on the pension, we must get better roads in every state in the union and return to the people of Florida what we think will help the healthy condition in real estate. Those of us up to the legislature should see fit with the over-head and we are able and do."

"Principal objections to a sales tax for Florida and especially the Miami area were expressed by Mr. Babby and Mr. Whitten, driving the car to away, and the business men of the city of neighboring states getting equally split on ten and political machine for enforcement and forcing retail merchants to take the risk of losing their millions of their hope for any pro-

8 Spectators At Airship Exhibit Killed In Crash

Authorities said today they learned from some of the spectators near the accident that one of the reasons for selecting the site to view the exhibition was that an admission charge was made at the field proper.

Spectators in the crowd of several thousand which had surrounded the field proper said the plane was heading for a landing at an elevation of only 10 feet when it dropped suddenly on the group gathered on the embankment. Al Gombert, manager of the flying organization which sponsored the exhibition with the American Legion post, said he believed the plane struck a downward current.

"It was over so quickly I couldn't tell what happened," said Covert. He requested a physical examination after the accident and said doctors found him to be condition to operate a plane.

Covert had taken up the plane alone three times, he said, to become accustomed to a brisk wind from the south. He then took up two passengers and it was on his return from this flight that the crash occurred. He had planned to follow the passenger trips with a series of stunts.

Four of the victims were decapitated by the propeller of the plane and the others were crushed by its weight. Gombert said the spectators had been warned several times not to stand near the embankment.
