DEMPSEY WILL BEGIN TRAINING SOON FOR GENE

Former Champ Ayers Stories About Being Poisoned And Throwing Fight "Hokum"

LOS ANGELES, Dec. 7.—(P)—Jack Dempsey, former heavyweight champion, waiving the formality of a few warming up fights, will start training next week in the hope of having a return bout with Gene Tunney, to whom he lost the world's title last September at Philadelphia.

This he announced today saying: "If I can come back, I can whip Tunney, and if I can't come back, I'm through with the fight game. I don't want any 'set ups'."

Replying to reports that he had been poisoned before the fight with Tunney, the former champion declared:

"All this stuff about throwing fights, being poisoned or worried to death is a lot of hokum. Tunney can whip any man in the ring today. He is a stiff counter puncher and while I think he could have whipped Fights—and probably held Carpenter even—Jess Willard and Bill Brennan would have slaughtered him."

"I was worried in Philadelphia the day of the fight, I had enough to worry me with a lot of litigation hanging over me—but it didn't bother my fighting ability. I lost to Tunney because I was over-trained—down too fine."

A fast semi-final has been arranged for tonight, according to Dr. George Lewy, who is promoting the show, and another bout between two boys who are to weigh in at 1700 pounds is also listed. The fight between the heavies brings out both Sanford and Orlando fighters to pair off with each other.

"The next time we meet—and I sincerely hope we do—Tunney will be the defender—he will carry the load of a title."

Involve Two Decades
Dynastic Changes In
Country; King's Operation
Encourages Other Rumors

RIG, Dec. 8.—(P)—Fresh
news of a grave crisis in Rumania,
with conflict between the king
and far-reaching designs for
changes in that country.

Two almost simultaneous
announcements that King
Carol would undergo a so-called
internal operation from

the plan is in place, former
Prince Carol on the throne
since his son died in the event of
his father's death. This to be
followed by establishment of
a constitutional monarchy, the
leaders of which are John
Mihai and Dr. Niculae Iancu.

The other is a reported scheme
by the former Premier Ionel
Bratianu and his brother Vintila, who
are the real rulers of
Rumania, "to hand over the crown
to an unnamed British prince after
a period of rule by the re-
gency as at present constituted."

The army is said to be thoroughly
sympathetic with the ambitions
of the ex-monarch, Prince Carol.
But what Rumanians are not
told is what British schemes, if
any, are being plotted.

The reported Bratianu plan is not
clear, but it is said in any event
it would only be attempted after the
return of the regent, General of
Finance Nicholas, the president of
the supreme court, and the Rumanian
patriarch had actually
shouldered the reins of power over
more or less protracted period.

In certain, however, say the
former Rumanians here,
British schemes are opposed to
any changes whatever in the

DECISIONS TO BE GIVEN BY JUDGES IN ILLINOIS RING

Western State Joins New York, Pennsylvania In Changing From Method Deciding Winner

CHICAGO, Dec. 8.—(UPI)—Illinois today joined New York and Pennsylvania in providing for boxing decisions by two judges, as they did before.

The State Athletic Commission decided upon this method after it had voted to uphold referee Henry W. Moore's decision awarding the middleweight title to Mickey Walker in his ten-round match last Friday with Tiger Flowers.





