Washington Believes England and Japan Favor Proposal Chief Executive Expressed To France, Italy
Business of French toward Britain May Develop Opposition

WASHINGTON, Feb. 11.—(INS)—Coolidge's bold application of the acid test to the sincerity of the world's great navies, it was said today by those of this government, would win whether the proposition in favor of disarmament are genuine, or if they are mere palliatives, meaning and effect.

Expectation prevails in Washington that Great Britain will respond favorably to Coolidge's invitation to go to the conference. No such expectation, however, prevails as regards France and Italy.

France that prevented the conference from limiting submarine, destroyers, and the like, now proposed to be limited. The French navy minister, however, has announced that he will not limit the number of his submarines as the British navy minister has done.

British relations have recently improved since 1921, in addition there has arisen in Italy, with his ambition to revive the glories of the ancient Roman Empire, a Mediterranean for its lake, a ambition that France has in recent years with distinct and mingling, as expected by some recent flat in both Paris and Rome.

The Wisconsin congressman's resolution, drafted after he had consulted many other congressmen, was regarded as due notice that the opponents of President Coolidge would try to keep the third-term issue in the forefront until the election in 1932.

In some quarters it was regarded as a retaliatory move by farm relief forces to offset the continued effort of opponents of the McNary-Haugen bill to convince congress that President Coolidge will veto the bill if passed.

Representative Tilton, of Connecticut, Republican leader, promptly declared that the Beck resolution would not get in the House certainly.

It is certain that the place for that question to be settled is among the people and in the Republican convention and not in Congress," he said.

Metal Magnate Tells Of Dinner Given To Miller
Richard Merton Takes Stand Again In Daughters' Trial To Describe Banquet That Preceded \$391,000 Payment

NEW YORK, Feb. 11.—Richard Merton, German metal magnate, resumed the stand today at the trial of Harry M. Daugherty, former attorney general, and Thomas W. Miller, charged with conspiracy, and described a champagne dinner which preceded his payment of \$391,000, the alleged bribe on which the prosecution is based.

Merton stated that the dinner occurred at a New York hotel on Sept. 30, 1921, and that of the next day he gave the \$391,000 to King and John T. King, congressional lobbyist. The money was paid in four installments of \$97,750 each, and was deposited in the name of the government to be split between Daugherty, Miller, King and John Smith, a friend of Daugherty's.

The prosecution then introduced into evidence an expense voucher signed by Miller showing that he made a trip from Washington to New York on the day the now famous dinner took place.
Several employees of the hotel held up their records and the clerk of another hotel, then testified that Miller used the rooms of Gen. Coleman Du Pont, as a guest, on the night of the dinner.

Another hotel employee said Jess Smith stayed in the rooms of the hotel in New York, according to further testimony, stayed at a Washington hotel from September 19 to 21, 1921.
John T. Durkin, King's private secretary, testified that he took care of his employer's bank books and private papers.

Railroad Executive Leaps To His Death After Beating Nurse

Edward Chambers, 68, Vice President Of Santa Fe, Has An Attack Of Insanity
Worked For Road Nearly 50 Years
Dead Man Described As One Of "Greatest Traffic Heads"
SAN FRANCISCO, Feb. 11.—(INS)—After beating a nurse and barricading the door, Edward Chambers, 68 vice-president of the Santa Fe Railroad, leaped to his death today from his fourth floor room in St. Luke's hospital here.

Surgeons at the hospital expressed the belief that the Chicago railroad executive had experienced a sudden attack of insanity. He was recovering from a stroke operation performed ten days ago. Chambers, a workaholic, was working at his post when he was stricken, and suddenly attacked the night nurse, Miss Florence Taylor, who was sleeping in a chair beside his bed. The nurse, after a struggle, broke away and ran to the corridor, screaming for help.

Chambers started to follow her, but he was stopped by a doctor. When doctors and attendants tried to enter the room, he locked the door with a heavy iron chair. The terrified attendants then heard his tearing about the room in frenzy, smashing everything within reach.

Finally the door was broken down, police said. As the medical staff started to enter the room, Chambers leaped from the window, falling forty stories in a vertical race to the street.

Chambers worked for the Santa Fe for forty eight years, starting as a laborer.

NEW YORK, Feb. 10.—All standing and sitting records for player turnover in the major leagues were broken beyond recognition today with the announcement that the New York Giants had taken title to Ed Roush in consideration for the passing of George Kelly to the Cincinnati Reds. That one just about closed the book, unless I am grossly in error in the notion that the Yankees are not seriously considering a transfer of Babe Ruth to the Phillies and that the Senators aren't likely to send Walter Johnson to Fort Wayne for further seasoning.

They are, with the sole exception of George Sisler in St. Louis, the only ranking figures of the profession who have remained, as is, during the exigencies of this most sensational of all off seasons.

Suppose you are informed of the conclusion of the last world series that the winning manager, Rogers Hornsby, would be traded to the New York Giants before another season began. You would have laughed in great glee. Suppose it was the day that Ty Cobb, Detroit institution and greatest player of the day, age, generation and time without memory, would appear during 1927 in the uniform of the Philadelphia Athletics and that Tris Speaker, deft native genius and great hitter, would leave Cleveland for Washington. You would have been entitled to punch your informant full on the nose on general principals. But you've have to go back now and apologize like a little gentleman.

However, if you still were conscious after the Cobb-Speaker shock, the next thing would be to demand bigger and better pads of cells after you were informed that Eddie Collins would leave Chicago for the Philadelphia Athletics; that Frank Fisch would leave the Giants for the St. Louis Cardinals; that Zach Wheat would leave Brooklyn for the Philadelphia Athletics and that Burleigh Grimes would leave Brooklyn for the Giants.

By that time, any sensible man would wish to leave the vicinity for the sake of his health.

And now Kelly for Roush. Roush, of course, will play center field, giving McGraw his first real star in that position since Denlin's day.

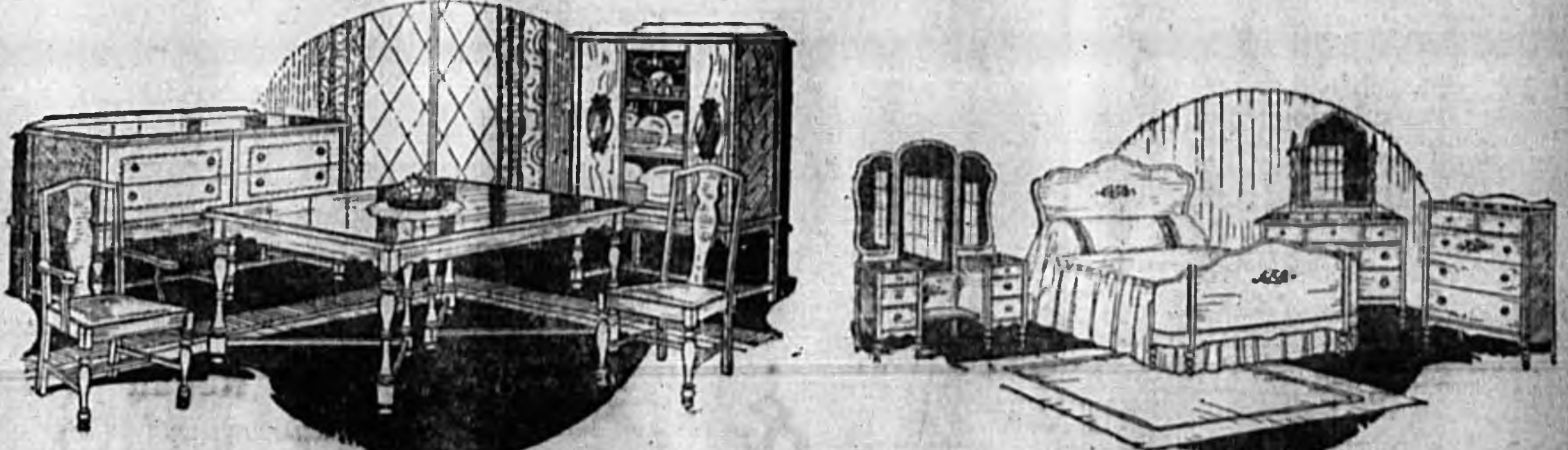
