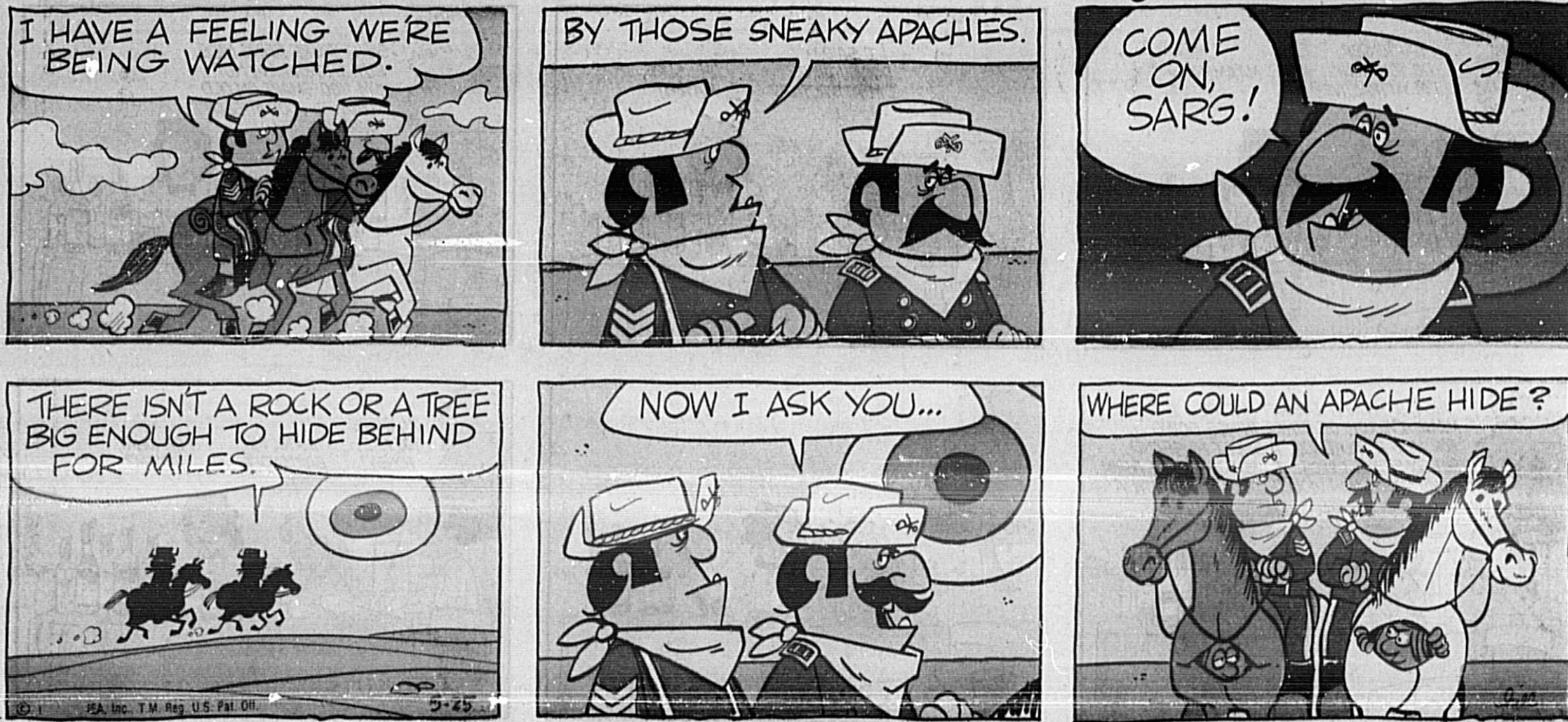


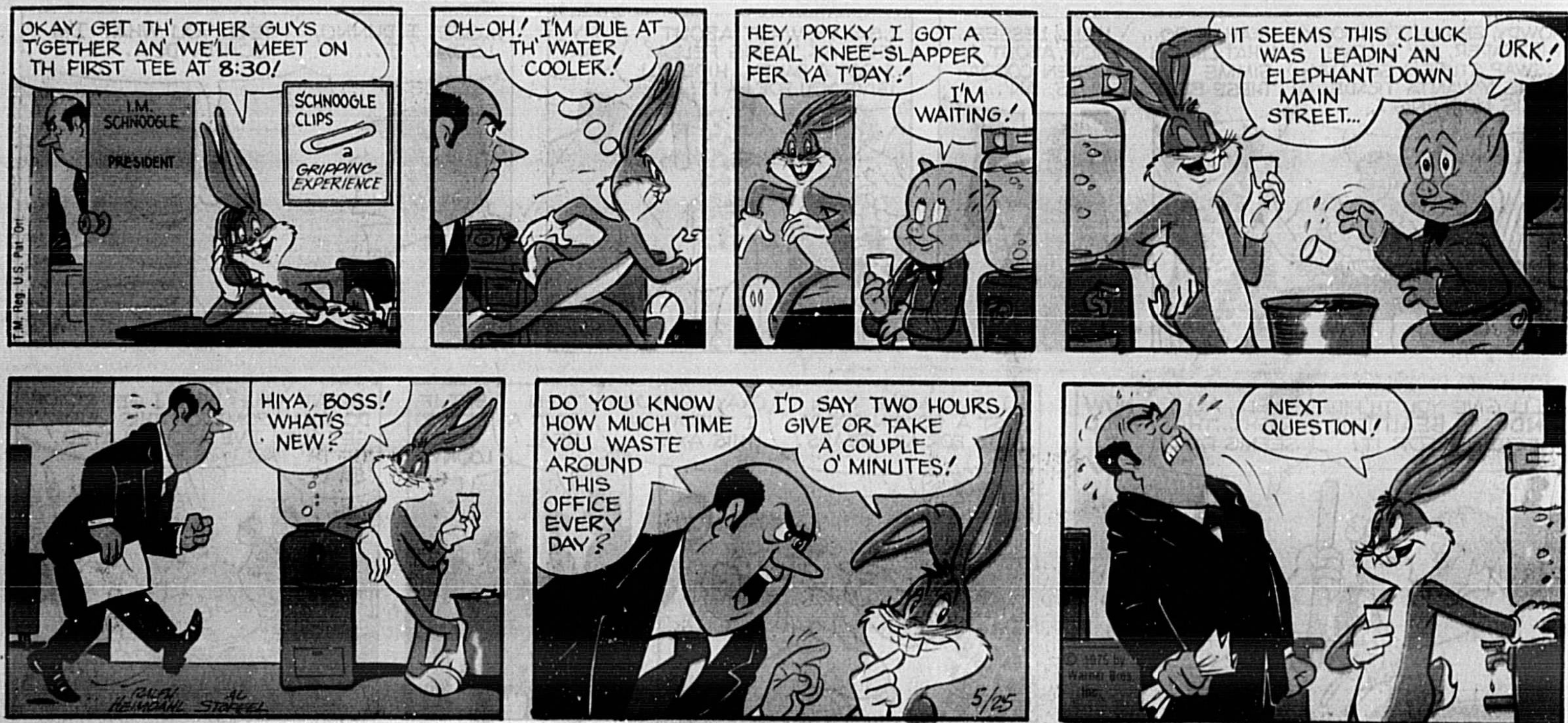

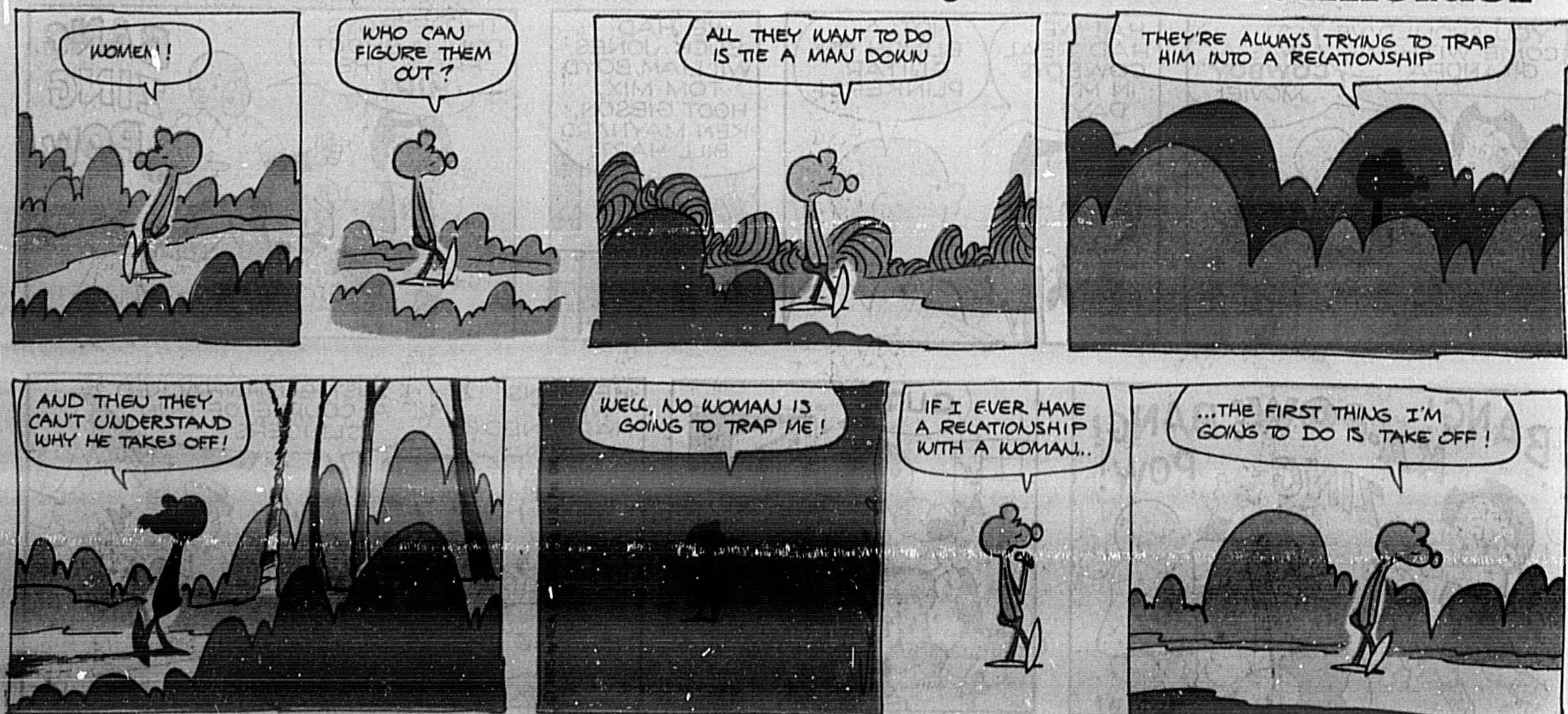

## Longwood Teacher Claims SEA 'Misrepresents' Facts

In a prepared handout, a Longwood elementary faculty representative who calls herself the "leader of a dissident teacher group" today called charges that Longwood teachers are interested in the American Federation of Teachers (AFT) a "deliberate misrepresentation."

"Gene Grooms knows full well that the position of our group is that we want no union representation at all. We've even been down to his office to tell him about it," Mrs. Constance Moore said.

Last week, the School Board's chief negotiator, Harry Pelley, advised the Longwood faction to hold meetings after school hours only. That advertisement

came after Grooms, the executive director of the Seminole Education Association (SEA), threatened to file an unfair labor practice complaint with the Public Employees Relations Commission (PERC), the state agency that sets collective bargaining guidelines for the entire state.

What Grooms was protesting was the fact that a meeting in which an AFT representative spoke to Longwood teachers was held on campus and during school hours.

That meeting, according to Mrs. Moore, was okayed by Longwood principal Arietta Coberly for 3 p.m. School lets out at 3:45. However, Mrs. Moore contends Mrs. Coberly didn't know who the featured speaker was. The featured speaker turned out to be

AFT's Bob Allan of the United Teachers of Orange. Grooms said that during-school-hours meeting was a violation of Florida's bargaining laws. He also said SEA is considering filing a protest to the Professional Practices Commission (PPC), a state agency with investigatory powers.

Asked about the AFT session which occurred last Wednesday, Mrs. Coberly replied, "You don't talk to me about that. That's out of my jurisdiction." But Mrs. Moore confirmed the meeting, and Pelley advised during-school-hours sessions cease.

Pelley said the meeting was held on an early dismissal day, which is a day, according to Mrs. Coberly, when a teacher is allowed to go home early if that teacher has all of his or her work completed.

Longwood has been a beehive of activity, most of it in opposition to the SEA. However, a petition to the School Board requesting an investigation of SEA's validity was signed by only six teachers. Various meetings have been scheduled at the Longwood campus, and speakers have been invited from different organizations.

The AFT meeting, Mrs. Moore says, was the only session held prior to the time school lets out. Today at 4 p.m., a meeting is scheduled to organize an association to speak for professional educators in Seminole County.

A major complaint the Longwood faction has is collective bargaining and the proposed 75-page master contract presently being negotiated between

SEA and the School Board.

Mrs. Moore claims "SEA is embarrassed by questions we are asking" about the contract proposal and as such are throwing up a "smokescreen" to confuse teachers.

SEA, on the other hand, says collective bargaining always has been the prime goal of any teacher organization. SEA officials also say teachers will have the final vote of ratification on any contract negotiated by the SEA team.

Mrs. Moore says SEA should have circulated copies of the contract proposal for all teachers to read for themselves.

Copies of the 75-page proposal, due to cost factors, were presented to Pelley's team members.

## 6-Year-Old's Death Is Probed By Police

Sanford Police are investigating the death yesterday of a six-year-old Sanford child, who died one day after his mother reportedly had given him "worm medicine," to cure diarrhea.

Police said the child, Lucious C. Inman, 1206 W. 4th St., was dead on arrival at Seminole Memorial Hospital at 10:30 a.m.

An autopsy on the death is expected today, according to police.

Police report the child had been sick for "some time" and appeared to have diarrhea on Saturday and Mrs. Inman was said to have administered the worm medicine.

Sanford Detective Lt. William Lykens said today no charges would be filed until an autopsy is completed.

## Board To Hear Parents' Input

Today at 4 o'clock is "parent input" time concerning the controversial School Board decision to close Rosenwald Elementary.

Initially, Laver recommended that Rosenwald be converted, but asked that the board bus some 207 black students to Lake Orienta, a new school scheduled to open next year.

## America's Holiday Is Mixed

Americans in all their variety of tastes and longings sought ease and release from daily tensions over the Memorial Day weekend, and at the same time remembered that the holiday was called to commemorate the country's war dead.

It was a holiday of triumph: Bobby Unser won the Indianapolis 500 for the second time and in Nashville, Tenn., Gary Chmley, a 22-year-old service station attendant, saved the life of a youth who had taken an overdose of a tranquilizer and tried to drown himself.

"As long as there are lawbreakers in the world, we must have the strength and resolve to stand up for what is right," President Ford said in Arlington, Va., at the Tomb of the Unknown Soldier.

As the final hours of the Memorial Day weekend ticked away, traffic fatalities continued to mount, reaching 264 by morning.

Stormy weather across the Central Plains into the mid-Atlantic seaboard cut down on travel somewhat in those areas, but fair skies and hot temperatures in western and southern states and in New England virtually guaranteed that holiday goers would clog the highways seeking their first full taste of summer.

## Various Reasons Given For Legislative Failure

WASHINGTON (AP) — Congressional Democrats have various explanations for their failure to legislate an energy conservation program for the nation. Some blame the Senate for not bringing legislation to get agreement before the current recess. Others say the freshmen aren't following enough. And others, including Senate Majority Leader Mike Mansfield, fault the committee system for permitting overlapping and competitive jurisdictions within Congress.

## 'Violation Of Trust'

CHICAGO (AP) — Women raped by men they know suffer greater psychological damage than those raped by strangers, a University of Illinois medical school sociologist says. "It is certainly not surprising that when a woman is raped by a man whom she has known well and has probably trusted, her ability to function sexually is very likely to become impaired," Dr. Pauline D. Bart said. "To be raped by a stranger is a violation of your body; to be raped by someone you know adds an even crueler violation of trust," she said.

## S. Vietnam Cooperating

WASHINGTON (AP) — The new head of President Ford's interagency refugee task force says the South Vietnamese government is cooperating with the United Nations in negotiating about refugees who wish to return to their home country. Julia Vadeis Talt said in an interview that the names of those who wish to return are being submitted to the U.N. high commissioner on refugees, who will submit them to the new governments of Cambodia and South Vietnam.

# Congressmen Make Holiday 'Inspections'

WASHINGTON (AP) — At least 49 members of Congress are taking advantage of the Memorial Day recess to make trips to Europe to investigate at taxpayer expense.

The trips include an inspection tour of NATO facilities, visits to the Paris air show and travels to look into the treatment of Jews in the Soviet Union and to examine prison systems in Sweden and Holland.

Time for sightseeing and shopping is set aside along with the work and members have time off at night for entertainment.

They get expense money plus their travel costs but members taking their spouses have to pay extra.

On the NATO trip, for example, the Pentagon says each of the 16 House members and one senator are getting \$825 in government funds for expenses.

The trip to Berlin, Brussels, Rome, Naples, Vienna, Athens and the Azores began after Congress began the 10-day recess Thursday night.

A Pentagon spokesman, when asked how the members were selected for the Pentagon-sponsored trip, said "most are members of the House International Relations Committee and the others all have an interest in NATO affairs."

But only two of the congressmen are members of that committee, Reps. Dante B. Fascell, D-Fla., and Robert J. Lagomastro, R-Calif. Five others are on subcommittees dealing with NATO affairs. They are Sen. Roman L. Hruska, R-Ohio, and Reps. Clarence D. Long, D-Md., Edward I. Koch, D-N.Y., Burt L. Talcott, R-Calif., and Edward T. Patten, D-N.J.

The 10 members not on any NATO-related subcommittee are Reps. Phil M. Landrum, D-Ga., Herman T. Smeeth, R-D-Mark, Andrew R.N.D., Don H. Clausen, R-Calif., Del. Clawson, R-Calif., Robert B. Duncan, D-Ore., C.W. "Bill" Young, R-Fla., Yvonne Brathwaite Burke, D-Calif., William N. Ketchum, R-Calif., and Trent Lott, R-Miss.

The Memorial Day Meaning

Memorial Day has always been a bittersweet holiday in America. But it is especially sad when the occasion for special remembrance of those who have fallen in the nation's wars becomes a matter of what is convenient — or profitable — for the commercial community.

Perhaps Americans no longer want to be reminded of the sacrifices of their wartime dead, especially this year when the loss of more than 56,000 of them in Vietnam is so fresh in mind and seems to have been so unnecessary and so useless.

We happen not to believe it. We believe that certain things are more important to Americans than the recreational or money-making opportunities afforded by a three-day weekend and that if they were asked, the majority of them would vote to put the holiday back where it was for more than a century.

As it is now, Memorial Day is just another Monday, different only because most of us don't have to get up to go to work.

There has to be both sympathy and applause for President Ford in his decisive actions that succeeded in saving the crew of the freighter Mayaguez seized by Cambodians in the Gulf of Siam.

Sympathy was due the President as he moved to discharge his constitutional function as commander-in-chief in time of crisis. Where the safety of the ship's crew was concerned, time was of the essence, but the War Powers Act of 1973 obliged Mr. Ford to seek congressional approval before he acted.

There is a valuable lesson in it all — that neither diplomacy nor military action can be accomplished by committee. Our Constitution did not contemplate any such arrangement, and the sooner we get congressional and presidential powers back in balance, the better.

Lebanon Premier Bows To Protest, Quits

BEIRUT, Lebanon (AP) — Moslem opposition forced Lebanon's first military premier in 32 years to resign today after only three days in power.

Brig. Gen. Nouraddin Rifai, 76, announced he was quitting after a storm of protest greeted his appointment. Gunfire and grenade explosions continued during the night, and police said most of it came from leftwing Moslem Lebanese militiamen trying to drive Rifai out of office.

President Suleiman Frangieh named Rifai premier Friday night after a week of street fighting between Palestinian guerrillas and Christian Phalangist party. About 100 persons have been killed in the street fighting and about 300 have been wounded, according to unofficial police counts.

A joint Lebanese-Palestinian committee called for a cease-fire and said joint patrols began touring the streets during the night trying to stop the firing and to get the warring factions to dismantle their barricades of barbed wire and sandbags.

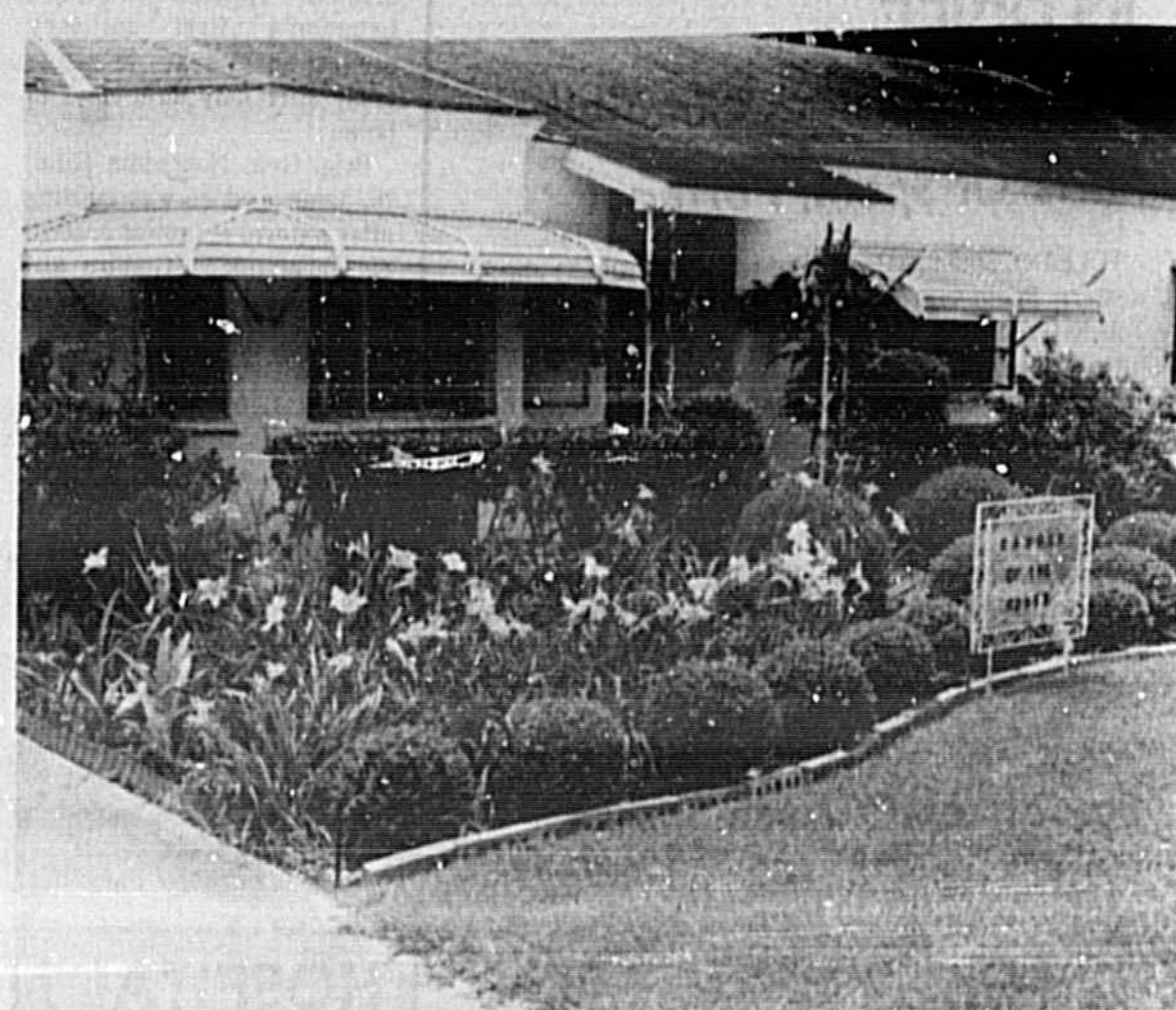

No Booze For Diabetics

DEAR DR. LAMB - My husband has been a diabetic for at least six years. He has been under the doctor's care ever since he found out about it. The doctor has told him he can have a six-ounce glass of white wine with his main meal every day. Whenever he drinks anything with alcohol his eyes get as red as a beet, also his neck and top of his chest and he has trouble breathing. By that I mean just one small glass on the average of three times a day. When he asks the doctor about this he gives him no answer. Could you please help us on this.

I was wondering if it is his blood pressure. But the doctor says it is all right. He only goes for a blood sugar test every four or five months. Is that frequent enough? My mother was a diabetic, but she used to send her for a blood sugar every four to six weeks. Isn't that proper? My husband goes into the hospital on the average of three times a year because of the sugar. DEAR READER - Alcohol has a pronounced effect on the level of blood glucose. In order to metabolize alcohol, a basic enzyme (NAD) in the liver is completely tied up. You need this enzyme for the chemical actions the liver must perform to release glucose into the bloodstream. The liver is the main organ that maintains a fairly constant level of blood glucose. When the blood sugar is too low the liver normally releases glucose into the blood or convert amino acids from protein into glucose. When the liver can't do this because it is processing alcohol, low blood glucose levels are apt to occur.

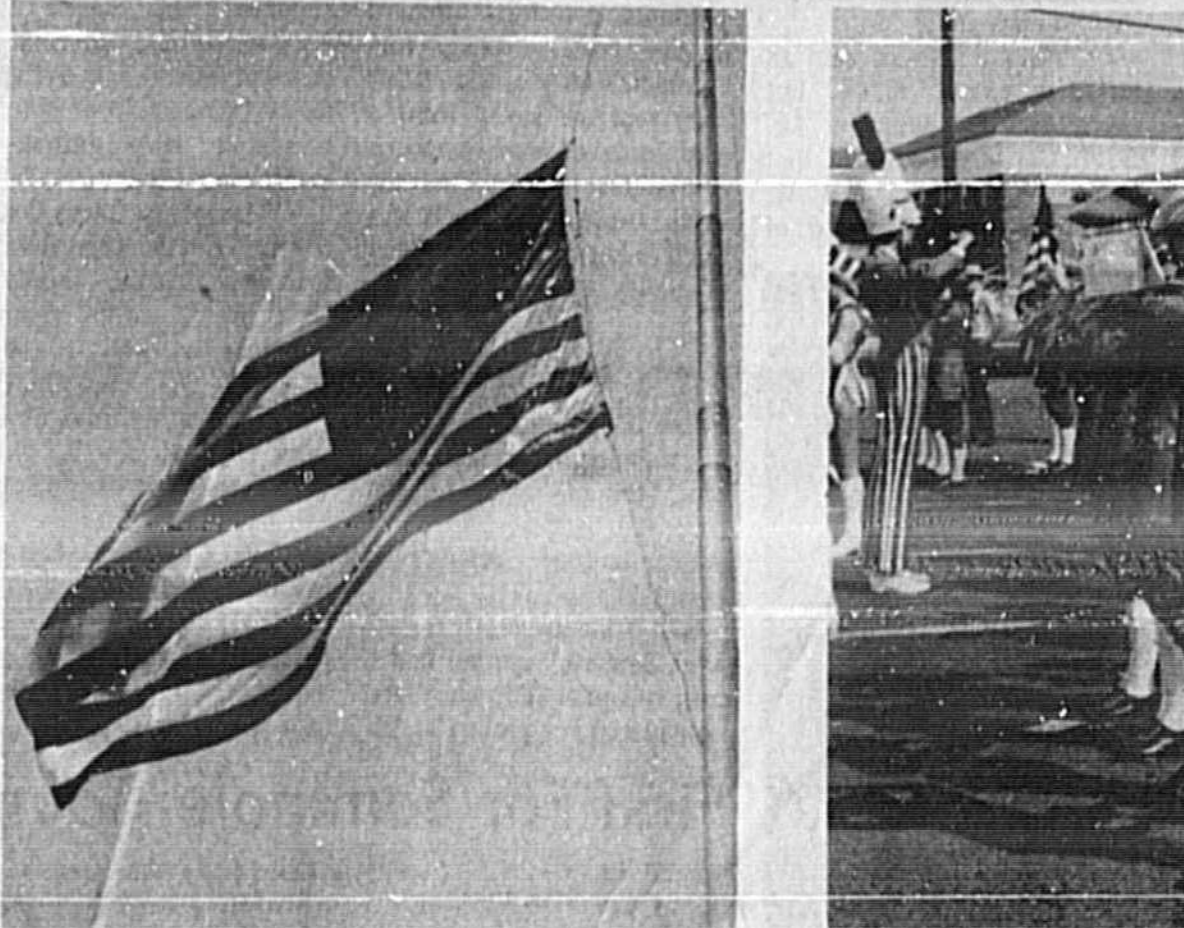

O'Malley Ouster Recommended By Select Committee

TALLAHASSEE (AP) - A select House committee has recommended the impeachment of Treasurer-Insurance Commissioner Thomas O'Malley on charges of extracting more than \$72,000 from insurance companies that had vital matters pending before him.

The House impeachment committee did not consider those charges because of the pending court case. The articles of impeachment charge that O'Malley took more than \$70,000 from his former Miami law partners, Bennett Feldman and Ricardo Carvalo, for referring insurance company clients to them.

O'Malley was re-elected last November while under indictment. He faces trial June 28 in Tallahassee on charges of accepting \$140,000 in kickbacks from a banker and perjury by failing to list the money on a state gift-report form.
