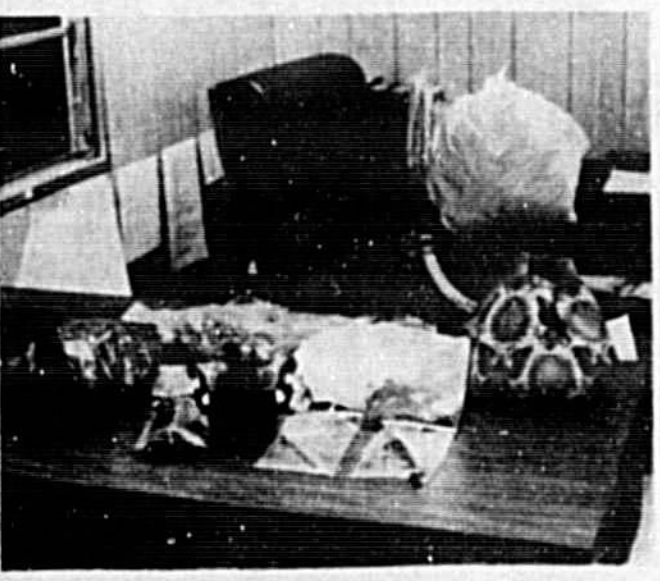

## 5 Are Arrested For Narcotics

Leonard Schildhouse, 708 Hermit's Trail, Altamonte Springs, was arrested on a warrant issued by Justice of the Peace Gene Ewald, charged with possession of marijuana (under five grams) and possession of narcotic paraphernalia. Bond was set at \$500 on each charge.

## Spry Found Guilty; Attorneys Appeal

Jack Spry, 36, Longwood, was found guilty of manslaughter by a five-woman, one-man Circuit Court jury on Friday. Spry was convicted in the June 2 beating death of his common-law wife Victoria Wesoowski, 36, in which he had been charged with second degree murder.

Spry was immediately sentenced by Circuit Judge Richard Muldrew to 15 years at state prison. The defendant will be eligible for parole in seven years.

Although Spry has had his day in court, the case lingers on with the statement from Assistant State Attorney Newman Brock that he will appeal the directed verdict of acquittal of second degree murder charges handed down by the court on Friday.

The court contended depravity of mind, an element of the charge, had not been shown by the state during the trial.

Brock argued testimony indicated the victim was drowning in her own body fluids, that she was unconscious for 16 hours and that five people testified the numerous bruises over the victim's body were recent.

Brock argued second degree charges must prove there was wanton disregard for a human being, and that the jury should decide the facts and the court decide the law. Further, he declared, the state had proved the facts.

Judge Muldrew contended that the only depravity of mind shown in the case was in the multitudinous bruises, and the court did not know the age of these bruises. Also, the court said, the defendant did not deny hitting the victim, but claimed self defense because she was attempting to cut him with a razor. Judge Muldrew disclosed the defendant did not attempt flight, but assisted the victim and called an ambulance.

## Airport Traffic Puzzle

A group of Airport Boulevard residents, as well as members of Sanford Airport Authority, are expected to appear during tonight's Sanford City Commission session to discuss a proposal to reroute bus and other heavy vehicular traffic away from that portion of the road that runs between U.S. 17-92 and Sanford Avenue.

Mrs. Natalie Emerson and other residents of the area, have appeared before the commission to request a portion of the road be barred to heavy type vehicles, which, they said, are causing an unsafe condition to exist.

Since most of the heavy traffic such as buses and trucks are coming to and from Sanford Airport, the situation has been brought to the attention of the Airport Authority panel which controls the airport operation. J. S. Cleveland, airport manager, has said the prohibition of heavy vehicles from using the strip would cause an economic problem to those firms having to re-route their vehicles along Old Orlando Highway or use 25th Street as an exit to Sanford Avenue.

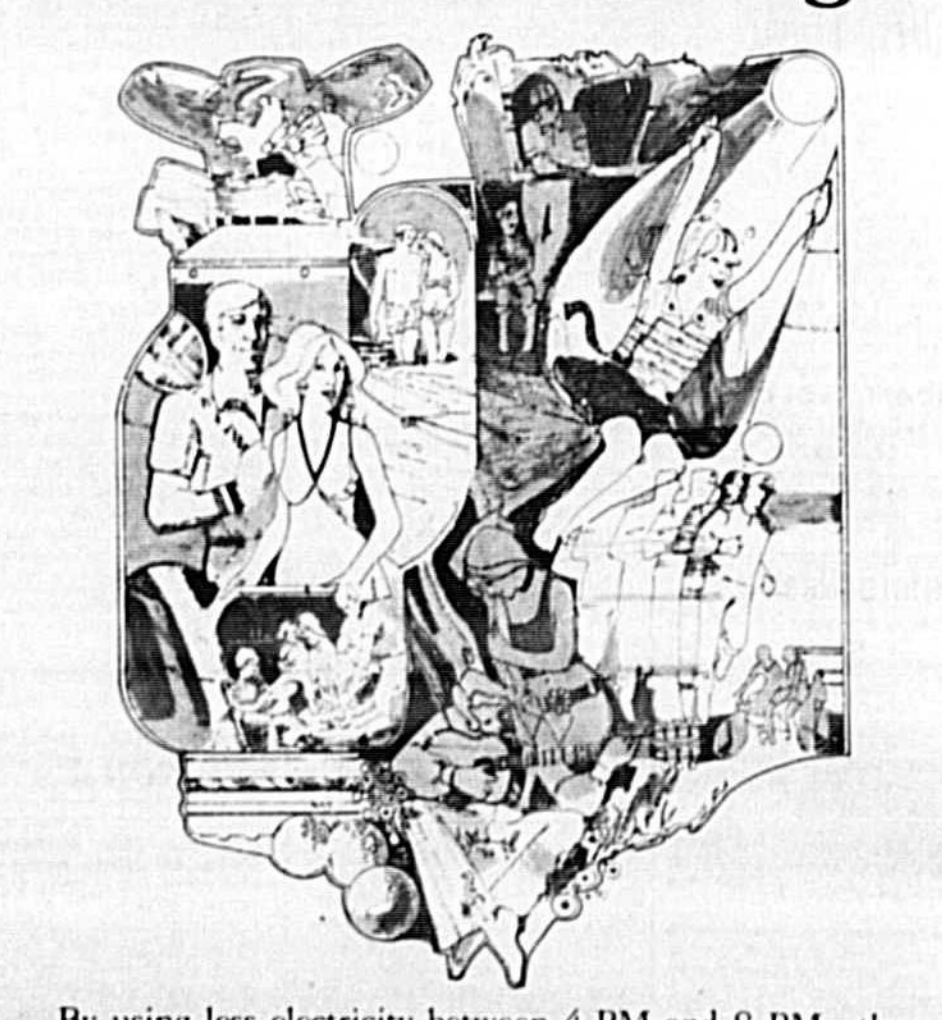

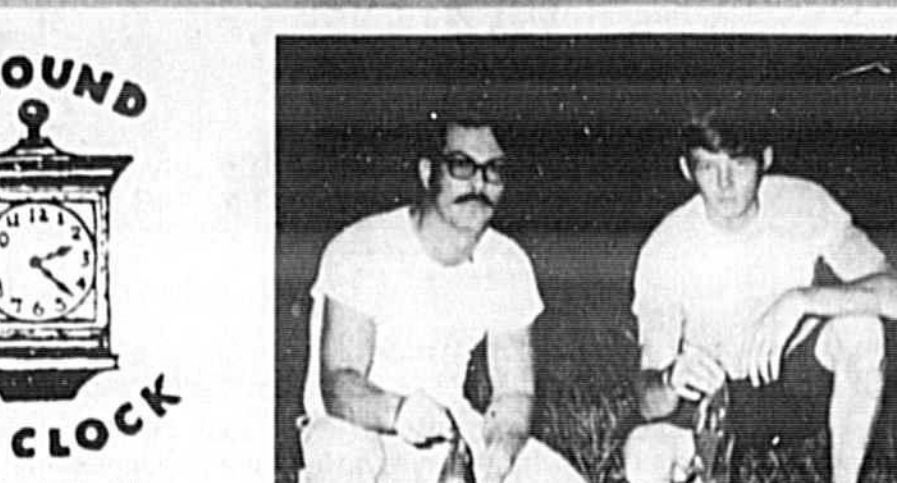

## County Urges Joint Program City Frowns On Road Plan

Sanford City Commission appeared dubious Monday evening to an overture from the County Commission for the city to participate in a joint street paving program.

W. E. Knowles, city manager, advised the panel of the request by the county for a list of roads on which joint city-county paving participation can be established.

Knowles mentioned as possibilities Airport Boulevard from SR 46 to County Club, which needs widening and surfacing portions of which are not in the city; Airport Boulevard from the Orlando Highway to the airport and Celery Avenue from Sanford Avenue, east to the Osteen Bridge.

The city manager recommended the county approach be handled with caution and further advised the county is now responsible for what formerly was state secondary roads.

Major Lee P. Moore agreed and pointed out the latest such incident was the installation of a light, which the city finally had to fund in total.

The city manager said in answer to complaints of road residents authorized W. C. Hutchinson, city attorney, to draw up an ordinance prohibiting the heavy vehicles from using the road but the ordinance was never implemented after the Airport Authority, Knowles and Ben Butler, police chief, advised it was not necessary.

## Ordinance 'Unavailable' Longwood Eyes Rate Hike

LONGWOOD — Substantial increases in the city's water rates ranging from 21 per cent for minimum users to 80 per cent for certain commercial users is contained within a new ordinance proposed for adoption by City Council.

The new rates were proposed by the city's water committee composed of Councilmen Agnes Weiser and E. E. Williamson. Council discussed raising the rates this morning at a work session with City Engineer William Palm, who insisted current rates penalize small users and give too much advantage to large users.

It was predicted nine months ago that a substantial increase in the water rates could be expected. However, the engineer and council have consistently insisted that the change would give the low users a break in rate.

Palm discussed his recommendations for increases in rates. However, it was reported that the water committee recommendations were somewhat different.

At the same time a copy of the proposed ordinance was not available at city hall. Mrs. Weiser and council Chairman
