PUBLICITY IDEA FOR CELERY IS GETTING AHEAD

6 Percent Of Acres Has Been Signed Up On Agreements To Advertise Product

Workers for the celery advertising campaign started out this morning with renewed enthusiasm as a result of the committee meeting last night at which it was found that 65 percent of the total celery acreage in the state had been signed up on advertising agreements. It was decided at the meeting last night to put the date for growers' contracts on a more intensive basis during the next two weeks with the expectation of securing the necessary 80 percent of the acreage within that time.

The workers in this campaign have been congratulated upon the excellent progress made during the past few weeks," said H. J. Johnson, chairman of the Celery Advertising Committee, "but we must continually continue any 'spurting Thomas' as is the final outcome of the campaign. The others have concluded that the idea of advertising in the way majority of growers in Seminole County, and that they realize something of this nature might become more popular to stimulate our market."
