Compressed Air Motor Popular In Germany

BERLIN, Nov. 27,-Compressor motors on automobiles are finding favor in Germany with drivers who want speed. This compressor attachment is similar to the supercharger as used for high altitude airplanes; compressed air is forced into the intake manifold and results in a supercharged fuel air feeding the cylinders.

The result of the compressor's action is an instant additional power impulse, amounting to more than fifty per cent of the normal motor performance. For instance, climbing a steep hill with full power and a motor slowly decreasing

in revolutions, a compressor-equiped car will suddenly leap forward with a roar and pick up new speed, after the normal maximum limit has been reached.
