Tw ounces of grapfruit juice has be come the standard for each poind loaf of grapefruit bread.

"We cannot expect to have a bread eaten in Florida made with eitrus juice, Lut if even a fair percentage is made, it will provide an excellent outlet."





#### Freedom

The meeting of a group of fascists in New York City not long ago, followed a few nights later with a meeting of a group of communists, both of which were designed

of a group of communists, both of which were designed to stir up opposition against the government of the United States and nearly resulted in free-for-all riots resembling miniature revolutions, gives rise to the question as to just how far freedom of speech and assembly in the United States are supposed to go. Everyone recognizes that freedom of speech does not give a person the right to stand up in a crowded hall and shout fire, when there is no fire, just to see what will happen. Nor does one have the right to mount a soap box at a busy street corner and harangue a crowd either with the intent of effecting a lynching or of merely blocking traffic. traffic.

But if our freedom of speech clause carries with it no right to precipitate a stampede in a theater by shout-ing fire, does it give a radio priest the right to inflame a portion of the public against another portion of the pub-lic with the possible disastrous consequences of race riots

and bloodshed 7 And if the Constitution of the United States is elastic ough to permit the consorship of the radio and the muzzling of avowed communists and fascists who rail against the laws and customs of this country, where is the line to be drawn between one who violently advocates a revolution to overthrow the government, and an article New Deal Democrat who shouts hardly less voeiferously that the Administration has betrayed the coun-ry and should be drawn and quartered?

Is there not at least the danger that when laws are passed to prevent the assembly of communists or fas-cists, the law might easily be expanded to include any other political party not at the moment in power, and that if anyone can be jailed who denounces the republican form of government, the time will come when it will be illegal to denounce a Republican?

These are just a few of the questions which today are troubling those who still believe in freedom, and al the moment no one seems to have the exact answer.
