LOW BIDDERS FOR ROAD CONTRACTS ARE MADE PUBLIC

Chairman Hathaway Declares Lowest Bidder Will Not Secure Contract For All Of Projects That Are Opened

TALLAHASSEE, Fla., Jan. 28. (INS)—Apparent low bidders in the \$2,012,685 road contracts which were opened yesterday at the state road department were announced here today.

Society Flocks To English Court To Hear Libel Action

LONDON, Jan. 28. (INS)—Thousands of fashionably dressed women and men crowded into Justice Avey's court today in the King's bench division to hear the libel action of Capt. Peter Wright against Lord Gladstone.

Wright charges Gladstone uttered a libel when he wrote a letter to the secretary of the Bath Club, denouncing Wright as a "snob."

Gladstone's letter was in protest against a passage in "Portraits and Criticism," written by Wright, in this book Wright referred to William E. Gladstone, former premier and famous figure of the Victorian era, stating that he "founded a great tradition since observed by so many of his followers and successors with such pious fidelity in public to speak the language of the highest and strictest principles, and in private to pursue and persecute every sort of woman."

Immediately upon publication of the book the present defendant, Viscount Gladstone, son of the former premier, and Henry Neville Gladstone, another son, bitterly denounced Captain Wright and succeeded in having him expelled by the exclusive Bath Club.

Wright yesterday asked police to aid in the search for his young wife whom he last saw leaving the house to take her usual stroll, he said, and expressed the hope that she might have met her husband.

PRESIDENT MAY DISPATCH SECOND NOTE TO SOLONS

Pressure For Arbitration Of Mexican Land Laws Are Great In Capital As Word Comes Of Coolidge's Plan

WASHINGTON, Jan. 28. (INS)—The president may send a special message to Congress shortly, dealing with the Mexican situation, it was reported today in administration circles.

The enormous has become the pressure upon the White House for arbitration of the land-law controversy that some such step is necessary, his advisers believe, if the country is to "understand" Mr. Coolidge's unwillingness to submit the questions between the two countries to the settlement of an arbitration tribunal.

The president has explained, through the medium afforded by the White House "spokesman," his aversion to arbitration of what he considers a vital principle at stake in the controversy with Calles.

This principle, as enunciated by Mr. Coolidge is "shall American property in Mexico be confiscated without being paid for?"

His advisers, however, believe, and have so told him, that the public generally does not realize or appreciate this position as emphasized by the constantly increasing pressure upon Washington for arbitration.

Over the week-end, the demand for arbitration became more pronounced.

The federal council of churches, claiming to speak for many millions of protestants, petitioned the government to settle the Mexican question without resort to an open break; a memorial signed by 101 college professors, representing 43 institutions; made a similar plea; the American federation of labor came out for arbitration—all this in addition to the apparent preponderance of opinion in the senate in favor of arbitration, as reflected by the foreign relations committee favorably reporting the Robinson resolution by 13 votes to 3.

Some of Mr. Coolidge's closest advisers believe this public opinion can be turned only by a special message to the Congress setting forth in detail the principle which the president believes is at stake, and which he thus far has enunciated only through the somewhat vague "White House spokesman."

They contend that the administration has not captured public opinion because of lack of directness of publicity.

The Indian troops marched through the international settlement to their barracks, attracting considerable interest from the foreign residents. The march was without incident. The first contingent of Punjabis, numbering 235, arrived yesterday. Fifteen adult American missionaries, accompanied by their families, arrived today from Chung King, Szechuen province. They declared the cities along the upper Yangtze river are tranquil, and said the United States consuls' orders for their evacuation came "like a bolt from the clear sky." Refugees Reach Shanghai Thousands of Chinese residents of Ningpo were arriving in Shanghai today seeking safety. They were afraid the Cantonese will shortly control all of Chekiang province. The financial position of the Cantonese government at Hankow is becoming increasingly difficult, due to the near approach of the Chinese New Year, prior to which Chinese custom demands that all outstanding financial obligations be settled. A public loan of five million dollars is being planned by the nationalist finance minister. Meanwhile the cantonese are levying a customs import duty of seven and a half percent on all foreign goods, and collecting the duty regardless whether or not a duty has already been paid on the goods at Shanghai.

Excavation Work Last Year In Canals Of Glades Area Largest In History

Tallahassee, Fla., Jan. 28.—(INS)—More excavation in the canals of the Everglades Drainage District was accomplished in the year just ended than in any other year since drainage work began, according to the biennial report just completed by Fred C. Elliot, chief drainage engineer. The report shows that the total for 1926 was 5,335,393 cubic yards of rock and earth taken from the canals and piled onto the south shore levee of Lake Okechobee. In the two years of the present administration, excavation amounted to 9,253,001 cubic yards, or more than half as much as was dug in the ten years from 1905 to 1915. The report shows that 111 of the 17 canals in which the district forces are now working are 100 per cent completed. The number of cubic yards excavated by the state dredges and those under contract to the state in the past twelve months in the various canals is as follows: St. Lucie, 1,459,712 cubic yards; West Palm Beach, 1,185,626; North New River, 1,242,673; Hillsborough, 404,177; Indian Prairie, 21,258; lateral canals, 128,731; various sectors of the Lake Okechobee South Shore Levee, 888,366; miscellaneous, 4,700. More excavation was done during November and December last year than in any other two months which may be accounted for by the increased levee work done following the September hurricane. He
