

High Court Nixes Part Of Gramm-Rudman Bill

By Henry J. Reske WASHINGTON (UPI) - The Supreme Court, telling Congress it must do its own dirty work. ruled unconstitutional today a key provision of the Gramm-Rudman balanced budget law designed to end deficit spending by the end of the decade.

The court's action returns the micany Unpleasant task of deciding specifically how to cut the budget - including programs dear to voters - to

Congress

The justices voted 7-2 to affirm a federal court ruling that found unconstitutional the key provision of the law that turned over part of Congress's budgetcutting powers to the comptroller general.

The court's action does not invalidate the entire law, but any cuts will have to be approved by the House and Senate in a joint resolution.

"By placing the responsibility

for execution of the (Gramm-Rudman) Balanced Budget and Emergency Deficit Control Act in the hands of an officer who is subject to removal only by itself. Congress in effect has retained control over the execution of the act and has intruded into the executive function," Chief Justice Warren Burger said for the court. "The Constitution does not permit such intrusion." Burger was joined in his op!nion by Justices William

Brennan, Lewis Powell, William Rehnquist and Sandra Day O'Connor, and Justices John Paul Stevens and Thurgood Marshall concurred in the ruling. Justices Byron White and Harry Blackmun dissented.

The Court also announced today it will decide whether the death penalty discriminates against blacks, one of the lingering constitutional questions about capital punishment. The justices will hear argu-

ments in the term beginning in the fall in an appeal by Warren McCleskey, a Georgia inmate who says he is on death row for two reasons - he is black and he tilled a white.

McSleskey's case has drawn attention from anti-death penalty forces nationwide because of a Georgia study that documente dista application of the death penalty depending on the race of a defendant and his victim.

McCleskey was sent to death row for the murder of Atlanta police officer Frank Schlatt during the May 1978 robbery of a furniture store.

His attorneys, in appealing to the high court, said imposition of the death penalty in Georgia "is marked by persistent racial disparities" and thus should be declared unconstitutional in all Instances.

Lake Mary city commissioners are interested buying a retail shopping center which was recently sold for \$3.2 million, and converting it into a new Lake Mary City Hall, police station, and government office complex.

Mayor Dick Fess told the commission during Thursday night's regular meeting he had a preliminary talk with a management representative of the Shoppes of Lake Mary, at the intersection of Country Club Rd. and Lake Mary Blvd., about the possible city purchase of the 38,075 square-foot shopping center.

Fess said the purchase, financed by a bond sale, would have to be agreed on before September 1, when a state law attowing not more than 25 percent of occupancy of a city building for purposes other than municipal uses may change.

The Shoppes opened in October, 1985 at a construction cost of \$2.5 million. Kent Kelly possibilities will be scheduled. of Azon Commercial Properties said recently. A Connecticut investor group, Roberta Real Fess said the center could Estate Growth Trust I. of Avon, purchased the center for \$3.3 million or \$84 a square foot in April, Kelly said. Azon continues to manage the complex. The Shoppes is about 45 percent occupied, but Kelley said the investor group was not deterred, and predicted a full center within a year. He also said the value of the site would increase by \$1 million in the next year.

County Considers 10 Percent Tax Hike

Seminole County Commissioners are expected Tuesday to tentively set the county-wide property millage rate for the 1986-97 budget ten percent higher than the current budget year which ends in September.

The action will be taken during the 1:30 p.m. segment of Tuesday's Board of County Commissioners meeting, County Services Building, 1101 East First Street, Sanford

The proposed property tax rate will increase to

\$4.60 per \$1,000 assessed property valuation from the present \$4.17 per \$1.000. If approved. the new rate will represent a ten percent tax increase. The first public hearing on the increase is expected to be set for September 9.

The tax increase is reportedly needed to compensate for a decrease in federal revenue sharing money amounting to more than \$1 million, and lower carnings on investments commissioners have said.

In addition, commissioners made up a \$2.5

million deficit in funding for the county jail expansion by dipping into the general fund.

A special penny sales tax was expected to yield \$17 million for the jail expansion, but fell \$2.5 million short, forcing the commission to make up the shorifall from general funds.

Final adoption of the 1986-87 budget is expected to come in late September, according to county administrator Ken Hooper. The new budget year begins October 1.

Today's The Day: Earth's **Population Reaches 5 Billion**

WASHINGTON (UPI) - Some time today, the birth of a child will bring the Earth's population to 5 billion people the largest ever, but that child will probably grow up poor. hungry and illiterate, the World Population Institute says.

Never before have so many people shared space on this planct," said Werner Fornos, president of the non-profit organization, which seeks a more equitable balance between population and the world's resources.

 Fornos said Sunday that because nine of 10 bables today are born in the Third World, that is the likely home of the 5 billionth human and it will grow up in "poverty, disease, hunger, illiteracy and unemployment."

Children born in the developing world have one chance in 10 of dying during their first year compared to one chance in 100 in the United States, he added.

According to institute estimates, the world's population is growing by 1 million people every four to five days, with about 85 million added to the population each year. In the last 35 years, global population grew by 2 billion; in the next 35 years, it is expected to grow by 3 billion.

Military' Gang Captures Aliens

PHOENIX (UPI) - An immigration official called the capture of 15 illegal aliens by an armed paramilitary group a "bizarre" abuse of civil rights, but the head of the anti-communist group said his men are patriots doing their duty.

Twenty heavily armed members of the Alabama-based Civilian Materiel Assistance apprehended the aliena Saturday while on "maneuvers" about 3 miles north of the border. The group held them for 90 minutes at gunpoint, Harold Ezell, regional commissioner of the immigration and Naturalization Service, said Sunday.

A member of the paramilitary group, which claims 5,000 members in all 50 states, told The Arizona Republic that 20 members had been on maneuvers cast of the border town of Nogales, sleeping in tents, dressed in military camouflage uniforms and armed with AK-47 Soviet assault rifles and American M-16s, which are legal in Arizona.

Ezell said the U.S. Attorney's Office declined to file charges because none of the sliens was hurt, but the FBI was investigating the incident.

GAO: Embassy Security Stymied

WASHINGTON (UPI) - Cost overruns, unworkable security systems and guards expected to walk the family pet have all put a dent in the State Department's \$4 billion program to increase embassy security worldwide, a report BRYS.

The General Accounting Office, the investigative arm of Congress, summarized the problems in a report that found big gaps in embassy security systems, including electric barrier systems that did not work and an ambassador who demoralized security guards by having them walk his poodle.

The State Department agreed with many of the GAO criticisms of the project, which was rushed into action following the bombing of the U.S. Embassy in Beirut, Lebanon, in September 1984.

The project, over five years, will cost more than \$4 hillon.

Talks Open In Philippine Siege

The leader of a revolt against President Corazon Aquino today left the luxury hotel occupied by hundreds of supporters of ousted ruler Ferdinand Marcos to negotiate with government officials.

Aquino gave civilian and military plotters of the attempted government takeover 24 hours to surrender from their stronghold at Manila Hotel but a spokesman for Arturo Tolentino, a Marcos political ally, said he was expected to return to the hotel.

Tolemino, Marcos' vice presidential running mate in the Feb. 7 election, left the posh hotel at dusk today and was reported by his spokesman to be meeting with government negotiators at the nearby Army and Navy Club.

MANILA, Philippines (UPI) - Marcos loyalists on a patrol jeep carly today that injured two people.

Police also said Mayor Joseph Estrada of the Manila suburb of San Juan and 10 of his men were arrested after they tried to enter state television in nearby Quezon City, the Philippine News Agency. Two truckloads of soldiers secured the television studios.

Florida-Based Boat Captains Freed In St. Vincent

FORT LAUDERDALE (UPI) - Three American fishing boat captains imprisoned on the Caribbean island of St Vincent were allowed to return to Florida after the country's prime minister negotiated an out-of-court settlement.

The accord drops charges of violating territorial waters against the captains, the Florida-based boats and the boats' owners. The three captains had spent 19 days in a 5-by-7-feet cell until they were released on \$5,000 bond each Tuesday.

"The captains, vessels, cargo and gear will be allowed to leave the island." said Stanley K. John, a St. Vincent attorney who represented the men.

Malcolm Miller of Fort Lauderdale, who owns two of the setzed vessels. Miller Time and Miller Time II, put up the \$15,000 ball for captains Mike Traynham. Harry Burgess and Colin Baldwin. The St. Vincent government will keep the money to defray administrative costs stemming from the incident.

Florida Growth Predicted

MIAMI (UPI) - Moderate growth in south Florida's economy over the next six months will be fueled by population growth and a weakening dollar, the Miami Herald's Board of Economists predicted.

The optimistic forecast came amid warnings about the large U.S. trade deficit and the increasing federal budget deficit, a concern which the board called a "land mine" facing Florida and the country.

Government services were being traded off against high interest poyments by the U.S. Treasury, said board member J. Kenneth Lipner, professor of economics at Florida International University

The group also said employment in Florida should also continue to outpace the nation. Job creation in the state is around 5 percent, compared to about 3 percent nationwide.

The spokesman said he was accompanied by three military officers who commanded some 180 soldiers still holed up in the hotel along with about 1,000 civilian Marcos loyalists.

NATIONAL REPORT: Plains thunderstorms that battered an Oklahoma airport with 98-mph winds poured nearly a foot of rain on Kansas, triggering floods that closed roads, damaged buildings and forced families to flee to higher ground today. Searing heat in the Northeast was expected to continue today. It was a record 100 degrees Sunday in Haltimore and 93 in New York, where the four-day Liberty Weckend ended on a sweltering note. In Philadelphia. where a strike by city workers. has halted garbage collection since last week, it was 96 degrees. Rain today reached from Texas to lowa, and National Weather Service meteorologist Paul Fike said the Plains storms showed little sign of movement. Flood watches covered east-central Kansas and northwest Missouri, and flood warnings were posted in westcentral Oklahoma and southeast Nebraska. Up to 11 inches of rain soaked northeastern Kansas Sunday, pushing floods 5 feet deep from the Sumnger River across Leavenworth. About 50 homes and a dozen businesses were damaged, Police Capt. Mitch Boyie said. "One car dealership had at least \$200.000 worth of damage," he said. No one was injured in the flooding. but police had one close call, he said. "One couple drove off in a tive humidity: 93 percent; 4-foot rapid," Boyle said, "We winds: NE at 5 mph; rain: 60





Plotting A Steady Course

President Reagan sounds more serious by the day about negotiating an arms-control agreement with the Soviets.

He has given up the harsh rhetoric against Soviet leader Mikhail Gorbachev and turned to praising him.

In an interview recently with the Los Angeles Times, Mr. Reagan for the first time hinted at a willingness to negotiate with the Soviets on the deployment of a Strategic Lenge Indative Star Wurs."

Until now, he firmly rejected the possibility of any "Star Wars" compromise, despite the recent Soviet offer to make deep cuts in offensive weapons in exchange for American restraint on deploying a space-based defense system.

This is a hopeful development, undiminished by the president's reluctance to offer specifics on how the proposed "Star Wars" defense might be used as a U.S. bargaining chip.

The president, after all, spent about 25 years engaged in labor management negotiations as head of the Screen Actors Guild.

It's understandable that he doesn't want to give details at the outset.

But he could take an action to convince both the Soviets and the American people he means business.

He should get rid of presidential advisers

who are trying to sabotage arms control. These individuals, mostly anti-Soviet ideologues, feud with other advisers who think a new U.S.-Soviet agreement is possible and desirable.

The hard-liners contradict what the president says, making Mr. Reagan sound befuddled when he speaks out on an arms-control issue.

The recent flap over whether the United States will give up the SALT II treaty was a prime example.

The house-cleaning should start with Mr. Reagan's arms-control director Kenneth Adelman, the man who led the charge for the United States to abandon the SALT II treaty.

Clearly, Adelman is an odd choice for his sensitive position.

He doesn't show much interest in curbing nuclear weapons.

Restructuring Needed In College Athletics

The tragically early death of the University of Maryland's talented basketball star, Leonard Bias, is one more heartbreaking episode in the dismal saga of drug abuse in America. It also raises a number of questions about the university athletic system.

What is the basic mission of a state university supported by the taxpayers?

Has the athletic program at Maryland and other universities taken priority over intellectual and personal growth?

Why would university and professional athletes, who work so hard to develop physical strength and agility, jeopardize this effort by ingesting drugs that can kill them or cripple them for life?

The University of Maryland athletic system took over Len Blas's life while he was still in his teens. After four years, that system turned him into an All-America prize draft target for the NBA. But he failed to qualify for graduation, and he failed to resist the lure of cocaine.

On the same day that medical examiners concluded Blas died from using cocaine. I happened to meet with a young man from Florida, with no special athletic ability, who had

had won a scholarship to Harvard.

It occurred to me that this studious, articulate, socially concerned honors graduate could die suddenly, and no one would know about it beyond his family and friends. No one, so far as l know, regarded him as a hero or celebrity.

The death of a star athlete, however, generates national headlines.

What does this disparity say about our values as a society? Certain thoughts come to mind.

First, the University of Maryland and similar schools must take a hard look at their responsibilities to their students and to the public that supports them.

It is an uncomfortable fact that five of 12 players on the basketball squad that included Bias were flunking at the time of his tragic death. Other prominent Maryland stars in recent years have fared poorly in academics. Some have been involved in drug abuse, breaking and entering and alleged rape.

Maryland coach Lefty Driesell says the roblem is no worse at his school than at other large campuses with competitive athletic programs. He is probably right, which only

graduated with honors from a small school and underscores the need for a nationwide reexamination of athletics and university priorities

A thoughtful friend has suggested to me that universities must stop playing the role of "farm" teams for those professional sports that don't have farm systems. It is difficult to see how Len Bias got anything out of his four years at the University of Maryland that he couldn't have learned, say, on a Boston Celtic farm team. This is the way big-league baseball teams develop their players.

Why, asks my friend, should universities and the taxpayers finance the training of big-time athletes for pro teams? Why not organize basketball and football recruiting along the lines of baseball?

Universities would then be able to confine athletics to a more wholesome intramural basis in which all students would be urged to participate. Faculties would then be able to concentrate their energies on quality education while athletes seeking a professional career could apply to farm teams and avoid the charade of pretending they are getting a university education.

ANTHONY HARRIGAN Fourth Of July Message

Is the goal of the United States to be interdependent or independent? That was a good question for the American people as they celebrated Independence Day 1986.

There is good reason to believe that the American people favor independence in every aspect of their national life. Nevertheless, the country is awash with talk of "economic interdependence" and a "global market." The economic theorists who want to impose this goal on the United States subscribe to the notion of Richard Cobden, the 19th century free trader, that dependence on foreign supplies makes impossible a policy of force and aggression in international affairs.

William R. Hawkins, a leading writer on trade and national security, has sent me a critique of this attitude. His comments follow:

"This attitude is seen today. Armand Hammer, who was the first American businessman to trade with the Soviet Union in 1921, has been a leading apologist for Soviet policy and an advocate of detente. Hammer once said that the policies of Leonid Brezhnev 'helped the relaxation of tensions between East and West. In this sense, Brezhnev is directly following the path begun by the great Lenin.' It was Brezhnev who embarked on a massive military buildup, crushed Czechoslovakia, armed North Vietnam, fostered war in the Middle East and Africa while invading Afghanistan. Hammer is now sponsoring a tour of Russian art treasures through the U.S. to promote goodwill. "When Congress was debating the Reagan administration's plan to provide aid to the anti-communist rebels in Angola, lobbyists for the Gulf and Chevron oil companies argued against such aid. These companies operate facilities for the marxist regime - facilities guarded by Cuban troops. 'Americans were outraged when European allies refused to support U.S. actions against Libya. But this was not so surprising given the evolution of economic ties between Europe and the Arab world. In the years since the OPEC cartel emerged, only England among the major European states was able to reduce its depedence on Arab oil by developing its own North Sea oil. England was also the only European state to fully cooperate with the U.S. air-strike on Libya." Though oil prices are down, the legacy of high prices remains. In order to finance oil imports, the Europeans had to develop export markets. Between 1970 and 1982, Germany, Italy, France.

SCIENCE WORLD 'Senility' **Comes In** Bottle

NEW YORK (UPI) - Retired, and sometimes depressed, elderly Americans are turning to drink with the urging of family members who want them to "enjoy" their twilight years, health professionals say.

But aging bodies are poorly equipped to deal with alcohol. The elderly get drunker faster and are more prone to alcohol-related injuries and diseases than the young.

"The same beer they drank with case at age 21, gets them drunk at age 65." said Mary L. Ganikos, a researcher at the National Institute on Alcohol Abuse and Alcoholism. The families are reluctant to seek treatment for the individual because they think it's either too late or not a significant problem."

In many cases, elderly alcoholics go undetected because family and friends chalk their confusion up to sentity rather than liquor, they sald.

The percentage of elderly Americans who are problem drinkers is the same as that of younger Americans - roughly 10 percent, said Ganikos. But she said the figure is misleading since most confirmed alcoholics die early.



In fact, a majority of House Republicans tarnished their record a bit further just last December, by joining ultra-liberal Democrats in a bid to keep Rostenkowski's flawed measure from even going to the Senate, where it could be (and was)

Certainly those chuckles about how Mr. Reagan would see his clout swiftly diminishing in his "lame duck" second term have died in a great many throats.

"They never make it to 'old age." she said. "What we're seeing are older people who were social drinkers when they were young starting to have problems as they age.'

While the vast majority of elderly Americans are not problem drinkers, the health officials said all older people should be aware they are physically less tolerant of alcohol than they were when they were young.

As the body ages, its ability to metabolize alcohol and other drugs slows. As a result, alcohol stays in the body of an older person longer and has more of an effect than it did when that person was young.

Older people also tend to lose weight and retain less water, both factors that make alcohol more potent, said Ganikos.

"Most people 'know their limit' when it comes to drinking," she said. "Limits change. Their limit may have been three beers when they were younger, but they can no longer tolerate three beers now."

Health officials said alcohol becomes even more dangerous to older Americans who are on medication.

"You have a high rate of medication in older persons and many of these medications interact with alcohol," said Dr. Sheila B. Blume, medical director of an alcoholism program."

Mexican Vote Fraud Being Fought

WASHINGTON - A traditional morale booster among Indian braves heading into battle was: "Today is a good day to die."

Their latter-day cousins south of the border who have run Mexico's ruling PRI party since 1929 have a less honorable, if more politically pragmatic, tradition: Stay in power any way you can: lie, cheat and steal, but win the elections at any cost. There's little reason to suppose that they are not now following that dubious tradition as the "vote count" continues today in the border state of Chihuahua.

The opposition National Action Party, commonly known as PAN, has predicted the customary electoral chicanery, and made plans to prevent it. PAN fielded candidates

in all 608 municipalities of Chihuahua, and took steps to have observers at every polling booth to "try to ensure that residents do not vote more than once and that ballot boxes are empty when the polls open." as the Mexico City News explained.

These tacties - the blunt instruments of electoral fraud - are not the wild imaginings of a paranoid opposition. Even when their candidates were lavored to win. according to intelligence sources. PRI hosses have resorted to a whole arsenal of dirty tricks to achieve overkill at the polls. For example:

- Hundreds of teachers have stuffed ballot boxes the day before an election. Complaints, and sometimes riots, have been touched off when voters who waited hours to cast their ballots early found that

the boxes were too full to hold even. the first votes

 Many known or suspected PAN. supporters have shown up on election day only to be turned away because their names had mysteriously disappeared from the registration lists.

- Bottles of indelible ink that are supposed to be used to mark the thumbs of departing voters have been found unopened. This meant that PRI supporters were allowed to vote repeatedly - sometimes with the bizarre result that the vote total exceeded the entire population of the community.

- The drawn-out vote-counting process gives the best opportunity of all to rig an election. Opposition observers are simply ejected forcibly from the polling places by police.

No less a figure than the Catholic archbishop of Chihuahua. Adalberto Almeida y Merino, has spoken out this time in a pastoral letter denouncing vote fraud - while carefully not mentioning the PRI by name. Electoral fraud, he told his flock. "emerges not only in falsification of votes, but also in all those reproachable methods that lead to weighting the results in favor of one party, going over the head of free elections by citizens."

President Miguel de la Madrid's vaunted "moral renovation" has been unable to curb the excesses of regional PRI bosses indeed, the CIA has concluded in a secret report that while de la Madr - did win the 1982 election. his majority vasn't what he and the PRI claimed. On the other hand, the CIA also doubts that PAN, which was officially credited with only 16 percent of the vote, got the 46 percent it claimed.



Campbell Wins Silver, **Promises Redemption**

WINTER PARK - Clifton Campbell isn't used to finishing second. The former Seminole High School standout and Augurn University freshman is used to running away from the competition and not chasing it.

Sunday at the 4th Pan-American Junior Athletics Championships, Campbell ran into someone with the same track record. Cuba's Roberto Hernandez, a protege for former **Olympic champion Alberto** Juantorena, turned back Campbell in the 400 meters and then capied a brilliant performance by holding off Campbell in the 4x400 meter relay before 2,501 fans at Showalter Field.

Campbell agreed. "I thought I was going to get it together on the backstretch." he said. "But as soon as I came out of the second turn, the wind straighted me up.'

The 19-year-old Sanford sprinter said his biggest problem has been a tendency to strain near the end of the race and

loose his rhythm. "I just have to learn to relax and stay loose," he said. "When I try too hard, I tighten up."

Campbell, who qualified for the U.S. team by winning the Junior TAC Meet at Towson (Md.) State, leaves today for Romania where he will compete in a dual meet this weekend.

Even though he was dissatisfied with his showing Sunday. Campbell is overjoyed with the progress he has made. He said most of his success is attributable to maturity and development.

"I've gained 12 pounds since Fin up to 177 now." he said. "And I've improved my bench press from 250 to 300 pounds. I think I'm capable of running in the low 45s yet this year. That's my goal."

Ethiopian Policeman Captures Marathon

MOSCOW, July 6 (UPI) - Ethiopian policeman Belaine Dinsamo, running only his third mara-thon, held off a late challenge from Soviet Igor Braslavsky Sunday to capture the first gold medal in the track and field events of the Goodwill Games.

Dinsamo clocked a modest 2 hours, 14 minutes, 42 seconds but was met with wild cheers from the usually sedate Soviet crowd as he entered the Lenin Stadium less than a minute ahead of his Soviet rival.

Dinsamo's win was a departure from the rest of the games, which have been dominated by the host Soviet Union and the United States.

In the women's 100-meter dash, American Evelyn Ashford and Heike Drechsler of East Germany ended in a dead heat for the gold in 10.91 seconds. Soviet Elvira Arbashina was third.

After two false starts, Ashford broke ahead and appeared to be cruising to victory when the East German came from behind only a few meters from the tape to earn the tie.

More than 3.000 athletes from 60 countries ar: expected to complete in the two-week sports festival, the brainchild of American television maverick Ted Turner.

In the 110-meter hurdles, American Greg Foster nipped Soviet Andrei Prokofev in a season-best time of 13.25. Prokofev finished in 13.28.

In the long jump, a new European record was established by Soviet Robert Emmiyan with a leap of 27 feet, 9 inches. American Larry Myricks took the silver and Soviet Sergi Layevsky captured the bronze.

American Tom Petranoff won the gold in the javelin with a toss of 273 feet, 10 inches. Soviets claimed the silver and bronze.

In swimming, the American men's and women's 4x200 freestyle teams both captured gold medals.



WIMBLEDON, England (UPI) - Boris Becker answered any lingering questions about his place in tennis' hierarchy Sunday when he defeated top seed Ivan Lendl to capture his second straight Wimbledon crown.

The 18-year-old West German - who last year became the tournament's youngest men's champion - beat Lendl 6-4, 6-3, 7-5, reasserting his dominance on grass surfaces

This year I really proved I can play well on grass, and I proved I can be a Wimbledon champion. It felt much better this year than last year," said Becker, who in 1985 did not play anyone seeded higher than fifth. 

Horner Belts 4 Homers But Braves Lose Again

On a day Atlanta's Bob Horner went into the record book, Braves' pitchers went to pieces.

Horner Sunday became the 11th major leaguer to hit four homers in a game, but even that effort failed to help his team avoid an 11-8 loss to the atting Proficient Lapon.

"It's a day I'll always remember." Horner said. "Of course, I wish we had won the game, but it's a day in my career as a ballplayer that I'll never forget.'

Horner hit a three-run homer in the fifth inning and solo shots in the second, fourth and ninth to become the first player in 10 years to hit four home runs in a game. Three of the homers came off Andy McGaffigan, and the fourth off reliever Jeff Reardon.

"It's really hard to put my feelings into words," Horner said. "That last ball I didn't think I had hit hard enough to get out of the park, but it went out.'

Of the Atlanta pitchers, Zane Smith, 7-9. allowed eight runs in four innings. Jeff Dedmon two runs in two, Paul Assenmacher one in two. and Gene Garber none in one.

Mitch Webster went 5-for-6 with three RBI to lead the Expos. It was the first five-hit game of his career and the 13th in Montreal's 18 seasons. Andre Dawson last had five hits, back on June 5, 1983 against San Francisco.

"That's the best day I've ever seen anybody have," Webster said of Horner. "He hit four home runs, and they were blasts. He really hit the ball good and I know Reardon was throwing good. It



Patty Moise of Jacksonville, Fla., the only woman driver in the race, finished last in the 30-car field.



Pontiff Lashes Out At Colombian Drug Traffickers

CARTAGENA, Colombia (UPI) - Pope John Paul II, lashing out at drug lords supplying most of the cocaine reaching the United States, accused traffickers of chaining addicts to a bondage "at times more frightful" than slavery.

The pontiff is scheduled to end his seven-day visit to Colombia today and fly to the Caribbean island of St. Lucia.

In remarks prepared for clergy at the chapel of St. Peter Claver, a Spanish missionary known for his work among black slaves in the 17th century, the pope said physical slavery has been replaced by "new and more subtle forms.

"The greed for money seizes the hearts of many people and transforms them, through the drug trade, into traffickers of the freedom of their brothers, whom they enslave in a slavery at times more frightful than that of the black slaves," he said.

Vote Fraud Charged In Mexico

CHIHUAHUA. Mexico (UPI) - Amid charges of voter fraud, the ruling Institutional Revolutionary Party claimed victory in the hotly contested gubernatorial race for the northern state of Chihuahua.

At a Sunday night news conference, Manuel Gurria, a member of the party's national executive committee, said preliminary results showed Fernando Baezahad won in more than a dozen of the state's 67 municipalities.

The PRI, as the ruling party is known, faced a critical test in the northern state of Chihuahua that borders Texas, where the conservative National Action Party, known as PAN, had sought to unseat the PRI, which has not lost a presidential or gubernatorial race in its 57 year history

Guillermo Prieto, president of the PAN's State Committee in Chihuahua, called the PRI's victory claim "cynicism, tack of sense and the ridiculous," based on information from only 27 of the nearly 1,900 polling stations.

Australians Hanged For Drugs

KUALA LUMPUR. Malaysia (UPI) - As holymen called the Moslem faithful to morning prayers, two Australians were hanged simultaneously at dawn today for trafficking In 6.4 ounces of heroin.

Kevin John Barlow, 28, and Brian Jeffrey Chambers, 29, were the first Westerners sent to the gallows under Malaysia's strict drug laws, despite last-minute pleas from Australia, Britain and Amnesty International.

South African Miners Stage Illegal Strike

In Pretoria, Law and Order Ministry officials confirmed that Winnie Mandela, wife of jailed African National Congress leader Nelson Mandela, is free of restrictions for the itrst time in at least 11 years.

Also today, authorities said three suspected ANC guerrillas were killed in a clash during the weekend with police at Empangeni, 100 miles north of Durban.

Police said they found Soviet-made AK-47 rifles, ammunition, land mines and hand grenades after the rebels were killed. They did not say exactly when the the shooting took place.

Marcel Golding, spokesman for the black National Union of Mine Workers, said 10,000 men struck six gold and diamond mines to force the release of tailed black labor leaders.

Mine officials said only 4,500 men were striking at only five mines. South Africa's mines produce a huge share of the nation's export carnings.

Police had no estimates on how many people came to New York for the Liberty birthday bash, but the disposition of the crowds was as sunny as the weather.

The prevailing mood was patriotic people were proud to be Americans. The group that waited all night to be on the first boat to the refurbished Statue of Liberty sang "The Battle Hymn of the Republic." Crowds at the Battery waiting for fireworks to begin July Fourth sang "America the Beautiful." All weekend the favorite anthems of America rang out spontaneously.

The spirit of Liberty Weekend was summed up by Miguel Jorge, 32, an office worker from Buenos Aires. Argentina, who hopes some day to emigrate to America.

"I came all the way from Argentina to see the Statue of Liberty and I'm so glad that I came," he said. "I cried the first time I saw it on the plane. It was marvelous."

Thousands of American immigrants or their descendants journeyed to New York for the four-day tribute. The statue received a \$66 million facelift for the event, paid for by contributions from the American public.

Liberty Weekend wound up Sunday night with a three-hour nationally televised spectacle with a cast of nearly 20,000 everything from Elizabeth Taylor to 100 Elvis Presley imitators brandishing unstrung guitars, to a living 85-yard-long

show officals gave out free tickets to fill empty sections.

One of the most moving moments in the show came when more than 300 workers who helped restore the Statue of Liberty came out on the 20-tier stage. Willie Nelson screnaded them with "Living in the Promised Land.

"It doesn't make any difference what you say," Wolper told news reporters after the show. "I got my review from the audien and they're still dancing out there.'

The finale marked the end of a four-day weekend in which there were few ugly incidents - not even when temperatures soared to 98 degrees on Sunday.

"My worst fears didn't materialize." said New York Police Capt. Robert Johnston, whose department worked in tandem with federal, state and city agencies to form the largest anti-terrorist, crowd protection, police force in national history

Why did the crooks and killers remain idle?

"Maybe they respected the Statue of Liberty," Johnston said.

The good-natured crowds were worldclass litterbugs.

Clean-up workers reported finding single shoes, half-eaten pretzels, underwear, broken American flags, empty champagne bottles. Popsicle sticks, chicken bones, broken lawn chairs. film containers and Justice Warren Burger swore in 270 new American citizens, and thousands more were sworn in all over the country.

The Fourth of July dawned bright, beautiful and breezy, as Reagan boarded the battleship lowa to steam up the Hudson River to review 21 foreign and 12 American warships. Next came Operation Sail 1986, a breathtaking procession of 22 tall ships, led by America's Eagle, and a flotilla of smaller vessels.

The greatest pyrotechnic display ever seen in the United States flashed and boomed across the harbor on the night of the Fourth of July.

On July 5, the Statue of Liberty reopened to the public after being closed for 54 weeks. So many people came to pay their respects - and stayed so long - that National Park Service officials had to halt ferry service early. By Sunday night, more than 20,000 people had visited the statue.

A crowd of 800,000 crowded the Great Lawn in Central Park Saturday night where Zubin Mehta led the New York Philharmonic in a classical music concert.

For producer Wolper, the high point of the weekend was the relighting of the statue Thursday night.

Women Are Happiest With Their Freedom

Statistically, the only good time for a woman to find a husband is between the ages of 20 and 24, according to the 1980 U.S. census. At that age, single men outnumber single women 126 to 100. After that, the odds drop.

There are only 77 unmarried men for every 100 unmarried women aged 25 to 29. Between 30 and 34, single women outnumber single men 100 to 62. Then it falls off even more.

For every 100 eligible women aged 35 to 39, there are only 48 unmarried men. There are only 38 single men to every 100 single women 45 to 49. And if you're 60 to 64, the odds are definitely not in your favor: There are a mere 27 single men to every 100 single women.

This isn't helped by the fact that men tend to marry women younger than themselves. And the older the man, the bigger the difference in age between himself and his bride.

Older women are also hurt by the fact that women outlive men. This is changing, with more women entering the work force and developing the same stress-related, life-threatening diseases as men. But it's not changing very quickly.

A large number of unmarried older nien are single because they're confirmed bachelors or have emotional or physical problems that keep them from making a marriage commitment. And many others are gay.

The only good news, it seems, is that studies show women are happiest when single. So don't necessarily envy your married sisters. They've got more emotional problems being married than you do being alone. That may be why divorce is so heavily on the upswing. More and more people are realizing that marriage isn't the answer all the books and our parents promised it would be.

This fear of divorce - a fear of failing - may be another factor that contributes to women being

single. If marriage is more of a sisk, maybe it's not a risk worth taking.

Of course, the fear of being alone generally outweight the fear of failure. And it keeps women trying to find Mr. Right. All we can say is good luck.

And happy hunting.

state of shock. I live in a small town and always though* doctors were supposed to keep medical records confidential. Now I find that my physician gave my records to the priest at my church. I never confessed the medical facts to anyone before my doctor. How can I make sure this won't happen again?

DEAR READER - This is a bad-news story. Clergymen are supposed to keep confidences, and doctors are supposed to keep confidences. Your doctor seems to have broken a cardinal rule. I think you owe it to yourself to ask the doctor point-blank why he or she released your records without your authorization. If the explanation does not satisfy you, make a formal written complaint to the county medical society. Then find another doctor who is more ethical. Make sure that you impress on any physician that you do not wish to have your medical records shared with anyone unless you approve the transaction beforehand.
