### Dangerfield Just Won't Fade Away

NEW YORK (AP) - You might think that old comedians never die; they just fade away, But that's not true of Rodney Dangerfield.

A lot of people have come up the hard way in show business. But Rodney has done it twice: first as Jack Roy, a reasonably successful comic on small club circuits, and then, after a lapse of 12 years, in his present name as one of the most popular comedians on television.

Rodney was born in Babylon. N.Y., the son of a vaudeville performer named Phil Roy. At age 15, Jack Roy started writing jokes and doing imitations of W. C. Fields and Charles Laughton in amateur hour shows, where he won prizes of \$1, \$2 and \$5. When he was 17 he the Polish Falcon in Brooklyn and as a "paid amateur" for eight quarters a night in Newark club.

He estimates that he has written between 10,000 and 15,000 jokes and used 3,000. Ninetenths of his material is his own

He admits that it was a tough road back when he decided to ecome a comedian again at age 40. At age 41 he was playing night clubs in the Catskills for use his own name. A hight club owner christened him Rodney Dangerfield. Then he persuaded his agent to book him on an Ed Sullivan rehearsal and Sullivan signed him up for two shows with an option for four more. Since then the going has been "up" for Rodney.

He has appeared on the Johnny Carson show 40 times and on the Dean Martin weekly show as the comedian-owner of a night club. And he really does own a \$250,000 Manhattan night club, Dangerfield's, which he opened in September 1969.

Rodney says he has turned down offers of as much as \$30,000 to appear in Las Vegas. "I do quite well in my own club or I'd go to Vegas," he said. "People have a good time at my place and I like to see you see people laugh. My place is probably the only one left that has a comedian working

"It isn't good for a comic to hit too soon. He can't handle it. It takes a comic 20 years of alking the boards to feel at home. My night club routine involves making 150 to 200 jokes in 45







#### Pat Nixon Disturbed

SAN CLEMENTE, Calif. (AP) - Pat Nixon is disturbed by a White House foul-up that resulted in the retraction of an announcement she was being appointed to the National Voluntary Advisory Council, sources say.

She was described Wednesday as worried about the effect the mixup might have on the work of the council. The council was established to help coordinate the government's volunteer programs.

The White House press announced on Sunday that the President had appointed his wife as a member and temporary chairman of the 25-member council. On Tuesday, the press office said the announcement was made before all legal and other checks were made.

It said Mrs. Nixon cannot legally hold a position ap pointed by the President. It also said the position would have paid the standard \$138.48 government consultant fee for each day spent on council duties.

In Washington, the director of ACTION, an umbrella group for federal social service organizations, said he hoped Mrs. Nixon would take an honorary post on the advisory council. Mike Balzano also said the 25 council members receive \$1 a day for their work, not the per diem

#### Sheikdom Strikes Oil

WASHINGTON (AP) - The small Persian Gulf sheikdom of Aou Dhabi struck it rich in oil and is now using some of the profits to equip its military -- only 8,000 strong - with \$90 million worth of sophisticated jet fighters from France. "They've got the money so they want to buy some of this, some of that - like out of a mail order catalogue.' remarked one U.S. official. However, what Abu Dhabi doesn't have is any experienced jet pilots or jet mechanics, so Pakistani Air Force personnel will fly and service the airplanes for at least several years.







Need 'Can Do' Attitude

# **U.S. Has To Face The Energy Crisis**

**By JEFFREY ST. JOHN** 

WASHINGTON-"The energy crisis is likely to prove," warned Georgetown University energy expert John Bridges, "the most severe test of our institutions ever.


Bridges offered this warning in a briefing on energy to members of the Grocery Manufacturers of America here in the nation's Capitol. "We don't know what we're doing," Bridges bluntly asserted of the political leaders of both parties, "and we better admit it now. Anything we do is going to make some people mad."

What worries Bridges, however, is that both the private and the political sector lack a "well thought-out long-range strategy" to solve a crisis he believes is manageable if we are willing to use imagination and intelligence and not engage in finding scapegoats.

"The argument over the energy shortage," Bridges commented in a gallows humor fashion. "is like the passengers of the Titanic; the ship strikes the iceberg. First, everyone believes the ship is unsinkable. Second, everyone starts believing it when the ship starts listing at the stern. But when someone goes up on the bridge to find out what to do, the captain is holding a courtmartial to find who had the command when the ship struck the iceberg.

Bridges contends that in 1974 Congress and the country must devise immediately a "can-do" strategy to come to grips with the problem. He makes the sound suggestion, for example, that with the cutback in the space program at the National Aeronautics and Space Administration (NASA) and the Atomic Energy Commission (AEC), many out-of-work technicians and specialists can be employed in the necessary research and developmen

Bridges is the first expert in energy to pinpoint the origin of the current crisis. "The current energy shortages," he states, "can be found in the philosophy of 'cheap' energy without regard to consequences. This philosophy goes back to the depression. We are at the change of

an era, cheap energy is at an end. Whatever is done, we will be forced to pay more."

The Georgetown energy expert apparently has more confidence in the public than in the political leaders. "I don't think they," he states, speaking of Congress, "realize how far the public is willing to go to deal with this problem. Right now there are too many speeches from politicians seeking to find scapegoats instead of sound solutions. When Congress reconvenes we will see whether our institutions like Congress will meet the crisis that can be overcome if we

don't rely on political Band-Aids. Bridges believes, moreover, that the key word in a sound energy strategy is "incentives. Here are two examples: Incentives for business

to invest in alternative energy sources and incentives for the individual American in the form of tax credits for insulating the home for conserving energy

When we left the Bridges briefing, perhaps the most brilliant we have heard, this columist walked past the White House and then to the small park beyond the executive mansion where I could see the Capitol building. The thought struck me whether both the federal executives and legislative would meet the test Jack Bridges rightfully points out might be our most severe. Later we turned to the past for some guidance and stumbled across a startling discovery. Since 1774, this nation has, every 40 years, reached a crucial turning point.

The animal, loaned to the church by a farmer, was killed Dec. 23 after it was taken from the nativity scene on the lawn of Forest Heights Baptist Church.

# World **News Briefs**

### **4-Day Holiday Begins**

CAIRO, Egypt (AP) - The cry of "Liberate Jerusalem" resounded through the Arab world today as it began a fourday holiday for Id al Adha, the biggest Moslem feast of the year. Egyptians relaxed in the wake of the Octoberwar with Israel, but their troops on the increasingly tense Suez front remained on full alert. Id al Adha, the Feast of Sacrifice, commemorates the Islamic version of the Biblical story of Abraham and Isaac. It comes at the end of the Hajj, the annual pilgrimage to Mecca, in Saudi Arabia, which a million Saudis and 750,000 Moslems from 62 other countries are making this year. King Faisal led them today to Mt. Arafat, 25 miles from Mecca, for the ritual sacrifice of hundreds of thousands of lambs and prayers for the recovery of the Arab sector of Jerusalem and its Moslem shrines, lost to Israel in the 1967 war.

### Jets Returned Home

BANGKOK, Thailand (AP) - The United States will complete the withdrawal of about 4,000 more troops from Thailand, leaving about 35,000 American servicemen in the Southeast Asian country, informed sources report. The sources said the Americans also are shipping home a squadron of about 25 EB66 jets, which are used to jam enemy radars. The United States had almost 44,000 troops - most of them Air Force personnel - in Thailand when the bombing of Cambodia ended last August. After the strength dipped below 40,000 in October, the Thai government said the withdrawal was being suspended because of the military and political situation in Indochina. The sources said most of the Americans withdrawn since then were ground personnel whose places were being filled by Thais.

#### Kuwait Assumes Control

BEIRUT, Lebanon (AP)-Kuwait has reached agreement with two major Western oil companies for a 60 per cent government takeover of their operations, a Kuwait official said today.

The Persian Gulf state's defense and interior minister, Sheik Saad el Abdullah, said in an interview with the Beirut newspaper An Nahar that the agreement affects the Gulf Oil Corp. of Pittsburgh and British Petroleum. He said it will soon be introduced into parliament and will leave the door open for total nationalization within five

Gulf and BP jointly own the Kuwait Oil Co., which produces more than 90 per cent of Kuwait's crude oil. The Kuwait parliament, which last year rejected an agreement that would have given Kuwait an initial 25 per cent ownership expanding to 51 per cent by 1982, has recently been pressing for total nationalization of foreign

#### **Bahamas Seek Protection**

NASSAU, Bahamas (AP) - The Bahamamian government, saving it fears more attacks by Cuban militants against ships flying the Bahamian flag in Florida ports, has asked the United States for protection. The request Wednesday followed the Dec. 30 sinking of the Mereghan II in the Miami River.

The 573-ton British-registered, Bahamian-owned freighter was flying a Bahamian flag when an explosion ripped into it. The ship settled to the bottom of the shallow river but did not submerge.





The post season activity on the gridiron proved to be more than just a bit of trouble for the Southeastern Conference warriors of the gridiron. Matter of factly the SEC emerged from the battles with only a precarious skirmish win in one contest out of the six conference teams entered.

Georgia wound up the only team that chalked the game up in the winners column. The Bulldogs played in their Peach Bowl against Maryland and raised their record to 7-4-1 for the campaign. Maryland dropped to 8-4 for the year to more evenly distribute the mediocrity between the ACC and SEC

### Rama Only Real Team

..... The only real football powerhouse in the South these days is the old standby, Alabama. The Crimson Tide came within one point cf winning the National Championship --- no light feat indeed.

After Bama though - the quality of tough competition drops severely to LSU, who is probably miles ahead of the next level of toughness.

The Bayou Bengals are one of the roughest teams in the Nation. Unfortunately for LSU they have a marked propensity to lose the football via the fumble -- as well as preferring to take the opponent's head off rather than concentrate on outscoring them. They are tough to beat - because they make you pay for your wins against them. However, a class football team they are not.

#### Then, Oblivion

After LSU and Bama - forget it. The only reason those four of the six SEC bowl teams went to the bowls is because the SEC is one of the few big conferences that

allows their members to go out and get embarrassed. Florida, unfortunately for the local faithful, probably was the most embarrassed of all. Losing to Miami of Ohio 16-7 on their own field did not exactly advance the fortunes of the "Fighting Gators." Running their season mark to 7-5 one wonders, if one is not from the SEC land, how in the heck the Gators got there?

Another pair that got in bowls, Georgia and Auburn, which were both beaten by Florida, had no business there. Georgia at least made the best of a poor situation - but Auburn got blown out by Missouri 34-17. Misscuri showed 'em.

#### Tennessee, Maybe

The Vols may be somewhat bowl worthy - at 8-3, but those wins over East Elbow State and Chicapaw Flats just don't make for number one ranking. The Vols still lost to a good Texas Tech team, 28-19, that had a 10-1 regular season with a reasonably hard

Tennessee entering a bowl after the past season is debateable -but after that there is no doubt. Florida (7-5), Georgia (7-4-1) and Auburn (6-5-1) are outclassed when considered as bowl teams by loads of people that didn't get the chance to go.



# UM's Rhodes Scholar Moves Into Record

Maryland's Rhodes Scholar is a pretty smart basketball

Tom McMillen knows exartly how to score points - and Wednesday night scored enough of them to break a school record in a 96-60 rout of Richmond. The erudite McMillen, cited as a Rhodes Scholar just a

couple of weeks ago, collected 17 points to move ahead of Gene Shue on the all-time Maryland scoring list. McMillen's point total of 1,405 surpassed the old Maryland record of 1,397 by Shue, now a coach with the professional

Philadelphia 76ers. "My appreciation of the record would have been greater had my father been here," said McMillen, whose father died

last week. McMillen has been playing indefatigably for the thirdranked Terrapins despite some personal distractions the past few weeks. The Rhodes Scholarship and his father's death have kept him busy - and tired.

"My thoughts have been muddled recently," said the 6foot-11 McMillen. "1 really hadn't given the scoring record much thought. I'll remember this game only by the fact that my father didn't come to it."

In other college basketball action, sixth-ranked Marquette blasted Cincinnati Xavier 73-53 and No. 20 Austin Peay was upset 88-86 by Missouri in an opening round game of the Senior Bowl tournament in Mobile, Ala. Host South Alabama crushed Southern Mississippi 96-75 in another first-round

McMillen not only broke Shue's scoring record, he enhanced his rebounding mark with 12. The classy forward ranks fifth in that department.

John Lucas was Maryland's high scorer Wednesday night with 25 points. He connected on 9 of his first 14 shots while the powerful Terrapins ran up a 46-22 halftime lead. Lucas added seven assists to his night's work.

The victory was Maryland's seventh straight since a onepoint, opening-night loss to topranked UCLA. Richmond, led by Aron Stewart's 23 points, lost its sixth game in nine starts. Maurice Lucas powered Marquette on an 11-2 tear at the beginning and helped the undefeated Warriors win their 10th game of the year with ease.

Lucas, who scored 19 points overall, helped Marquetto take

Tennessee 87-79, and the Thorobreds were bumped from third place after they were beaten by Armstrong and Wa-







profits?" The facts are that the oil inustry in recent years has not been as profitable as other industries. A study by First National City

Bank of New York shows that from 1963 to 1972, the petroleum industry's profits as a percentage of net worth were 11.8 per cent, compared to 12.2 per cent for all manufacturing ndustries.

During 1973, industry provise have risen dramaticallyearnings for the third quarter were up 79 per cent, and for the year to date 59 per cent.

Still, a study by the Federal Trade Commission shows that in the second quarter, of 1973 the oil companies made 10.7 per cent on equity, as opposed to 14 per cent for all manufacturing As John G. Winger of th Energy Economics Division of Chase Manhattan Bank points out, "For the last decade and a half, the net income of the petroleum industry has been too small relative to its capital

etween 1970 and 1985, the petroleum industry needs the astonishing sum of \$1.35 trillion dollars to operate at a level necessary to provide the nation with adequate energy-or, i must average annual earnings growth of 18 per cent.

And, says Winger, even in the big year of 1973, oil profits will fall short "by more than a billion dollars" of being adequate to cover needed capital expenditures.

Further, he says, next year the industry will have to earn 70 per cent more than this year, which thus far is up 59 per cent!

Recent opinion polls-such as one by Opinion Research-show that the public holds the oil industry in relatively low regard, and believes its profits are far larger than they actually are.


Politicians are baiting an uninformed public about "excess profits" of an underprofitable industry which must dramatically improve those profits to serve the

aforementioned public. And what is the oil industry doing about this? Depressingly little.

A communications specialist for the American Petroleum Institute points to the industry's inadequate earnings but laments, "The public looks at us like fat cats, rolling in money."

The institute spent \$4 million two years ago on a TV advertising campaign warning of a looming energy shortage, but canceled the series after critics charged it was trying to generate a "fear psychosis."

Now the institute is running a campaign costing half as much in consumer magazines. But API president Frank Ikard admits, "Apparently we have not tried hard enough."

"The hearing faculty members in the audience knew that my final 15 minutes of signs were unrelated to the Senator's spoken words, but our students didn 1 know the difference, since they couldn't hear. Some Indian chiefs visited Gallaudet College back in President Taft's administration and conversed readily via signs

For signs are basic and rather universal in their meaning, which let the Indian chiefs onverse with the deaf students abom they had not met before


