County budget climbs, taxes drop

SANFORD - In the next three days, five elected officials will appraise the Seminole County budget for Fiscal Year 1999-2000 - and if true to their intentions, allow citizens a tax cut for a second conseculive year.

Although the proposed \$438.5 million spending plan for fiscal year is \$60 million more than this year's adopted budget, residents won't be paying more taxes.

The county increased its revenue by 7.1 percent the previous year, and citizens are going to keep receiving improved

services, see their property values grow but have their taxes go down fifty cents.

The owner of a \$100,00 home who takes a \$25,000 homestead exemption currently pays \$602.81 in county taxes. "We're looking to reward taxpayers some of the 7.1 percent increase in revenues from the past year," District 5 **Commissioner Daryl McLain said**

Tuesday. "Their tax rate won't be going up."

Said Commissioner Dick

VanDerWeide: 'We have windfalls this year, and there is no need to eat them up. We have a chance to reduce taxes."

Hinson faces more charges

SANFORD - The Sanford man who ran a red light and struck a vehicle, seriously injurying the driver and killing her unborn twin sons, may face additional charges after testing positive for cocaine, methadone and anti-depressants at the time of the crash, police say.

Kenneth Hinson, 48, of Sanford, is already charged with

School safety task force hosts hearing

Educators focusing on behavior not teaching By Joe DeSantia

SANFORD - The Florida Senate Task Force on School Safety met Monday in Sanford to receive public input on how to curb violence and disobedience in the state's public school systems. They received an impassioned earful in the gathering that ran 90-minutes longer than scheduled.

"Educators and administrators now serve as drug counselors, parole officers, probation officers, psychologists and sociologists. If we could get back to the job of education, we could knock your socks off," explained Wolfgang Halbig, Director of Security for Seminole County schools.

Halbig and representatives from Central Florida schools districts, private organizations, and local law enforcement agencies painfully detailed the size and scope of problems for the bipartisan group who kicked off a series of summer-long fact-finding meetings statewide at Seminole County's Educational Support Center.

"School safety is a local issue, but if there was anything the Florida Legislature should be doing, especially the Florida Senate, I wanted to make sure we were doing it," said Senate presi-See Safety, Page 7A

Sanford police report decline in most crimes

However, authorities report increase in 'victimless' crimes of prostitution, drug use

SANFORD - Although burglary and sexual battery are declining in Sanford, the number of drug and prostitution arrests are increasing, according to an annual review by the Sanford Police Department.

From 1997 to 1998, sexual battery cases declined 20 percent, burglaries decreased 24 percent, and there were 44 percent fewer robbery cases. Auto theft cases also decreased by 2 percent, the report said.

"Those are good trends," City Manager Tony VanDerworp said. "I think the trends are pretty good in terms of getting a handle on some of the crimes."

However, aggravated assaults increased eight percent, from 365 in 1997 to 397 in 1998, and homicides increased from one in 1997 to four in 1998.

The department's QUAD unit made 63 percent more arrests for the sale or purchase of a controlled substance, and vice arrests increased 50 percent. Out of 3,648 index crimes See Crime, Page 3A

SANFORD - He is a young boy who fishes alone at a secret lake almost every day of his summer vacation.

Josh Garrett went to the lake at 7:30 a.m. Tuesday.

"We can't keep him in bed," his mother said. "He goes fishing every morning."

Josh, 10-years-old, fancies himself as a good fisherman. He's been at it five years, since his uncle Jerry taught him the ropes.

Since then he's fished the mountain lakes of Tennessee, the streams in North Carolina, the

He was a 27-inch, 9 pound large mouth bass.


Josh and Cameron fished awhile longer before they hurried home to show the catch of the day to their parents and friends.

George Bush wanted America to read his lips. His son, Gov. George W. Bush of Texas has begun campaigning for the Presidency by asking Republicans to read their hearts.

The purpose of prosperity is to make sure no one is left out and no one is left behind." Eight months before the first Republican or Democratic votes in a Presidential primary, Gov. Bush is the prohibitive favorite for his party's nomination. Two of the biggest states -Florida and Texas - appear to be in George W. Bush's hip pocket. "Having his brother (Jeb Bush) in the Florida Governor's Mansion is a very powerful tool," said Jim Stelling, the Vice Chairman of the Republican Party of Florida. "Florida is **Bush Country."** Stelling doesn't believe Jeb Bush will leave Florida to join brother George in Washington should he become president.

Baby Brian died just before midnight on March 15, and baby Joshua died shortly after noon on March 16 at the Arnold Palmer Hospital for Children & Women.

The twins were delivered by Casaerian section March 15 at the neo-natal care unit of Arnold Palmer Hospital. Brian weighed two pounds, five ounces, and Joshua weighed two pounds, nine ounces at birth, hospital officials said. The twins were in extremely

SANFORD - The Sanford **City Commission on Monday** approved a \$949,000 bid to construct a retention pond on 65 acres of land as part of the city's Mill Creek project.

The city is contracting with the Bishop & Butrey company to provide on-site drainage, grassing and fencing for the Mill Creek retention pond. The property will be deeded to the city when the project is complete. Bishop & Buttrey lowered their previous bid by \$75,000. Staff also assured commissioner Velma Williams that Mill Creek Canal will be enclosed in a black-coated chain link fence to enhance safety. Williams, who represents the residents around Mill Creek, has been the commission's leading proponent of the project. "I am so glad that this project

reported during 1998, the clearance rate for solving the cases was 45.2 percent. Index crimes include homicide, sexual battery, burglary, auto theft, larceny, aggravated assault, and robbery.

The Criminal Investigation Division made 811 felony and misdemeanor arrests and recovered \$839,665 worth of stolen property.

A Community Policing Team has been put into action in the Goldsboro area. The team is making contacts with businesses and community leaders. Other community policing activities have included assemblies to promote bicycle safety at Crooms Academy and **Golsboro Elementary School,** and partnership in the Harbor Organization that promotes education for children living in Public Housing and sourrounding areas of Sanford. "The reports are getting a lot better than the reports that we've had," Mayor Larry Dale said. "(The police) are doing a good job of community policing." Police conducted traffic surveys of the Academy Manor subdivision, and removed graffiti from the wall surrounding Academy Manor.

"The assumption that no one has the right to tell owners what they can and can not do with their property is a sham contradicted by experience and fact. Zoning and land-use plans are precisely a function of government that places limits on how a property may be used. Property owners not only accept these restrictions, but welcome them as protecting their property values." (David Tropf, "My Word" "The Orlando Sentinel")

An important decision will be made on June 22 at 7:00 p.m. in the Seminole County Commissioner's chambers 101 East 1st St., in Sanford. County Commissioner's will decide whether to change the zoning on 13.7 acres of land from UC (University

Community) to PUD (Planned Unit Development)

to allow student housing 100 feet from Creekwood, a single family development. University Community zoning is no longer used. It is a wide open zoning which allows to everything from libraries, museums, botanical gardens, schools, clinics, and housing. Philip Emmer, a developer from Gainesville, wants to build 14 three-story high buildings of 168 and a total of 456 bedrooms next to a McCulloch Road neighborhood. With recent Orange County decision to deny **Knights Krossing Phase IV** and Spanos because of the problem with student housing crime and noise you would think that the decision for this project is an easy one. However, this is not the case. Despite a crowd of at least 30

local residents in opposition to this project, with about a dozen speaking against it, a petition opposing the development signed by nearly all of Creekwood residents, the May 5th zoning board voted to recommend the zoning change to allow for the apartments to be built.

Up to now Seminole County has not had that much experience with student housing. This is rapidly changing as Orange County is oversaturated with apartments catering to students and they are starting to deny these projects. -Mr. Emmer wanted to build a student

housing project on Alafaya near Colonial Dr. However, a very vocal group of local residents told Commissioner Edwards that "no way did they want student housing next to their neighborhood." The commissioner listened and Mr. Emmer dropped the project. In a recent conversation with Mr. Emmer he acknowledged that Orange County is slowing down on student housing projects and that at least two other developers are looking to build student housing on McCulloch Rd.

With the recent denial of Knights Krossing and Spanos and the disclosure of crime and noise complaints; it is obvious that student housing is not compatible with single family homes. Orange County is proposing a new Ordinance to deal with buffering student housing, hotels, boarding houses with single family homes. The Ordinance recommends 1500 feet between hotels or boarding houses and single family homes would be adequate. Seminole County needs to use this ordinance and adopt one similar to it now before allowing additional student housing.

The main issue is why doesn't the University of Central Florida accept responsibility and house 30-50% of their students on campus? According to the UCF housing office only about 21,00 students live on campus. Knights Krossing, off

campus? According to the UCF housing office only about 2,100 students live on campus. Knights Krossing, off campus housing, has, 2,532 beds. Many of the major universities house nearly half of the students on campus. The benefits are many. First, students had a safer environment which is more conductive to learning. Second, they are already on campus so the nearby roads are not so overburdened with traffic. Third, they would be a happier, more cohesive students who would be more likely to participate in on campus activities.

Graduation rates would be higher. They would be more likely to financially help support the University after graduation. Lastly, the community as a whole would benefit as the students would be in a safer, quieter environment. 

Hastert looking for reinforcements

The rap on Speaker Dennis Hastert is that he's not Newt Gingrich. For conservatives, that's a shame. For moderates, that's just fine. For those who like a politician to be something he is not, they have Bill Clinton. A visit with the Speaker last week reveals a kind of principled pragmatism. It is founded on Republican core beliefs, but tempered with the realization that, given a six-seat majority with no philosophical unity on which to construct a voting bloc, there is a limit on what he and his majority can do without reinforcements.

"We'll have a tax cut bill on the floor of the House by the 26th of July. We'll have a tax cut bill out of the Senate Finance Committee by the 26th of July. I think that's what the people want. I don't know what the formula is, but we'll be looking at the marriage penalty and inheritance and death taxes which hurt small business and farmers."

Hastert suspects the reason for the angst among his critics is the difficulty in getting the Republican message through the post-Monica, post-impeachment and now post-Kosovo Washington. About criticism of his leadership, the former wrestling coach and teacher of the Constitution says, "The only way to win is to bring people together.

Whether you're a moderate or conservative, our margin is too small not to pull together to get things done. We don't have the luxury to be fractionalized so that 15 or 20 people can go off at their leisure and do their own thing. But in order for us to add to our majority, the people are going to have to see that this Congress and the Republicans are doing good for the country. It's to the advantage of our adversaries not to let us

do anything. Their game plan will divide us, drive wedges, slow us down. They'll pick off six peotle whenever they can."

The Speaker offered new details about his dealings with Hillary Rodham Clinton which might be of Interest should she decide to run for the Senate from New York.

Six years ago, Mrs. Clinton and a staff that

met in secret were attempting to nationalize health care. "In June, 1993, we had a dinner," Hastert recalls. "It was Mrs. Clinton, Rep. John Kasich, four or five other people, and me. I was the last one to ask a question. I said, "Mrs. Clinton, have you thought about medical savings accounts (MSAs)?" She said, "They won't work.' I

said, 'Why not?' She said, 'Well, for two reasons. People are greedy. They'll want to take that money and won't get the services for their family — the screenings, preventive care.'"

Hastert says he told Mrs. Clinton that part of it is an educational process to inform people that if they do certain things they'll be healthier. He recalls her saying, "No, no. The government will tell them when to get the screenings, when to get the preventive care. That's how we're going to do it in my health care plan."

Hastert says he thought to himself, "That's dictatorial." Asking her the second reason for her doubts about MSAs, he says she responded, "All that money goes to the: private sector and the federal government will spend that money better than the private sector will."

For Hastert, this crystallized the difference between the parties. Democrats believe government can spend people's money better than the people who earn it. Republicans think "the individual is at the center of the decision-making process and we are accountable for our decisions, not gover,men\$."

Hastert plans to take that message nation-; al and ask for additional Republica. troops. _ To do what? To do more of what he p"omises his limited majority has planned for the current sessio.

Many conservatives confuse loudnes0 with Idadership and personality with policy, whether one wins or not. Speaker Hastert says he knows the House and how : Democrats play the game. He's betting that not making himself a target and staying focused on what is doable will be enough to widen the GOP majority next year.

We'll know in 16 months.

Serve Dad steak 'n' taters on his day

I'm going to be a culinary sexist and suggest that, for Father's Day, you serve Dad a great big helping of that quintessential guy food: meat and potatoes. Really good meat and really crispy, fried potatoes. Yes, we're talking fat, salt and cholesterol here, none of them nutritionally correct. But for a once in a blue moon blow out, a celebration of guy-hood, and a delicious feed, nothing can beat it.

The recipes here all call for porterhouse steaks, which "Food Lover's Companion," by Sharon Tyler Herbst, defines as "one of the best and most expensive meats." It is cut from the tenderest part of the beef, the short loin, and is like a T-bone, only thicker. Suffice it to say, it is food worthy of a great Dad. The recipes also call for 18-ounce individual servings of steak. You can reduce the portion size or just make sure Dad is good and hungry when you call him to the table. It's best to make these steaks on a grill. Not only will the flavor be supe-

rior, but you need your oven to do the potatoes. A broiler will work, though. The first recipe below comes from John Rinaldi, a student at the New England Culinary institute in Montpeller, Vt. The others are from "The Steaklover's Companion," by Preder-ick J. Simon, which, come to think of it, might be a good gift for Dad on Father's Day. You'll notice that none of the recipes call for fancy marinades, and they call for very little in the way of spices; the steak is left alone to taste like itself.

If you can't support such culinary sexism, I have a suggestion to make: Save these recipes until next May, and serve one of them on Mother's Day. Mom will love them, too.



GRILLED PORTERHOUSE STEAKS WITH THYME AND BAKED POTATO SKINS

For the potato skins: 2 large russet potatoes

freshly ground black pepper 1 tablespoon butter, melled

- For the steaks: 4 porterhouse steaks, about 16 ounces each poone olive oli

1/2 tessipoon cayenne, or to taste 1 tablespoon fresh minced thyme

Preheat oven to 375 degrees. Bake the potatoes for one hour, or until cooked through. Remove from the oven and let cool (do not turn off the oven). Scoop out the flesh and reserve for another use (such as making mashed potatoes). Cut the skins into wedges and place them on a baking sheet. Season skins with salt and pepper, and drizzle with the melted butter. Return to the oven and bake for about 10 minutes, or until crisp and golden.

Meanwhile, prepare a grill or broiler. Rub the staaks with the oil and season both sides with the salt and cayenne. Sprinkle with thyme and press into the meat, to coat. Grill or broil until done to your liking.

To serve, place the steaks on warm

serving plates with the potato skins next to them. Serve immediately.

Note: These potato skins are so yummy you may want to make a double batch of them. Yield: 4 large servings.

Remove with a slotted spoon and drain on paper towels. When cooled, cut strips into 1/4-inch dice.

If there was a common theme expressed by all who attended, it was that kids want safe schools, but educators and administrators lack the resources and training to foster a healthy learning environment.

Referring to a report he coauthored with other members of T.D. Wolf and Associates, Halbig provided the group, spearheaded by Jennings and co-chaired by Senators Buddy Dyer and Jack Latvala, with a laundry list of why the public school system has transformed from a promising learning landscape, to a virtual battle ground where daily survival for kids and teachers has become the norm rather then the exception.

Among indicators of an educational system desperately in need of rescue from unruly and violent students:

 A lack of respect for any form of authority

• A diminished respect by students for the rights, feelings, and property of others

 A sense by many of today's students of entitlement to immediate gratification

embrace violence as a means to solve problems

 A yearning for many students for recognition and a sense of belonging by peer groups that often leads to gang affiliation

 And perhaps the most striking, a desensitization among many students regarding the value of human life itself.

"This is the feedback we get directly from teachers who are on

the front line each day," Halbig informed the senate panel. 'These are not some results from another 'form' survey. These are indicators of a turbulent society." He explained that he felt money alone won't solve the problem.

"All the cameras in the world, all the metals detectors, are not going to stop school shootings and violence on campus. There was one common denominator in the high profile cases like the Columbine, Pearl and Arkansas," he said. "Most of the kids in those schools knew threats had been made. It's not so much a code of silence, but students are reluctant to come forward. Kids have a lot so say but we don't listen and they

know it." Halbig pitched the idea of developing six regional training centers that would offer teachers and administrators education and resources to deal with violent student behavior.

"The one thing we don't teach teachers while they are in college is how to deal with violent kids. They come to us begging for training in classroom management skills," continued Halbig.

Now its gotten to the point where teachers don't want to • A willingness by students to stick their heads in the restrooms to see what's going on because if you see it, you have to deal with it. Teachers and administrators are responsible for breaking up fights and physical confrontations, but where is the training to do that. If they walk away from a fight they get sued for negligence."

> The Senate panel also heard from the private sector on how to deal with increasing school vio

executive director of Youth Crime Watch of Florida detailed how the organization's program has helped reduce the number of viotaking hold nationally.

Based on a collaborative effort by groups of students representing all cross sections of the student body, Youth Crime Watch advocates making students as much a part of the solution as they are the problem.

"Students are the key and reporting is the key," he told the panel. "But I would caution against an effort that only emphasizes reporting potential trouble. Some kids could be seen as 'snitches.' All of the systems that touch upon this problem schools, law enforcement, courts and corrections - must forge a policy they will implement. I've seen a number of cases in which either the courts or the schools make a mockery out of what the others were attempting to do. This has especially been the case in recent years when there has been a zero tolerance for violence

or drugs or guns on school campuses.

Pat Ramsey, principal of Orlo Vista Elementary school in Orlando told the panel that for many kids, school is the safest haven they will find.

"Schools have to have a positive, safe, caring learning environment," said Ramsey.

She then went on the recount some of the problems she and her staff face at their elementary Halbig and Modglin agreed on school, among them lack of cam-







Root's favorite major league team is the Braves and his favorite part of baseball is pitching. Matthew Mallin (9), is going


