German Name Cancelled On Pact Of Peace

Nation Has Done None Wrong, Hitler Says In Address On 4th Nazi Anniversary

Bank And Rail Control Taken

Reichsfuehrer Begins Another 4 Years As Leading Light

BERLIN, Jan. 30.—(AP)—Reichsfuehrer Adolf Hitler, starting to rule Germany for another four years, "withdrew" Germany's signature from the Versailles Peace Treaty today in which the Reich was declared "guilty" of launching the World War.

Asserting that Germany's resumption of military sovereignty was a matter affecting only the Reich, the Nazi chanceller told the Reichstag "we have taken nothing from any nation, nor have we done any nation wrong."

He declared German Government from now on would exercise sole sovereignty over the federal railway system and the Reichsbank.

Not quite a year ago the same Reichstag which Hitler addressed today on the fourth birthday of Nazi power, renounced the bread Rhinebank in violation of the Treaty of Versailles.

May Vary Program Of Filing Work Sheets For 1937

Work sheets to be taken under the 1937 Federal Soil conservation program probably will be filed not only in the office of the County farm agent, C. R. Dawson announced today.

In the operation of the 1936 program, there were some instances where workers went into the fields to collect data.

Mr. Dawson said the new work sheets are tentatively scheduled to be taken beginning about the middle of February, although the definite date has not been established.

The farm office this morning was busy distributing Government checks which arrived here the middle of the week as payments to farmers and growers who participated in the 1936 soil plan.

About \$5,000 was in the first consignment of U. S. Treasury drafts. Nearly \$40,000 will have been handed out here or completed by the end of the month.

Remains Of Retired Methodist Minister Are Sent To Biloxi

The body of the Rev. James Lewis Jordan, 90, was sent early today to Biloxi, Miss., his home for burial tomorrow. He succeeded Friday while visiting his daughter, Mrs. W. H. Young in Orlando.
