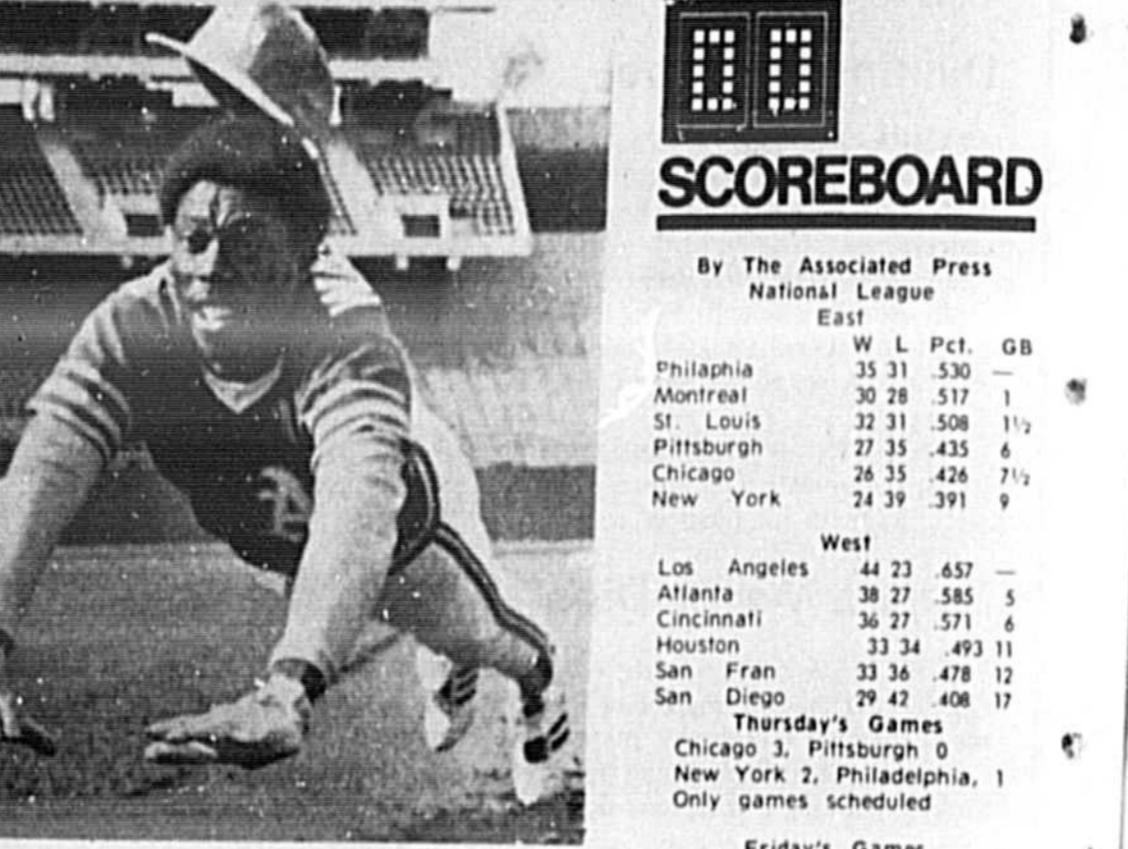

Lightning Knocks Out Sanford's Water Plant

Sanford residents have been warned to brace for a critical water shortage until a water plant transformer — knocked out during a violent electrical storm — is repaired or replaced.

The storm, which raged across Seminole County for hours, not only destroyed the transformer in the water plant adjacent to the Mayfair Country Club and Golf Course, but spawned several tornadoes that wreaked substantial damage in the Woodland just west of Longwood on SR 434. No injuries were reported.

The water supply has been cut by one-third. The auxiliary water plant on U.S. 17-92 is carrying the load now, but it is not able to deliver the normal supply.

There is no danger to the water supply. It is just as good as it was before the lightning hit, however, just don't use it as quickly, Pete Knowles, city manager, said.

The lightning bolt somehow bypassed the protection system, Officials explained. The officials are urging the 7,400 customers of the Sanford Water Plant to cut lawn-sprinkling and car washing as Seminole Sheriff's deputies continue to patrol "high-use areas" warning customers of the situation via loudspeaker.

"The only major danger is if we have a serious fire," Knowles said adding, "fire hydrant pressure is also reduced."

"Yes, we do have a water problem. It is critical. Please conserve. Yes, it may continue for days," worried customers were told.

A perplexed Knowles said there is simply no explanation as to how the lightning ruined the transformer.

Apparently, the control panel that is connected to the transformer is undamaged, but, Richard said, they need the transformer in working order before they can even check for other damaged parts.

Calls to all Central Florida supply houses revealed the transformer was unavailable.

Grand Jury Has To Decide Whether To Call Swofford

The Seminole County Grand Jury will resume its probe Monday into building department practices in Altamonte Springs under the regime of ex-mayor Lawrence Swofford, says State Atty. Abbott Herring.

While the session is expected to extend throughout the week, Herring said, the question of whether to grant Swofford's request to be called has yet to be settled.

"That will be up to the grand jury, based on the information they receive from other witnesses and what questions they want answered," Herring said after the 18-member investigatory body adjourned for the weekend.

Herring also refused to comment on the questioning, commenting only that it is "well known" Swofford was mayor during the time period being probed.

The state attorney, while declining to name witnesses he planned to call this week, noted that last week's list began Thursday with several past and present city officials.

Chief Investigator Jack Fulenwider, who has been working on county and city government relations with the building industry since September, has confirmed that contractors and builders will be invited to testify.

"It will be entirely up to the grand jury to determine what the facts dictate and what action, if any, needs to be taken," Herring said Friday.

New State Law Repeals Longwood's Recall Vote

LONGWOOD — A charter amendment passed by city voters 2-1 on June 11 and not yet certified to Tallahassee appears to have been repealed by state law passed June 9 and signed by Gov. Reubin Askew June 10.

The amendment placed on the ballot following the petition method permitted under state home rule law would have required certified petitions signed by 33 per cent of the registered voters to initiate a recall election.

"The density of this development is not in keeping with (the Seminole County Master Land Use Plan)," the letter contends. "Clearly this development is in violation of that plan."

Kimbrough's letter cites proposed commercial areas on U.S. 17-92 and SR 427 as leading to "a traffic congestion problem."

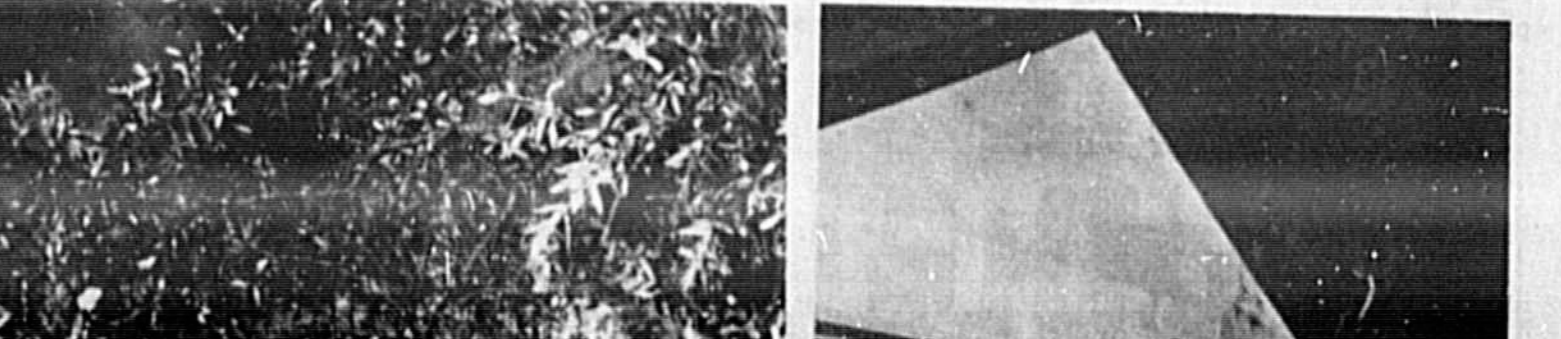
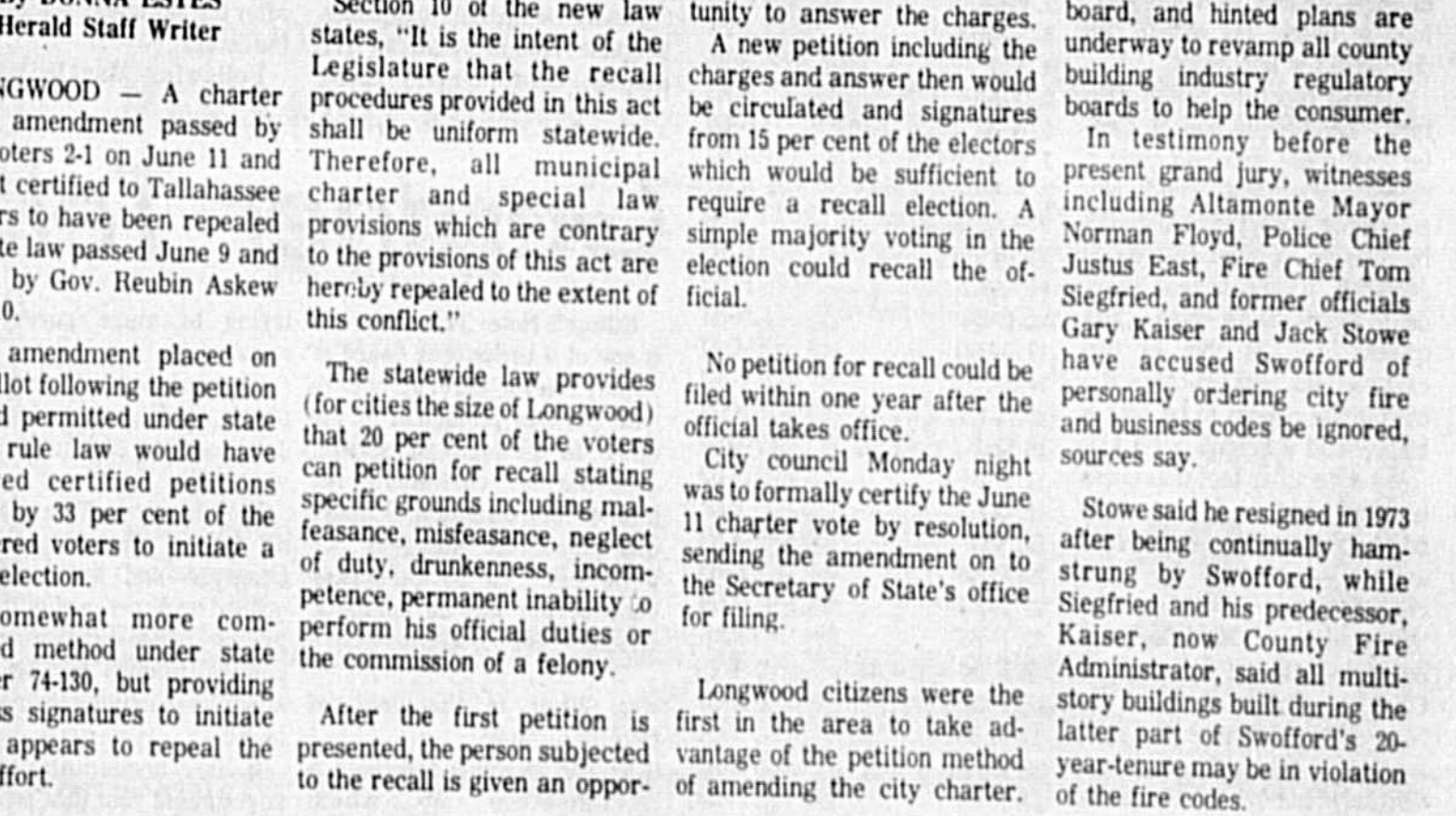
He goes on to say the cost for four-laning SR 427 from the entrance of the PUD to U.S. 17-92 would be about \$210,000, including additional rights of way.
