## PARTY MOVES TO STAVE OFF RASKOB PLANS

**Anti-Prohibition And Economic Suggestions Of Chairman Ark Southern Wing**

**WASHINGTON, Mar. 27.—(AP)—**A definite movement in the southern wing of the Democratic party was under way yesterday to head off the anti-prohibition and economic proposals made by Chairman Raskob at the recent meeting of the national committee.

The movement, its leaders said, is designed to prevent approval of the Raskob program at the next national committee meeting.

Plans for carrying it out were discussed by four of them at an informal conference Wednesday in the office of Senator Robinson of Arkansas, the Democratic leader.

Those who attended, in addition to Robinson, were Senators Swanson of Virginia and Hull of Tennessee, and former Governor Byrd of Virginia.

Robinson and Hull, a former chairman of the national committee, led the attack on Raskob's proposals at the national committee meeting.

Robinson and Hull have been mentioned as potential presidential candidates.

Those at the conference agreed that the Democratic party must continue in stressing the economic aspects of the Raskob program.

## Seminole Indian Maiden Is Married To Brave Amidst Scenes Of Tribal Ritual

**MIAMI, Mar. 27.—(AP)—**While Seminole tribesmen chanted the weird mountings and cries of the "scratches" and "buffalo" ceremonial dances, young Oceola, 21-year-old Indian maiden, and Henry Cypress, stalwart brave of the tribe, sounded solemn tones of matrimony here yesterday.

The two dancers never before seen by white men were accomplished by a ring of gaudily costumed Indians, led by Cory Osceola, chief of all Florida Seminoles. They preceded a marriage ceremony which bound Henry and his new spouse according to Seminole custom, to life together, under penalty of disappearance of the Great Spirit. Other celebratory dances followed the wedding.

The ceremony was performed by Josie Billy, chief of the West Coast Seminoles, while the stolid Henry and the more bashful life of the girl, held hands on a raised platform. Related never before were plaited palm leaves woven into a canopy of nature.

Chief Osceola, who had been awaiting and attending the ceremony, aged counsellors of the tribe sat at one side—dressed in ceremonial ceremony.

In front of the platform were vowed as life partners of strict Seminole tradition.

## PALMER AND HEIDT TO DIE FOR SLAYING

**TAMPA, Mar. 27.—(AP)—**Victor Palmer and Norman Heidt who shot down Sen. William Borah, were convicted in circuit court last night by a jury which reported the verdict after an hour and a half deliberation.

Both received their fate calmly, until the last they had hoped for at least a mistrial.

"Johnson's blood is not on my hands—I believe I can say that," Palmer said as he held out his arms for the handcuffs, after it was over.


