

Refinery Tower Blast

Kills Eleven Persons

CHALMETTE, La. (AP) - An explosion tore through a 207-foot oil refinery tower late Thursday, killing 11 persons, authorities said. Authorities said they believed the bodies of two other workers were inside the wrecked tower at the Tenneco plant in this New Orleans suburb.

The bodies of the 11 victims were brought to the St. Bernard Parish morgue.

Campaigner Gets Job

WASHINGTON (AP) - A real estate developer who serves as a campaign fund-rai-ser for President Ford is being handed a "plum" job on the Postal Service board of governors, five years after politics was supposed to have been eliminated from the Postal Service.

Hung Wai Ching, finance chairman for Ford's campaign in Hawaii, is being named to the board at least partly because of his efforts on behalf of the Republican party, according to Sen. Hiram Fong, RHawaii, who recommended him for the postal job.

To Avenge Fall Of Camp

BEIRUT, Lebanon (AP) - The Palestinians and their leftist Moslem Lebanese allies threatened today to avenge the fall of the Tal Zaatar Palestinian camp and vowed that Lebanon's civil war would continue.

Palestinian leader Farouk Kaddoumi said his men would "avenge Tal Zaatar elsewhere in Lebanon." Leftist papers said the Moslems might "escalate fighting in Christian-held mountain areas," through which Moslem villages are still scattered.

"Lebanese will have to brace for protracted war," said Kamal Jumblatt, the Moslem leader of the Lebanese leftists. "We must brace ourselves for more shocks, similar to that of Tal Zaatar.

Ministers In Oil Dispute

UNITED NATIONS, N.Y. (AP) - The Greek and Turkish foreign ministers come face to face today in the United Nations Security Council to vent their dispute over the oil that may lie beneath the Aegean Sea.

Turkish Foreign Minister Ihsan Sabri Caglayangil missed the opening of the debate Thursday. Speaking then, Greek Foreign Minister Dimitrios Bitsios urged the council to prevail on Turkey to halt what he called the "provocative" activities of a research ship probing for evidence of oil.

Exiles Kidnap 2 Cubans

MIAMI (AP) - A Cuban exile group captured the two employes reportedly missing since last Monday from the Cuban embassy in Buenos Aires, Argentina, a Spanish-language radio station has reported.

Dr. Salvador Lew, president of station WRHC, said Thursday that reliable sources had told the station that commandoes of the United Revolutionary Organizations had seized embassy workers Jesus Cejas Arias, 22, and Crescencio Galanena Hernandez, 26.

LARGO (AP) - "Our trailer rolled six times. When it was over, I thought my husband was dead," Rexanne Schwadron said after a tornado struck a community of mobile homes for retirees, killing one and injuring a dozen others.

"Big sheets of metal were coming straight at us," Mrs. Schwadron said. "We just grabbed each other's arms and hit the floor." When the wind stopped, 30 mobile homes lay in soggy ruins and 70 others were damaged in this Florida Gulf Coast city of 55,000.



That economic benefit cannot be denied, but is no justification for ignoring the implications of the arms buildup in the Middle East and Africa. That arms buildup, we should remember, does not arise from the availability of U.S. weapons but from the determination of certain leaders to turn the economic strength of their countries into military strength. The United States, for instance, did not give the Shah of Iran the ambition to make his country a major power in the Middle East. If he did not find a source of weapons in the United States he would find it elsewhere.

Arms are flowing into the Middle East and Africa from the Soviet Union and from Western Europe as well as from the United States. King Hussein of Jordan has demonstrated how a leader can try to play one side off against the other in the arms market. Peeved at the rising cost estimates for an American-made missile system, he nounced he would shop for one in Moscow instead. He is now apparently changing his mind, with the assurance of more help from the Saudi Arabians to pay for what he wants.

Our arms-sale policy must not be blind to the uses that might be made of U.S. weapons. In the case of Jordan, and the proposed resumption of arms sales to Egypt, we have sought to keep a balance between the military capability of Israel and the Arab states that confront her. All the Middle Eastern states are dependent on outside sources for weapons. Those nations on which they are dependent gain a measure of influence over their policies. Whether it is the Russians or the Americans who hold that influence can be crucial to the future of the Middle East and Africa.

It is the buyers of arms - not the sellers - who will answer the question of how much is enough. The United States and the Soviet Union are trying to answer that question right now in their strategic arms negotiations - an example of how hard it can be to fix what is an adequate level of defense.

We know from our own experience vis-a-vis the Russians that when two countries are both welldefended they search for alternatives to war. The hopes for a negotiated peace between Israel and the Arabs are based on that principle. The flow of U.S. arms into any region is not dangerous in itself. Danger arises when any nation decides to use weapons available from one source or another to change an equilibrium that serves as an inducement to keep the peace.

"The poor do not want your pity," she says. "They want your love. But do we see them? Do we know them? Are we with them? When we come before God, He will judge us on what we have been to the poor, on what we have done to the poor."

At the Congress, a global gathering of Roman Catholics centered on faith in Christ's real presence in the bread and wine of the eucharist, or holy communion, Mother Teress gave several talks and "People have told us that we spoil the poor with our work," she said. "It is good to have at least one

congregation that spoils the poor because everybody is always spoiling the rich." She told graphic stories of work with the desperately poor, of a family of eight which, on being given some rice, first shared it with hungr neighbors before eating; of a starving woman who died saying "thank you" simply for being picked up . from the street and shown some concern.
