# Laughing it up Police agencies crack down on truant students

SEMINOLE COUNTY - Police agencies throughout Seminole County are committing to consistent truancy enforcement. Seminole County Sheriff Don Eslinger is designating November as the month to begin enhanced truancy enforcement. Students under 18 years old must attend school, with the exception of 16 and 17-year old students who have officially withdrawn. All enrolled students found to be truant will be transported to the Seminole County Juvenile Assessment Center, the sheriff's office said.

"All county agencies are collaborating together." Olga Cortizo of the assessment center said. "More officers will be available to crack down on truancy. We're making a statement that truancy will not be tolerated."

School Resource Deputies will review daily attendance records at high schools and middle schools to locate truants on a daily basis, the sheriff's office said.

Eslinger is coordinating a countywide effort to review statistics regarding school truancy and daytime burglaries. The Sheriff's Office suspects that enhanced truancy enforcement will result in a significant decrease in daytime burglaries.

The assessment center has taken in over 500 students since it opened Nov. 3, 1997, Cortizo said. The center processes all the truant students in the county.

## **Police identify beaten body** found in local factory

SANFORD - The Sanford Police Department has identified the body of the deceased found Thursday morning in the breakroom of a factory in Sanford.

Police are treating the death of 53-year old Frederick (Fred) Norman Jordan as a possible homicide, sargeant of detectives Pat Smith said. Jordan received blunt forced trauma to the head, and there was blood around the body, Smith said.

"He was severely beaten," Smith said. There was a pool of blood (around the body). We have to wait for the medical examiner to

determine cause of death, but I think it was a homicide."

Smith said he estimates the time of death as "sometime before midnight." An autopsy is being performed today. The police are still investigating whether a front door was unlocked when a co-worker arrived and found the body in the middle of the breakroom, Smith said. No murder weapon was found at the scene, Smith said.

Jordan lived and worked at the Federal Parts factory at 3795 S. Sanford Avenue, Smith said. Federal Parts is a small business with four employees, police said. The employee who discovered Jordan called the police at 7:46 Please see Body, Page 3A

SEMINOLE COUNTY . A four-month investigation into the battle of Geneva on July 8 is concluded. State Attorney Norm Wolfinger said law enforcement officers were justifled in fatally shooting a man who killed one sheriff's deputy and wounded two others.

It took 13 hours and nearly 1,000 rounds of ammunition for SWAT members and deputies to kill Alan Kent Singletary, who was armed with a 9mm semi-automatic handgun. a .22 caliber rifle and a .22 caliber revolver.

Singletary killed Deputy Eugene "Gene" Gregory, who was investigating a dispute Singletary had with his landlord. After the initial round of

gunfire, SWAT members from Seminole and Orange came to the scene. Singletary held them off all night, firing as many as 100 rounds. Singletary,43, had a history of mental illness.

Wolfinger reviewed the investigation conducted by the Florida Department of Law Enforcement and said he considered the matter closed. He said the Singletary's death was justifiable homicide. "No further criminal inquiry is warranted," Wolfinger said.

Lt. Sammy Gibson and Deputy Scott McLeod , who arrived later in the shoot-out, were wounded and were laid off from duty but are both back at work now. Deputy John Harper, Gregory's partner, escaped the incident without injury.

## Jury will have say in suit against sheriff

SEMINOLE COUNTY - A jury is going to have at least some say in a suit against Seminole County Sheriff Don Eslinger concerning an incident seven years ago when Seminole County deputies mistook an innocent Lake Mary man for a fugitive.

Circuit Judge Seymour Benson ruled Thursday that the deputies had the legal right to arrest Luis Garrido, Jr. 48, but that jurors will have to decide whether SWAT officers had the right to search his house with-

out a warrant and order family members out on to the street.

Attorney Manuel Authur Mesa, who represents the family, said he was pleased the trial would continue with the jury. Julius Parker, Jr., the Sheriff's office attorney argued that the officers had every right to do what they did because the suspect was believed to be armed and dangerous.

The deputies were looking for a federal fugitive named Garrido. The FBI wrongly listed the address and the license plate of the Luis Garrido as being that of the fugitive. Al-Please see Jury, Page 3A

though he was four inches shorter, nine years older and had blue - not brown eyes -Garrido did not convince the officers he was not the fugitive they were seeking.

Benson ruled that the deputies, going on this information supplied by the FBI, had the right to stop Garrido and his wife. Benson seemed miffed that no FBI agent was present in the courtroom.

What the officers did inside the home and how they treated the other family embers is what Benson said concerned him and was the reason why the jury would be called back. One of the women said she was kicked. The others said they were pushed or pulled from the house

Officers have said they did not point guns at anyone and that they harmed no one. They were in the house approximately 15 minutes.

The trail resumed at 10:30 this morning.

Students are brought into the center by law enforcement officers, Cortizo said. The school and the parents are notified. If a student has 10 or more unexcused absences, a social worker makes a homevisit and the student will be referred to Boys Town. Some students are assisted in receiving counseling.

We're essentially a turnaround center," Cortizo said. We're here so students get the help and the services they need. We're not here to punish. We try to find out what the problem is, and to find a solution.'

Workers at the center work with families of a truant student, Cortizo said. Some students have received help in going to counseling, either at the school or in private counseling, Cortizo said. At other times, workers help students who are being harassed by gangs, Cortizo said.

We have had many instances where the parents or guardians are not providing the proper support." Cortizo said. "Some students may be getting scared away from school by gang members."





## More people using less water in nation

### SPECIAL TO THE HERALD

TALLAHASSEE - Newly released statistics on water use by the United States Geological Survey (USGS) show that the nation is using less water--402 billion gallons per day (bgd) for all uses, which is 2 percent less than in 1990 and nearly 10 percent less than in 1980. despite a continuous increase. in population over that same time period. Freshwater per capita use also decreased for 1995. Total freshwater percapita use was 1, 280 gallons per day (gal/d), compared to 1.340 gal/d in 1990. In Florida. the freshwater per-capita use was 509 gallons per day, one of the lowest in the nation. A detailed. soon-to-bereleased USGS water use report for Florida shows a similar trend since 1980, with water use decreasing 14 percent to its 1995 value of 18.2 billion gallons per day. Florida's total (tresh and saline) water use from 1990 to 1995 increased 2 percent, although freshwater usage decreased 4 percent. "If you were to ask people if the nation was using more or less water now than say 15 or 20 years ago, the vast majority probably would say that we are using more water now," said Robert Hirsch, USGS Chief Hydrologist. Hirsch states the "the overall decline in water use is an encouraging signal. The nation is clearly using surface-and ground-water resources more efficiently. Enhanced citizen awareness of the value of water and conservation programs in many communities across the country have helped to cut water use in spite of continued population growth. Improved irrigation techniques and more efficient use of water by indus-

Long-term concerns remain about the quality of available water, however, "with increased demands for water for instream uses such as river-based recreation, esthetic enjoyment and fish and wildlife habitat, the overall competition for good quality water will continue to increase," Hirsch said. Irrigation is the top freshwa-

ter use category-=-134 bgd nationwide in 1995, of which Florida used 3.47 bgd. When treshwater and saline water are combined, more water continues to be withdrawn nationwide for thermoelectric power generation (190 bgd, of which 58 bgd is saline) than for any other category. Of the 11.6 bgd of water used for power generation in Florida, most (11 bgd) was saline

In a state-by-state comparison. California accounts for the largest total water use [46] bgd), followed by Texas, Illinois, and Florida. Two dozen states and Puerto Rico had less water withdrawn during 1995 than during 1990.

The USGS has compiled and reported national water-use

statistics once every 5 years since 1950. Reports specific to Florida were published for 1965, 1970, 1985, and 1990, and will soon be published for 1995. The USGS national water-use report, searchable by county and watershed, along with an expanded section on trends, is available on the Web at: Wide World http://water.usgs.gov/public/w atuse/.

This information is gathered in every state by USGS scientists to minimize the loss of life and property from natural disasters, contribute to sound conservation, economic and physical development of the nation's natural resources, and to enhance the quality of life by monitoring water, biological, energy and mineral resources.

eases/98/oct/fw\_pop.gif. Where do Florida residents get their water? About 86 percent of Florida's population are served by public water-supply systems. The remaining 14 percent were self-supplied, served by their own water systems. Ground water was the

source for all self supplied use. Domestic water use includes water for normal household purposes, such as drinking. food preparations, bathing. washing clothes and dishes, flushing toilets, and watering lawns and gardens. Public supply refers to water withdrawn by public and private water suppliers and delivered to multiple users for domestic. commercial, industrial and thermoelectric power uses. Public supply (as defined in the USGS report) includes public and private water systems that furnish water to at least 25 people, or that have a minimum of 15 connections. Of the total water withdrawn for public supply (1.2 bgd), 61 percent was for domestic use. Ground water accounts for 90 percent of Florida's public-supply withdrawals-more than any other state.

· Less Irrigation Water Used-Total irrigation withdrawals totaled 3.5 bgd, a decrease of 7 percent from 1990. This trend can be attributed to: 1) the use of more efficient irrigation systems, 2) the use of alternative water sources, 3) a higher than normal use on 1990 caused by low rainfall, and 4) improved data collection.

· Saline Withdrawals Increased--Total water use (fresh and saline water) has increased slightly since 1990. Although freshwater withdrawals decreased 4 percent, saline water withdrawals increased 7 percent. This increase was related to increased usage of saline water in the thermoelectric plants. Virtually all of the saline water is returned to its source.


Reclaimed Wastewater Use Highest in Florida--Instead of returning all of its treated domestic wastewater to surface or ground waters, Florida is using 23 percent of this water for irrigation. In 1995, Florida used 271 Mgal/d of treated water for irrigation--more than any other state.

# Avoid bacteria, read cider labels

This fall's jug of fresh apple cider will look different from the cider jugs of previous years. It will wear a label that warns of the hazards of drinking juice that has not been pasteurized or otherwise treated to destroy potentially harmful bacteria. This new warning label, which is expected to be announced by the Food and Drug Administration this month, will apply to all fresh fruit and vegetable juices. not just apple cider, whether they are farm-made or from a large manufacturer. Such labeling may help worried parents, like the woman who asked last week whether it was safe for her daughter to drink fresh chilled raspberry juice. "Is it pasteurized or not?" she asked. "It doesn't say anything on the label."

Currently, there is no way to know whether juices in a refrigerator case have been pasteurized, if the label does not say so. It is, however, safe to assume that packaged or canned juice not held under refrigeration has been pasteurized. The story adds that



most juice sold in the United States is pasteurized; only about 2 percent is not. There are no figures on how many people are sickened by tainted juice each year, but a number of cases have gained national attention.

In 1996 there was pressure from public health proponents for pasteurization of all juices. In response, the FDA proposed a rule in April to require all fresh juices, both fruit and vegetable, to be processed to remove harmful bacteria through pasteurization or other means. Until that rule takes effect, in about 2 years, all unprocessed juices will have to carry a warning label that states: This product has not been pasteurized or otherwise

treated and may contain harmful bacteria, which can cause serious illness in children, the elderly and persons with weakened immune systems."

Caroline Smith DeWaal, the director of food safety for the Center for Science in the Rublic Interest in Washington, was cited as saying that the new labeling rile "puts parents on notice that it is no longer safe. to serve unpasteurized juices to their children." As bacteria like E. colt 0157:H7 and salmonella have mutated and made their way into foods in which scientists did not believe they could survive, the consumption of fresh juices has become something of a hazard.

For example, through citrus juices like orange juice have a high actd content and would seem immune from these harmful bacteria, there are types of salmonella that can survive in unpasteurized orange juice. One of these culprits was in an outbreak in 1995 in Florida. So that means all those juices that are freshly squeezed at the grocery will

have to carry warning labels, too. (The FDA news release about the warning labels assures the public that children's lemonade stands are exempt.) Apple cider also poses problems, in part because the whole fruit, including the skin, is used in making juice. Since 1974, there have been at least three reported incidents of people becoming sick after drinking apple cider. People have eagerly turned from canned pasteurized or otherwise treated juices to fresh juices, even though they are more expensive. Ms. DeWaal was further quoted as saying. "They are fresher, and the perception is that they are healthier. But parents aren't doing their kids any favor by giving them unpasteurized juice. Extra vitamins are no help to a kid hospitalized with E. coli poisoning.


