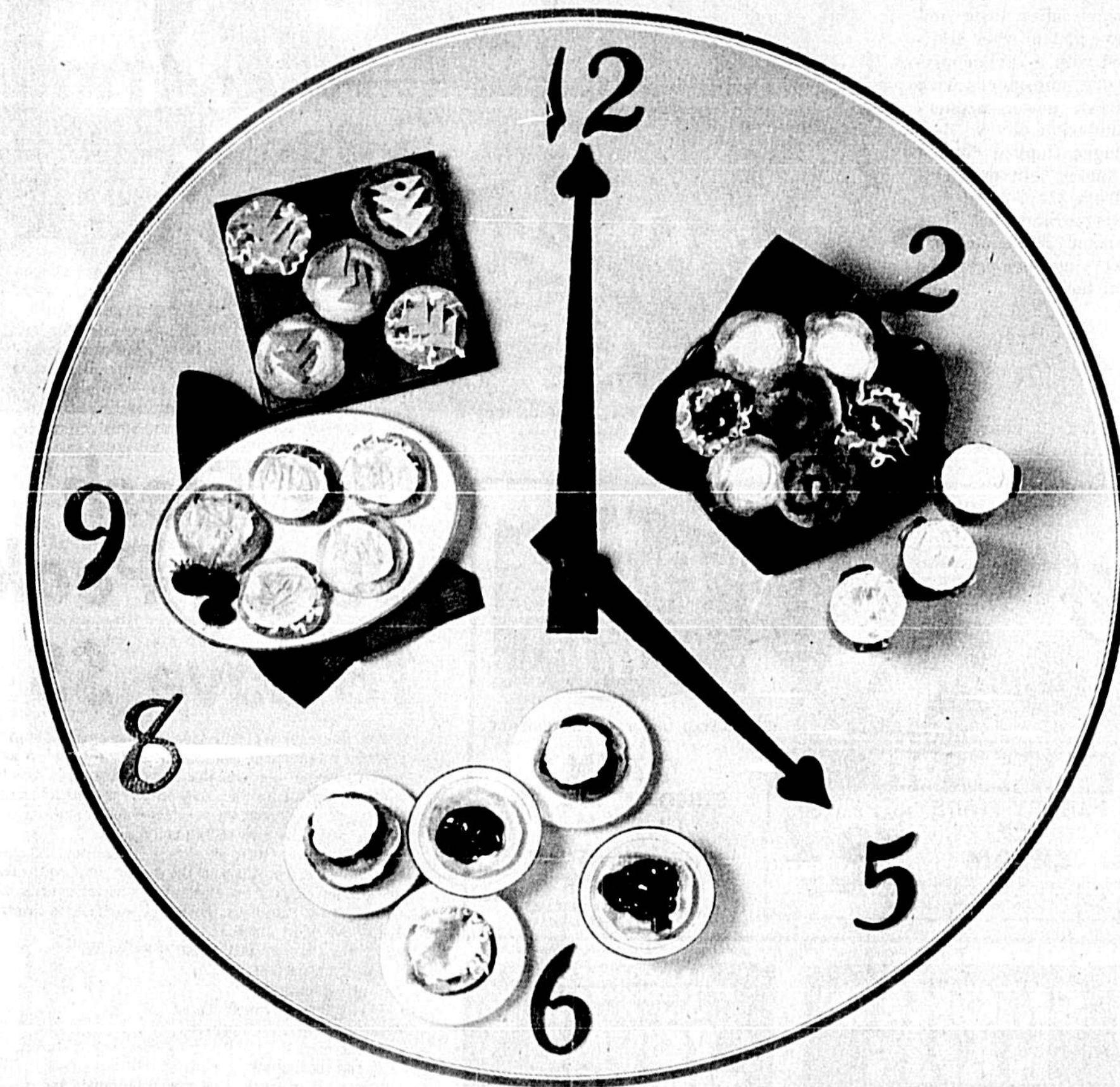

6 frozen Individual Cinnamon Raisin OR Individual Cheese OR Individual Apple Danish
1/2 cup butter, softened
2 teaspoons grated orange peel
2 tablespoons pineapple preserves
2 tablespoons honey
Warm Danish according to package directions. While Danish are warming, prepare the three flavored butters. Whip together 1/4 cup butter and orange peel. Then whip together remaining 1/4 cup butter with honey. Serve flavored butters with warm Danish.

Variation: 1 tablespoon grated Parmesan cheese may be whipped with 1/4 cup butter.

4 PM: APPLE DANISH A LA MODE
A new version of that traditional favorite of apple pie and ice cream.

6 frozen Individual Apple Danish
1/2 cup caramel topping
1 tablespoon rum
1 pint vanilla ice cream
Warm Danish according to package directions. While Danish are warming, stir together caramel topping and rum. Place Danish on plates; top each with scoop of ice cream. Pour about 1 tablespoon rum sauce over each serving. Makes 6 servings.

6 PM: FRUIT TOPPED CHEESECAKES
Unbelievably easy yet scrumptiously delicious — now you can surprise unexpected guests or family with this instant dessert.

6 frozen Individual Cheese Danish
1/2 cup cherry or blueberry pie filling
Warm Danish according to package directions. Place Danish on plates. Spoon about 1 tablespoon pie filling on each Danish. Makes 6 servings.

8 PM: STRAWBERRY SPICED SHORTCAKE
Surprise the family tonight with a new twist to strawberry shortcake.

6 frozen Individual Cinnamon Raisin Danish
1/4 cup whipping cream
1 tablespoon confectioners' sugar
2 packages (16 oz. each) frozen strawberries, thawed and drained
Warm Danish according to package directions. While Danish are warming, whip cream, gradually adding confectioners' sugar. Beat until stiff peaks form. To serve two layer shortcakes: place 3 warm Danish on 3 plates, spoon about 1 tablespoon of whipped

State: 'Profit' Hospital Would Cost County

Seminole County stands to lose \$718,000 in medical care funds for the poor over the next eight years if Seminole Memorial Hospital is taken over by a for-profit corporation, according to a state agency.

In addition, if the county relinquishes control of the hospital to a for-profit group, the county would have to repay the federal government a percentage of the current worth of the hospital.

Nathaniel Ward, director of the Health and Rehabilitative Services Office of Community Medical Facilities in Tallahassee, confirmed the amounts that would be lost for care of indigents.

Because of these losses, a citizens group will inform county commissioner today that they object to Hospital Corporation of America (HCA), Nashville, possibly taking over Seminole Memorial.

The commissioners are considering proposals for purchase or lease of the hospital from HCA, Florida Hospital, Orlando, and the current hospital board of trustees.

Florida Hospital is a not-for-profit organization which proposes to buy Seminole Memorial and renovate. The current trustees propose to become a private, not-for-profit entity and lease the building from the county.

HCA pledges to build a completely new 200-bed facility in Sanford and proposes to lease Seminole Memorial during construction. After the new hospital is built HCA would return the old building to the county.

The citizens group, Seminole County Resources for Human Needs Committee, points out in a letter to the commission that under the current hospital administration, funds for care of indigents must be provided due to obligations the hospital incurred when it received funds for construction and equipment under the Hill-Burton Act.

Hill-Burton provided federal grant funds with the stipulation that the hospital would spend a percentage of its net operating money yearly in care of indigents. The obligation with each Hill-Burton grant is for 20 years.

Seminole Memorial received money under the act four times for a total of \$1,168,023.

In 1963, they received \$325,000; in 1964, \$75,000; 1968, \$678,000; 1973, \$90,000. The hospital will have some obligation under the act until 1992, 20 years after the most recent grant. The obligation for indigent care from the other grants expires in 1983, 1984 and 1988.

Until 1983, when the oldest grant expires, Ward said, the hospital is required to provide \$10,000 yearly in care for indigents. The figure is 10 percent of the current total obligation. It can be adjusted up or down, annually, depending on options the hospital may choose, he said, but the total obligation remains the same.

The obligation under Hill-Burton can be transferred to another non-profit group, Ward said, but a for-profit corporation could not assume it.

Thus, he said, if a for-profit organization took control of the hospital, his office would insist on an immediate recovery action against Seminole County.

Seminole County, as the entity that applied for the grants, would be required to make the repayment. The amount to be recovered would be calculated by first determining the "now" value of the hospital. The government would want to know the same percentage of that "now" value as they provided when the building was under construction.

But Douglas B. Lewis, HCA's director of domestic development, said today Seminole Memorial Hospital "is in such bad shape that the Hill-Burton payback would be minimal."

With HCA the county would not have to subsidize the hospital, Lewis said, and that would provide great financial benefit to the county. HCA would request only that the county reimburse the hospital for indigent care at the Medicaid rate, which is below cost, Lewis added.

"We feel certain," HCA's proposal states, "that the amount of additional (property) tax revenue provided by HCA as a result of private ownership... will, to a great extent, assist the county in providing indigent care more so than under its present, not-for-profit system."

Ward said, however, that the for-profit groups statements are "just a promise."

"Under the not-for-profit present system, care for indigents is guaranteed," Ward said.

Iran Students Rule Out Yule Visits

TEHRAN, Iran (UPI) — Militant students ruled today that relatives will not be allowed to visit 50 American hostages at Christmas even though the Iranian government said it hoped such a humanitarian gesture might be arranged.

"No relatives will be allowed to see them at Christmas," a militant spokesman said. "After all, they are hostages."

He refused to say whether the hostages — now in their 47th day of captivity — would be allowed to attend Catholic and Protestant church services next week as promised by Foreign Minister Sadegh Ghotbzadeh. "That's his opinion, not necessarily ours," the spokesman said.

Interior Minister Hashemi Rafsanjani Wednesday raised the possibility of Christmas visits when he said, "There is a possibility their (the hostages') families will be allowed to visit them for Christmas and we would like such a thing to happen."

The students and Ghotbzadeh were locked in a power struggle after Iran's ambassador to Sweden was arrested on charges of being a CIA agent.

A militant spokesman said on state television late Wednesday that Ambassador Abbas Amir Entezam was taken into custody after secret U.S. Embassy documents were turned over to the revolutionary

Hostages Receive Huge Florida Card

TEHRAN, Iran (UPI) — A 10-by-64-foot Christmas card addressed to "fellow Americans" and signed by 22,000 Floridians was delivered to the U.S. Embassy today and Foreign militants outside said the 50 U.S. hostages were receiving all their cards and gifts.

The giant card came from the people of Panama City, Fla., along with thousands of other ordinary-sized cards, bringing to 300,000 the number received in Tehran in the past week.

Militant captors at the embassy said they had "already distributed the first batch of mail to the hostages" Monday.

The spokesman said the captured documents proved the ambassador was a CIA spy. He read out portions of the American documents, quoting one in which Charge d'Affaires Bruce Laingen wrote that Amir-Entezam had been working to re-establish closer ties with the United States.

The ambassador, a deputy premier in the provisional government of Prime Minister Mehdi Bazargan, had himself transferred to Sweden to maintain his CIA contacts, the spokesman charged.

He read another document purportedly showing a former political officer identified merely as Mr. Stempel had been a CIA officer in Iran.

The latest announcement was a deep embarrassment to Ghotbzadeh and highlighted the current struggle with the militants for influence in Iran and the ear of Ayatollah Ruhollah Khomeini on the 47th day of the embassy crisis.

In Washington, a White House official, who asked not to be named, said President Carter would not press for international trade sanctions against Iran until after Christmas Day, at the earliest.

The aide said the administration had decided not to press for sanctions while U.S. Secretary General Kurt Waldheim is having "intensive discussions" with Iran. Earlier in the week, the militants launched a full-fledged public attack on Ghotbzadeh, calling his optimistic statements on the future of the American hostages "irresponsible."

They accused him of "deviating" from Khomeini's wishes and said many Iranian embassies were nests for "counter-revolutionaries."

Sanford Housing Authority Seeks \$1,800,000

An application to the U.S. Department of Housing and Urban Development (HUD) for \$1,799,789 to upgrade all six public housing projects in Sanford was approved by the Sanford Housing Authority (SHA) Wednesday night.

The improvements are to include energy conservation and much needed repairs to structural components and provide greater tenant comfort and safety, said Tom Wilson, SHA executive director today.

Wilson said the three-year comprehensive modernization program would begin in 1981. Since the SHA has a completed comprehensive plan for modernization, the local organization has an edge on gaining the funding, he said.

Currently, SHA is in the process of upgrading the housing in Castle Brewer Court and Cowas-Moughlin Terrace. The other housing projects are: William Clark Court, Edward Higgins Terrace, Lake Monroe Terrace and Redding Gardens.

In other business, authority members approved a \$2,300 write-off in uncollectible rental fees. Portions of the uncollectible fees were from three instances in which tenants had failed to report higher incomes and then moved without paying the retroactive rental increases.

Wilson noted rental fees in the public housing projects are based upon income and family size. He said when it was found that three tenants had failed to report higher incomes and when his office tried to collect the increased rents then required, those tenants moved.

Income is verified during the year, he said, by checking social security and employment records.

Wilson reported to the board that \$222,000 of the \$480,000 allocated to the authority during the past year in community block grants from the federal government has been spent. The balance will be carried over into the new year to complete the program.

The goal of the program is to acquire and renovate 15 dilapidated houses in the Sanford area for resale to low-income families. In addition, portions of the money, Wilson said, was used to provide drainage improvements at one of the housing projects.

Wilson said one house has been completed in the acquisition-renovation program and is on the market and work is to begin on the second house at 1292 Oleander and 12th Street, in the next few weeks.

Wilson said a local developer has received commitments for constructing 30 low income housing units in the Sanford area and will hopefully begin construction of those units in the new year. More than 2,000 persons are currently on the waiting list for low income housing, Wilson said.

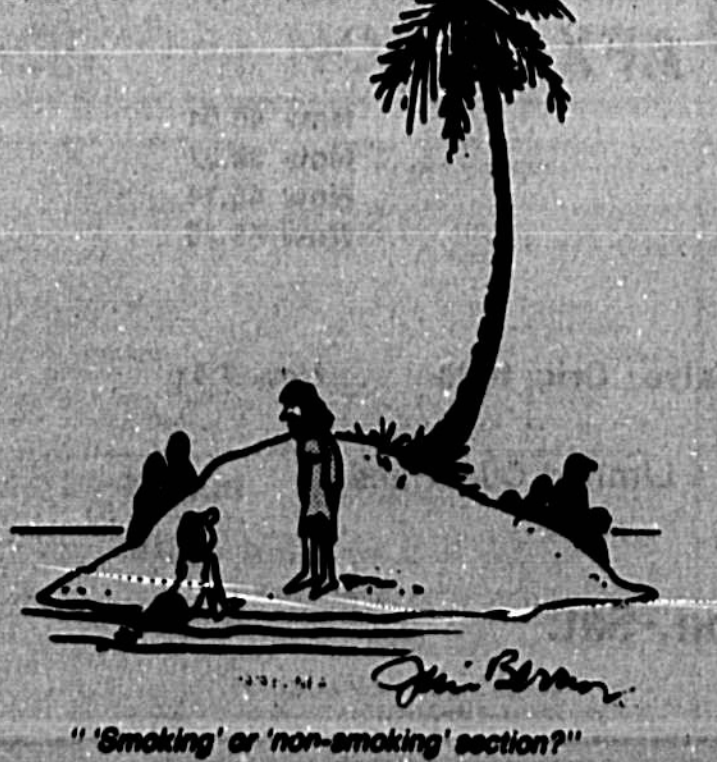
TV's Archbishop

Some 20 million television viewers tuned in each week in the 1960s to watch Archbishop Fulton J. Sheen and his "Life is Worth Living" — a program that inspired Milton Berle, Groucho Marx and Frank Sinatra.

Sheen, who died at 84 Dec. 9, 1979, was appealing to Roman Catholic and non-Catholic alike. They found his religious commentary inspiring and admired the slim priest with the deepest eyes for his warmth and humility.

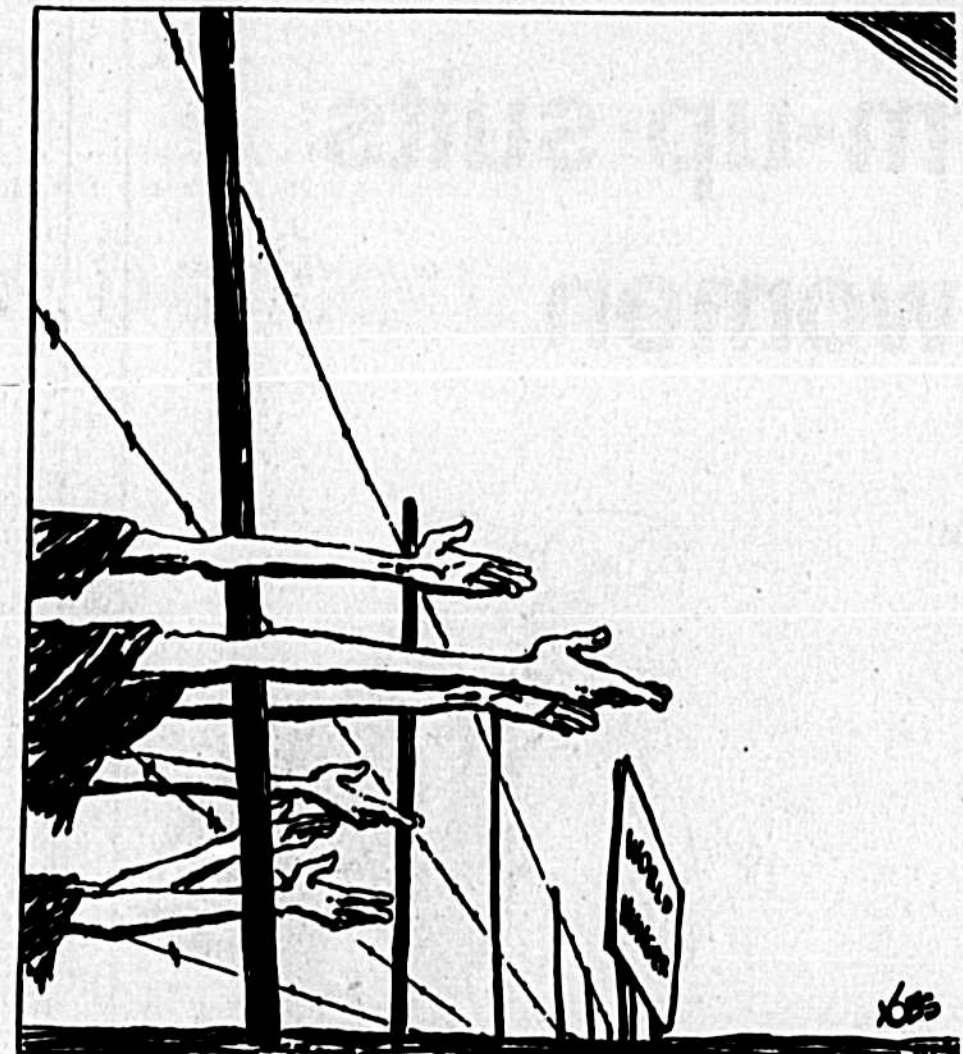

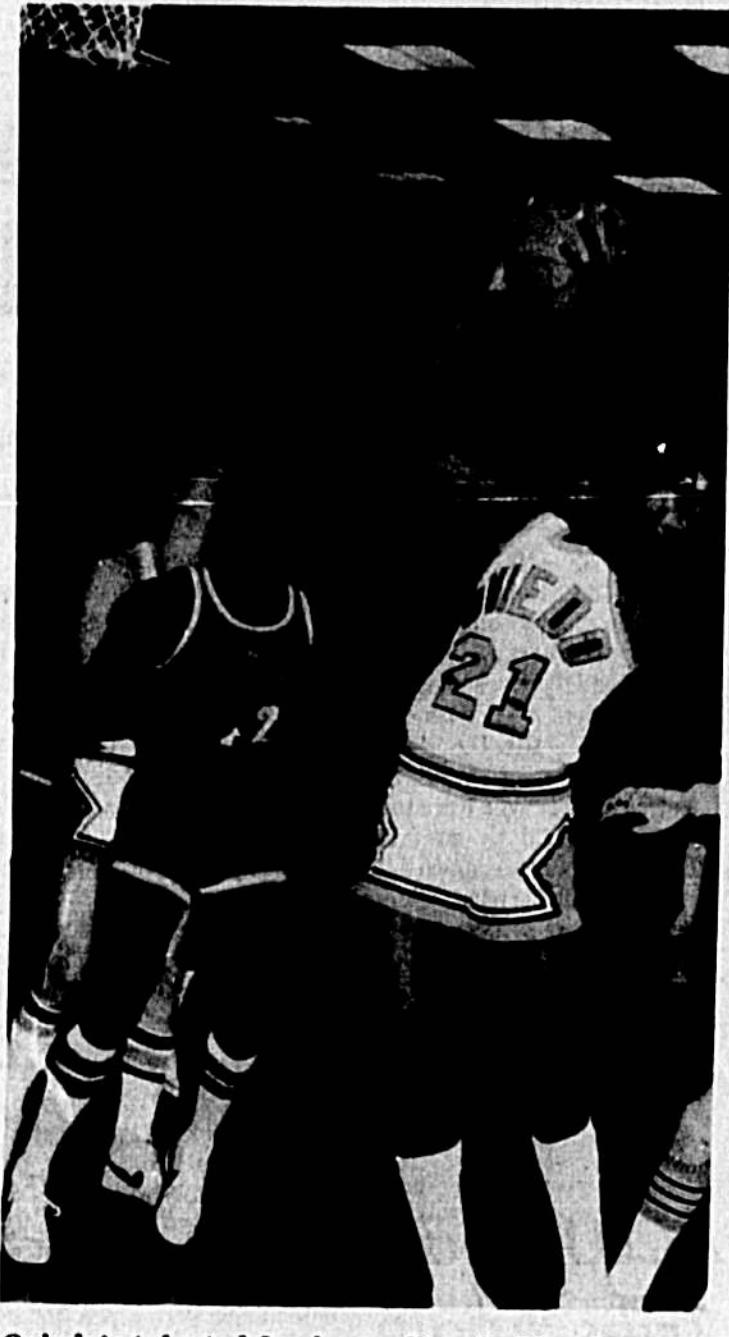

State To Appeal Case Affecting Use Of Land

TALLAHASSEE, Fla. (UPI) — Attorney General Jim Smith will ask the Florida Supreme Court to overturn a 1st District Court of Appeal decision he believes seriously jeopardizes state efforts to protect environmentally valuable lands.

Smith said Wednesday he will appeal the ruling requiring the state to allow the development of privately-owned land or buy it.

Shuttle Tests Plagued

Simulation More Difficult Than Reality, NASA Says

CAPE CANAVERIAL, Fla. (UPI) — Space officials say they feel that an actual launch of the Space Shuttle could be easier to accomplish than to simulate one.

Technicians have scheduled the 45-minute simulated launch and flight into orbit of the Columbia again today — the fifth time it has been rescheduled since the dress rehearsal tests of the Space Shuttle's operational systems and crews began Sunday afternoon. The tests are due to end Friday.

The troubles plaguing the test program are all centered in the simulator equipment, not the shuttle itself, space agency officials said. The Columbia rocket plane is sitting in its hangar, not on a launch pad.

"Keep in mind that these are simulations using a computer program especially designed for this test. It is with the test program that we are having the problems," said A.P. O'Hara, director of Space Transportation Systems

Processing at the Kennedy Space Center. "The criteria and launch processing system are performing quite well together," O'Hara said, "and this is what counts on actual launch day."

A new Space Shuttle problem — not related to the tests at the Cape — cropped up Wednesday.

Officials from NASA and Rockwell International, the shuttle's builder, said all three of the Columbia's engines will have to be removed so that modifications can be made.

During an early test of identical engines, a turbo-pump seal began leaking, the officials said. Parts of the engine will be shipped to California for modification.

After several failures, three identical engines were classified successfully this week for 500 seconds — more than the time needed to put Columbia into orbit — at the Bay St. Louis, Miss., space laboratory, "said A.P. O'Hara, director of Space Transportation Systems

The latest and fourth postponement of the Columbia's prime crew — veteran astronaut John Young and Navy Cmdr. Robert Crippen — arrived at the Cape Wednesday afternoon. They had been monitoring the test efforts earlier from the Johnson Manned Space Flight Center at Houston, Texas.

Judge Orders 'Pirates' To Stay Away From Booty

MIAMI (UPI) — A federal judge told two treasure hunters Wednesday to stay away from salvage operations being conducted off the Marquesas Islands by Key West treasure hunter Mel Fisher.

Fisher had come to court to complain that John Gasque and Owen Frick of Caribbean Ventures Inc. are "pirates" trying to recover booty from the wreckage of the Spanish galleon Nuestra Señora de Atocha, which went down in 1622.

Fisher told U.S. District Judge William O. Mehrrens that Gasque and Frick had fired shots at his salvage ships two weeks ago as they worked the treasure site.

Fisher's two companies, Treasure Salvors and Aramada Research Corp., announced three years ago they had found the wreckage of the Atocha scattered across the ocean floor.

Fisher was given exclusive rights to salvage the wreck after a long battle with the state and federal governments.

On Wednesday, Gasque and Frick, claiming they had used a satellite to scan the Caribbean, said they had discovered the ship.

"How do you explain the fact that Mr. Fisher has found items which were on the Atocha's main deck?" Mehrrens asked the two men.

In separate testimony, Gasque and Frick said the cargo of the Atocha is actually that of the Spanish galleon Santa Margarita. The cargo had somehow been transferred from one ship to another, they said.

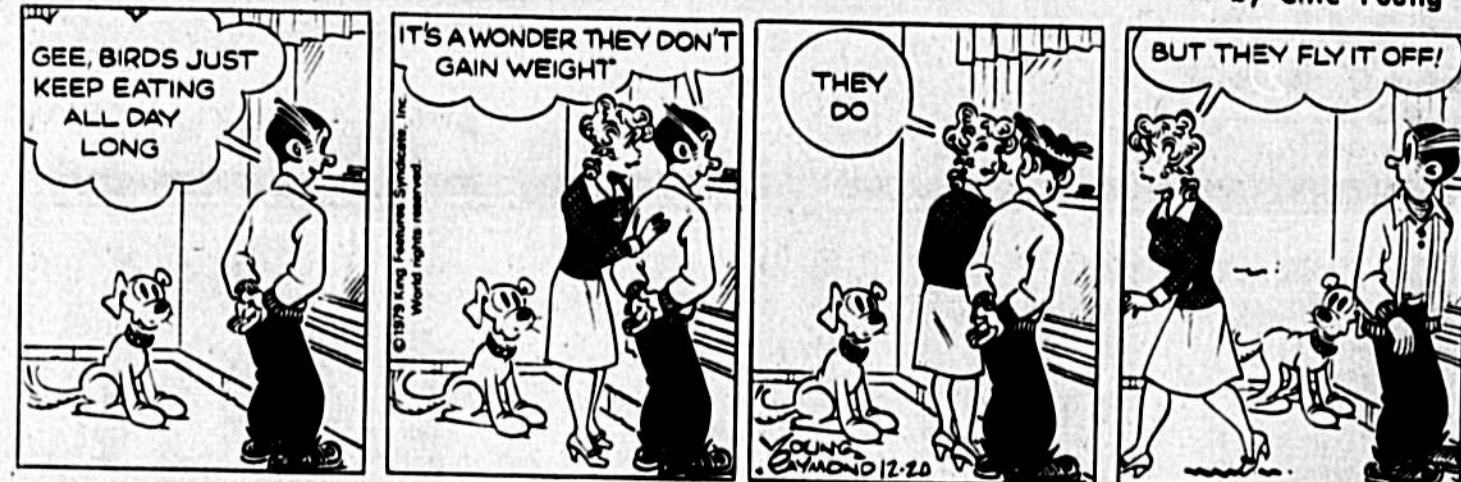

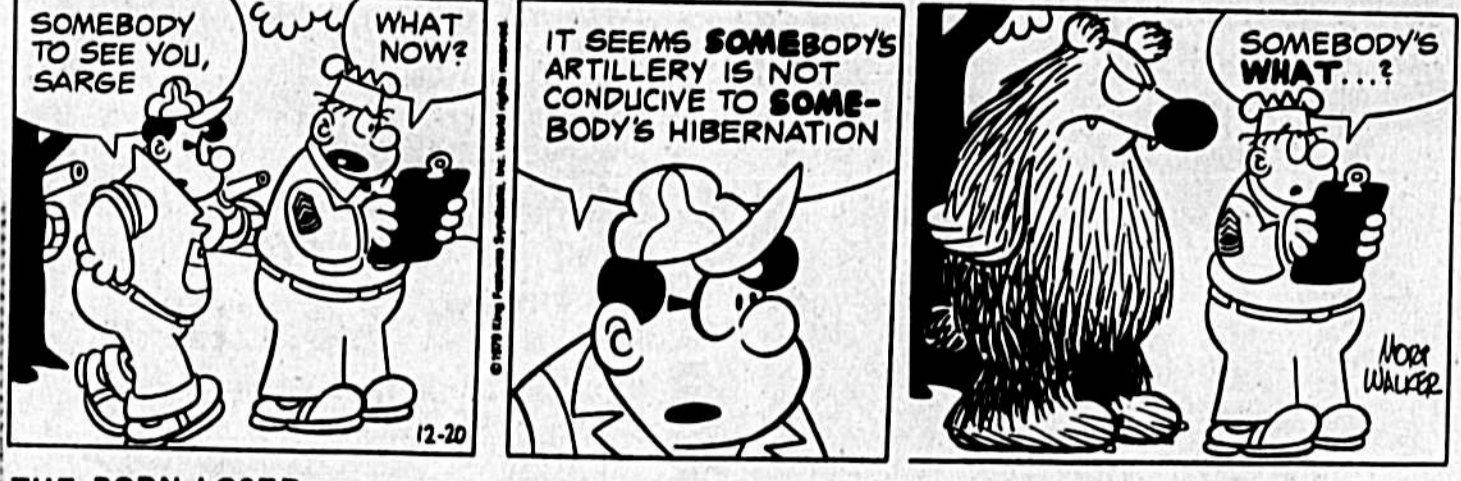

For-Profit Hospital Remains In Running

Allowing Seminole Memorial Hospital to become a for-profit facility would not necessarily cost Seminole County more money than if the hospital is taken over by a not-for-profit group, according to county commission chairman Bill Kirchoff.

In looking at the proposals for the hospital from the for-profit Hospital Corporation of America (HCA), Nashville, and not-for-profit Florida Hospital, Orlando, Kirchoff said the county had taken the Hill-Burton obligation into consideration.

Under the federal Hill-Burton Act, the county obtained grants for construction and equipment for Seminole Memorial Hospital. A percentage of this money will have to be repaid if the hospital is taken over by a profit making corporation.

After subtracting an estimated repayment amount from HCA's offer, Kirchoff said the county would receive approximately the same financial benefit from the for-profit group as from Florida Hospital.

HCA proposes to lease Seminole Memorial Hospital for 36 months while it constructs a new 200-bed facility. It offers to pay \$6,800,000 for the lease. Deleting the hospital's liabilities, this payment would net the county \$5,100,000. Kirchoff said after the estimated Hill-Burton repayment, the county would have about \$4 million of this money left.

HCA's new hospital would cost \$18 million. After it is constructed, the old hospital building would be returned to the county. Kirchoff estimated the value of the building at about \$2 million.

Thus, HCA's offer amounts to about \$24 million.

Florida Hospital proposes to buy Seminole Memorial Hospital for \$8.25 million, spend \$6 million renovating and \$10 million building a satellite hospital somewhere between downtown Sanford and Florida Hospital Altamonte. Again, \$24 million would be spent.

Both groups urge that they are the most cost-effective," Kirchoff said. "That's why we're going to study the matter further."

The commission, he said, has submitted questions concerning the anticipated sale or lease of the hospital to County Attorney Nikki Clayton for her legal clarification.

Ms. Clayton said Thursday the

questions are:
"What can be done with funds received if the hospital is sold?"
"Can the county deal with a for-profit corporation and what would be the limitations or restrictions?"
"What limitations or restrictions would there be on the various forms of contracts that could be made?"
"Who has what responsibility for indigent care?"

Kirchoff said the residents of Seminole County should be concerned with the future management of the hospital as it relates to the quality of care provided, the cost of care and the future cost to the county of each proposal.

He also said the possibility of a hospital being built in Deltona will depend on what the Seminole County Commission decides to do with Seminole Memorial.

The commission has narrowed the possible choices to three, among the original six groups that submitted proposals for the sale or lease of Seminole Memorial. They will interview representatives of each of the three groups Jan. 10.

A public hearing on the matter will be held Jan. 15.

County Hospital To Try To Settle Suit With Low-Income Patients

Seminole Memorial Hospital trustees directed Hospital Administrator Charles Bentley to negotiate a settlement with a legal-aid group suing the hospital for not spending the federally required amounts of money to treat low-income people.

The suit, brought by Florida Legal Services, Inc., was filed on behalf of five people who claimed the hospital refused them free care during 1976 and 1977. The suit says the hospital did not spend \$39,487 of the money it had budgeted for indigent care. The hospital has a total of \$176,338 budgeted for care of indigents in 1978 and 1979.

Bentley said he hopes the settlement will be less than \$29,487.

The federal court suit asks the court to judge it to be a class-action suit on behalf of 20,000 low income Seminole County residents.

Gasoline prices at the pump increased by 1.7 percent.

The only encouraging sign in the housing sector was that fuel oil prices rose by just 0.4 percent, compared with an average monthly increase of over 4.5 percent during the first 10 months of the year.

Gas and electricity prices declined by 2 percent as some utilities across the country reduced fees.

Transportation prices rose 1.4 percent, nearly triple the October increase, the Labor Department said.

Gasoline prices at the pump increased by 1.7 percent.

Florida Legal Services, said the agency is willing to settle the case out of court if the hospital agrees to absorb the bills of the individuals and to provide additional free care to qualified indigents.

The suit is based on the federal Hill-Burton Act, which provided construction and equipment grants to the hospital with the stipulation that for 20 years following each grant a percentage of the hospital's yearly operating funds would be spent on free care for the poor.

Hospital Public Relations Director Kay Bartholomew emphasized that the free care is dispensed only among those who provide proof of their income.

Although the hospital was behind in its Hill-Burton obligation at one time, Ms. Bartholomew said the hospital is rapidly making up for it. In the fiscal year beginning Oct. 1, the hospital has dispensed \$84,570 in care to the poor.

A Sanford migrant-labor camp operator has been charged with housing workers in substandard conditions by Department of Labor officials.

Joe Jones, who operates a camp for migrant laborers in Sanford is being sued in U.S. District Court in Orlando, on charges he is not providing proper facilities and pay information for the workers at the camp, by Secretary of Labor Ray Marshall. The suit, alleging violations since January, 1977 was filed Dec. 6.

Jones could not be reached for comment on the action.

Consumer Prices Surge 1%

WASHINGTON (UPI)—Consumer prices surged upward another 1 percent in November, pushed by a steep climb in housing and gasoline costs, the government reported today.

The 1 percent jump in the Labor Department's Consumer Price Index represented the 11th consecutive double-digit increase and virtually guaranteed that the nation will finish 1979 with its highest inflation rate in more than 30 years.

Over the first 11 months of the year, consumer prices advanced at a 13.1 percent annual rate.

The inflation since 1946 when World War II price controls were removed.

The main trouble area last month was in housing, an important sector of the economy. Mortgage interest rates have increased sharply ever since the Federal Reserve Board moved Oct. 9 to severely restrict credit in hopes of stemming inflation.

The Labor Department said more than half of the overall November increase was due to rising house prices and mortgage interest rates.

Mortgage rates in November rose 1.9 percent, while the home prices rose 1.8 percent.

County's Pot Sniffer Hanging Up His Nose

Dennis, the pot sniffing German shepherd who has been the entire K-9 unit for Seminole County law enforcement agencies for the past four years, is retiring.

Dennis is now the personal pet of former Lake Mary Police Sgt. Dale Pico, his handler during his time of service to the local criminal justice community.

He is not sniffed lockers at Seminole County schools, searching out drugs, but also provided tracking when needed by the sheriff's department and other law enforcement units in the area.

Dennis' retirement was called not only because he is getting older (he is nine years old, which computes to 63 years in human life) and has a hip problem, but also because Pico has quit the Lake Mary Police Department to join the Altamonte Springs force.

The Lake Mary City Council Thursday night voted to give Dennis to his handler.

Commissioner Burt Perinich said the dog had been given to the Lake Mary department as a gift and under the condition that he and his handler be treated together.

"I would like the city to give Dennis to Pico as a pet now," said Perinich after the city council accepted Pico's resignation from the force.

Sheriff John Polk said today the dog and Pico had been a great help to his department over the years. "We'll just have to find some other means," Polk said today, adding his department can borrow K-9 dogs from the Winter Park Police Department when needed.

Oops Shotguns Greet Fliers

Two men flying a light plane from the Bahamas thought they had problems when their radio and other electrical systems failed. But their problems were not at all beginning.

By 9 p.m. Thursday night they found themselves on the ground at Sanford airport, surrounded by shotgun-wielding police, after being chased through the skies by a U.S. Customs jet.

Due to radio failure, the two unidentified fliers in a Cessna 337 were unable to file a flight plan or notify Customs of their presence as they entered U.S. airspace, explained Sanford Police Sgt. William Barrows.

So Customs sent up a jet to follow them from Miami, following reports the plane was making "evasive maneuvers near Orlando. The evasive maneuvers turned out to be a flight path into Sanford.

Sanford Police responded in force, believing they had nailed another smuggler, and might soon be able to add another plane to the growing Seminole County Sheriff's department fleet, consisting of two small planes and a DC-4, caught filled with drugs.

But instead they found only two confused fliers, scared as they looked down the barrels of police shotguns. — DAVID M. RAZZIER

"My wife won't talk to anybody. She hands the phone over to me. It's really bothering her a lot more than it is me; her and our daughter," he said.

And there are Zane and Dorothy Hill in Little Falls, Minn., who are waiting for word of their son Joseph, an Army warrant officer. They start and end each day by watching news programs.

"We keep hoping something will happen. But nothing ever does. It is the same thing every day," Lewis said. "I know he won't be home for Christmas."

Iran's Chorus Sings Same Tune: Get Shah

TEHRAN, Iran (UPI) — Ayatollah Ruhollah Khomeini charged President Carter is more concerned about the deposed shah than about the 50 American hostages and the former ruler be returned to Iran, offering little hope for the success of diplomatic negotiations with Iran to try to break the impasse.

"Why do the Americans sending the shah to Panama?" Khomeini asked. "He must be sent here, to our country. We know what to do with him. But the fact is Carter cares more about the shah than the 50 hostages."

The reports followed verbal attacks by the militants against Ghotbzadeh for his "irresponsible" softline toward the hostages, in their 8th day of captivity, and after the foreign minister was refused public backing by Khomeini in his struggle for influence over the militants.

The chief justice of Iran's Islamic courts, Sheikh Saadeq Khalkhali, told the London Times newspaper that he considers the hostages innocent and they should be released.

The militants Thursday ruled out any Christmas visits to the hostages by relatives, a possibility raised earlier by Iran's interior minister.

Khomeini, in his latest interview published Thursday in the newspaper, backed the hardline of the captors and offered little hope of an early solution to the embassy crisis although U.N. Secretary General Kurt Waldheim is engaged in "intense discussions" with Iran to try to break the impasse.

Iran's Contradora Island, must be returned to Iran to face trial or the captives would be tried as spies.

But Khalkhali, who personally ordered the execution of more than 200 former officers of the shah's regime, told the London Times from his home in the holy city of Qom, "Even if they (hostages) are spies that is not enough reason to keep them... We cannot execute any spies according to Islamic laws.

"They will only be executed if they are directly responsible for ordering a murder."
