





Turning the corner

Do's and don'ts for launching or loading your boat

Launching Your Boat From A Trailer

· Don't block the boat ramp unnecessarily. Transfer equipment before backing on to the ramp.

 Disconnect trailer lights from tow vehicle. Be sure you allow bulbs enough time to cool down before launching to extend their use.


* Remove all tie-downs except the winch line before backing down the ramp.

 Make sure your drain plug is in.

• The a line to the bow to maintain control of the boat while launching.

 Initially back the boat into the water far enough so that the lower unit of the engine can be lowered and submerged with the boat still on the trailer. As an added precaution always set the parking brake on the towing vehicle. Start the boat's engine with the lower unit submerged. This way, your boat is still on the trailer and if you have engine problems, you can easily retrieve the boat.

 Once the engine is started and sufficiently warmed up. back the trailer further into the water until the boat floats. Undo the winch line, put the boat engine in reverse and back slowly off the trailer.

SCC men win third straight

SANFORD - The Seminole Community College men's basketball team may be coming of age as it won its third straight game with a 74-60 thumping of Johnson County Community College from Overland Park, Kansas on Saturday at the

SCC Health and Physical Education Center.

The young Raiders pounded the ball inside against the bigger Cavaliers and controlled the contest, moving out to a 36-28 halftime lead and never looking back.

SCC, under first-year head coach Stan Cromartie, has now won three straight games and is now 7.9 on the season despite playing with eight freshmen on its 10 man roster.

"We're getting better and better," said Cromartic, "I think we're going to be all right."

The Raiders will close out their pre-conference schedule with three games this week. On Wednesday, SCC will

 Back the trailer into the water so that approximately two-thirds of the rollers or bunks are submerged in the water. Set the parking brake of the towing vehicle and put it in park or first gear.

Drive the boat onto the trailer far enough so that the winch line can be attached to the bow eye of the boat. Finish pulling the boat on to the trailer by cranking the winch.

* Shut off engine and raise the outboard or stern drive.

Pull the boat out of the water and off the ramp out of the way of others.

 While still at the landing. remove and dispose of all weeds from the boat; remove drain plug and release bilge water.

 Reattach tie-downs and plug in the trailer lights. Check to see that the trailer lights are working before departing.

SHUPS'S SCOOP

Never back down to the boat ramp unless you are ready to immediately launch your boat. Ramp etiquette dictates that boaters load their boats and attend to other matters away from the ramp, and leave it open for people who are ready to launch

FISHING FORECAST

Expect great bass action in the river and in local lakes. Shiners will take most of the lunkers at this time of year. Fish shiners tight to heavy cover such as floating water hyacinths for sure action. Slow trolling with shiners is another deadly tactic. Monday night at the UCF Arena, the host Golden Knights got 25 points from Sanford's Brad Traina and raised their record to 2-0 in the TAAC with an 88-70 triumph over preseason conference favorite Georgia State University.

The University of Central Florida had opened conference play on Saturday with a 78-52 thumping of Campbell University from North Carolina.

An oddity on scheduling has the Golden Knights, now 6-6 overall and 2-0 in the TAAC, going to Campbell on Thursday and to Columbus, Georgia to take on the Panthers on Saturday afternoon.

All eight of Traina's field goals came from three-point land, which tied Harry Kennedy's record set at Samford in 1996, He was 8-for-12 on "three's", 8-for-14 overall, including a 6-for-8 effort in the first half that accounted for 19 points.

The senior forward may have broken the record if he had not aat out most of the second half after reinjuring an ankle that had been bothering him for the past few weeks.

happening or how bad it would be," Franchine Mitchem said. "We heard the weather reports carlier in the evening. We heard the tornado warnings. We were in bed when it happened. We're thankful we were not hurt."

A massive tree crashed into the roof over the Mitchems' bedroom, barely missing their bedpost. On Monday, the Mitchems waited for insurance people to come. Meanwhile, county officials roped off an area of the property as unsafe -and off limits to unauthorized personnel.

The winds knocked down a 70-foot tree at a Deltona residence on Atmore Circle. The force of the falling tree cracked the walkway leading to the Ray Osteen's home. His home was not harmed and no one was hurt. "We're the talk of the neighborhood," Osteen told reporters.

For many of the people in the area where the storm had hit, it was an unexpected opportunity to be interviewed by TV report-ers, who invaded the scene on Sunday and again on Monday. "Our 15 minutes of fame," one resident said.





A big storm and a big chill for Seminole

SEMINOLE COUNTY . First there were the scary weekend storms that caused nearly \$200,000 in damages, and now Central Florida is bracing itself for another night of freezing temperatures.

The high today may not be much more than the low-to-mid 50s, with the temperatures dipping into the low 30s by to-night or early Wednesday. The main concern is in nearby Volusia County where from oversees are toting to near
