representatives who expressed interest in the plan.

Meanwhile, a British-Foreign Office spokesman said that thus far Denmark, Norway, Belgium, Holland and Italy had asked Britain for further details on the Marshall plan through their diplomatic representatives in London.

Other authoritative informants said Foreign Secretary Bevin had called for a report from British occupation authorities as to how Germany should be fitted into any plan of continental reconstruction.

In Berlin the official newspaper of the Soviet military administration in Germany observed today that "the people of Europe look with great hopes" to the Marshall plan conference opening Friday in Paris.

"All European people now suffering the effect of the war would welcome with joy the aid that can be given them by America, a country which, as is known, did not suffer from the war but without doubt actually became richer through the war," said the newspaper, the Taegliche Rundschau.

"But the Marshall plan must be, as Secretary Marshall said, a fight against hunger and must not bear any political strings like 'dollar diplomacy.'"

Two of these would authorize continuation of the information program and the third would authorize employment of clerks and secretaries for federal judges.

The House eliminated funds for bought on credit. It also requires that installments be paid off in 15 months at most.

With controls removed, purchasers will be able to buy at whatever terms a dealer is willing to give.

With this Congress session scheduled to run only about five weeks more, leaders are beginning to whip together a stretch program. (They aim for adjournment about July 31).

One big measure put down for action is that to put the Army and Navy under a single cabinet officer. It is part of the answer the administration framed to one of the major questions confronting Congress when it met.

What can be done to strengthen national defenses?

President Truman asked also for a universal military training law, but G.O.P. leaders have passed the word there will be no decision on that at this session. It is getting study and the House Armed Services Committee decided today to go ahead with hearings.

Also in today's developments: Foreign Broadcasts.—The Senate Appropriations Committee recommended that the State Department be allowed to continue its foreign language radio broadcasts, known as "The Voice of America." It recommended however, an appropriation of \$11,500,000 to finance that and other information programs instead of the \$34,000,000 asked for operations in the 12 months beginning July 1.

Radio.—The Senate Commerce Committee, continuing hearings on legislation to rewrite radio broadcasting laws here at home, heard Rolf Kaltenborn recommend that radio stations be required to give a "fair presentation" of differing views on important public issues. the new federal mediation agency created by the Taft-Hartley Act.

In any event, the lawmakers will have some time to act on the question of funds to administer the new labor law. The

Wagner Act revisions, such as the ban on the closed shop, do not go into effect for 60 days. (The new legislation set up will start operating in 30 days).

But another major provision of the act is in effect now. This provision authorizes the government to obtain 80-day injunctions to block or stave off national emergency strikes.

However, Taft says he still is not certain that this section will list its purpose in the event of a coal strike next month when the government turns the soft coal pits back to private owners. The Ohioan says it is open to question whether the government could force the miners to remain at work for a new employer with whom they have no contract.

Meanwhile, there has been swift and bitter reaction from organized labor to enactment of the Taft-Hartley Act. There are actual mine shutdowns in effect and there have been irate calls for widespread protest strikes across the nation.

Union leaders have been stung by the ease with which the House and Senate overrode Mr. Truman's veto. And they have threatened reprisals at the polls against legislators who favored the labor law.

Other labor leaders have promised to work for the prompt repeal of the act and still others are going to try to get quick court tests of the constitutionality of the law.

Cries of anger and protest have come from many of the nation's top labor leaders. One of these has declared privately he sees about 10 years of litigation ahead for organized labor and industry. There has been some scattered talk of a general strike by the more than 15,500,000 members of labor unions. But AFL and CIO headquarters in Washington are minimizing the possibility of any such move.

However, the San Francisco CIO council, in a telegram to CIO President Phillip Murray, has proposed a 24-hour nationwide work stoppage in protest against congressional enactment of a law labor bosses have described as a "slave" labor law.

Murray has made no public reply. But he has summoned his 51 member executive board to meet with him Friday in Washington in an emergency session to

discuss the situation now confronting organized labor.

Enactment of the Taft-Hartley bill also is having its repercussions on the political front.

Democratic Senator Claude Pepper of Florida says he believes the Senate's action in overriding Mr. Truman's veto has given what he calls "tremendous impetus" to a fledgling Third Party movement. Says Pepper:

"Political history has been written here. Congress has done more than Henry Wallace ever did to lift a Third Party. We have seen a demonstration that neither party can muster a majority in Congress for liberal proposals. Nobody but intellectual liberals have been interested in a Third Party up to now, but if the working people feel that their rights aren't going to be protected they may make a third

party movement a vital affair." Some Democratic Senators, including Harry Byrd of Virginia, are not in agreement with Pepper's views on the political effects of the enactment of the labor law.

And Republican colleagues are disrupting the views of Vermont's Senator George Aiken. Aiken declares that as he sees it, the Republican party as of today has lost the rank-and-file labor vote. However, says Aiken:

"If (the GOP) has a chance to recover some of it if it will act in the next Congress to amend some of the law's objectionable features before the 1948 election."

Aiken explains that on the strength of promises from GOP leaders to sponsor such amendments, he voted with his colleagues to override the President's veto.

## U.S. Protests Arrests Made In Romania

### Note States Action Seen As Effort To Suppress Anti-Communist Party

MOSCOW, June 25 (AP)—Pravda declared today that if future American economic aid to Europe is conditioned on the "Greek-Turkish example" then the whole idea of the Marshall proposal is doomed to fail.

"The question of the conditions which the United States will place on their economic aid is of decisive significance for European nations," the Communist Party organ said editorially. "It is precisely the character of these terms that will reveal the real essence of the Marshall proposal and will determine its success or failure."

WASHINGTON, June 25 (AP)—The United States protested sharply to the Romanian government today against the "arbitrary arrest without warrant or charge" of "hundreds" of opposition party members and others.

A note said that the arrests appeared to represent "a deliberate effort at the suppression or terrorist intimidation of democrats opposing the present Communist-dominated regime."

The State Department made public the note which Roy H. Melbourne, acting United States Representative at Bucharest, has been instructed to deliver to the Romanian foreign minister.

The note said that the arrests appeared to violate formal assurances given by Romanian officials that public liberties would be safeguarded. It said further that "such evident deprivation of the most elemental human rights and fundamental freedoms" conflicted with terms of the Romanian peace treaty. This treaty has been signed by the Romanian government and ratified by the United States.

## De Nicola Sends Resignation As Italian President

ROME, June 25 (AP)—Provisional President Enrico De Nicola sent his resignation to the Constituent Assembly today.

The resignation came after approximately 6,000,000 members of the Communist-dominated Constituent Assembly held a nationwide half hour strike at mid-morning in protest against a series of attacks on Biellian Communist headquarters Sunday.

De Nicola's message, read to a hushed assembly by speaker Umberto Terracini said his health prevented him from exercising "my functions any longer." De Nicola is 69.

"I apologize for not having been able to fulfill my duties as I should have desired," his message read.

The assembly gave De Nicola a standing cheer and adjourned until tomorrow.

The possibility remained that the assembly might ask De Nicola to serve again. Other candidates mentioned were the three old men of Italian politics, all former premiers: Franco Bonomi, Francesco Saverio Nitti and Vittorio Emanuele Orlando, last survivor of the four of the first World War.

## Congressman Shows Up At May Trial

WASHINGTON, June 25 (AP)—Rep. Charles A. Buckley (D-N.Y.), angrily denied in a federal courtroom today that he had avoided "in any way" appearing as a witness in the May-Garrison war fraud trial.

Buckley showed up this morning after government prosecutor William A. Paisley had complained in court yesterday that the Justice Department had been trying to find a way to keep him from New York as a trial witness.

"The impression has been created not only in my own ally but all over the nation that I was avoiding coming here," Buckley shouted from the witness stand.

## U.S. Warned Of Over-optimism About 3 Nation Paris Meeting

### Marshall Plan Is Interpreted By Sec. Snyder

#### U. S. Not To Have Representative At Paris Conference

WASHINGTON, June 25 (AP)—Secretary of Treasury Snyder made plain today that he does not view the Marshall plan for European recovery as giving foreign countries a blank check on the United States for what they need.

Snyder told a news conference that Secretary of State Marshall has not extended an implied invitation to other countries to tell this nation "what they need or want."

"My interpretation is that he is asking them to make a self-inventory and see what they can do for themselves," Snyder told reporters.

Meanwhile, Marshall said at another news conference that he does not plan to have a representative attend the talks of British, French and Russian foreign ministers concerning the European recovery program. These discussions are scheduled to begin in Paris Friday.

Asked whether he plans to have an observer there, Marshall said he does not. He flatly declined to give out any more information now about these proposals. When a questioner referred to the program as "your proposal" Marshall interrupted quickly to say the reporter meant the American government proposal.

Snyder said he gave this interpretation to the Marshall plan proposal. "He invited them to sit down and see what their problem is. He didn't say anything about letting the United States know how much is wanted. He said they should get together and make up their own minds as to what they ought to do in their own countries."

Snyder's comments were made not only as treasury chief but as chairman of the Government's National Advisory Council on International Finance. This was set up by Congress to supervise government financial dealings with other countries. Marshall is a member of that council.

The Junior Chamber has agreed to furnish \$100 and the Senior Chamber \$200 toward the project, he said. ## Army Bans Sending Tobacco To 2 Nations

FRANKFURT, Germany, June 25 (AP)—The U. S. Army today banned the shipment of American cigarettes to military personnel in Austria and France, effective July 1.

Mailing of tobacco goods to Germany was prohibited May 26. The Army said it hoped the order would "cut black market trading in cigarettes, tobacco and cigars."

Under the new ruling, relatives and trading companies in the United States will no longer be allowed to mail cigarettes to the following army post offices in France or Austria—APO M, 761, 174, 841, and 777.

## District Commander

(1) Full-hearted participation in the Marshall project with determination to make it work; (2) participation with the idea of scuttling the ship; (3) outright rejection of the proposal with a knowledge that this would further solidify the division of Europe into eastern and western camps.

That's not being cynical but a merely employing horse-sense in these dangerous days when caution is necessary. It's recognizing facts instead of indulging in wishful thinking.

There's a difference, though between wishful thinking and hope. It is legitimate for us to hope that this reconstruction proposal may break the ice and in at long last permit of cooperation between the Russian bloc and the Western Allies. Such cooperation may not be possible at this time, but it is possible.

Mind you, I don't believe Russia has completed her maneuvering for positions of advantage in Europe. The signs are that she intends to consolidate her hold on Hungary, to bring Austria within the Red fold, and to establish her influence over Germany. There is every indication, too, that Moscow hasn't the slightest intention of abandoning its campaign for communication of the world.

However, it is possible the Soviet has extended its influence sufficiently so that it now would be willing to cooperate with the Western Allies—provided it fits against it.

Russia is deeply suspicious of her former allies. She has charged America and Britain with attempting to encircle her. And the Western Allies on their part have been suspicious of her.

## Cargo Ship Guttled By Fire In 2 Holds

JERSEY CITY, N. J., June 25 (AP)—Fire spread through two holds of the U. S. President Lines' 10,782-ton cargo ship, the S. S. Marine Flor, today as longshoremen loaded the vessel for sailing Friday to the Far East.

A heavy pall of blue-gray smoke rose from the ship and drifted across the Hudson River over downtown Manhattan. Two Coast Guard boats including the fireboat, the New York City Fireboat John Harvey, 10 rail-road tugboats, and 13 fire companies joined in subduing the blaze that broke out at 11:10 A. M. (EDT) and was not under control until an hour and a half later.

## Missouri River Sets New Record Level

OMAHA, June 25 (AP)—The turbulent Missouri River set a new record level in southeast Nebraska today as residents of Nebraska, Iowa and Missouri braced for new floods expected to follow widespread rains.

Water covered low-lying crop lands as far as the eye could see at Rulo, Neb., where the Missouri climbed to a new all-time record of 21.02 feet at 8 A. M. (CST) today. The previous record, 20.96, was set last June 16.

## Steel Hit As More Miners Join Walkout

### 200,000 Bituminous Workers Said Idle: U. S. Steel Losing 70,000 Tons Daily

PITTSBURGH, June 25 (AP)—Thousands more of the nation's coal miners joined pre-emption walkouts today and the fifth steel industry curtailments because of the two-day old fuel stoppage were announced.

Field reports indicated nearly half of the 400,000 bituminous miners were idle. Some miners said they walked out protesting adoption of the Taft-Hartley union-curbing bill, while others said the stoppage was merely a "head start" on vacations which start in the coal-pit Friday midnight.

An attempt by United Mine Workers leaders to start a return to work in West Virginia mines was outdone by new mine closings there. Against 2,000 men returning in Monongahalia county, more than 11,500 joined the walkout, raising the state's total of idle to 41,000.

Reports from the coal mines administration and operators listed another 10,000 men idle in western Pennsylvania, raising the total to 51,000 or more than 50 percent of the soft coal diggers there. In eastern Pennsylvania, the first walkouts occurred in anthracite mines, with more than 3,200 quitting work in the Panther Valley area.

The Carnegie-Illinois Steel Corporation announced the shutting down of the equivalent of 4 1/2 blast furnaces in the Pittsburgh district. A two-thirds curtailment of its bessemer department at Youngstown, O., was also effected, cutting off production of 1,500 tons of steel daily.

The corporation's parent firm, U. S. Steel Corp., reported all its coal mines in Pennsylvania and Kentucky were closed, causing the loss of about 70,000 tons of coal daily. Other steel firms were similarly hit.

## Carmony Testifies On Shipyard Deal

WASHINGTON, June 25 (AP)—John M. Carmony, former member of the Maritime Commission, denied today there were any irregularities in the sale of the St. Johns Shipyard at Jacksonville, Fla., to the Tampa Shipbuilding Co.

Carmony said he asked the company if it would change its installment-plan bid of \$1,927,500 to a cash offer "because the Commission was anxious to get rid of all surplus yards as quickly as possible."

He testified before a House subcommittee on surplus property, which is investigating the sale, that maintenance costs for surplus yards were running above \$1,000,000 a month in February, 1946, when the Florida property was sold.

## Inquiry Begins Into Tanker Explosion

WILMINGTON, Calif., June 25 (AP)—A special Coast Guard board of inquiry convened today to determine if possible, what caused the tanker Markav, loaded with nearly 3,000,000 gallons of fuel oil, to explode Sunday, killing at least five men and leaving eight still missing.

Capt. John Trebes, chief of staff of the district Coast Guard headquarters, was named senior member of the investigating board. Assisting him is Comdr. P. A. Orenden of the Washington Bureau of Marine Inspection and Navigation.

William Anderson, division superintendent of the Keystone Shipping Company, which operated the Markav, denied that the vessel, at the time of the explosion, was filled with butane.

WASHINGTON, June 25 (AP)—Federal Reserve Chairman Marriner B. Eccles told Senators today it may be necessary to shift the location of several Federal Reserve branches, banks unless Congress alters a 24-year-old limitation on cost of their buildings.

## Eisenhower Urges National Economy Pan-American Plan Blueprinted Armament Pact By Industrialist

### Area Of Great Lakes Said Vulnerable Spot In New War

WASHINGTON, June 25 (AP)—Gen. Dwight D. Eisenhower, chief of staff, said today that "an initial step" by the enemy in any new war would be a probable air strike against the industrial area near the Great Lakes.

He appeared before the House Foreign Affairs Committee to urge speedy approval of legislation authorizing United States aid to standardize arms of all American nations. He emphasized that it is needed particularly between the United States and Canada.

The standardization is vital to the security of the North American continent.

## Suspension Of Curley Sentence Is Asked

WASHINGTON, June 25 (AP)—Attorneys for Mayor Joseph P. Curley of Boston, sentenced to 10 years of 18 months in jail on mail fraud charges, asked federal court today to suspend sentence because of his "past serious and previous physical condition."

The 72 year old political leader who came here last night from a hospital where he had been undergoing treatment for diabetes and high blood pressure, is scheduled to appear in court tomorrow morning for committal to jail.

## Laney Drug Installs Air Condition System

The Laney Drug Store has installed a Carrier air conditioning system which uses a water circulating system as a cooling basis. Fresh air is brought from the rear of the building through aluminum ventilators. The cabinet with the mechanism is in the prescription room and draws in and recirculates air in the store.

J. O. Laney, proprietor, pointed out that a temperature 10 degrees cooler than outside, proves most satisfactory. The store recently installed a new soda fountain with stainless steel sinks and fittings.

## Legislation On Housing Seen By Taft

### 23 States Are Represented In "Fight For Homes" Rally In Senate Offices

WASHINGTON, June 25 (AP)—Senator Taft (R-Ohio) told a "Fight for Housing" rally here today that he believes long-range housing legislation can be put through the Senate before Congress adjourns next month.

He said that when House and Senate leaders meet next week to lay out a program for the remainder of the session he is "hopeful" of an agreement that will mean enactment of "some sort of a housing program."

He implied, however, that the program he is backing, embodied in the so-called Wagner-Ellender-Taft bill, might have to be modified considerably to win House acceptance. A similar bill passed the Senate in the 79th Congress but was bottled up in the House.

Some 400 housing advocates from 23 states attended the rally in the Senate office building.

Both Taft and Senator Ellender (D-La.), another co-author of the bill now pending before the Senate, told the crowd they knew of hardly any other legislation in recent years which had been so misrepresented.

Meanwhile, politics got all mixed up in Capitol Hill as Senate Democratic leaders organized a fight against presidential succession legislation requested by President Truman.

## Palestine Makes Report To U. N. Inquiry Group

JERUSALEM, June 25 (AP)—The Palestine government told the United Nations today its administration was based on the principle that the Holy Land "should neither be a Jew State nor an Arab state, but one in which the two peoples in Palestine should share authority in the government in such a way that the essential interests of each are secured."

In a 14-page memorandum submitted to the UN special committee on Palestine (UNSCOP), the Palestine government outlined Britain's 27-year mandate administration.

"Community of interests even more than material resources is fundamental to any large scale planning," the memorandum declared. "Creation of that community of interests has hitherto been blocked by a predominance of political influences."

"It may be that at any given time a few more battalions or airplanes or tanks would, as has sometimes been represented, have produced a different frame of mind in one or the other of the local communities."

"It may be that it would not, but in any event what frame of mind it would have produced in the other community?"

"It has seemed to the Palestine government that only through free recognition by both Arabs and Jews of the position, needs and rights of the other community, through free recognition of the other community."

## Chinese Reds Near Fushun Coal Mines

NANKING, June 25 (AP)—Chinese Communists have seized virtually all of the key Manchurian rail town of Szepingkai and are within 18 miles of the big Fushun coal mines east of Mukden, press dispatches said today.

Szepingkai's garrison was reported holding grimly to a single stronghold in the Japanese-built walled section of the town. Nationalists were reported to have recaptured Chongtshien, 60 miles southwest of Szepingkai, and the old walled city of Kaiyuan, about 42 miles southwest of Szepingkai.

# Patriotism Of French Proves Block To Reds

France may turn out to be one of the first imperial powers in history to let events internally through unrest and rebellion in her colonies.

With metropolitan France just barely staggering along, natives of Indo-China, Malagascar and North Africa have availed themselves of the opportunity to rise. Paris has taken stern restraining measures, promising reforms but backing her administrators with increasing numbers of bayonets.

Taking the side of the underdog (as usual, pending their ability to regiment him to their own purposes), the Communists have sought to appear liberal by trying to hamstring this colonial policy. By doing so, they have run up against something in the French National character which has definitely weakened the Communist position. A whole few months ago, the Communists seemed about to take over France. Today, even with their purported control of the Labor unions, they have been unable to sway the government from an increasingly rightist program for financial reorganization.

The French colonial situation would have seemed ready-made for the Communists. New impartial observers have ever had anything good to say about it.

When the late President Roosevelt met the Sultan of Morocco at his Casablanca, trip he appeared to take slight delight in discussing Winston Churchill, who was present, with references to French oppression of the natives, to Anglo-French syndicates which drained the riches of colonies and to the possibility of self-development of Morocco's resources with American help merely hired for the purpose. The Sultan, says Elliott Roosevelt, assured the President that something would be done after the war. That something has developed into an independence movement.

That's why the French are so nervous over the presence of the old riff leader, Abd-El-Krim, in Egypt. Krim, at the head of the wildest, most atrocious bunch of bandits in modern history, practically threw the Spaniards out of North Africa, in 1921, and the French had to stage a pretty good four-year war to subdue him. If Krim goes back to Morocco, as some observers fully expect, the French are in for real trouble.

So what possible good can France get out of such trouble abroad?

Just this. That French National trait over which the Communists have stumbled is patriotism. The average Frenchman is French before he is anything else. With a Communist, the Moscow line comes first. A lot of Frenchmen lean to Socialism, and a lot of frustrated European Socialists have been willing to team up with the Communists who are better trained for direct action.

But French Communists, by putting the policies of Russia ahead of those of France, and by giving comfort to the rebels within the empire, which they are doing merely to serve the Communist aim, may find that they have overreached themselves in the

Investigation Commission's report holding Yugoslavia primarily to blame for support of guerrilla warfare inside Greece was made public today.

The commission's findings and recommendations, already made known in dispatches from Geneva, were expected to precipitate a showdown between Russian and the Western powers in the Security Council on the perennial Balkan problem.

Covering a three-months inquiry into the Balkan situation, the 230,000-word document was formally submitted to members of the Security Council last Saturday.

The council was expected to begin a discussion of the report either Friday or early next week. There was speculation that the United States might inject into the debate the Communist assumption of power in Hungary and Communist moves in Bulgaria.

With Russia and Poland dissenting and France abstaining, the Balkan Commission fixed upon Yugoslavia the primary blame for support of Greek guerrilla warfare, and held Albania and Bulgaria blame-worthy to a lesser degree.

Disturbed political and economic conditions and the persecution of minorities inside Greece were cited in the commission's report as contributing factors to the turbulent Balkan situation.

As a means toward alleviating this situation, the commission recommended that the Security Council establish a commission of investigation on the troubled frontier area of Greece for at least two years to observe incidents and settle disputes.

Such a commission or commissioner should, if established, report to the council every three months, and should have access to Albania, Greece, Yugoslavia and Bulgaria, the report said.

With Russia and Poland also that support of frontier-violating bands should be considered a menace to world peace and subject to U. N. action.

To the majority report, that Yugoslavia was the chief offender, the Russian and Polish delegations affixed a minority report asserting that the Greek government was primarily to blame.

The majority held that exploitation of the Macedonian question by venturing claims to this territory outside the United Nations is "a positive threat to the tranquility of the Balkans and can only add to existing tension and suspicion and increase national passions."

A Greek representative appearing before the commission during the on-the-spot inquiry charged that Bulgarian and Yugoslav interference in Greek internal affairs was aimed at incorporating Greek Macedonia into the federal Yugoslav state of Macedonia. Both Yugoslavia and Bulgaria denied this charge.

France, which abstained from voting the blame for Greek guerrilla warfare, said in a statement contained in the report that "it is to be feared that in reaching conclusions with insufficient legal foundation we might only aggravate an already critical situation and do unnecessary harm to perfectly natural sympathies."

"Moreover," the French statement added, "the United Nations are faced not only with a critical but with a chronic situation, not with a flagrant aggression which requires a prompt and immediate intervention, but with a tension which, owing to a multiplicity of

can continent," Eisenhower said. He said the major requirements of a comprehensive military collaboration must be three-fold, listing them as:

1. "We must continue to send military missions to other American countries when requested by them to assist in reorganizing and training their military establishments.

2. "We must provide quotas for attendance at our service schools and institutions by military personnel from these countries in order to afford them the opportunity of studying at first-hand our methods of reorganization and training.

3. "We must be able to make available to them the equipment necessary for their peacetime establishments, since all the training and indoctrination of personnel will be largely ineffective unless all of the armed forces of the hemisphere are identical in terms of organization and equipment."

Eisenhower expressed conviction that the legislation is in accord with "our national interest," will "assist materially the maintenance of peace and security throughout the American continent," and will be "a distinct contribution to world security."

He emphasized that the War Department has "no intention of initiating or encouraging an armament race among the other American countries."

He said that the United States would conclude with each participating country "a definite agreement" as to the size of the armed forces for which this country will make available arms and equipment.

He said, too, that it is not intended to increase the quantity of arms possessed by any other American country, but rather to better the quality of their defensive armament.

WASHINGTON, June 25, (AP)—Secretary of the Navy Forrestal today confirmed plans to furnish South American nations with modern U. S. warships as part of a Western Hemisphere policy of cooperation for mutual security.

"It is the intention of the Navy Department to substitute newer U. S. naval vessels for the obsolete types of our neighbors," Forrestal said. "This substitution is proposed on an approximately equal tonnage basis."

He did not tell exactly what types of vessels this country proposed to furnish but said in a statement prepared for the House Foreign Affairs Committee that the Navy "has been holding in reserve for transfer certain naval vessels which are in excess of our present defense requirements."

(Two weeks ago, the Associated Press reported the existence of a memorandum from Forrestal to Secretary of State Marshall saying the Navy is prepared to transfer four light cruisers and 117 smaller vessels to Latin America. The cruisers are the Nashville, the Phoenix, the Boise and the St. Louis.)

Forrestal's testimony today was in support of legislation providing for military cooperation between the American Republics, including standardization of armaments. Marshall and Secretary of War Patterson previously urged its enactment.

"Under the proposed legislation," Forrestal said, "these ships can be made available at a reasonable cost to the other American governments."

"The result should be an actual saving to the United States, for in the event of a new threat of aggression, the other American governments will be expected to assist in a coordinated defense of the Western Hemisphere."

He said that assistance would substantially "augment our ability to protect the vitally important Panama Canal," and added that the vessels slated for transfer are those "whose preservation and safeguarding are today costing us money."

## 5 Big Powers See Hard Job Ahead For UN

Pledges Renewed On 2nd Anniversary; Ultimate Success For Body Forecast

LAKE SUCCESS, June 26, (AP)—The world's top-flight political leaders joined today in sounding grim warnings that the United Nations still faced a difficult and uncertain road ahead on this second anniversary of the world charter signing at San Francisco.

The warnings were voiced in recorded charter day messages broadcast to the world by President Truman, Prime Minister Aulet of Britain, Premier Ramadiah of France, President Chiang Kai-Shek of China and Deputy Foreign Minister Andrei A. Gromyko of the Soviet Union.

At the same time each of the representatives of the five big powers expressed conviction that the United Nations would succeed and pledged the world organization the full support of their governments.

President Truman, declaring that the U. N. so far "has gone forward in an atmosphere of disturbance and uncertainty," said the government and people of the United States were aware that realization of the organization's objectives "is not easy."

"They know that it is a continuing task," he said. "They will not be discouraged by temporary setbacks." (Continued on Page Eight)

### "Work Or Fight" Law Advised For US Preparedness

Baruch Recommends Military Training, Brains, Brawn Pool

WASHINGTON, June 26, (AP)—Bernard M. Baruch called today for a "work or fight" law applicable to men and women alike as one of the "minimum" essentials to mobilizing America's "full might" in the event of a future war.

The white haired adviser to presidents in two world conflicts declared, however, that while this country faces a future that is "uncertain" it is "not alarming."

"I see no war with Russia as an immediate threat," he asserted in an address prepared for the first graduating class of the Armed Forces Industrial College.

But Baruch cautioned that "with the new instrumentalities of mass destruction, we will not have time to improvise" should war come again. Accordingly, he said, this country must be ready to mobilize its full might, "militarily, economically and spiritually."

To accomplish that, he said, (A) There must be universal military training, (B) "All men and women (must be) subject to mobilization with a work-or-fight clause" and (C) "Surveys must be made of underground industrial establishments, refuge for civilians and dispersal of populations."

"Until some effective international guarantee of security has been established or resort to war is averted, we cannot disregard the dangers inherent in developing mass housing in cities," he said.

As for the "work-or-fight" clause, he said, "the same applies to the professions, the sciences, the arts, industrial and agricultural efforts, including labor of all kinds. In other words, there should be a pool of all our manpower, brains and brawn, ready to be mobilized."

## Schedules For School Term Are Discussed At Meet

Suggestions relating to school year for the coming school year were made yesterday at a meeting of principals with Supt. T. W. Lawton, and it was recommended that schools in Seminole County open on Monday, Sept. 8, and that pupils register on Wednesday, Sept. 3, June 4 was the date suggested for closing of schools, said Mr. Lawton.

It was unanimously agreed that dress and other recommendations relating to school schedules be submitted for approval to the County Board of Public Instruction at the next meeting, said Mr. Lawton.

The State law requires 180 days of actual teaching exclusive of holidays. Mr. Lawton pointed out, however, that the Florida Education Association, which includes Armistice Day, Thanksgiving and the Friday following the Christmas holidays from Friday Dec. 19 to Jan. 6, Good Friday and Easter and one day in the Spring, when teachers attend the meeting of the Florida Education Association.

The new law, said Mr. Lawton, requires teachers to be paid monthly for 12 months, but it also requires them to be on duty for 10 months. They therefore remain on duty until June 15, assisting the principals in work connected with closing of schools, unless expressly to attend summer sessions.

Teachers will then report for duty on Aug. 25 and will devote the two weeks prior to school opening to sessions with principals and supervisors in general preparation for the opening. A program is now being prepared for submission to the school board outlining duties of the teachers during the period, Mr. Lawton declared.

Extreme variations in temperature recently in Montreal, Quebec, were reported by Marcel Fallo and Mr. Falls who have returned to Sanford after a two-month visit to Montreal, their former home.

## Wool Support Bill Is Vetoed By President

Measure Described As Blow To Campaign To Reduce Trade Barriers

WASHINGTON, June 26, (AP)—President Truman's veto today of the wool import restriction bill was his 76th veto since he entered the White House Apr. 12, 1945. It was his fifth this year. He vetoed 49 bills in 1946 and 22 in the 8½ months of his 1945 incumbency.

WASHINGTON, June 26, (AP)—President Truman today vetoed the wool price support bill because he said it would have "an adverse effect on our international relations."

The measure would have continued government prices on wool at present levels and authorized the President to boost tariffs, or restrict imports if foreign wool or wool products pushed down domestic prices.

"The enactment of a law providing for additional barriers to the importation of wool at the very moment when this government is taking the leading part in a United Nations conference at Geneva" to reduce trade barriers "would be a tragic mistake," Mr. Truman said.

He added in a message to Congress:

"It would be a blow to our leadership in world affairs. It would be interpreted around the world as a first step on that same road to economic isolationism down which we and other countries traveled after the first world war with such disastrous consequences."

"I cannot approve such an action."

The CIO asked Congress today to act at once to prevent "collapse of our economy."

Asserting that up to now "there has not been a single step" to halt rising living costs, the Labor organization contended that Congress has "worked in the opposite direction."

"It urged immediate creation of a federal investigation board to shed light upon the unwarranted levels of many prices." It said that "by the use of public pressure."

## AFL Chief Rejects Strike Proposal To Protest Labor Law

1800 Evacuated In Des Moines As Level Is Broken

Record Flood Crest Reached By Two Converging Rivers

DES MOINES, June 26, (AP)—At least two persons were missing and 1,800 evacuated from their homes today as the raging Des Moines River smashed a two-block breach in a levee to flood about 30 square blocks in one area, poured into several other areas totaling another 30 blocks, then started receding slowly.

This capital city of 170,000 went through the unique experience of having its two major rivers reach flood crest simultaneously and set an all time record high stage at their Scott Street confluence a few blocks from the business district.

The rivers, the Des Moines and the Raccoon, had become swollen north of here after torrential rains of last week-end.

After the Raccoon poured its swirling, dirty waters into the abnormally large channel of the Des Moines, the crest moved menacingly south toward Red Rock, Eddyville, Ottumwa and Keosauqua — four communities already battered twice this month by record floods.

There was no immediate estimate of the damage caused by Des Moines' first big flood since 1944, but the U. S. Soil Conservation Service issued a report saying that soil erosion during the state's earlier June floods cost an estimated \$107,000,000.

The service said a survey showed 102,000,000 tons of topsoil had been washed from 5,000,000 acres of sloping land and that 600,000 acres of bottomland used for corn and soybeans had been flooded.

Volunteers, policemen, firemen, sailors, Coast Guardsmen and others climaxed several days of work preparing for the flood by toiling all of last night — laying sandbags atop levees, plugging holes in dikes, removing lowland residents and their property.

The crowd of sightseers became so large early last evening that a curfew was placed in effect at 9:30 P. M., requiring all non-flood workers to get off the streets so that the job of preparing levees could be done.

## Standardization Of Arms In Western Hemisphere Said Vital

Funds Released For Expenses Of State Agencies

\$3,000,000 In Appropriated Funds Are Held As Reserves

TALLAHASSEE, Fla., June 26, (AP)—More than \$18,000,000 was released by the Cabinet Budget Commission today to State agencies, departments and institutions for expenditure in the next year — but another \$3,000,000 in funds appropriated for them were withheld as reserves.

Governor Caldwell and the board, declaring a general fund deficit was in sight, had instructed all agencies to make up their budgets for the fiscal year beginning July 1 on the general basis of budget commission recommendations to the legislature less 10 percent for reserves — not on the \$6,000,000 high figure of the Biennial Appropriations Act which the legislature passed.

## FBI Is Requested To Investigate Shipyard Sale

WASHINGTON, June 26, (AP)—Rep. Risley (R-Okla.), chairman of a House subcommittee on surplus property, declared today that he will insist that the Federal Bureau of Investigation investigate to the fullest extent the sale of the St. Johns Shipyard at Jacksonville, Fla.

Risley's declaration came during a verbal outburst aimed at Fred Weber, of Jacksonville, who was testifying in the subcommittee's own investigation of the sale to the Tampa Shipbuilding Co. for \$1,928,500 in February, 1946.

Weber testified that the late David B. Knapp, the Maritime Commission's resident engineer at the St. Johns Shipyard, was paid \$25,000 by him for Knapp's interest in a partnership they formed to promote establishment of a steel mill on the Jacksonville yards.

Weber now is an employee of the Florida Pipe and Supply Co., which is partially owned by L. E. Wolfson, a majority stockholder in the Tampa Shipbuilding Co.

"I want to tell you, Mr. Weber, that we are sometimes pretty glibly told," Risley said, "but I'm not glibly enough to think that \$25,000 was paid to Mr. Knapp, who was an official of the Maritime Commission, because he was in on some promotional scheme."

"You ought to tell this committee the truth and tell the commission that you paid him that in connection with the purchase of this yard. It's as plain as the nose on your face."

## Crisis Threatening In Dutch East Indies

JOGJAKARTA, Java, June 26, (AP)—A tightening Dutch-Indonesian crisis threatened today to overthrow the Indonesian Republic government of Premier Sultan Sjahrir and held the prospect of renewed military action in the Netherlands East Indies.

The cabinet met for the second day to hammer out a decision on Dutch demands for information of an interim government to rule the Indies until the United States of Indonesia becomes independent on Jan. 1, 1949. Announcement of the decision was expected late today or tomorrow.

## Globe Circling Flight Stops Over In Japan

TOKYO, June 26, (AP)—American newspaper executives on a Pan American Airways' round-the-world flight talked over some of Japan's problems with Premier Tetsu Katayama and Foreign Minister Hiroshi Ashida today.

The globe-circling party landed at Hameda airport at 12:48 P. M. from Shanghai. Top American officials were on hand to greet them.

Mrs. Oveta Culp Hobby, vice-president of the Houston Post and former commander of the Women's Auxiliary Corps, got a special welcome from a WAC band directed by Cpl. Eleanor Crawford of Baltimore.

The publishers and editors attended a cocktail party given by George Atcheson, Jr., American diplomatic representative here. They will see General MacArthur tomorrow.

## Suit Is Begun On St. Johns Fishing

TALLAHASSEE, June 26, (AP)—The State Game and Fresh Water Fish Commission today asked the Leon county circuit court to enjoin the Florida Board of Conservation from exercising jurisdiction over fishing in Lake Okechochee and the St. Johns River.

In its suit the commission charged three legislative acts giving the Conservation Board authority over the Lake and River were "hostile to" Commission regulations and asked that they be held unconstitutional. The 1947 acts were designed to reopen the bodies of water to commercial fishing. The case will be heard July 11.

## BUGSY SIEGEL BURIED

BEVERLY HILLS, Calif., June 26, (AP)—While friends moped for an elaborate ceremony, one-time Public Enemy Benjamin (Bugsy) Siegel was hurried almost in secrecy today, in a \$5,000 silver-plated bronze casket. Only five mourners were present, including his divorced wife and two children. The rites were conducted by Dr. Max Kert of the Olympic Jewish Center.
