

General Bradley Disparages Talk Of Another War

MILWAUKEE, June 20 (AP)—General Omar Bradley said today that "if we once again risk disaster by turning our backs on the world, we shall not be given another chance." "There is not enough room in the world for both civilization and atomic conflict," he said.

"Twice the United States has snatched victory out of defeat in the event of another war, we shall become the target."

The Veterans Administrator disparaged talk of "another and inevitable war," however. People who follow this line display a lack of faith in America, he said in an address prepared for the national convention of the American Veterans Committee.

"Democracy," Bradley asserted, "can lose through the fears of its people, through their failure to trust in its strength, through timidity in meeting problems at home and confusion in solving problems abroad."

He said American people must:

1. Be prepared to sustain a bold foreign policy.
2. Strive for economic security which will give other nations confidence in the wealth and productivity of the American system.
3. Contribute willingly to maintenance of armed strength "essential to the security and stability of the world."

Bradley advised the AVC to oppose additional benefits and special privileges for veterans. "There is no such thing as a free ride on the government for any deserving citizen," he said.

"Veterans who demand unwarranted expenditures now are saddling themselves with an unreasonable tax burden in future years."

Truman Veto

(Continued from Page One) might occur before the board of inquiry could make its report or "perhaps even before the board could be appointed," Mr. Truman said.

The measure was sent to the House where Republican leaders already had marshaled their forces for a quick vote to override the veto and pass the measure over Mr. Truman's disapproval.

Here are the major provisions of the bill:

1. Let the government get court orders to block "national calamity" strikes, as in the coal or steel industries, during 90 days of mediation.
2. Forbid the closed shop, in which the boss can hire only union help.
3. Ban various kinds of special strikes and boycotts.
4. Permit court suits against unions that break contracts.
5. Deny collective bargaining rights to any union having as an officer a Communist or sympathizer, or anyone who could "reasonably be regarded as one."
6. Make it an unfair labor practice, which could be stopped by a court order, for a union to keep non-striking workers from their jobs by mass or violent picketing.
7. Forbid "excessive or discriminatory" union dues and initiation fees.

In a 5,600 word message, the President told the Congress members that the legislation is a "clear threat to the successful working of our democratic society."

"The bill would go far toward weakening our trade union movement, and it would go far toward destroying our national unity."

"By raising barriers between labor and management and by injecting political considerations into normal economic decisions, it would invite them to gain their ends through direct political action."

"I think it would be exceedingly dangerous to our country to develop a class basis for political action."

The President said there still is a genuine opportunity for enactment of this session of appropriate labor legislation, and added:

"I still feel that the recommendations which I expressed in the State of the Union message constitute an adequate basis for legislation which is moderate in spirit and which relates to known abuses."

In that message in January, the President said he recommended "a step-by-step approach" and indicated specifically problems which should be handled immediately. He also proposed a non-partisan investigation covering the entire field of labor-management legislation. He said he was "fairly convinced" that such a measure would weaken the economy and weaken the unity of the people.

The President's veto was the second one slapped on legislation developed by the Republican-dominated Congress in line with pledges made by party speakers in last year's political campaigns which gave it control of the national legislature.

Two big GOP campaign promises were:

1. A reduction in taxes.
2. Revision of the labor laws.

Mr. Truman vetoed their cutting bill last Monday and the House upheld his action by a two vote margin. Today's action swept away any remnants of White House-Congress cooperation in the domestic field that had survived last Monday's veto.

Disagreeing with the whole philosophy of the labor measure, the President declared it would be "a dangerous strike in the direction of a totally managed economy" and said "it contains seeds of discord which would plague this nation for years to come."

In an analysis of the legislation, the President declared he had put it to four tests. He said:

1. That he had considered whether it would result in more or less government intervention in our economic life and concluded it would "inject the government deeply into the process by which employers and workers reach agreement" and "superimpose bureaucratic procedures on the free decisions of local employers and employees."
2. That in a second basic test as to whether it would improve

(Continued from Page One) put failed to satisfy union demands for job reclassification.

Several hundred automobile workers marched on the National Assembly to demand the pay. Police dispersed the fight 50 to reach the square behind the assembly building, the Place du Palais Bourbon, and a second and bigger crowd broke up peacefully after sending a delegation inside.

Police guards around the building had been doubled when word came that some 2,000 workers had gathered in front of the suburban Hispano-Suiza automobile factory and were planning the march.

Some marchers in the first group were taken to a nearby police station for verification of their identity papers. This group carried a Red flag labeled "CGT," initials of the Communist-led General Confederation of Labor.

Communist deputies in the assembly received the workers' delegates and listened to their demands. Socialist and Communist public men and deputies refused to receive the delegation.

It would deprive workers of the power to meet the competition of goods produced under sweat shop conditions by permitting employers to halt every type of secondary boycott, not merely those for unjustifiable purposes.

Mr. Truman also contended the legislation would "strait jacket" the National Labor Relations Board's operations by a "series of special restrictions unknown to any other quasi-judicial agency."

The procedure provided for dealing with major strikes affecting the public health or safety, the President argued, would "do more harm than good" and increase rather than diminish "wide-spread industrial disturbances."

Repair Bids Asked On County Roads

TALLAHASSEE, Fla., June 20 (AP)—The State Road Department today asked contractors to submit bids July 15 on 70 miles of road and bridge work in 12 counties.

The proposed projects are located in Dade, Nassau, Duval, Gadsden, Citrus, Taylor, Madison, Dixie, Seminole, Volusia, Hendry and Polk counties.

The project includes resurfacing four sections totaling 13 miles of roads 15, 46, 415 and 600 in Volusia and Seminole counties.

(Continued from Page One) undated and all 600 residents have left. Canton, Mo., was half under water from earlier floods, but its levees are well sandbagged and new damage was expected unless the river rises higher than predicted.

At Hannibal the Red Cross made preparations for caring for 1,000 persons expected to be made homeless. The Mississippi River reached a stage of 22.9 feet last night, a foot under its high mark of the previous flood.

In interior Missouri, the Missouri River was overflowing more lowlands between Lexington and Booneville.

Water was receding at Oakville and Wapello, on the Iowa River. Oakville Mayor O. D. Johnson said the crest there of 18.6 feet, was more than two feet higher than the 1929 previous record. Oakville was completely evacuated but life water got into the town of 440 population as voluntary workers managed to hold the levees.

At Ottumwa, water was receding slowly, but still was four feet above flood stage.

The Mississippi continued to rise at Keokuk and A. A. Kowert, chief engineer for Quincy, Ill., said the great would reach Keokuk about noon.

At Hamburg, Ia., on the Nishnabotna River near the Missouri River, about half the town was still flooded, and 300 families were being cared for in Red Cross centers.

(Continued from Page One) vided with a ramp for easy loading.

A 20-by-101 concrete platform separate from the building and about 75 feet of it will be built to unload automobiles. It was announced by O. H. Page, supervisor of transfer of the ACL at Savannah, who on a visit here this morning predicted that the new fireproof terminal building would be of fine advantage to Sanford.

Sanford is not considered a transfer point now as during the war when it "saved the day" by serving as a statewide transfer point to relieve the overcrowded facilities at Waycross, Ga., he said. The new freight terminal is designed to give service to Sanford and Seminole County.

"I am a great believer in Sanford," declared Mr. Page. "It has wonderful, natural advantages with its lake and river location and its vegetable section. He praised the work of the freight terminal men here who, he said, did a great wartime job during the emergency."

Waycross now has fine mechanized loading equipment and two thousand foot platforms, and can accommodate 125 cars at a time on the eight tracks, he revealed. This will handle "all normal transfer traffic for Florida, but in an emergency Sanford facilities could again be used, he said.

(Continued from Page One) adoption of a new measure to the President's recommendations. He said the things Mr. Truman proposes already are in the Taft-Hartley bill and that Congress would make it "law, veto or no veto."

Halleck noted that 103 House Democrats voted for the bill when the case passed it while 60 Democrats opposed it. In this minority, Halleck said, were "radical New Dealers."

"Henry Wallace need not worry any more about forming a third party," Halleck added. "In his veto message Mr. Truman practically turned the Democratic party over to Wallace and his gang."

While Republican party leaders denounced it, AFL President William Green praised President Truman's veto. Green said it was "a masterpiece of statesmanship" and that the President "has stately upheld the fundamental principles of freedom and fair dealing in industrial relations which the Taft-Hartley bill set out to wreck."

The veto of the Taft-Hartley labor bill was described today by President Walter P. Reuther of the CIO United Auto Workers as "an act of courage and wise statesmanship."

Reuther added, "His action calls for the same kind of courage and statesmanship on the part of all congressmen in both parties who believe in progress." He urged Congress to uphold the veto.

In the late afternoon, the prospects as to the time for a Senate vote were uncertain. It was clear that Democrats would want to, and could by talking, force a delay until after the President's speech.

One Republican leader said efforts were underway to get an informal agreement fixing a time for a Senate vote tomorrow.

He said this hinged on whether the Republicans would provide a "pat," a parliamentary device by which senators register their views when they are absent, for Senator Elbert Thomas (D-Utah) who is in Geneva attending the World Trade Conference.

Democrats were reported willing to vote tomorrow if Thomas' absence could be matched by two absentees on the side of those supporting the bill. It requires two-thirds of those voting to override a veto.

The House acted on the bill swiftly and with little demonstration. A bellow of boos came from the Republican side when reading of the President's message was ended. Some applause came from the Democratic side.

Rep. Haxley (R-NJ) moved that there be no debate and his

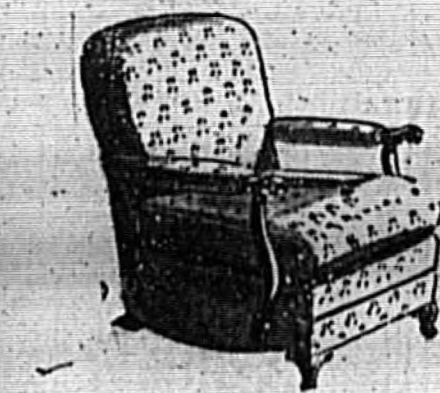

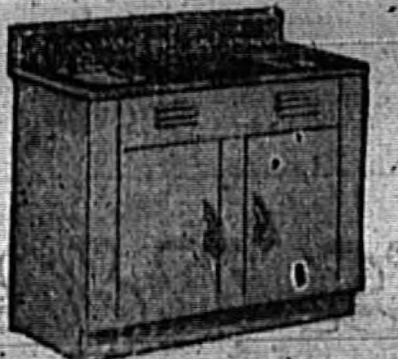

HARTLEY-TAFT LABOR BILL BECOMES LAW

Russia Will Join Britain, France Meet

Foreign Ministers To Hold Conference On Marshall Plan Friday In Paris

LONDON, June 23, (AP)—Russia announced today she would join Britain and France in a conference on American aid to Europe, and France called the three European foreign ministers to meet in Paris Friday.

The French Foreign Ministry said it would be happy to welcome Russia's V. M. Molotov and Britain's Ernest Bevin to join the conference on American aid to Europe, and the Soviet suggestion that the meeting begin Friday.

In London, Bevin told the House of Commons: "The Soviet government agrees that the primary problem of European countries at present is the quickest possible reconstruction and further development of their national economies which has been destroyed by the war."

Anthony Eden, former foreign secretary, welcomed Bevin's announcement of Russian agreement to the three-power meeting. Extending his best wishes to the British delegation, Eden said:

"They make swift and sure progress. All afternoon newspapers in Paris gave top play to the meeting. France-Soviet declared the conference beginning Friday would determine the success or failure of the next four-power meeting of foreign ministers at London in November. The Paris-Times cautioned that Russia's 'yes' might be modified by several 'ifs' or 'buts'."

Russia delivered a note of acceptance to Bevin yesterday at his country home near Lamboulet, and early today had the official agency Tass broadcast public announcement. Several hours later France announced the Friday date was acceptable.

William L. Clayton, U. S. Under Secretary of State for economic affairs, who arrived in London yesterday, was expected to begin meetings today with Bevin and other cabinet ministers on the proposed aid program.

British government informants looked for him to propose that a U. S. observer attend the British-Soviet-French talks. They mentioned Paul Porter, head of the U. S. Mission for Economic Affairs.

In Rome a foreign ministry official said that Italy viewed the Marshall plan for American aid to reconstructing Europe with "profound satisfaction" and would help make it work.

Dr. Umberto Grazzi, economic director of the ministry, said, however, that Italy would insist on participating in "a feeling of parity" with other nations and not with a feeling that "we are beggars." He said notes had been (Continued on Page Two)

Senate Committee Votes Increase In Navy Budget

\$176,500,000 Is Added To Give U. S. Well-Balanced Fleet

WASHINGTON, June 23, (AP)—Legislation making permanent the present 3-cent postage rate on first class letters was passed unanimously by the House today. The rate will revert to 2 cents on July 1, 1947, unless the Senate and the President also approve the legislation before then.

WASHINGTON, June 23, (AP)—The Senate Appropriations Committee today added \$176,500,000 to the Navy appropriation voted by the House, an increase which Senator Saltonstall (R-Mass) declared will give the nation "a powerful, well-balanced fighting fleet."

The measure approved by the committee will give the Navy's personnel strength of 395,000 enlisted men and 43,000 officers; an active fleet of 293 combat ships; and 5,793 aircraft, exclusive of those used for reserve training.

This is 1,000 more officers and 40,000 more men than allowed by the House bill; 24 more combat ships; and 252 more aircraft. Saltonstall, chairman of the subcommittee which considered details of the program, declared the net effect of the changes voted today would be to add \$15,500,000 in usable appropriations to the sum voted by the House.

The Senate Committee voted to authorize approximately \$3,462,000,000 in new money for the fiscal year beginning July 1. This compares with the \$3,285,500,000 voted by the House, and the \$3,668,000,000 asked by President Truman.

Saltonstall told reporters the Senate Committee's action permits operation of the same number of ships the President asked for, and substantially fulfills his requests for personnel and operating aircraft.

The Senate bill would permit operation of 11 large carriers, 23 smaller carriers, 4 battleships, 12 heavy cruisers, 20 light cruisers, 135 destroyers, 24 destroyer escorts and 78 submarines.

In addition, it would keep in service 149 amphibious craft, 53 minesweepers, 54 patrol vessels, 272 auxiliary vessels and 24 floating docks.

The President's budget called for an average employment of 371,300 civilians in the Navy Department next year. (Many of these are employed in Navy yards) (Continued on Page Two)

Tax Against ACL Upheld By High Court

Anti-Petrillo Law Is Ruled Constitutional; Government's Oil Claim Approved

TALLAHASSEE, June 23, (AP)—Governor Caldwell said today a U. S. Supreme Court decision upholding a federal claims to California coast oil lands has "no direct bearing on Florida but may serve as precedent in events of oil field suits over ownership of Florida tidelands."

WASHINGTON, June 23, (AP)—The Supreme Court handed down three important decisions today, ruling that Georgia may levy a 1 1/2 per cent. tax on the Atlantic Coast Line Railroad and Banking Company; holding that the "anti-Petrillo law" is constitutional; and upholding the government's claim to oil tidelands.

Justice Frankfurter read the court's unanimous decision concerning the ACL. The Atlantic Coast Line contended that under the State charter granted the Georgia Railroad and Banking Company, the income could not be taxed at a rate higher than 1 1/2 per cent.

The charter provides that stock of the Georgia Railroad and Banking Company and its branches is subject to a tax "not exceeding 1/2 per cent per annum on the net proceeds of their investments."

The Georgia Supreme Court decided that the provision referred only to a property tax on the stock of the lessor company and did not bar a tax on net income derived from use of the company's property by a tenant. The high court agreed with that view.

The court also decided the Law Act, generally known as the "anti-Petrillo law," is constitutional. It sent the case of James C. Petrillo, head of the AFL Musicians Union, back to the trial court, however, for new proceedings.

The case came before the high court on the government's appeal from a Chicago court's ruling that the law is unconstitutional. That ruling was on charges brought against Petrillo under the law.

The act prohibits forcing employers to hire more workers than they need to perform actual railroad services. It was passed by the last Congress to curb powers of Petrillo.

Petrillo was accused of violating the act by calling a strike at Chicago radio station WAAP. The strike was in support of a demand that the station hire three additional record librarians, although WAAP said extra employees were not needed. The strike (Continued on Page Two)

3 Negroes Caught After 6 Day Manhunt

ATLANTA, June 23 (AP)—Three negroes, sought for six days over a wide area of Georgia in a multi-county manhunt after the killing of a United States revenue agent, were taken in custody early today, the FBI announced.

Edwin Folts, special agent in charge of the Atlanta office, said the negroes were captured in Banks County, Ga., officers took them a few miles from the wooded spot where revenue agent Melvin John Clark, 41, fell under a fusillade of bullets June 15 as he approached a hidden liquor still.

The arrests culminated one of Georgia's biggest manhunts, in which state county and federal officers, including sheriffs of seven counties, directed a search through swampland and thick undergrowth in rolling North Georgia.

Aid Neighbor Nations, Urges Gen. Marshall

U. S. Is Warned Latin America, Canada Will Get Help Elsewhere If Refused

WASHINGTON, June 23, (AP)—Secretary of State Marshall said today that the United States would not help Latin American nations standardize their arms and armies along United States lines.

WASHINGTON, June 23, (AP)—Secretary of State Marshall said today Latin America and Canada will seek aid elsewhere if this country fails to help them get weapons and military know-how for their armed forces.

Leading a delegation of top-flight government officials, the former Army chief of staff asked the House Foreign Affairs Committee to speed action on legislation permitting this country to take the lead in trying to standardize Western Hemisphere armaments.

Marshall was the first of a group of witnesses that included Secretary of War Patterson, Secretary of the Navy Forrestal, General Dwight D. Eisenhower, and Admiral Chester W. Nimitz.

President Truman requested the legislation in a special message to Congress last month.

The House committee approved a similar bill last year, but the measure never reached the floor of either chamber. It is given little chance of passage this year either.

The legislation would permit the President to turn over United States arms, planes, ships and other military equipment to the Latin American nations and Canada and to train their soldiers and sailors. In return the President could accept any benefit.

Quality, Quantity Vital To Success Of State Market

JACKSONVILLE, Fla., June 23 (Special)—Quality and quantity are both important factors in the development of a successful produce market, and the availability of such a market is vital to the individual grower who has vegetables to sell into State Market officials here this weekend, in discussing the Spring season, and earlier operations during the 1946-47 fiscal year now drawing to a close. An outstanding feature of the year, according to G. H. Hogan, assistant director of State Markets, was the record made at Fort Pierce where gross sales for the Fall and Spring seasons exceeded the combined totals for the five preceding years, both in volume and dollars. In connection with the growth of this market, there is a demand on the part of some interested operators for facilities to concentrate products available in adjacent territory, the assistant director indicated.

Market Manager M. B. Williams, in his summary of operations at Fort Pierce, just received in the Jacksonville office of William L. Wilson, director of State Markets, noted shipments totaling 412,792 bushels of produce during the current fiscal year. Gross cash revenues totaled \$2,069,975.65. While tomatoes constituted the bulk of these shipments, a considerable variety of other products passed through the Market.

The availability of several products in quantity is important in attracting buyers to a market. Mr. Hogan pointed out Plant City, Sanford, Pompano, and other outstanding produce sales centers operated by the State Markets system, have run up good scores again this year, in the matter of diversity and volume of quality produce, he said.

Truman Makes Eleventh Hour Plea To Senate To Uphold Veto

Senators Override President's Veto By Vote Of 68-25; More Than Needed

WASHINGTON, June 23, (AP)—President Truman today made an eleventh hour appeal for Democratic support to uphold his veto of the Hartley-Taft labor bill, fearing it would be overridden by the Senate.

The letter was made public at the White House at a time when the Senate was expected to vote on the bill. Mr. Truman made public a letter to Senator Barkley (Ky) the Democratic leader, asking him for "my unqualified support" in the effort to kill the union-curbing bill which the Senate bill was to be called in little more than 48 hours.

"I am convinced that such a vote would be the result if the veto of this bill should be overridden," he wrote.

"I want you to know you have my unqualified support and it is my fervent hope for the good of the country that you and your colleagues will be successful in your efforts to keep this bill from becoming law."

"Very sincerely yours, Harry S. Truman."

The Senate Democratic caucus, which asked not to be named, said a last minute caucus indicated a vote of 68 to 27 to pass the measure over Mr. Truman's veto. This would be well over the required two-thirds of that vote.

Senators Override President's Veto By Vote Of 68-25; More Than Needed

Senators Override President's Veto By Vote Of 68-25; More Than Needed

WASHINGTON, June 23, (AP)—The Senate voted the Hartley-Taft labor bill into law today by overriding President Truman's veto 68 to 25. This was six more votes than the two-thirds margin required to enact the hotly-contested bill of labor unions.

The action was taken despite an 11th hour appeal from Mr. Truman to Senate Democrats to uphold his June 20 veto and kill the measure as "dangerous legislation."

Mr. Truman wrote Senator Barkley (D-Ky) just before the Senate vote that he is convinced the bill will "do serious harm" to the country.

The new law provides for government injunctions to halt national emergency strikes for at least 80 days. It also bans the closed shop and amends the Wagner Act to restrict some other union activities.

The result was a major victory for the Republican-controlled Congress over Mr. Truman. Last week the House sustained by a two-vote margin the President's veto of the \$4,000,000,000 Republican tax-cut bill.

The House overrode the labor bill veto last Friday, by 311 to 83, a four to one margin. Thus more than two-thirds of the members of Congress, including many of his own party, went against Mr. Truman's wishes.

Labor leaders bitterly assailed the measure, calling it a "slava bill," they and their followers flooded lawmakers with thousands of messages urging them to sustain the President's veto.

The Senate action places on President Truman and his Administration the enforcement of a law that he defined flatly in his veto message as "unworkable" and "a clear threat to the successful working of our Democratic society."

Senator Taft (R-Ohio), one of the authors of the measure, expressed confidence, however, that Mr. Truman will do his best to administer it.

Senators Sparkman (D-Ala) and Lucas (D-Ill) were the only Senators who voted May 13 when the Senate passed the bill who changed their stand today. Both voted to sustain the President's veto. They previously had voted for passage of the measure.

Senators Tobey (R-N.H.) and Overton (D-La.) who were absent when the Senate first passed the bill, voted to override the veto.

Senator Wagner (D-N.Y.), who has opposed passage of the measure since May 13, did not vote today, although his position was announced as opposing overriding the veto.

Twenty-two of the Democratic members voted to sustain the President; 20 to override his veto. In addition, two absent Democratic members were announced as against overriding the veto.

(Continued from page one) properly. There has been a somewhat similar situation in Austria, though not so vital. However, the picture in Central Europe differs from that of Western Europe. Eastern Germany and Austria enter into Moscow's project for the establishment of a zone of influence for security purposes. It would not necessarily follow that Russia intended to apply this policy to all Europe. But Moscow has kept its purposes to itself.

Russia's hidden intentions in this respect of course have been the crux of the whole situation. They represent the answer to the great question which Western democracy long has wanted settled, namely:

Has Russia just about fulfilled her ambitions in the way of establishing her new zone of influence, or is she bent on indefinite expansion of Communism?

To in effect this is the query which General Marshall's plan raised in such manner that a reply couldn't be avoided. Refusal to cooperate in putting Europe on its feet would, in the view of Western democracy, mean that Russia intended to play a lone hand in the interests of spreading Communism and, ipso facto, Moscow's influence over other nations.

That much has seemed clear. But what if Russia agreed to participate in rehabilitation with the other powers? At first blush it would seem the answer must be that Moscow would really play ball with the West and the idea of forcing Communist expansion. However, that doesn't necessarily follow.

Authorities in the Western capitals are noting that it would be possible for Russia to accept the invitation and then work to defeat the project. They base this unhappy thought on such past events as the inability of the Big Four to agree on a German peace treaty, on German economic reconstruction, and developments (or rather lack of them) in important matters in the United Nations Security Council. The Western Allies charge that these failures were due to deliberate obstruction by Russia, staged with the idea of causing delays and thereby giving Moscow a chance to strengthen its hand.

Russia's indirect answer to such charges has been along the line of an editorial in yesterday's

BIBLE VERSE FOR TODAY

HAVE YOU EVER GOTTEN ACQUAINTED WITH YOURSELF? YOUR REAL ETERNAL SELF? YOU CAN HAVE A RICH EXPERIENCE. I communed with mine own heart.—Ec. 1:16.

President Truman who has just vetoed the tax reduction bill and the labor control bill is expected to accept an invitation to visit Brazil. We can't say we blame him.

Did you know that as of the end of 1946 there were still 45 prisoners-of-war at large in the United States? But don't let this disturb you, or cause you to look under the bed, or have any more restless nights. Most of them have probably been caught by now. And if they have not, it may be comforting to know that at one time there were over 2,800 prisoners-of-war at large in this country. And you survived it all, little the worse off for knowing nothing about it.

Sanford citizens should become more familiar with their local civic affairs. How can you possibly go about improving conditions in your town if you do not know what the facts are regarding it? How can you possibly vote intelligently on matters of public interest? How many know, for instance, what the City tax millage is, what the current bonded debt is, what our assessed valuations are, where the city limits are and what the population is? Can you name the five city commissioners?

For once, we have found something in a Russian publication with which we can agree. "The method of keeping prices high by destruction of products and spending state money on them," says the Moscow New Times, "is by no means an honorable affair." In discussing the recent destruction of potatoes by U. S. government agencies, a practice which it calls a "monstrosity." However, the New Times has evidently forgotten that the plan originated with the New Dealers and the Roosevelt administration which the New Times has always seemed to think were the only decent people in America.

The Florida State Chamber of Commerce is gratified with figures prepared by its statistical experts which show that Floridians are much better off today than they were in 1937 because the income of the average Floridian has risen by 44 percent, that of the national average by only 19 percent. That is indeed encouraging, but if compared with the rise in the cost of living may not be so commendable. We do not have the figures on the price index at hand, but what does it profit a man if his wages are raised from \$30 to \$45 a week when his cost of living goes up from \$25 to \$50?

In the current issue of the Florida Legionnaire is a story from The Sanford Herald in which the advantages of Sanford as a site for the American Legion memorial and headquarters building are clearly outlined by State Adjutant Reid Mann. "Many Legion officials were very much impressed by the site, which is now occupied by the municipal softball diamond, and where 135 persons attended the barbecue given for the visitors," Mr. Mann is quoted as saying. This city is getting some mighty favorable publicity on the project and if the people of Sanford continue to give their whole-hearted support, favorable action will be forthcoming at the Panama City Convention.

The Truman Veto

The political sagacity of President Truman in vetoing the Hartley-Taft labor bill becomes clearer the more one studies his veto message and analyzes the political support upon which he must depend for re-election next year. Taken into consideration with the third party threat from Henry Wallace, the labor bill plainly put the President on the spot and left him with no alternative... as long as he continued to entertain any political ambitions whatsoever.

It may be safely assumed that it was not the labor bill itself with which Mr. Truman concerned himself; it was the labor vote. He had previously, when he first took office and the next election was more than three years away asked Congress for an even more drastic bill in order to prevent strikes. And in vetoing the bill, he did not criticize the bill itself but another bill which was a figment of his imagination.

If Mr. Truman had signed the Hartley-Taft bill he would have alienated the support of northern Democrats, whose ranks are now largely composed of organized labor. With both the Democratic and Republican parties against them, there would have been nothing left for union bosses and the big city machines to do but to form a Third Party under the banner of Mr. Wallace. And with Mr. Wallace appealing to the country with forebodings of a war with Russia, that was a dangerous threat.

Mr. Truman knew, too, that southern Democrats who include in their number virtually all farmers and business men as well as organized labor, which in the south is not quite so strong politically as in other parts of the country, would not like his veto, but he knew, too, that there was nothing they could do about it. He did not have to worry about southern Democrats voting for Mr. Wallace, and he knew their prejudices against Republicans.

And so, politically speaking, Mr. Truman did the wise and sensible thing. He has the South in the bag, and he has lined himself up solidly with organized labor. If the Senate overrides his veto, weak administration of the labor bill can bring on more strife and discord, thus further discrediting the Republicans. If the Senate doesn't override, he gets the credit for blocking an iniquitous labor bill.

The Big and the Small

To paraphrase an old song, the big get bigger and the small get smaller, and here's more proof.

Two hundred daily newspapers consume 85 per cent of the newspaper used in the United States. Two hundred, mind you. And get this. The other fifteen per cent is spread around 17,000 (yes, thousand) small dailies, weeklies and trade publications.

To make it easier to understand, one Sunday issue of the Chicago Tribune uses more than do all the dailies of Mississippi together in an entire year. That's hard to believe, but it's so, and you may understand now why the small fellows, lacking mills; inside connections and the like, are up against the wall.

One more thing. We're paying almost twice as much for newspaper as we did in 1941. Want to know part of the reason why? Here it is, and we quote: "International Paper Co. and subsidiaries report released last week show 1946 consolidated net profit of \$31,179,048 equivalent to \$8.50 a common share, compared with \$8,546,078, or \$2.14 a share in 1945." —Greenwood (Miss.) Morning Star.

69TH DIVISION VET WANTS TO REVISIT EUROPE

By HAL BOYLE SAN FRANCISCO, June 23

(AP)—The American frontier is the world. One of the men who made it that in Europe is former Capt. Phillip J. Sinnott, Jr., of San Francisco liaison officer with the battle-happy Sixty-ninth Infantry Division. He is an old friend from war days who wants to see what the peace has come to.

The 69th Division was an outfit new to battle which stumbled to immortal glory by sealing the capture of Leipzig and contacting the Russian army vanguard in an unforgettable meeting which ended the European phase of World War II along the River Elbe.

The taking of Leipzig 14 months ago was a dubious military adventure. The Second Infantry Division—a combat-wise outfit—was pushing from the west, but the 69th decided that the honor of capturing this German stronghold must come to it.

So the division created a task force of some 16 tanks and 185 doughboys and sent them in to clean out Nazi resistance and to take the fortified city.

Only 65 doughboys were still in fighting condition when the tank force finished battering the city hall fortress, where the poison-killed corpses of the burgo-master and his assistant—as well as their wives and daughters—bore testimony to the dramatic decline of the Nazi cause.

It was a great charge that deserves to live in American anti-aircraft guns and small arms fire existing in western Europe.

"Everybody was trying to climb into his helmet," recalled Capt. Sinnott. So we were.

This blood-won territory was subsequently yielded to Russian control under a previous grand-scale military agreement that still exists. Americans won the territory under fire and gave it up to Russians who took it over without loss of life or military struggle. The Russians are still there.

Now 26-year-old Sinnott, six rank forsaken, is shipping as a yeoman on a ship leaving for Japan to pick up German war prisoners destined for return to their fatherland.

"I want eventually to teach economic geography," he said.

"Women are being criticized very much. I thought it would be nice for us to get together and talk things over."

"Women have been rather slighted; they haven't had their place in the sun. I thought perhaps we should get together and take stock of ourselves," Mrs. Dickinson said. The speaker would discuss ideas of the day, including displaced persons, relations with other nations of the world and the American home.

She took issue with charges that women's clubs of the nation were primarily interested in social affairs and that clubwomen take themselves too seriously and the

He said the new system, known as Ultrafax, "could transmit twenty 50,000 words novels from New York to San Francisco in only 60 seconds."

It is so speedy, the National Broadcasting Company head told Congress, that present communications methods will seem as slow as the ox cart compared with a stratoliner.

Ultrafax was developed by Radio Corporation of America and will be ready for a public showing some time this summer. Trammell said this is the way it works:

"Each printed page is treated as a picture and placed in rapid succession, like a thimble, to be used when the page is reproduced by new high-speed photographic processes for quick delivery."

WESTBURY, N. Y.—Talking with John Magee is a refreshing experience. Here is a steeplechase rider who topped his field last season, winning 28 races over the jumps and four on the flat.

He is generally regarded as one of the best steeplechase jockeys in the world, yet he is a quiet, soft-spoken Irishman who lays his success to long association with horses, unpriced schooling by James E. Ryan, veteran trainer of jumpers for Mrs. E. duPont Weir, and the firm conviction that there is no better life than bounding over the jumps, dangerous as it may be.

"I've heard people say that anyone who wants to take those chances in steeplechase races must be crazy," explained Magee after an early morning workout. "But for me this is the most thrilling, the greatest life in the world. I want to go riding steeplechase races until I can't sit in a saddle and then I want to become a trainer."

"Really, I don't know what life would be like without a horse. I was brought up among horses in County Kildare, Ireland, where I was born. My father was a steeplechase rider. He rode in several Grand Nationals but I don't remember too much about that for he was dead when I was five years old. I kept right close to the horses as a youngster, learned to understand them like humans and I hope I'll be around them for the rest of my life."

Magee came to this country in 1929, but it wasn't until 1935 that he started to ride seriously. That year he hooked up with trainer Jim Ryan and the combination has been hitting the bullseye since.

"I've been with Jim Ryan all that time," went on Magee, "and I'll stick with him until he says 'scram.' We've been a very successful combination and, as far as I'm concerned I don't want to see it broken up."

Magee, regarded as one of the coolest riders in the business, is a superb judge of a race. He knows just when to make his moves and whether in front by five lengths or back by the same distance his supporters know he'll get everything possible out of his mount. But he attributes all his ability to the training received under the handling of Ryan.

Magee is 38 and weighs 125 pounds, good weight for a steeplechase rider.

"If I were lighter," he explains, "I'd probably be a flat rider, but I would hate to go through all the tortures of making weight. As it is now I don't worry a bit about poundage. During the summer I just keep myself in good condition and in the winter I get plenty of exercise breaking in horses at Camden, S. C."

Most jockeys, of course, have their favorites so the question was put to Magee. He just smiled and said:

"Well it would be pretty hard to get away from Burma Road. He did everything I asked and when beaten it was due mostly to bad racing luck. I'll settle for Burma Road."

Scribes Nominate All-Star Teams For Game On July 13

(AP)—The Class D Florida State League's scribes and sportswriters had their way, fans from every city would be satisfied with the make-up of the all-star "veterans" and "rookie" teams slated to meet in a gala exhibition game Sunday afternoon July 13 in the park of the team leading the league at midnight July 4.

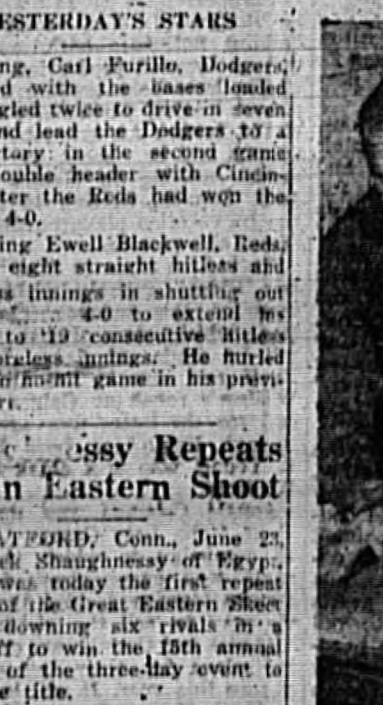

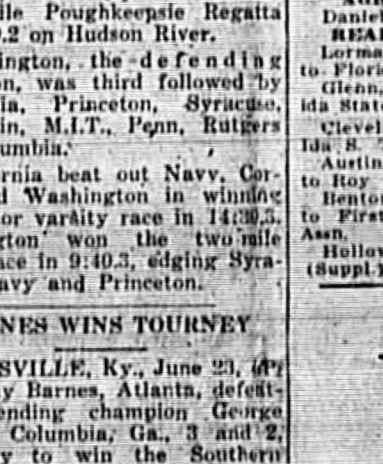
