A Matter Of States' Rights

The controversy over the Supress. Court has now reached the point where it is perfectly clear to everyone that the real issue is not whether there should be nine sarily passed the age of usefulness, but whether the federal government should possess certain powers which it does not have, and which it never has had under our exist-ing Constitution. Supporters of the Administration are no onger making any bones about it that the reason they want "new blood" on the Supreme Court is so that modern air-conditioned streamlined laws can be exacted by Congress without the danger of later being invalidated by the Supreme Court.

Since this is the issue, it is important that every citi zen, particularly every citizen of Florida and of the South consider what this new legislation is to be, if the Court is put in a straight-jacket, and whether we want the kind of laws that are going to be enacted. In view of the fact that much of the New Deal has already been approved by the Supreme Court and that much of it has already been in effect for four years without coming into any conflict whatever with the courts, it goes almost without saying that the proposal to pack the Supreme Court has nothing whatever to do with the reduction of the gold content of the dollar, the creation of the Tennessee Valley Authority the establishment of the Civilian Conservation Camps, the re-financing of home and farm mortgages, the organization Housing Administration, or the providing of relief and work o millions of our people through the PWA, the WPA and the FERA. These and many other of the New Deal policles have either already been declared constitutional or were never in any danger whatever of being in conflict with the Constitution.

Now if the government has the power to do all these things, and has done them, and in doing them has admittedly been responsible for lifting the country out of the depression, what power is it then that the government needs, or wants, now that the battle against the depression has been largely won? There were essentially but two New Deal laws vitally affecting the lives of the people, out of the hundreds actually enacted, which have been declared unconstitutional. They were the NRA, or the National Recovery Act of Blue Eagle fame, and the AAA, the Agricultural Adjustment Act, which established its reputation by raising the price of pork and white bacon, and by plowing under wheat and cotton.

It is the power exemplified by these two laws which the federal government does not possess and which it wants. It is the power to fix wages, regulate hours and working conditions, establish prices, and otherwise regulate and manage the business affairs of the country, as well as the power to govern similar conditions as they apply to farm operations, that the President is in reality demanding. This power, as our Constitution exists today, and as it has been interpreted by the Supreme Court for 150 years, the federal government does not possess. And it must be remembered that with respect to the NRA, the decision by the Supreme Court was unanimous, while seven out of nine justices decided against the AAA.




