Burglars Strike Tax Annex

Thieves, armed with blow torches and burglary tools, did a professional job of stealing the safe and taking \$300 from the Seminole County Tax Collector's Casseberry annex some time either last night or early today.

Located in the Seminole Plaza, the tax office was primed for the first day of selling motorist's 1970-71 license plates and except for the missing amount, other money from past tag sales had been deposited in the bank.

Seminole County Deputy Charles Smith said about \$300 was left in the office for use in change machine today and it was this amount that yeggs took from the office safe, after first cutting a hole into the office roof to permit entrance through the restroom, into the tag office.

Tax Collector Troy Ray said the \$300 was removed from a safe drawer and reported the thieves "made a mess" of the place.

In addition to the safe-cracking the burglars also ransacked cabinets and opened a locked desk in a search for money.

Ray reported six inches of water had poured through the hole into the office floor and reported he was tired today after spending most of the night "cleaning-up-the-place."

Deputy Roy Rice, in his report today, stated the entry was discovered by Steve F. Smith, a Casseberry policeman, who was checking Plaza stores and found water coming from the office building, apparently from the roof hole, and also heard sounds like tools clanking.

Smith also reported seeing someone climb down a ladder from the office roof and run between the Seminole Plaza Theater and Montgomery-Ward Department Store.

The suspect was shot at by Patrolman Smith, Rice reported, and several of the pellets struck the glass window at the Ward Store, Smith stated.

\$300 Stolen From Safe

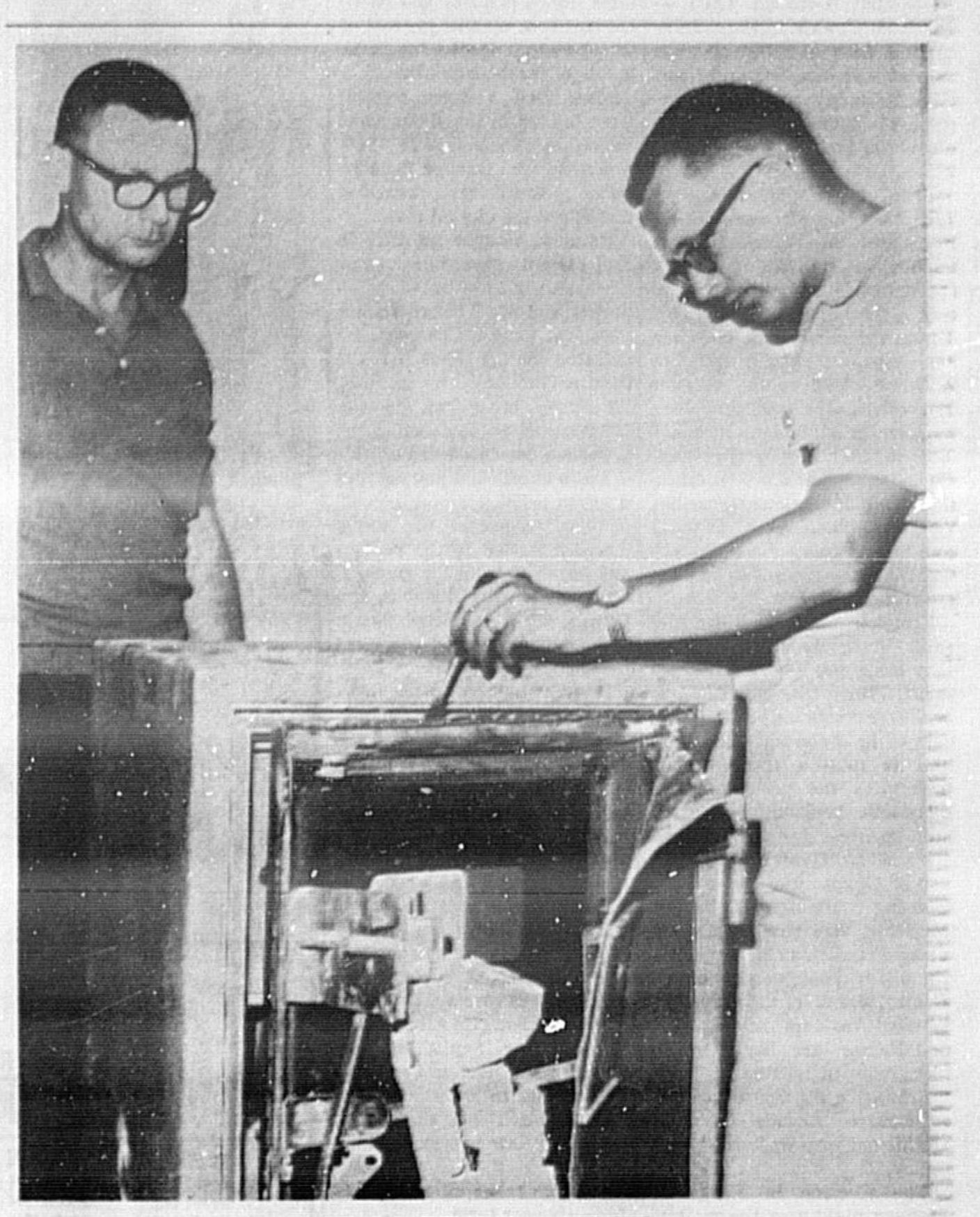

S.I.C. Favors Design Of Airport Authority

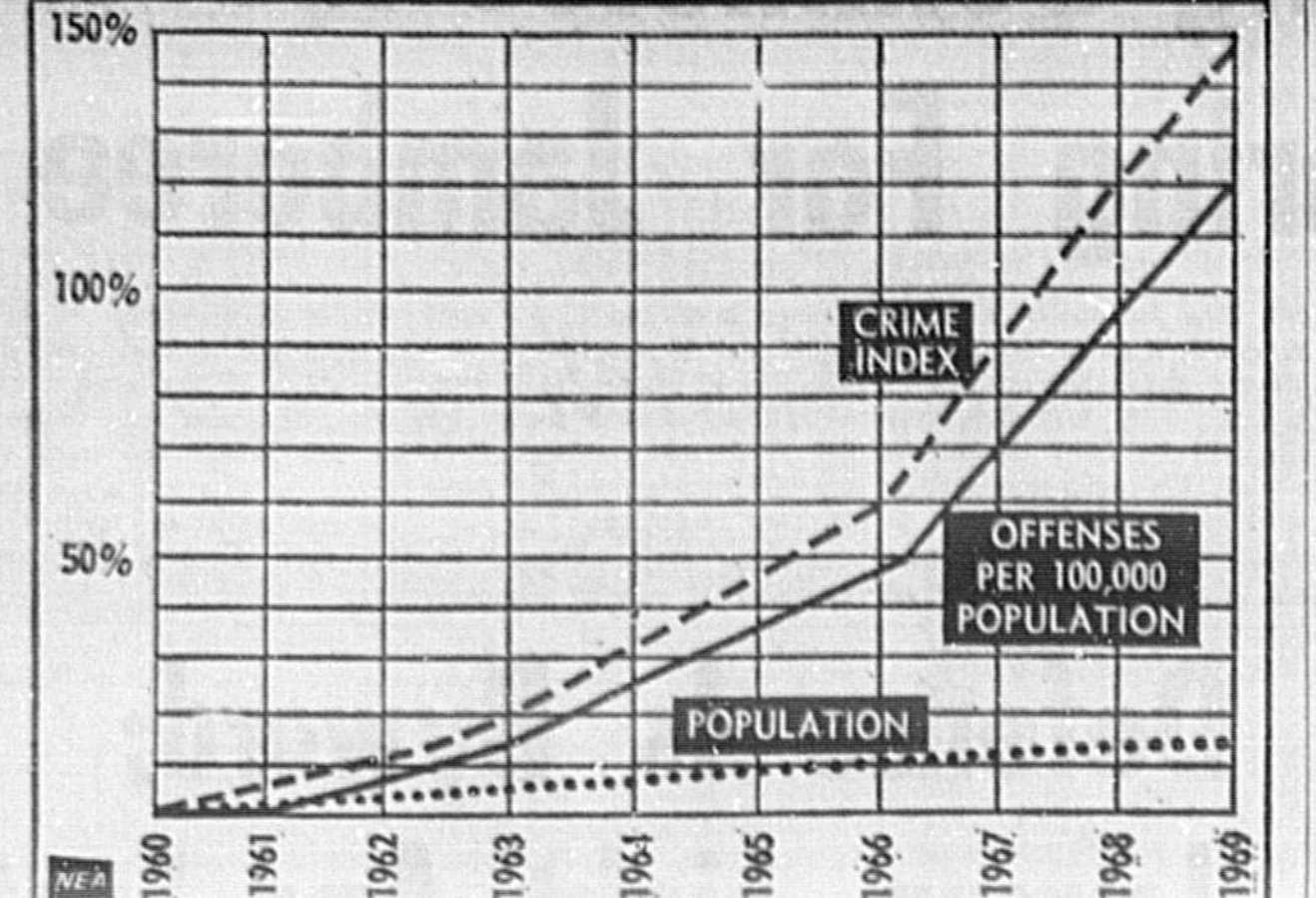

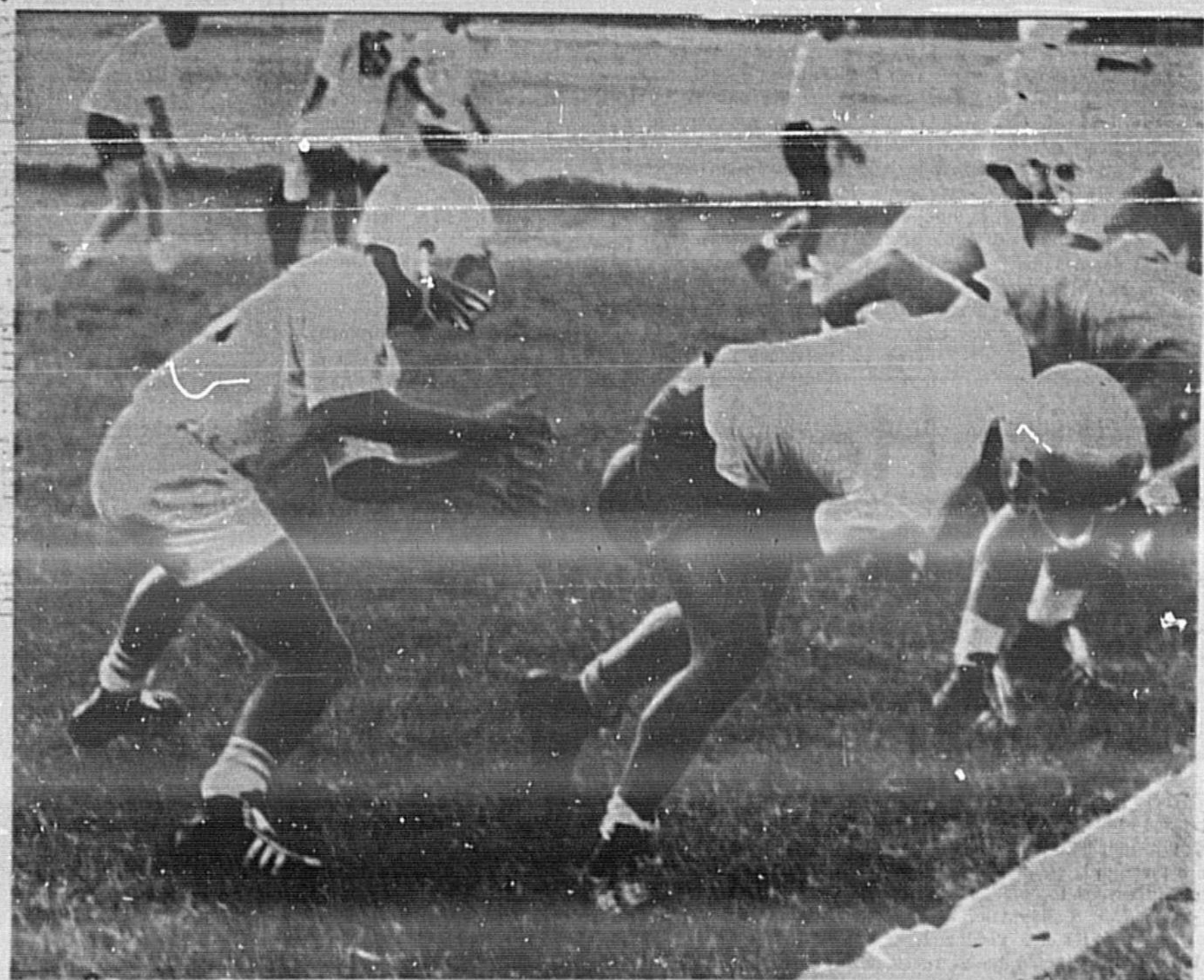

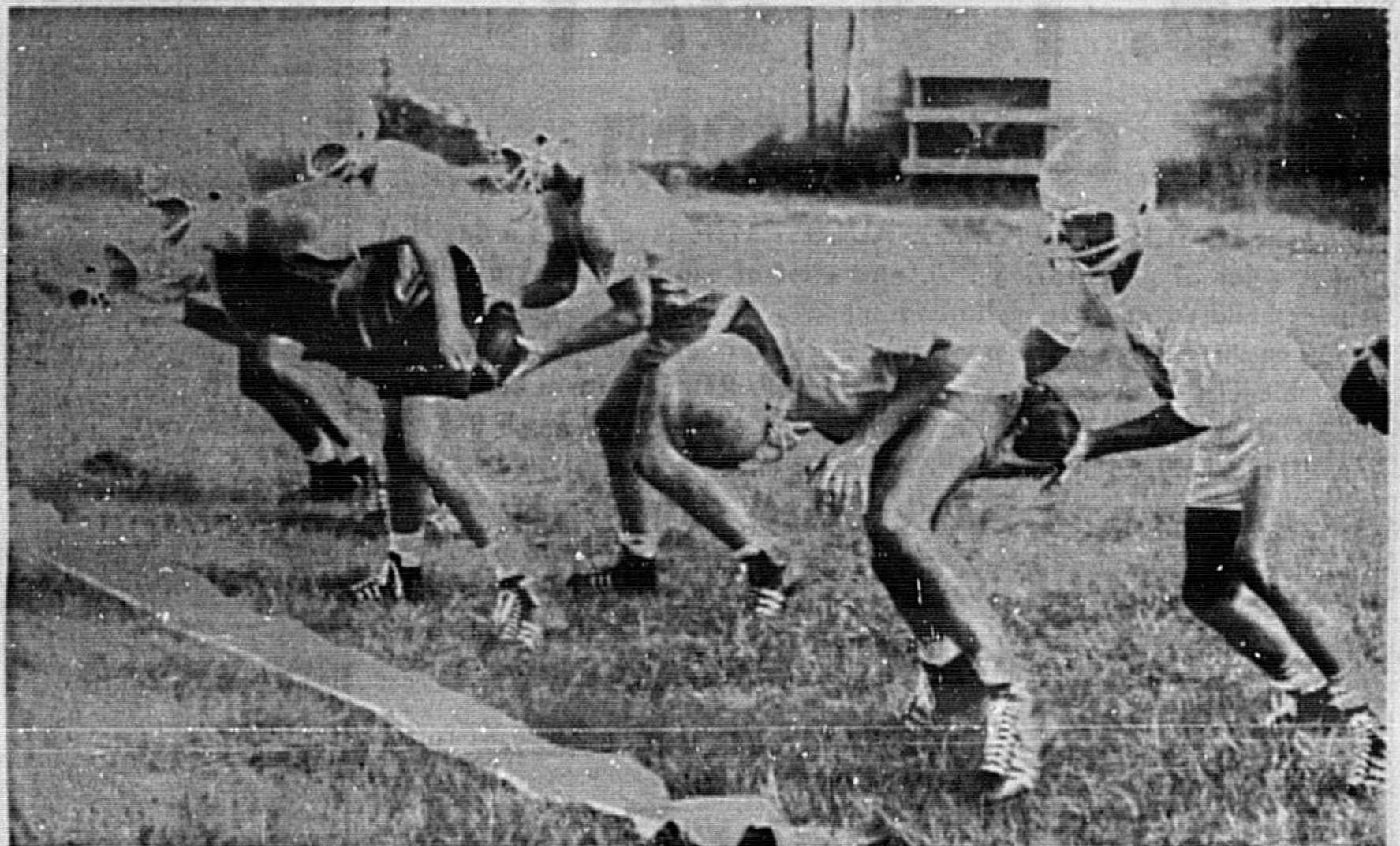

Fighting Seminoles Eleven Preparing For Jamboree

The 1970 edition of the Fighting Seminoles will be quick, strong and fast. The team will be a lot of spirit and every one is really hustling. The players from Crooms fit right in with the Seminoles and now all the players are full fledged Seminoles.

This year's coaching staff will be composed of head coach Tom Ferrin, offensive coach Jerry Posy, defensive coach Grey Boyles, secondary coach Wayne Epps and end and specialty team coach Dick Evans. The team is working out in shorts this week and is working on conditioning, reaction and fundamentals. A few basic offensive plays and a basic defense will be worked out by this Friday. The team will play in a Jamboree September 4 at Winter Haven and the team will be Lakeview, Ocoee, Bishop Moore and Seminole.

A lot of work must be accomplished in the next two weeks and the team plans to improve on last year's 6-4 record.

The Seminoles averaged 321 yards a game last year on offense and gave up 202 on defense. This offensive average will be hard to improve on but the defensive average should be improved.

Last year's statistical leaders are all back. Quarterback Tommy Barks passed for 1,045 yards and 18 touchdowns and had only 12 interceptions. Fullback Ronnie Howell rushed for 889 yards and halfback Tommy Whigham gained 264 yards on pass reception.

All the players (there are presently 42 varsity members) will be given a shot at both offense and defense and the top player at each position will start. The team must improve on it's kickoff and punt returns, but this will come with the great spirit and desire that the team members are showing.

Defense Is Byword; Lyman, Light And Fast

Our defensive line should average about the same as the defense. We won't be running over anyone with our speed, but we hope our speed will make up for this.

Copeland wouldn't go out on a limb and try to predict this year's record, but he did say, "We'll have a tough time improving on last year's record of 7-3." When asked what he thought would be the three toughest games this year, Copeland replied, "Sanford is always a tough game for us. Picking two others is hard, but I would probably pick Boone and Mainland."

Head Coach Dick Copeland has not had much time to look over this year's players yet, but he did give some opinions on what he thought would be this year's strong and weak points. "Defense should be our strongest point. Although our team is light (line averages near 185 pounds per man) for a Class AA school, this should be the quickest team we've had since I have been at Lyman."

Coach Copeland seemed worried about his team's offensive punch and a general lack of depth. "When you lose players like Rick Brown (third year starter at fullback), All-State and All Southeast selection, John Wilkerson and Charlie Mathews, it is nearly impossible to replace them. We are fortunate to have our starting quarterback (Junior Rose) returning."

NO, HE'S not just resting. This Lyman pigskin falls while he and another player go out for passes. The Greyhounds will be out to match or better last year's record of 7-3. The Greyhounds are working under the supervision of head coach Dick Copeland and his staff.

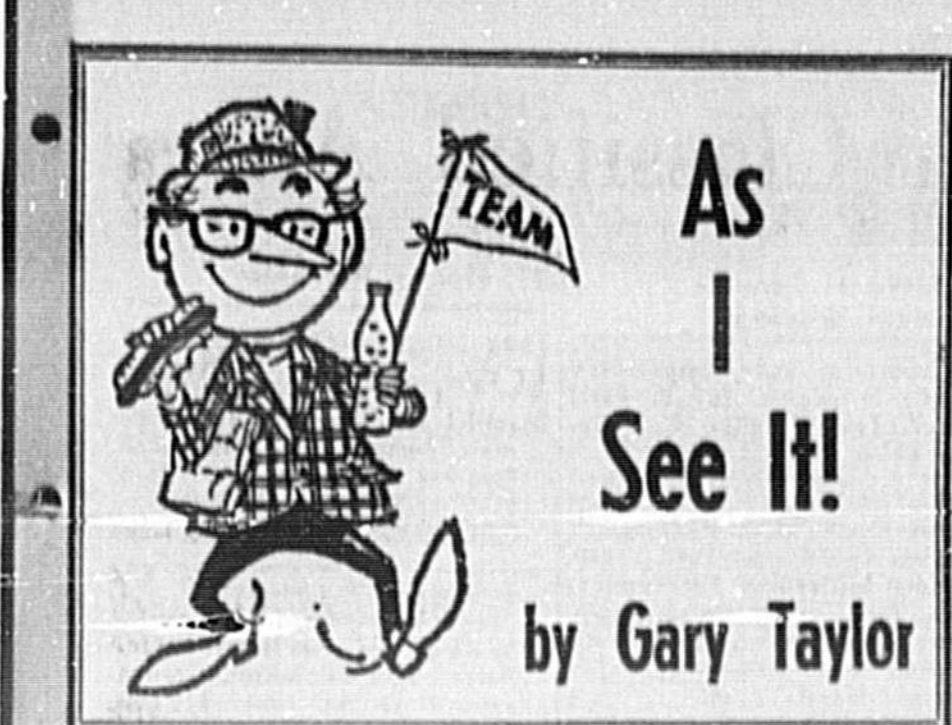
Shaw Happy; Not So With Retirees

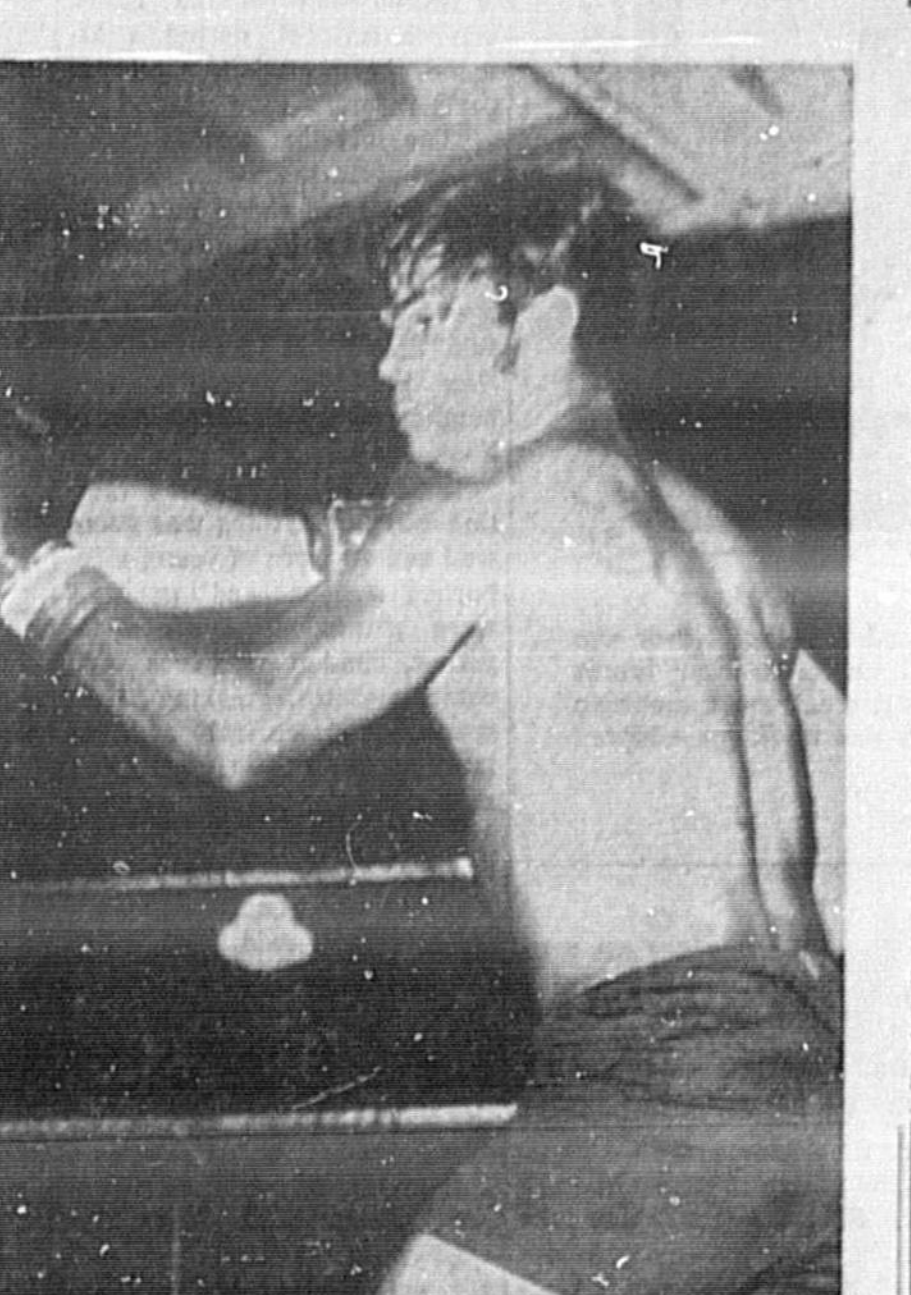

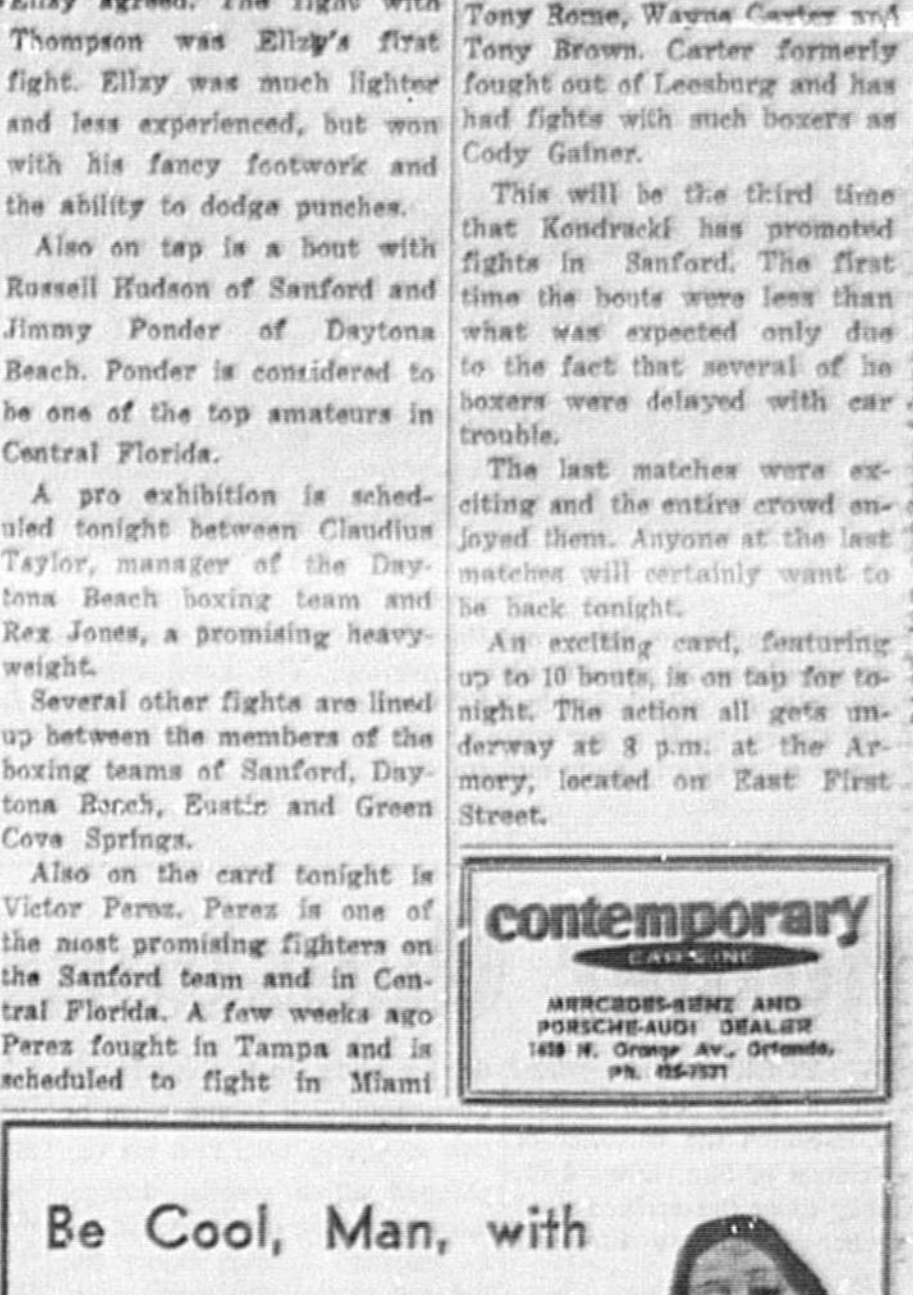

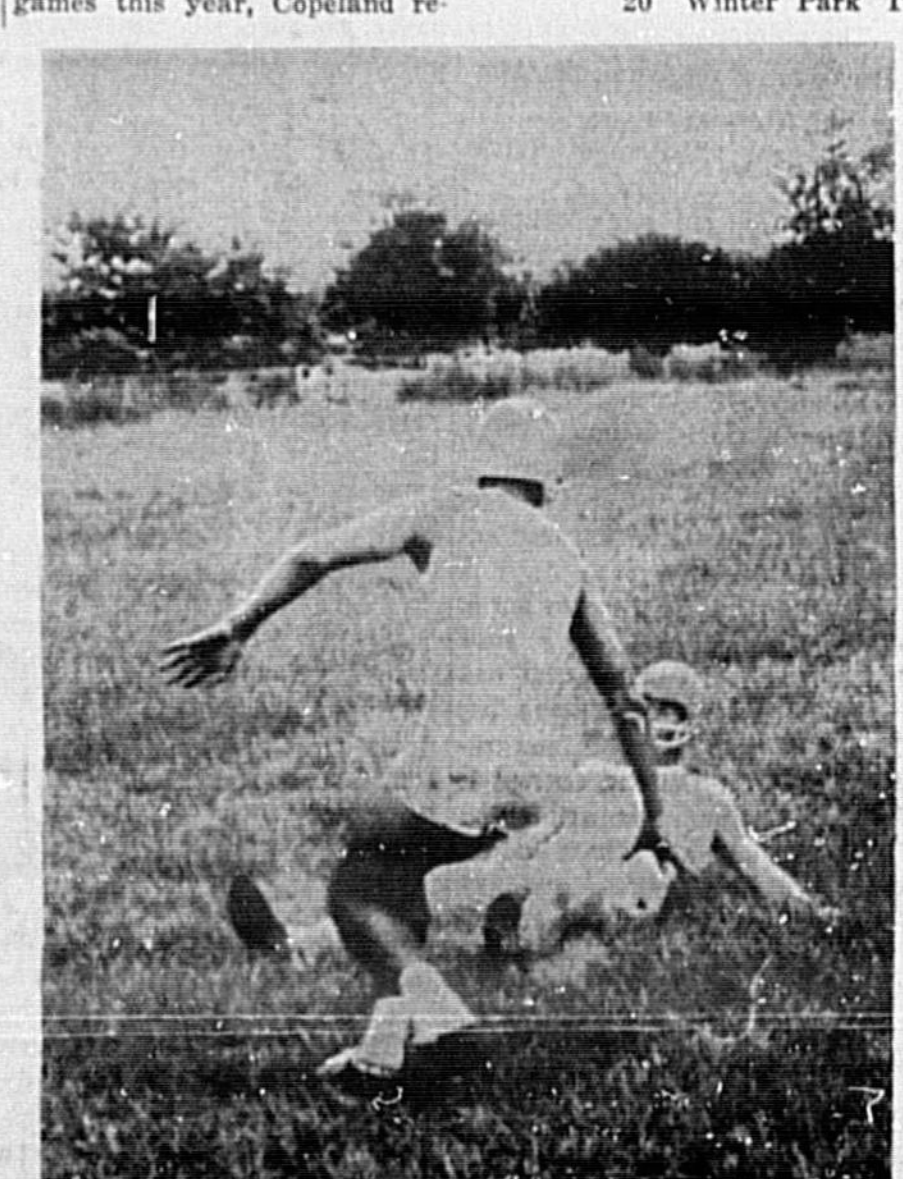

Pentagon Task Force Offers Amnesty

WASHINGTON (AP) — A Pentagon task force recommended today establishment of a trial program to grant amnesty to U.S. servicemen who voluntarily stop using illegal drugs and seek help in kicking the habit.
The massive report, made public as it was submitted to a Senate subcommittee probing the extent of drug abuse in the armed forces, stressed the trial nature of the program which already has been instituted in parts of South Vietnam where it is reported "having a salutary and beneficial effect."
"The task force deliberated long and hard on this recommendation," said Vice Adm. William P. Mack, head of the group, "because there must be a balancing of seeking to rehabilitate an individual with the equally important and necessary precept of military life which is discipline."
In testimony prepared for the subcommittee, Mack said the group's drug abuse problem "has grown radically... in the last few years, and particularly in the high school age group from where the majority of armed forces recruits and draftees are obtained."
The extent of such abuse in the armed forces, he added, probably is "not more widespread than in the civilian population."
The massive report, made public as it was submitted to a Senate subcommittee probing the extent of drug abuse in the armed forces, stressed the trial nature of the program which already has been instituted in parts of South Vietnam where it is reported "having a salutary and beneficial effect."

ALTAMONTE SPRINGS — City Council has accepted the resignation of Police Chief Fred Polson, but has not appointed a successor to the position.
Administrative Assistant A. Roife Wagner said that citizens who desire a deflection upon their tax assessments must file a written petition with him no later than Aug. 31. Council will sit as a Board of Equalization on real and personal taxes on Sept. 1 at 4:30 p.m.
Announcement was made of the opening date for bids upon the new sewer project as being Aug. 28 at 10 a.m. Mayor Lawrence Swafford labeled the date as a "memorandum occasion" representing a project of \$1,800,000. Representatives of the municipality of Eatonville concerning the city's 16th St. Altamonte sewage treatment plant, Consulting Engineer William Palm told the group that there would be more information on the matter following the bid opening on the system.
He continued that the city would be served on a bulk basis with a metered plant, and that the estimated cost would be 15 cents per 1,000 gallons. Palm said that a section of the plant has been reserved for Eatonville's capacity. Palm told the council that 20 firms had submitted bids on the sewer system and were estimated in the range from \$450,000 to \$600,000.
Also on the agenda for the special meeting of the city council was a request to provide water and sewer service to an apartment complex at the intersection of I-4 and SR 40E.
An agreement with fiscal agent Kirk Gandy will also be considered at this meeting.

Viet Cong On Move New Phnom Penh Threat

PHNOM PENH, Cambodia (AP) — Heavily armed Viet Cong and North Vietnamese forces overran the Cambodian defenders of a village nine miles from Phnom Penh today and pushed to within six miles of the capital.
Air strikes continued as an estimated three enemy battalions pushed southward from the village of Prek Tameak, which is northeast of the capital and on the other side of the Mekong River.
One reinforced Cambodian battalion was reported holding out on the Prek Tameak side of the river. A spokesman in Phnom Penh said fighting was continuing at Prek Tameak with heavy casualties on both sides.
But newsmen who drove to the village found everything quiet. Troops in the area said a large number of Cambodian soldiers left Prek Tameak by boat Wednesday night, taking their wounded with them. Cambodian and South Vietnamese gunboats were positioned on the river to provide covering fire during the night.
At least two villagers were wounded during the night by what they said was unprovoked fire from the gunboats, but a Cambodian captain on the scene said the villagers were hit by Viet Cong fire from across the river, which at that point is nearly a mile wide.
Prek Tameak, a village of 1,000 houses and a few Chinese shops, has been attacked three times. Once the Viet Cong held it for three days.
"The Cambodian command has long feared enemy attempts to secure positions in the wooded lands just across the river from Phnom Penh. From there they could harass the capital with rocket and mortar fire."
In Saigon, the U.S. Command would neither confirm nor deny that American bombers were supporting the Cambodians. An American spokesman said "interdiction" raids are flown in Cambodia every day, but "we don't discuss specific locations or targets."

Peace Talks Asked By UN Ambassador

WASHINGTON (AP) — A resolution which calls for the use of defoliants in Vietnam says President Nixon may be using a 45-year-old treaty to bar the use of chemical warfare to settle his proposal.
Administration officials said Wednesday that use of defoliants is still permitted under the 1925 Geneva Protocol.
President Nixon sent the treaty to Senate for ratification on Wednesday. Most observers expect it to be approved.
Sen. Gaylord Nelson, D-Wis., said his amendment to ban the use of herbicides may be the reason the President acted this week—months after he announced he would seek Senate ratification of the treaty.
"I think their point is to get an administration position in opposition to the amendment," Wisconsin Democrat said. "They want to exert the pressure of having their position clearly delineated."
Although he favors the treaty, Nelson took sharp exception to the administration view stated by Secretary of State William P. Rogers in a letter accompanying the treaty, that tear gas and defoliants could still be used in Vietnam.
"It is the United States understanding of the Protocol that it does not prohibit the use in war of riot-control agents and chemical herbicides," Rogers said. "Smoke, flame and napalm are also not covered by the Protocol."
Officials said the administration takes the position that last year's General Assembly 803 resolution declaring that tear gas and herbicides are covered by the Protocol is without standing in international law.
"The standing is that everyone in the world wants it that way," Nelson said. "If that is their interpretation, I disagree with it."

Patrolman Is Killed

BERKELEY, Calif. (AP) — A patrolman writing a traffic citation was shot to death today in the third similar San Francisco area police slaying in two months.
Ronald T. Tsukamoto, 28, on the force 11 months, died two hours after an unknown assailant fired two shots, one striking the officer in the head.
Richard Berger, the slaying spokesman, said the slaying "resembles a San Jose shooting death and a San Francisco one in that police were on traffic stop during early morning hours when the assailant came up."
King Hussein of Jordan went to Cairo today to review the Middle East situation with Egyptian President Gamal Abdel Nasser, official sources in Amman reported.
The acceptance of American peace proposals by Egypt and Jordan has created a split between Arab militants and the two governments. Palestinian guerrillas, and the governments of Syria and Iraq strongly have opposed the peace efforts. An Israeli army spokesman said four Arab guerrillas died Wednesday morning in a clash between two rival Palestinian commando organizations north of Gaza Town in the Gaza Strip.

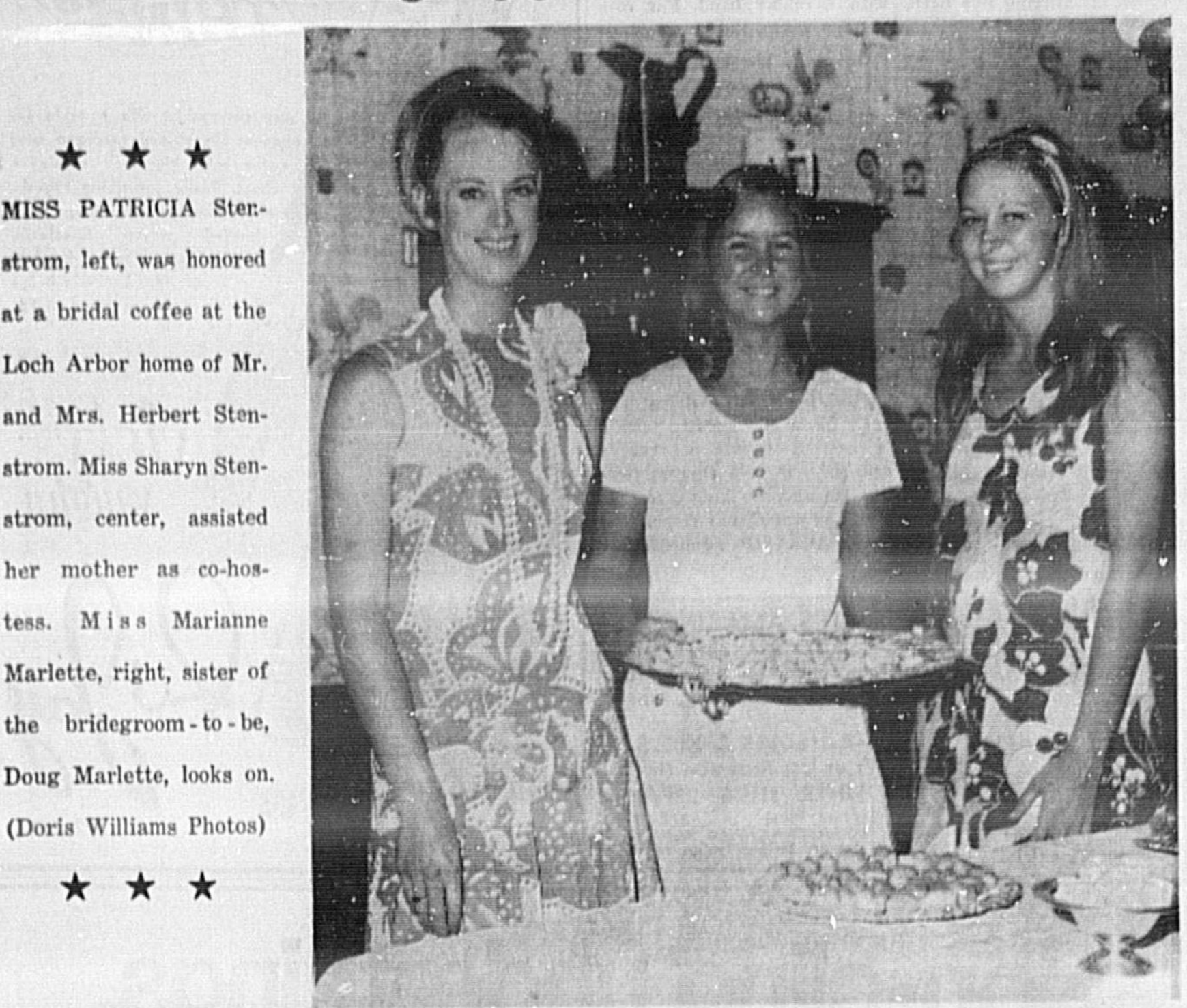

Medical News

TOOTH DECAY
In a program designed to prevent tooth decay, "the total amount of sugar eaten is less important than the frequency of eating," according to the National Institute of Dental Research. The Institute frowns on between meal snacks of foods containing sugar, but recommends as a compromise that sweets be eaten once a day, preferably as a dessert, after a well-balanced meal.

MEASLES
A five-year measles immunization program in New York State has cut the number of common measles cases by almost 85 per cent.

An analysis of the statewide immunization program, the N. Y. State Journal of Medicine states in an editorial that 15 lives have been saved, 50 cases of mental retardation have been prevented, 8,565 hospital days have been eliminated, and all most 500,000 school day absences have been avoided. "Savings in hospital bills and lost time are estimated at more than \$7 million," the editorial notes.

Pointing out that New York has mandatory legislation for measles vaccination prior to school entrance, the publication reminds physicians that the medical profession is dedicated to immunization of all children against measles. No matter what the circumstances, the editorial emphasizes, no child should be without common measles protection.

Match Moods With Tie-Dying

NEW YORK — (NEA) — Getting dressed today is no longer a simple matter. It's a challenge. You must choose your own skirt length, you must accessorize with scarves, vests, capes, floppy hats. You have to decide where your waist should be and whether to belt it. It boggles the mind.

But one way to stand up to the situation is on your own exciting legs—covered with pasty hose or tights that you have designed and colored yourself. It's done by tie-dying and doesn't require skill or a fantastic color sense. All you need is the desire to turn out a unique-looking you.

Tie-dying is an ancient method of fabric design being revived by swinging do-it-yourselfers as well as by the coun-

try's top designers. It involves tying off sections of fabric with rubber bands or string and dipping the fabric into pots of shimmering household dyes. Patterns of color are formed because the dyes do not penetrate the tied areas.

The results are vibrant designs that may range from geometric patterns to overall, lush organic effects. Experimenting with various knots, folds and colors will produce unexpectedly delightful designs. There are no mistakes—just improvisations which can be more fun than a planned pattern.

Here's how: Start with inexpensive white or pale pastel hose. Supplies needed are Rit dye in powder or liquid form, a stock of rubber bands, wood-

en spoon for stirring dye bath, rubber gloves and a glass, metal or enamel pan large enough to completely immerse the garment.

Wet down the tights or pastyhose, fold in half, lengthwise. Working on a flat surface, hand a series of closely-spaced rosette knots over the entire surface of the tights. Just pinch the fabric into puffs of desired height and secure the base of the puff tightly with a rubber band. For concentric circles or a sunburst effect, band the puff in several places. The more rubber bands you use the more circles will result.

Use ¼ cup of liquid dye or ½ package of regular powder for each quart of water and heat in the pan. The dye solution should be kept simmering throughout the process but never allowed to boil. Stir occasionally with wooden spoon.

Keep tights in dye bath for 16 to 20 minutes making sure all fabric is covered by the dye. When the desired shade is reached, squeeze out excess and rinse in cold running water. Unband the knots, retense until the water runs clear. And stand back and admire your handiwork.

Boards Jet Monday Polk To Leave For Capitol

By BILL SCOTT Seminole County Sheriff John Polk will leave for Tallahassee by plane Sunday afternoon from Herndon Airport for his Monday 11 a.m. hearing on his 1970-71 budget appeal. Expected to accompany the sheriff in his action to increase the allotment for county law enforcement is Douglas "Tom" Polk, Polk's attorney, who will aid in the presentation of the sheriff's argument that came after the county commission in its budget session slashed \$78,229 from a requested \$642,804, giving the sheriff's office \$564,275 for the next fiscal year. Harold Johnson, county attorney, and County Commission Chairman John Alexander are expected to attend the session and plead the commission's case against restoring the sheriff's funds. Included in the deletions were five additional bonded law enforcement personnel that Polk felt was needed to police a growing county population in the wake of Disney World. It is assumed this will attract many drifters and hoodlums along with the tourists, who will flock to the area just 39 miles away from Sanford. Polk told The Herald he could not do what was politically expedient for him and accept the cuts that deprived him of needed crime fighting gear. Polk listed a recorder for incoming telephone and radio calls that in good conscience, he was unable to deprive the citizens of the apparatus needed to protect them. There is a possibility that if the appeal committee grants the sheriff his budget requests and restores the money, an additional one-sixth mill will have to be levied by the county commission to raise the funds. The sheriff said he reasoned it was the protection of county residents that was more important. Therefore, he would have to accept the small millage increase to bring the per capita crime fighting dollar to \$4.47 for each of the county's 82,550 persons. Present per capita amount for each county resident is \$3.09 if the budget cut is allowed to stand. The total county approved budget for all departments is \$8,644,700 with the sheriff's department expected to receive 6.5 per cent of the amount. Polk said this year's request was above last year's \$407,204 amount because crime had increased greatly and he proposed \$400,000 to show that in the first six months of 1970, 302 felony arrests had been made in comparison to the total 219 arrests in the entire 12 months of 1969. The criminal case load has increased 60 per cent since and if the budget cut is allowed to stand, (Continued on Page 3A, Col. 3)
