Senator Walsh Dies Aboard Train On Way To Roosevelt's Inaugural; Capital Is Surprised And Grieved

Recently Appointed Attorney General Victim Of Heart Attack Early Today

ROCKY MOUNT, N. C., Mar. 2.—(A.P.)—Senator Thomas Walsh, Montana, died suddenly of heart attack aboard the Atlantic Coast Line train near Wilson today while enroute to Washington with his bride whom he married Saturday in Havana.

The senator, who was named to be attorney general in the Roosevelt cabinet a few days ago, was stricken and died within a few minutes as he lay face downward in his berth. He was 74.

Walsh died as Conductor Herbert Weatherup held his pulse. Only the conductor, Mrs. Walsh, and her Cuban maid and the porter were present.

Mrs. Walsh, who speaks little English, said her husband died about 8:30 A. M. and that he "died in pain. She said she found him holding his stomach with his hands.

He was from his birth and crossed over to his wife's birth and there collapsed.

The senator's body was taken from the train here and will be sent to Washington later today.

Dr. M. A. Pittman, who attended Mrs. Walsh here, said she told him the senator was ill when they left Daytona Beach where they made a stop.

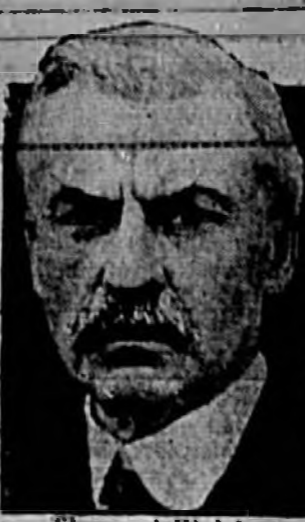
Senator Thomas James Walsh has served continuously in the U. S. Senate since 1912 and was elected as one of the prominent attorneys in Congress. He was best known as the man who prosecuted the Senate's investigation of the Teapot Dome and Elk Hill oil leases.

He was known to his colleagues and the country as a brilliant investigator and a sound and skillful debater. His legislative achievements have been notable.

He led the fight for the confirmation of Justice Brandeis as a member of the Supreme Court. He supported woman suffrage and the Child Labor Amendment. He led the movement to prevent the use of federal money to prosecute trade unions under the Sherman act. He aided in concentrating national attention on conditions in the steel industry and was instrumental in obtaining the investigation of the power trust.

The seventy-four-year-old Senator married Senora Nerva Fernandina Chaumont, wealthy widow of Eugene Troffin and a member of a (Continued On Page Four)

FARMERS WILL CONTINUE TO DESTROY CROP

(Continued from Page One) state must necessarily be curtailed if such market conditions and prices are to be maintained or improved.

"And whereas, as said meeting every possible means or method to accomplish such curtailment was fairly, honestly, fully and carefully debated and discussed, and the method then decided upon, namely, the destruction of one-third of the crop by plowing under as it matures was then and there declared to be the most fair, equitable and practical.

"And whereas, as a consequence of such decision the following resolution was unanimously adopted at said meeting: 'BE IT RESOLVED: That it is the sense of this meeting that beginning Monday, Jan. 30, of next week, the acreage of celery of this state, maturing during the two weeks following, be curtailed by one-third through destruction by plowing under in solid rows, at its maturity, and that on Friday of each week hereafter the Florida Celery Growers take action as to a continuance or revision of this practice for each second week thereafter."

"And whereas, this program has been extended from week to week by resolutions unanimously adopted at similar meetings held at Lakeland on Friday of each succeeding week without revision or change, so that such policy remains in force and effect, by virtue of such resolutions, for the current week and for the week beginning Mar. 6.

"And whereas, for a period of almost five weeks, this program has been carried out in every important section of the state through the unselfish cooperation of at least 98 percent of the growers, resulting, in our opinion, in a greatly improved distribution, and a steady improving market.

"And whereas, a careful survey of the State at this time indicates that the movement of celery for the weeks now ensuing will show a steady increase as compared to recent movements, and we are advised by men in whose judgment we rely that the future movement of celery must be controlled if present price levels are to be maintained or improved.

"And whereas, recently several growers in our immediate section, who seemingly fail to appreciate that a self interest must in such a crisis yield to community interest, have been agitating a discontinuance of this policy which would only result in an unfair advantage over those growers who have complied and are now complying with such program.

February 1933, that the program now in effect relative to the curtailment of the present celery movement be continued, and that all growers in accord with this committee consider themselves as a committee of the whole to individually visit among such of their neighbors who are not now enthusiastically supporting the same, and to appeal to them in a kindly spirit to yield their individual opinion to the end that the continued welfare of this community may be insured."

The resolution was signed by E. J. Meyer, and R. R. Pippin, comprising the Resolutions Committee of the Seminole Agricultural Club, and it was passed unanimously.

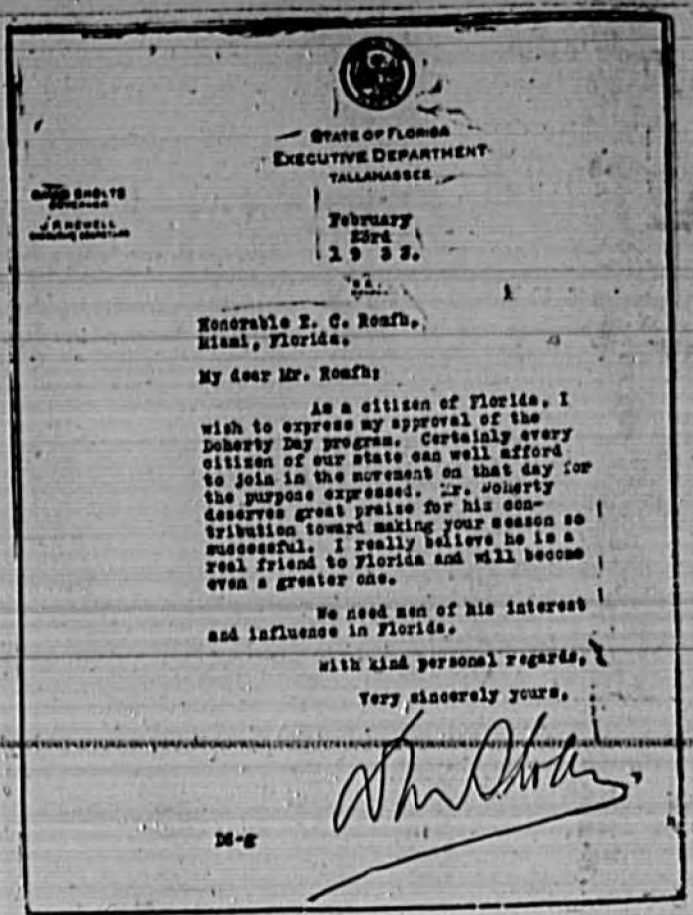

The inference from this demonstration is that the same procedure could be carried out on people with the same success.

UNNECESSARY CRUELTY

BY MARJORY STONEMAN DOUGLASS

In times such as these, it is difficult to draw attention to the suffering of animal. I am thankful, therefore, to learn that the Florida Federation of Women's Clubs is sponsoring a movement for an anti-steel-trap bill in the coming legislature.

The steel-trap is without a doubt the most heinous instrument of torture left in a so-called civilized age. It does not kill its victim, but catching and crushing its leg, holds it there for days in agony from pain, swelling, struggle, fever and thirst, until the trapper returns to club it to death, or until it escapes (as at least one-third do) by gnawing off its own foot. Since the present craze for fur came in, more than 100,000 animals suffer in this way every year in North America.

Florida supplies large numbers of the smaller ones, coons being the chief catch. Coons are one of the most intelligent and highly sensitive of mammals. What woman would want a raccoon coat or trimming if she had seen the creature gnawing off its foot after days of anguish? What woman would buy a scarf if she had come upon the fox swinging from a spring-pole-trap which, fastened to a bent sapling, had sprung upward and kept the animal suspended there by the broken leg for a week?

Women do not know these facts; yet they go on all about us, in every woods and swamp and hammock. And quite unnecessarily. For there are now on the market a dozen kinds of humane traps, which either catch the animal by the head instead of the leg, killing instantly, or take it alive and unhurt. All that is required of the trapper is that he use these instead of the old, torturing kind. He will still take his pelts; women will still have their furs; but the business will be robbed of its cruelty.

If every woman will ask her club, or other society, to pass a resolution requesting the legislators of her district to vote for the anti-steel-trap bill in the Spring, we can wipe the stigma of this cruelty from the State of Florida, as has already been done in South Carolina, Georgia and Massachusetts.
