**Five Ways To Get Things Done**

A snowbound house party, last winter, unearthed an interesting parlor game which substantiated some scientific facts we had been compiling," says Donald Laird in Your Life Magazine. "Each one of us picked a friend-without revealing his name—who was not getting along in the world as well as his ability would suggest that he should."

"We tried to diagnose each of these absent friends to see what was keeping him from success. We discussed many reasons why each seemed to have failed to reach the high level of achievement of which we knew him to be capable. It was agreed that their one outstanding fault was their inability to get things done." And here are five rules that they might have used to correct their trouble:

Rule 1—Stop detouring. Remember Mark Twain's story about the steamboat that had such a large whistle that the engine had to stop every time it was blown? A lot of people are like that—they spend so much time on unimportant things that they don't have time to do things they should do.

Rule 2—Stop putting off disliked things. Unpleasant tasks make putters of people. The cure is simple—get busy.

Rule 3—Stop wasting time deciding trifles. Indecision lulls not spring from time that is spent doing the minor jobs, it springs from time that is spent thinking about them and doing nothing.

Rule 4—Stop wasting your spare time. The spirit that wins, and the spirit that uses spare time, are often the same thing.

Rule 5—Stop accepting your alibis. The proverbial Alibi Ike is usually a person who does not get things done. He is always ready with some excuse for the unfinished job. He can often make his alibis so convincing that he believes them himself. Promiscuous use of alibis is one of the surest ways known not to get things done.

**Let 'em Forget**

"Service men like to be entertained—not cried over", says a feature writer in the Times-Union. And he calls attention to the common sense rules adopted by Stage Door Canteens throughout the country which are banning sentimental war songs. You don't talk shop when a lawyer comes to your home for dinner. So don't talk shop when a soldier or sailor is there. They want to forget the war.

"People entertaining service men should avoid these heart-rending ballads," says the Times-Union article. "When a service man goes to a canteen, or to an affair planned for his entertainment, he wants to forget the war, and especially the grim side of it. He has probably spent his day in bayonet drills or commando tactics and that's enough for one day!"

This song "The White Cliffs of Dover" is a knockout number, but its sentiments are apt to produce tears. So is "Miss You" and "Dear Mom" and "My Buddy". And maybe the service man had a friend whose fate he would rather forget, so why play "Remember Pearl Harbor" at a social affair?

"In a very short time after a fellow enters the service he learns how to forget mawkish sentiments. In his heart of hearts he is still the old human being, but, on the surface, he is a gayhearted fellow with not a care in the world."

"Among the many reasons why these Stage Door Canteens have been great hits with the service men is the strong disciplining they exert over their volunteer personnel. A man or woman is expelled from further service if they are overheard plying the boys with grim questions. The war jitters have no place in Stage Door Canteen psychology."

"And we wish that more civilians would adopt these practical rules when trying to give service men a good time. Why talk to these chaps about their girls, wives or kiddies? Why do folks want to remind them of their sacrifices, their hazards, their loss of a job, etc.?"

"And as for the so-called patriotic persons who likes to 'pep' em up by fiery speeches—fellow like that should be shot at sunrise! A man who wears a uniform has a very active and practical sort of patriotism. He expresses it in his action. He needs no civilian to prompt him; in fact, civilian patriotism is liable to sound a bit hollow to him. Better keep the spirit of all these occasions on the up tempo side."

## Navy Announces Destruction Of 3 U. S. Cruisers

### Marines Reported Enlarging Positions On Guadalcanal In Solomon Islands

WASHINGTON—The Navy announced today the United States Marines have established positions on Guadalcanal Island in the Solomons during two days of offensive fighting in which the Japanese had many casualties. An announcement was also made of the destruction of 15 Japanese planes and damage to two enemy light cruisers and the loss of two United States planes in action of Oct. 9-11.

Loss of the U. S. heavy cruisers Quincy, Astoria and Wisconsin during a fierce close-range night battle in the opening phase of the Solomons Islands invasion last August was revealed last night by the Navy which said a majority of the personnel were saved but that "there still were many casualties."

It was the biggest single blow suffered by the fleet since the Jap sneak attack on Pearl Harbor. It sent five warships to the bottom.

The Navy said the sinkings had been withheld until now for reasons of military security.

The battle was the same which resulted in the sinking of the Australian cruiser Canberra, announced previously from Australia.

"The loss of these four cruisers," the Navy said, "has been offset by the appropriate realization of ships which in mode performance were able 'construction'." The new ships were the three American destroyers commissioned between 1934 and 1937.

The Quincy was of 3575 tons and the Wisconsin of 4000 tons.

Each carried a normal complement of 852 officers and men.

The Astoria was of 3525 tons

and normally carried 859 men.

The sinkings reduced to at least nine the number of American warships which were authorized to sail in the Solomons campaign this far.

Besides the three cruisers, two destroyers and four transports have gone to the bottom.

The Navy said it was impossible to determine the extent of damage suffered by the enemy.

But, since the marines launched their offensive against the Solomons Aug. 7, the navy has encountered 30 Jap ships sunk or damaged—five more, it was probably, sank in 25 days.

At least seven Jap ships were

damaged.
