Iranians convicted in arms plot

BOSTON - An Iranian man and his son were sentenced in federal court to prison terms of 14 months and six months for their attempt to smuggle missile parts out of the United States to their native country.

Federal prosecutors sought two-year terms for both Ahmad Modarresi, 64, and his son, Majid. 30, of Cincinnati, but U.S. District Judge Mark L. Wolf on Monday cited mitigating factors including the father's belief that the United States wanted to sell such items.

Wolf characterized Majid Modarressi, an unemployed architect, as a naive man trying to make money to please his father, who asked him to help procure military parts from **Raytheon Corp**

Wolf said the father, aging and in poor health. wanted to help his country in "s war with Iraq and also believed that the United States wanted to sell the weaponry to improve relations.

Hijacker sentenced to jail

UNIONDALE, N.Y. - An Albany woman who spent 19 years evading federal authorities will only serve a month of a six month jail sentence. for her role in the 1969 hijacking to Cuba of a

Miami-bound flight carrying 146 people. U.S. District Judge Jack Mishler Monday gave Linda Joyce Grinage, 39. credit for good behavior and for time she has served since her arrest last July.

"I realize I endangered the lives of innocent people," Grinage said, weeping before a courtroom packed with relatives and friends.

Hitchhiker killer executed

STARKE - Five-time killer Jeffery Joseph Daugherty, declaring himself finally "free," was executed Monday for the 1976 slaying of a hitchbiter whose body was found near a dump. Daugherty delivered a sometimes rambling final statement, exhorting other condemned men to keep fighting, before the executioner sent 2.000-volts through his body. Doctors declared him dead at 5:16 p.m. EST.

He was the 10th person executed this year the 103rd since the Supreme Court lifted its Games in full swing

"One precinct called in to say people were standing in line at 20 'til 7,'' Goard said. ''One clerk called in and asked for more voting boothm but we have all of them out."

Goard predicted 78 percent of the county's 112,499 registered votern will participate today. She said the heavy turnout is normal in Seminole County for a presidential election year.

The ballot's lengthy list of candidates and issues may cause those voter lines to move slowly.

Longwood lake cleanup planned

LONGWOOD - City commissioners are colicerned about the quality of their lakes.

At last night's meeting, they approved a \$17.232 contract to Aquatic Systems Inc. of Sanford, an environmental services firm specializing in lake restoration, to clean up 14. city lakes and ponds-

The firm's bid was the lowest of three, with one being a no-bid, according to City Administrator Gene DeMarie, Funds will come. from the public works department.

To maintain the city's lakes and ponds, the Pompano Beach-headquartered company will perform 12 inspections annually to control and prevent algae and noxious aquatic weed. It will stock the lakes with grass carp at its ownexpense, according to DeMarie.

The firm will report its progress in monthly written reports to Fernand J. Tiblier, assistant city engineer in the public works department. It will also answer Longwood citizens' questions - garding the condition of lakes.

Aquatic Systems Inc. is involved with lake restoration at Wet 'N Wild in Orlando, where it is maintaining a 25-acre lake, and Gulistream Development at Tuscawilla where it is fishstocking and restoring 14 lakes.

The Longwood lakes and ponds to undergo restoration are: Lake Jane, at Oak and Maine: Lake Wayman, at Georgia and Wayman: Pelican Lake, at Sparrow and Wren: Gull Lake, at Martin Circle: Lake Winsor, at Winsor Manor: Lake Lemon, at Valencia Court West; Columbus Barbour Pond, at Pinta Place; West Lake, north of E.E. Williamson: Tiberon Pond, at Waverly Drive and Alameda: Coventry Pond, at Sunset Drive; Lake Orange, at Orange and Wayman; Lake Norton, at Grant and Pasadena; Crane Lake, at Grant and Quail; and Bird Lake, at Sky Lark Circle.

The company will be hired for one year with; consideration to renew the contract.

Man drowns during fishing trip

BOCA GRANDE - A Fort Myers fisherman who had survived nearly a week with two friends after their boat capaized in the Guif of Mexico became delirious and swam to his death, 30 minutes before help arrived.

The body of Granville Bryant was found by a Coast Guard helicopter at 11:50 a.m. Sunday about 27 miles off Boca Grande, said Petty Officer Dan Sutyak. Bryant was two miles from where his friends, Charles Stevens, 25, and Dane DePuis. 18, were found fonting on their He preservets by a passing fishing boat on Saturday.

Stevens and DePuis declined comment about their ordeal, but Stevens' girlfriend. Martha Calvert, said the three were on a fishing expedition for her family's seafood market in Pine Island when their boat capsized Tuesday or Wednesday.

She said they survived on a gallon of milk and clung to a large cooler as pilot fish nipped at their legs and feet. Bryant, who was captain of the vessel Miss Vancas and went by the nickname "Lucky," became delirious and swam away from them.

Lotto dealer closing shop

ST. CLOUD - The newsstand where the winner of Florida's latest \$8 million Lotto jackpot claims he bought the winning ticket is going out of business Friday, and the owner blames the popular numbers game. Proprietor Sherry Lambert, 35, of the St. Cloud Newsstand

said once her shop became a hub for Lotto sales in this rural community of about 20,000 people her more lucrative business was destroyed.

"We k c the commissions that we make on books and magazines, which is anywhere from 9 percent to 15 percent. The same sale going into the Lotto machine is only 5 percent. and it doesn't cover your overhead." ahe said. "You end up losing your underwear." Lambert claims ahe sold the winning ticket for the latest

weekly game. State lottery officials have not disclose whether a winner has stepped forward.

The newsstand opened in August 1987 and had been gradually building profit margins until bringing in the Lotio computer terminal, she said, but the store is now grossing about the same as upon opening.

TALLAHASSEE - Elections officials said Monday they expected a heavy turnout in the general election that has featured a hotly contested U.S. Senate race and a multimilion dollar battle over damage awards in civil lawsuits.

"With the Senate race, two Cabinet seata, the legislative races and all the amendmenta, I can't believe we will have anything less than a 75 percent turnout." state elections supervisor Dot Joyce said.

Joyce said there are slightly more than 6

million registered voters in Florida. National Weather Service forecasters predicted mostly sunny skies for Florida Tuesday, something election officials said would help increase the turnout.

While the presidential race may draw voters, in Florida it appears Republican nominee George Bush will carry the state and its 21 electoral votes. Polls show Bush with a 21 percent lead over Democratic challenger Michael Dukakia.

That kind of presidential blowout has left most people focused on the race to replace U.S. Sen. Lawton Chiles, D-Fia, who is retiring after three terms.

Polls showed the senate race was a toss-up, with Rep. Kenneth "Buddy" MacKay, D-Fla., owning a negligable 1 percent lead over Rep. Connie Mack, R-Fla.

Mack has spent much of his time - and money - trying to label MacKay as a

mainstream voters. MacKay has focused on what he calls Mack's "bizarre" voting record and has hammered away at Macks poor voting record on issues like the environment and social concerns.

MacKay also charged Mack with being Indebted to foreign industry. MacKay cites a Democratic Senatorial Campaign Committee suit filed last week that charges Mack conspired with Japanese auto makers to get free advertising.

Mack denies the allegation.

In the U.S. House races, there will be at least three new faces from Florida when Congress convenes after the elections.

Three scats have been vacated by candidates who decided to run for other offices including Macs., MacKay and U.S. Rep. Dan Mica, an unsuccessful contender for the

Democratic Senate nomination

Eight of Florida's 19 U.S. Representatives were re-elected with no opposition and little change in the makeup of Florida's congressional delegation is expected.

Republicans hope to gain at least one seat on the state Cabinet, something they have not done since Reconstruction.

Incumbent Secretary of State Jim Smith is considered a strong favorite to beat Democratic challenger Tom Moore, a former state legislator.

Smith, who became a Republican after his 1986 bid for the Democratic gubernatorial nomination failed, was appointed secretary of state last year by Gov. Bob Martinez.

The GOP also has high hopes for Insurance Commissioner candidate Tom Gallagher, a former legislator and Department of Professional Regulation chief.

Gallagher is locked in a close race against state Sen. Ken Jenne, D-Hollywood.

Also at stake are all 120 seats in the state House and 22 in the Senate, though many of those seats will be taken by candidates running without opposition.

Republicans are predicting gains in both chambers, gains that would put them in position to win control of the Legislature in 1990, something that would give them the edge during the crucial reapportionment after the 1990 census.

A good showing in the House - GOP spokesmen say they can g'in 10 scats also would allow Republicans to form a coalition with conservative Democrats,

Five-time murderer executed Monday

He was the 10th person executed this year and the 103rd since the Supreme Court lifted its han on capital punishment in 1976.

Daugherty was sentenced to die for the March 1, 1976. abduction and slaying of hitchhiker Lavonne Patricia Sailer. 48, whose body was found in the Brevard County dump near Melbourne.

The victim was robbed and shot five times with a .22-caliber pintol. A Titusville jury voted for the death penalty Nov. 21, 1980, after he pleaded guilty. He also received life sentences for hilling two convenience store

clerks - Carmen Abrame, stabbed during the 1976 robbery of a Plagter County convenience store, and Judy Campbell, killed during a robbery at a Voluata County business.

"Some of you look at this as an execution." Daugherty said, his lips trembling. "I look at this as freedom. I've been in prison for 15 years - now I'm free."

The execution proceeded when the Supreme Court, on a 5-4 vote, refused hours earlier to grant a stay. A federal appeals court rejected Daugherty's bid Friday.

Daugherty refused a last meal of steak, potatoes, beans and corn, but ate a pint of ice cream and root beer his father brought earlier in the day.

Trident 2 submarine missile launched

CAPE CANAVERAL - A Trident 2 submarine missile was successfully launched from a ground pad Monday in the 16th test of the powerful weapon system and the first since a missile was deliberately blown up in September.

The three-stage \$23.7 million missile blasted off from the Cape Canaveral Air Force Station at 11:30 a.m. and quickly streaked through a clear blue sky and out of sight.

The flight sppcared normal but, as with all such test firings. no details were provided other than a brief statement from the Air Force that said the test was a

The 15th Trident 2 flight Sept. 19 ended in failure when an Air Force range safety officer radioed self-destruct commands to the missile after it flew off course a little more than a minute into flight. It was the third Trident 2 to be destroyed since testing began in January 1987.

Officials said later the missile was performing properly and that its guidance system had altered the trajectory to lessen unexpected aerodynamic forces. or "loads."

The range safety officer, however, had not been told to expect such behavior and in any case,

the missile was just a few seconds away from violating limits on its flight path, Air Force officials said.

The first known failure in the Trident 2 program occurred Jan. 21 when a missile had to be destroyed shortly after thirdstage ignition because of a malfunction. The second failure occurred July 6 when the 13th missile in the series was blown up after a first-stage malfunc-

tion. All American rockets, including the manned space shuttle, are wired with explosives to blow them up in the event of major malfunctions, thus preventing an errant vehicle from reaching populated areas.

The 126,000-pound Trident 2 missiles, built by Lockheed Missiles and Space Co., are thought to be an accurate they can deliver a nuclear warhead to within about 400 feet of a target.

Critics claim that with such pinpoint accuracy the Trident 2 could be used to knock out "hardened" enemy command posts and missile silos and as such, it should be viewed as a "Arst-strike" offensive weapon.

The launching Monday was the 16th in a series of at least 20 test firings planned before deployment aboard Ohio-class nuclear submarines begins in late 1989.

Canadian Conservatives, free trade agreement in jeopardy



OTTAWA - The Liberal Party, campaigning against the U.S. Canada free trade agreement, has a solid grasp on first place ahead of the ruling Conservatives, according to a Gallup poll released two weeks before the crucial general election.

Liberals, riding the crest of a wave of popular opinion against the trade pact, have turned the election into a virtual referendum on the treaty.

The strategy has propelled them into a position where they are now favored by 43 percent of voters who expressed a preference in the Gallup poll released Monday. The ruling Progressive Connervatives were backed by 31 percent and the socialist New Democratic Party 22 percent. with 10 percent undecided.

The treaty was signed Jan. 2 by President Reagan and Conservative Prime Minister Brian Mulroney.

Jernigan said buildings available to rent would cost \$6 to \$8. per square foot for \$42,000 to \$56,000 per year. He said for that amount, the city could be making payments on its own building

ment has several advantages. including a lower interest rate. and would eliminate the necessity of the city selling bonds to pay for the project.

Jernigan said the recreation center could be built on cityowned land on 25th Place off South Sanford Avenue. The Sanford Gymnastics Association presently is constructing a building on the site, which includes about 25 acres.

Commissioner Whitey Eckstein questioned whether 7,000 square feet would be enough space, and suggested a classroom be included in a recreational facility to provide space for tutoring children in kindergarten through third grade in reading and reasoning. He pointed out that Florida has the highest school dropout rate in the nation and said the city could help alleviate the problem by providing a space for a tutoring program.

Eckstein, a teacher with Seminole County schools, said city recreational programs should be expanded to include education. He said he would try to recruit teachers to join him and his wife to volunteer their services to tutor the children.

Other commissioners agreed with the suggestion and said perhaps a portable classroom would be available from the

tioning of the space requirements for the recreation center that 7,000 square feet is considered a minimum, and that no decision on the actual size would be made until architects' proposals are sought and received. The commission also approved a schedule for advertising and accepting bids for the remodeling of the Youth Wing to serve as a senior center. The city will begin advertising for bids Nov. 13, aiming at a bid opening Dec. 6 or 7, approval of a contract Dec. 12, and work beginning soon after the first of the year.

The commission also decided to have City Manager Frank Faison contact school officials to determine what plans they have for a dilapidated building at Seventh Street and Pine Avenue. Commissioner A.A. Mc-Clanahan said the city looked into condemning the building about 10 years ago but found it didn't have the authority to condemn school property. He said the building is a safety and fire hazard.

The commission also heard about an anonynous donor who is offering \$60,000 to the city to complete landscaping improvements and the construction of a new gate area at Evergreen Cemetery.

SANFORD - Jennifer Kelley. **Republican District 5 Seminole** County commission candidate. has raised \$134,629, more than any other candidate for local office in Seminole County, according to the most recent campaign contribution reports.

Sandra Goard, county supervisor of elections, said today that Kelley's contributions set an all-time record. The re-ports were due at the Seminole **County Supervisor of Elections** Office Friday.

By Nov. 4. Kelley reported, she had raised \$83,429 in contributions and made another \$51,200 in loans to her campaign. She said she had received an additional \$1,291 in goods and services that are not included in

the total dollar income.

Kelley reported spending \$130,547. She spent \$24.635 during the last two weeks before the Nov. 4 reporting deadline. Most of the expenditures were for newspaper advertising. brochure mailings and postage costs, she said.

Among the \$25,050 she received during the last two weeks, Kelley received \$1,000 contributions from Mid Florida PAC of Mattland and Larry W. Toler, a Maitland builder. Most of her contributions in the latest report came from professionals in the contruction industry and attorneys. She also received \$3,500 from the Seminole **County Republican Executive** Committee PAC.

Among the Kelley contributions was \$600 from Mark collector, added \$5,551 to his

troversial 334-acre site on Lake total of \$34.597 during the last Svivan and \$750 from Oviedo developers Whitemark, Inc.

The second-highest amount of contributions was reported by Fred Streetman. a Republican seeking re-election to the District 3 county commission seat. Streetman reported receiving \$93.612 in contributions, with no loans. He reporting spending \$92.288, mostly in advertising and other promotions.

Among Streetman's contributions was \$3,500 from the county party organization. \$1,000 from the state party organization and \$1,000 each from Baird-Ray Nissan of Longwood and Lake Hays Properties developers.

two weeks. He received \$2,000 from the state party and \$1.000 from the county party.

EDITORIALS Vote first, then reflect

When this day is finally over, Americans may breathe a collective sigh.

Campaigns have become year around allairs. They were the major topic of

conversation during the past two months. The Seminole County ballot contains 28 separate voting elements ranging from the presidency of the United States through state and local conditates to Constitutional Amendments and the Charter question. Because of this, the early turnout indicates the total vote will be higher than the projected national percentage.

The importance of an individual vote has been impressed on everyone repeatedly and the number of important elections decided by that one vote has been printed and reprinted.

The polls will remain open until 7 p.m. so there is still time to cast a ballot.

Tonight there will be more unhappy candidates than happy ones since some races involve more than two competitors. If the national polls are accurate, the clear winner in the presidential campaigns will be the pollstern retained by the candidates, the media and various research organisations. The polls, with commentary, appear to have been the top news stories with the percent-ages indicated for Mr. Bush and Mr. Dukakis showing wild swings. Mr. Dukakis was way ahead in the summer, the race was neck-and-neck by August, then Mr. Bunh surged ahead in October. Today is each's date with destiny.

There are two or three races in Seminole County which are touted as likely landslides. but without "scientific" polling locally, who's to know for sure in advance.

Voters also have been introduced to the phrase "negative campaigning," which can be interpreted as one candidate objecting to the opponent calling attention to portions of his record that may prove injurious.

Campaign expenditures have escalated to an extent that millions of dollars are spent on ale elections. A new record Seminole County with one candidate spending more than \$130,000 on the campaign. Why be a candidate? Nationally, candidates run for power, prestige, and a sense of purpose. Locally, the motivations, by and large, are more sincere. There are but few unqualified candidates in the county and city races. Most are committed individuals who wish to serve the public. The posts are not enriching and the aggravations are many. Challenges abound for the winners.



A researcher at the San Francisco Veterana Hospital recently was accused by the Food and Drug Administration of failing to get "informed consent" from patients before he used an experimental drug on them. Rego is one of 26 patients whose records indicated that they may not have been adequately warned about the drug 6-aminonicotinamide or 6-AN

We first reported nearly a year ago on Rego and his struggle to find out more about the drug. Now the researcher, Dr. Herschel Zackheim has signed an agreement in which the FDA alleges he violated FDA rules governing experimental drugs. The FDA has ordered Zackheim to work under supervision and with only small numbers of patients Rego a Vietnam veteran, went to the

The case for George Bush

WASHINGTON-The campaign, having promised instruction and barely diversion. now sags to a stop and I herewith complete the task begun in my last column. Then I made the case for electing Michael Dukakis. Today I undertake the comparably Herculean task of arguing George Bush's case.

is Bush better than he seems? No. This low. dishonest campaign, which squandered the precious commodity of the nation's attention. was the carefully prepared and freely chosen culmination of his public life to date. He seems to have passed through the tumults of the 20th century unmarked by any of its great passions or arguments or aspirations. Paradoxically, that may be the key to putting the best face on his performance.

Perhaps he has campaigned basely because he has, in place of substantive political motives, a single ideal. He is moved entirely by an abstract duty to "serve," not by any idea he wants to be in the service of. In the absence of ideas, mere tactics are everything.

He is at once vaguely admirable and ominously empty. What matters is who will fill him up.

That brings us to 5,000 reasons for electing Bush. They are the appointments, from senior White House and Cabinet officers on down. that a President makes or are made in his name. An important question in any election. and the crucial question when both candidates are so inadequate, is: Which party has the better pool of talent from which to draw? The Republican Party is to be preferred until the Democratic Party regains its political acumen and intellectual vigor.

Three other reasons for preferring Bush also pertain to the presidential power to shape the composition of government. Four days after the election. Harry Blackmun will become the third Supreme Court Justice over 80. The others are William Brennan and Thurgood Marshall. All three are liberals. The next president probably will have at least three nominations to make.

Almost the entire public agenda seems to pase through courts. It is urgent that new justices reverse the tendency to turn what should be legislative decisions into litigation. This is important to the rejuvenation of the Democratic Party. The liberal party's powers of persuasion have strophied as liberals have increasingly relied on judicial flat rather than mass persuasion to achieve their aims.

A Bush-directed change in the Court's composition might result in reversal of the 1973 abortion ruling, but that might not result in much change in abortion policy. It would ignite 50 arguments by restoring to states the right to regulate abortion. The arguments are needed, given such bio-medical developments as intra-uterine medicine. But abortion is, after circumsion, the nation's most common surgical procedure. The culture has moved far in 15 years and there now is a majority in favor of liberal abortion laws.

The careful selection of justices requires an interest in constitutional theories that is as foreign to Bush as Mongolia. Liberals should take comfort from the possibility thathe may squander his opportunities. There is precedent. Two of the three liberal octogenarians were appointed by Republicans-Brennan by Eisenhower (who also nominated Warren) and Blackmun by Nixon. The fourth liberal.

In foreign policy, Sush will offer warmedover Reaganism-whatever Reganism means after eight years of dilution. Reagan's grand passion, the Reagan Doctrine-aid to armed resistance within the Soviet impire (Nicaragua. Afghanistan), seems to matter little to Bush. Reagan has forcefully licensed detente, and hence the moral disarmament of the West. Thus there is little to do but watch to see if he is right-to see if the Soviet regime really has repudiated its first seven decades of words and deeds.

If not, we are in trouble too big for Bush. As Soviet military spending continues its steady increase, the U.S. defense budget is declining and is under increasing pressure that can not be residted by Bush, the anti-tax warrior.

Bush's probable secretary of state, James Baker, is a clever fellow, but h may suffer the diplomatic fidgets that afflict political dealmakers when they become diplomats. They think that deals made are the only meaningful reatifications of their exertions. The armscontrol lobby should rejoice. Arms agreements are always popular and Bush campaign indicates that no consideration will ever weigh more than crude political calculations.

Still, Bush may at least have the instinctive caution of a man without a compass.

The 6-AN treatment was stopped after six monu's when Rego broke out with pustules. Later, Rego was diagnosed as having amyotrophic lateral sciencels, or Lou Gehrig's disease. It is an incurable and fatal nerve disorder. Rego's attempts to find out if there was a connection between 6-AN and the disease led the FDA to look into Zackheim's use of the drug.

Zackheim disputed claims that Rego didn't know the drug was experimental, and denied any connection with Lou Gehrig's disease. The doctor told our associate Stewart Harris that the paperwork informing Rego of the experimental nature of the drug was lost. At the very least, Zackheim said that he told Rego he was using an experimental treatment

If he did tell Rego, that was not reflected in the medical files reviewed by FDA investigators. In fact, the investigators reported that half of the 52 patient's charts they looked at did not contain consent forms.

Zackheim also failed to follow proper research protocol and mixed his skin ointment with the controversial chemical DMSO without FDA approval, according to the investigators' report.

Faced with the evidence, Zackheim signed an agreement with the FDA saying he would not do any more studies using more than 20 subjects and that his research will be closely supervised.

Zackheim told us he didn't like the agreement, but said he signed it because, "If I did not sign it, I would not be allowed to continue my research."

FDA investigators have documented numerous cases of researchers who failed to obtain informed consent from patients before using an experimental drug. One FDA official told us that most cases are simply paperwork. problems. Subjects learn informally about the drugs, but they don't sign the forms. FDA investigators are understandably edgy about the informality.

Concern over the use of experimental drugs prompted Rep. Fortney "Pete" Stark, D-Calif., to draft a bill that would cut off Medicare funds to researchers who don't follow the rules on those drugs.

Stark's bill did not pass before Congress adjorned, but he said he would introduce it again next year.

Americans choose 41st president today

A confident Republican George Bush ended his campaign with a raucous rally in Texas, but underdog Democrat Michael Dukakis stumped around the clock today as Americans cast the first votes for the 41st president of the United States.

"It's in the hands of the gods and the American people," Bush told reporters wearily at the conclusion of the nearly twoyear race for the White House. "I feel good about the election. I feel strong."

The Republican entered today's voting with a lead in public polls ranging from 4 to 12 percentage points, and he expected to become the first sitting vice president elected to the Oval Office since Martin Van Buren in 1836.

But Dukakis, the Massachusetts governor, refused to give up and campaigned well into the early morning hours. hopscotching from San Francisco to Boston and predicting a "November surprise" in the form of the biggest upset since Harry Truman stunned Thomas Dewey in 1948

Holding to a 28-year-old tradition, the 38 registered voters of the mountain hamlet of Disville Notch, N.H., cast the nation's first ballots after midnight Monday. Bush won 34 votes: Dukakis got three: one went to New York Rep. Jack Kemp, who vied unsuccessfully for the GOP presidential nomination.



Action heats up in Golden Age Games competition At age 70, Louise Wing keeps on wowing 'em in the swimming pool

SANFORD — Louise Wing docsn't need sequins on her suit to stand out from the crowd in the synchronized swimming arena.

At the age of 70, Wing is a 15-year veteran of the competition.

"I was working as director of swimming at the Boston YWCA when the sport first was opened to women," Wing said Monday. "I was considered 'too old' for competition, but I really loved the gracefulness of the sport."

For several years, she got her feet wet in the sport through coaching and judging. She organized and choreographed shows at the Y, as well as started the first synchronized swim league in New England, but felt that age was a barrier to competition for herself.

Nowadays. Wing is one of the finest swimmers in her age group. She has won a gold medal in the Golden Age Games every year since she began competing. The Southland Corporation named her Olympian of the Year for 1988.

Part of the key to her success is her athletic talents coupled with her musical background. Wing studied the french horn at the Julliard School of Music.

"It helped build up my lungs," she said. Wing is modest about her winnings, however

and would rather talk about the benefits of the sport for older Americans.

"I would suggest the sport in anyone. It's fun and it keeps one fit," she said. "I have very bad arthritis. If it weren't for this I probably wouldn't be able to get out of a chair to exercise."

When Wing started competing and doing well, she started travelling to contests all over the country. When her husband Fred retired, he would sometimes travel with her. He complained, however, that while she was busy winning gold medals, he was bored.

She said that when she and Fred were married 37 years ago she worked during the day, but she "had to be home when he walked through that door in the evening." Though she's a very strong-willed woman, she said that women just did things that way at the time.

It took several years to convince him, but four years ago. Fred, then 72, slipped into the pool to take Louise's class at the Y.

"It's so much fun doing this together," she said.

While Fred's scores average about 5 (a perfect score is 10), Louise is more apt to be awarded scores in the range of 6½ or 7. She said they are a pretty good duo and will compete in the mixed team contest in the Games.

This summer the Wings plan to travel to Denmark to compete in the World Masters competition.





WASHINGTON - Ronald Reagan, hoping for a political milestone not seen in 152 years. rested at the White House today after a sentimental journey to California for the presidential bid of his loyal protege, George Bush.

Though it was a marathon round trip for the 77-year-old leader. Reagan flew to his western home base on the eve of today's election because Re-

publicans worried California was a lossup between Bush and Democrat Michael Dukakis and the president has proved an effective surrogate for the GOP ticket.

True to form. the former governor rallied the Golden State faithful and had tears in his eyes by the time his day ended in San Diego, as several hundred fans joined him in singing "God Bless America" and gave him the American flag flown at the final rally in front of a shopping mail.

"My name is not on the ballot and won't appear on the ballot ever again." Reagan reminded the crowd. "But if my name is not on the ballot tomorrow, something more important is a principle, a legacy. And that's why I'm here today, to ask you to turn out the vote tomorrow ... so our principles survive, our legacy endures and our truth goes marching on."

Rebeis from the Farabundo Marti National Liberation Front said in a broadcast on clandestine "Radio Venceremos" early Tuesday that they "will continue with actions against officials of the corrupt regime of Jose Napoleon Duarte."

The FMLN is waging an 8-year-old war against the U.S.-backed government of ailing President Duarte. The rebels have stepped up attacks as the March 1989 presidential elections draw closer.

Police said that four bombs designed to spread FMLN propaganda pamplets also exploded Monday evening in the center of San Salvador. There were no injuries or damage.

China quake toll expected to climb

BEIJING - Authorities today were still trying to assess the damage from a massive earthquake that struck a remote mountain region of southwest China two days ago, killing at least 600 people and severing roads and communications over a wide area.

The quake, one of the worst to hit China this century, struck Sunday night in southwestern Yunnan Province. It measured 7.6 on the open-ended Richter scale, officials of the State Seismological Bureau said in Beijing.

Severe damage was reported around the towns of Lancang and Menglian, about 1,600 miles southwest of Beijing near the border with Burma.

Officials said the powerful temblor destroyed most of the houses in Lancang and an adjacent county and damaged

Photographer held in Spain returns home

NEW YORK - The parents of an American photographer sentenced in Spain to six years in prison for a cocaine smuggling conviction held out little hope for their son's quick release despite his transfer to the United States. Conan Owen, 24, of Annan-

dale, Va., arrived Monday in New York along with Justice Department officials who accompanied him on a flight from **Barcelona's El Prat international** airport.

Owen, who once worked as an intern for Vice President George Bush, was sentenced in April to six years and a day in prison and fined \$18,000 for smuggling nearly \$200,000 worth CF cocalne into Spain in the faise bottom of a sultcase. A Barcelona judge refused to accept a confession by a drug trafficker in a U.S. federal court that Owen had been framed.

A parole hearing for Owen was scheduled for the week of Nov. 21. a Justice Department official said in Washington.

The Spanish government approved Owen's transfer Oct. between the European Community and the United States that allows prisoners to serve out their terms in their own countries.

predicted the final toll would be much higher.

The official said he tried to drive to Lancang on Monday, but was forced to turn back because of massive slides along the road. The county has a population of about 40.000, he said

"Troops are racing to clear the road now," the official said. "Butaccording to early radio reports. from rescue learns that have reached Lancang, damage to the families of the victims. Xinhua town is extremely severe and most buildings are down."

A reporter at the official Xinhua News Agency, also and many telephone lines rereached by telephone, put confirmed deaths at between 200 and 300.

Officials said the provincial government had launched a major relief effort, sending medical teams and utility crews into the area and planning to dropemergency supplies by airplane. including tents, food and medicine.

At least 34 aftershoeks were felt between Sunday night and Monday morning, most between 4 and 5 on the Richter scale. officials said.

Yunnan Province Gov. He Zhiqiang flew by helicopter to the quake's center from the provincial capital of Kunming. and Premier Li Peng voiced sympathy for local residents and sent "heartfelt condolences" to said.

Main roads into the area were blocked by damage and debris mained cut, officials said.

It was the worst earthquake disaster in China since a massive quake destroyed the city of Tangshan, cast of Beijing, in 1976. killing 240.000 people.

More than half of China's major cities lie in potentially dangerous seismic zones. Morethan 100 earthquakes have been recorded in China this century.

36 killed in Philippine landslide by Typhoon Skip

MANILA. Philippines - Typhoon Skip, the third killer storm to hit the Philippines in two weeks, blew into the South China Sea early. today, leaving behind a swath of flattened homes, grounded ships and a landslide that devastated a village. At least 36 people were killed.

Hundreds of thousands of people were left homeless by the typhoon, which slammed into east-central Leyte island with winds of 110 mph Monday afternoon and plowed west across the archipelago overnight.

The storm left the Philippines and moved into the South China Sea with slightly diminished force after sunrise today. Weathermen said Skip was heading toward Vietnam Tuesday evening.

Philippine relief officials immediately began tallying damage reports from the remote islands of the central Visayan region, many of which were cut off from communications. The same area hore the brunt of Typhoon Ruby. which killed at least 300 people on Oct. 24.

Skip forced at least two ships to run aground and two others were reported missing.

Authorities said 19 crewmen fled in a life raft when the tanker Ethane ran aground off Tres

Reyes island 110 miles south of Manila. The sations were believed to have made it to a nearby lighthouse safely.

Another vessel, the Oroquieta City, was reported missing but officials could not say what kind of ship it was or how many people. were aboard.

A passenger ship, the Sampaguita, went aground near Zamboanga in the extreme southern Philippines but all passengers and crew were reported safe. Search crews also were looking for a small boat with one personaboard that went adrift in the same area when a towline from a university research vessel broke.

Combined reports from relief agencies showed at least 36 people died during the typhoon, most of them drowning victims. The deaths included nine in Manila, 10 in Camarines Sur province, seven on Panay island, seven on Negros island and three on Mindoro Island

Rescuers were digging through tons of mudin Santa Rosa village in Camarines Surprovince, 170 miles southeast of Manila, where several homes were destroyed and 20 people were missing under a landslide caused by torrential rains. Four bodies had been recovered from the site.

Poisoning suspected in Haitian colonel's death

PORT-AU-PRINCE. Halli -Diplomate say the death of Col. Jean-Claude Paul, a suspected drug trafficker who died after eating what police believe was polaoned pumpkin soup, may help case tensions between the United States and Haiti.

said Monday that officers arrested Mireille Delinois, Paul's former wife, and two servants shortly after his death Sunday.

Independent Radio Raiti Inter quoted Valcin as saying the three were suspected of potsoning Paul's pumpkin soup. No motive was disclosed.

Paul, Delinois and Paul's brother. Antonio, were indicted in March by a federal grand jury in Miami on charges they smuggled more than 200 pounds of Colombian cocaine to the United States in 1986 through a landing strip at Paul's farm.

Delinois was arrested in Miami on a drug charge in March 1987 but fled to Haiti after posting ball.

A diplomat said that Paul's death might help case tensions. between the United States and Halti stemming from Washington's anger over cocaine amuggled through the troubled Caribbean nation from South America.

"He is not in this world. anymore and this is something that has passed." said the diplomat, who spoke on condition of anonymity. "Jean-Claude Paul or not, in terms of drug fighting. (Haiti and the United States) are cooperating right now."

The United States has made June. suppression of drug smuggling a key to restoring \$70 million in annual economic aid to Haiti. The assistance was cut off after November 1987 elections were halted by gunmen allied with the least 34 people.

NEW YORK - Only two people showed up to enroll in a government program giving free needles to drug addicts, but the city's health commissioner suggested critics "ask me in 90 days" if the program is a suc-CC35.

The two enrollees - both described as men who had been put on a waiting list at a Brooklyn drug rehabilitation center - were given needles at the city Health Department's downtown headquarters, said Commissioner Stephen Joseph

The controversial pilot program to distribute free hypodermic needles to intravenous drug users, described as the first governmentsponsored program of its kind inthe United States, is designed to slow the spread of AIDS. Shared needles are one of the major sources of transmission of the virus that causes the deadly discase.

"The AIDS epidemic has been drawn to the drug epidemic," Joseph said, "AIDS has become the worst health crisis in modern times."

He suggested that critics "ask me in 90 days" whether the Pilot Needle Exchange Study has been a success.

Joseph has taken heat from law enforcement officials and members of the black and Hispanie communities, who have blasted the plan to give needles to drug users as a form of "genocide" and a step toward legalization of drug use.

But city officials said the thrust of the program would be almed at getting participants into drug treatment programs.

More than 17,000 AIDS cases have been diagnosed in the city since 1981, said Sam Friedman. a Health Department spokesman.

Joanne Thomas, of the Bronx. who spent more than three hours at the Health Department wailing to get a birth certificate. agreed.

But an attorney for Fantasy Records was upset by Fogerty's performance.

Leonard stops Lalonde

LAS VEGAS. Nev. - After defeating Marvin Hagler in his previous bout, Ray Leonard gazed in the mirror the next day and sold he hardly looked like someone who had been in a fight.

He won't feel that way Tuesday. Leonard became the first boxer in history to win titles in five weight classes Monday night, but took more of a beating than usual.

Leonard went down for the second time in his career Monday night and had his nose bloodied in the fourth round before rallying to stop Donny Lalonde at 2:30 of the ninth round.

Leonard took Lalonde's World Boxing Council light heavyweight title and the new WBC super middleweight crown. He previously held championships in the welterweight, junior middleweight and middleweight divisions.

"The knockdown was similar to Kevin Howard in 1984," said Leonard, referring to the first knockdown of his career. "I knew what he was going to do, and he came on strong. It wasn't a matter of lighting out of desparation. It was a matter of me gaining respect."

Oilers shoot down Browns, 24-17

HOUSTON - Warren Moon and the Houston Oilers finally beat the Cleveland Browns' jinx.

Moon, who had not beaten Cleveland in eight starts since joining the NFL in 1984, threw one touchdown pass and Mike Rozier and Alonzo Highsmith ran for scores Monday night, leading the Otlers to a 24-17 victory over the Browns. their AFC Central rival.

"I said at the beginning of this year if we wanted to win this division, we would have to beat Cleveland," said Moon, whose team has wonnine straight in the Astrodome. "We're in prettygood position now. We only trail Cincinnati by one game and they still have to play here later this year."

Houston, 7-3, remained one game behind the division-leading Bengals while the Browns, bidding for a fourth straight division title. dropped two games back at 6-4.

The victory was the first by Houston over Cleveland since 1983, not counting last year's strike game. Cleveland had won four in a row in Houston, including a 40-7 pounding last year.

Houston rushed for 148 yards while the Otlers defense held Cleveland to just 44 yards rushing.

"There should be 50 game balls given out tonight," said Houston Coach Jerry Glanville, You can't say enough about Warren Moon. The things he did tonight, maybe only he and Bernie. Kosar can do in a game."

Moon completed 11 of 17 passes for 182 yards. including an 8-yard TD strike to Ernest Givins, Rozier scored on a 3-yard run and Highsmith ran in from 1 yard out.

Tony Zendejas added a 47-yard field goal with 1 44 left to give Houston a 24-17 lead. Cleveland had one more possession and moved to its 44 before Kosar couldn't handle a high snap out of the shotgun Ray Childress recovered for Houston and the Otlers ran out the clock.

"In a close game between evenly-matched teams, you have to make plays and we just didn't make enough of them." said Cleveland Coach Marty Schottenheimer.

Zendejas missed a 52-yard field goal on the game's opening drive, then Bahr hit a 40-yarder with 5:18 left in the first quarter.

Houston came back with a 51-yard drive, capped by Highsmith's 1-yard run, his first score. of the season.

Cleveland threatened just before halftime, but did not use a time out to stop the clock and Kosar's pass to Langhorne in the endzone from 10 yards out was overthrown, leaving Houston with a 7-3 lead.





Leonard was the far quicker fighter, but felt the power in Lalonde's right hand in the fourth round. After staying away from Lalonde for three rounds. Leonard decided to pick up the pace and attack in the fourth.

He landed several jabs and a good left-right combination, but paid for his boldness. Lalonde landed a short right from close quarters and Leonard stumbled to the canvas. He jumped right up at three, but caught another big Lalonde right hand that brought blood from his nose and forced Leonard to hold on.

Leonard led on two of the three judges cards entering the ninth. Chuck Glampa had Leonard leading by three points and Franz Marti had him ahead by two. Suprisingly, Stuart Kirschenbaum had Lalonde ahead by one point.

Lalonde, at 167 pounds and 6 foot-1 15, had two pounds and three inches in height over Leonard, but Leonard compensated by smothering his bigger opponent whenever Lalonde missed.

Leonard found the range with his left hook in the fifth round and kept peppering Lalonde with It to back up the champion and wear him down.

Lalonde lived down to his reputation as a one-armed puncher. But his right hand proved a punishing weapon. Leonard knew it was coming. but still caught some flush shots. He credits Lalonde for that.

"The fight indicated this man is for real." Leonard said. "When I would throw a right, he would throw a right hand, and being taller and quick, his would get there first.

"He got a little right-hand happy, but he timed it well."

DEAR DR. GOTT: 1 get severe tching and blisters from all the heart patches I've tried. My Estraderm patches are fine. I'd radier have patches than take pills. What do you suggest? DEAR READER: Many medi-

cines, such as nitratres (for angina) and female hormones (for menopause) are now available in patch. rather than pill. form. Patients can suffer allergic reactions to one or more components - including the adhesive of dermal delivery systems. You may have to resort to pills in order to avoid the itching and

If you are using nitroglycerine patches for heart trouble, your doctor might try you on nitroglycerine paste instead. However, in my practice, I've found that pilis, despite their inconve-nience, are usually a reliable substitute for patches.





Closing arguments begin in Kirk trial

MEMPHIS, Tenn. - Prosecutors called Dana Kirk a greedy schemer who cheated the federal government but of \$80,000 in tay's, but the defense contended that the fired Memphis State basketball coach is guilty only of ignorance of the law and sloppy bookkeeping. U.S. Attorney Hickman Ewing Jr. and defense lawyer alim Paines tays those conflicting are

lawyer Jim Raines gave those conflicting portrayals of Kirk Monday during closing arguments of his trial on charges of tax evasion and obstruction of justice. The case could go to the jury today.

Ewing summarized the government's case in a two-hour closing argument before the federal jury

"He became a man who wanted money and more money, and he cut corners and bent rules more money, and he cut corners and bent rules and left money off his tax returns. When confronted, he didn't say, 'I made mistakes.' He did everything he could to mislead the IRS, and asked people to obstruct justice. Had he been successful, maybe we wouldn't be here today." Raines was steadfast in his denial that Kirk

broke any laws, claiming instead that a miscue does not constitute breaking the law.

"You cannot commit a crime by being lazy, by being poorly educated," Raines told the jury. "You cannot commit a crime by relying on anybody else. That's the law, ladies and gentlemen."

Defense lawyers say Kirk's wife handled all the family finances, characterizing Kirk as un-sophisticated and having little knowledge of tax rules and financial matters.

Ewing rebuffed the description, however, say-ing Kirk arranged the numerous promotional deals and speaking engagements, as well as his Memphis State contract, that earned him the money.

"Well, if he was such a poor country boy, unsophisticated, how did he end up with \$550,000 in the bank. He was sharp," Ewing said. Ewing said Kirk could have succeeded in bilking the government had not a federal grand jury subprenaed his bank records in an investigation of college sports gambling. He said Kirk took business deductions on his

He said Kirk took business deductions on me taxes and filed the tax forms for his summer basketball camps, yet claimed to know nothing about business. He also said Kirk did not take advantage of tax shelters because he did not want his accountants to know of the income he samed. his accountants to know or the income ne earned. Ewing said the definat's contention that Kirk comitted income from his return through sloppi-ness or forgetfulness was unbelieveable. "You might leave one thing off your return. You might leave two things off your return. You might even leave three off your return. But 13 in one year and 15 in another - to believe that somebody would just forget that defies any reason."

Drexel said to discuss chairmanship with Baker

WASEDNGTON - Embattled Wall Street firm DreigtBurnham Lambert Inc. has been talking to former White House chief of staff Howard Baker about becoming the company's new chairman. The Washington Post reported Tuesday.

The private negotiations are seen by some company officials as a way of possibly avoiding criminal charges, said the newspaper, which quoted unidentified sources. Neither the company nor Baker would discuss directly the status of the talks. Drezel did issue a statement acknowledging it has been working with Baker and his law firm in Tennessee "on matters relating to internal corporate governance. and which are unrelated to either the ongoing investigation by the U.S. attorney or any Washington matters," the Post said. Senior executives at Drexel have talked about the possibility of Baker's becoming chairman as part of internal discussions aimed at avoiding criminal securities fraud charges. Some of the company's executives hope the arrival of such a widely respected former official would persuade New York U.S. Attorney Rudolph Giuliani not to name Drexel in an expected racketeering indictment, sources told the Post. In the past few weeks, lawyers for Drexel have been trying to persuade the Justice Department in Washington that racketeering charges against the firm would not be justified. If Drexel were not able to head off an indictment in Washington. then the firm would begin a final round of talks with Giuliani, the sources said. No such talks are underway, the newspaper said.


